## THERE ARE TWO WAYS TO REQUEST A CERTIFICATE OF ATTENDANCE:

#### **OPTION 1: PAPERLESS**

Check-in to sessions you attend via the conference app. You must check-in while the session is in progress. Each presenter has a four-digit code that they will provide to attendees during their session. Use the step-by-step instructions below to check-in to sessions you attend. You **must** check-in to **every** session you attend to properly track.


### **OPTION 2: USE THE PAPER FORM**

Check-in can be completed 5 minutes before the session begins and until the session ends. You cannot check-in to a session once it ends.


#### THINGS TO KNOW:
