CHAPTER 33 THE CIVIL PROCEDURE CODE

An Act to provide for the procedure and related matters in civil proceedings.

PART IA PRELIMINARY PROVISIONS

Short title	1 . This Act may be cited as the Civil Procedure Code.
Application	2. ¹ Subject to the express provisions of any written law, the provisions of this Code shall apply to all proceedings in the High Court of the United Republic, courts of resident magistrates and district courts.
Interpretation	3. In this Code, unless the context requires otherwise-
Cap. 341	 "advocate" has the meaning ascribed to it in the Advocates Act; "court", except in the expression "foreign court", means the High Court of the United Republic, a court of a resident magistrate or a district court presided over by a civil magistrate and references to a district court are references to a district court presided over by a civil magistrate; "decree" means the formal expression of an adjudication which, so far as regards the court expressing it, conclusively determines the

rights of the parties with regard to all or any of the matters in controversy in the suit and may be either preliminary of final and it shall be deemed to include the rejection of a plaint and the determination of any question within section 38 or section 89, but shall not include-

- (a) an adjudication from which an appeal lies as an appeal from an order; or
- (b) any order of dismissal for default.
- *Explanation:* A decree is preliminary when further proceedings have to be taken before the suit can be completely disposed of. It is final when such adjudication completely disposes of the suit. It may be partly preliminary and partly final;
- "decree-holder" means any person in whose favour a decree has been passed or an order capable of execution has been made;
- "foreign court" means a court situated beyond the limits of Tanzania which has no authority in Tanzania;
- "foreign judgment" means the judgment of a foreign court;
- "High Court" means the High Court of the United Republic;
- "judgment" means the statement given by a judge or a magistrate of the grounds for a decree or order;
- "judgment debtor" means any person against whom a decree has been passed or an order capable of execution has been made;
- "legal representative" means a person who in law represents the estate of a deceased person, and includes any person who intermeddles with the estate of the deceased and where a party sue or is sued in a representative character, the person on whom the estate devolves on the death of the party so suing or sued;
- "mesne profits" of property means those profits which the person in wrongful possession of such property actually received or might, with ordinary diligence, have received therefrom together with interest on such profits, but shall not include profits due to improvements made by the person in wrongful possession;
- "movable property" includes growing crops;

- "order" means the formal expression of any decision of a civil court which is not a decree;
- "rules" means the rules contained in the First and Second Schedules or made under sections 29, 45 or 82;
- "share in a corporation" shall be deemed to include stock, debenture stock, debentures, or bonds; and
- "signed" save in the case of a judgment or decree, includes stamped.

4. For the purposes of this Code, every court of a resident magistrate and every district court is subordinate to the High Court, and every district court is subordinate to the court of the resident magistrate within the area of whose jurisdiction it is situate.

5. In the absence of any specific provision to the contrary, nothing in this Code shall be deemed to limit or otherwise affect any special form of procedure prescribed by or under any other law for the time being in force.

6. Save in so far as is otherwise expressly provided, nothing herein contained shall operate to give any court jurisdiction over suits the amount or value of the subject matter of which exceeds the pecuniary limits (if any) of its ordinary jurisdiction.

PART I

JURISDICTION OF COURTS AND RES JUDICATA

7.-(1) Subject to this Act the courts shall have jurisdiction to try all suits of a civil nature excepting suits of which their cognizance is either expressly or impliedly barred.

(2) No suit shall be open to objection on the ground that a merely declaratory judgment or order is sought thereby, and a court may make binding declarations of right whether or not any consequential relief is or could be claimed.

8. No court shall proceed with the trial of any suit in which the matter in issue is also directly and substantially in issue in a previously instituted suit between the same parties, or between parties under whom they or any of them claim litigating under the same title where such suit is pending in the same or any other court in Tanzania having jurisdiction to grant the relief claimed.

Explanation: The pendency of a suit in a foreign court does not preclude the courts in Tanzania from trying a suit founded on the same cause of action.

9. No court shall try any suit or issue in which the matter directly and substantially in issue has been directly and substantially in issue in a former suit between the same parties or between parties under whom they or any of them claim litigating under the same title in a court competent to try such subsequent suit or the suit in which such issue has been subsequently raised and has been heard and finally decided by such court.

- *Explanation I*: The expression "former suit" shall denote a suit which has been decided prior to the suit in question whether or not it was instituted prior thereto.
- *Explanation II:* For the purposes of this section, the competence of a court shall be determined irrespective of any provisions as to a right of appeal from the decision of such court.

Explanation III: The matter above referred to must in the former suit have been alleged by one party and either denied or

10. Where a plaintiff is precluded by rules from instituting a further suit in respect of any particular cause of action, he shall not be entitled to institute a suit in respect of such cause of action in any court to which this Code applies.

11. A foreign judgment shall be conclusive as to any matter thereby directly adjudicated upon between the same parties or between parties under whom they or any of them claim litigating under the same title except-

- (a) where it has not been pronounced by a court of competent jurisdiction;
- (b) where it has not been given on the merits of the case;
- (c) where it appears on the face of the proceedings to be founded on an incorrect view of international law or a refusal to recognise the law of Tanzania in cases in which such law is applicable;
- (d) where the proceedings in which the judgment was obtained are opposed to natural justice;
- (e) where it has been obtained by fraud;
- (f) where it sustains a claim founded on a breach of any law in force in Tanzania.

Where a suit is to obtain relief respecting, or compensation for wrong to, immovable property situate within the jurisdiction of different courts, the suit may be instituted in any court within the local limits of whose jurisdiction any portion of the property is situate if, in respect of the value of the subject matter of the suit, the entire claim is cognizable by such court.

Place of institution of suit where local limits of jurisdiction of courts are uncertain

16.-(1) Where it is alleged to be uncertain within the local limits of the jurisdiction of which of two or more courts any immovable property is situate, any one of those courts may, if satisfied that there is ground for the alleged uncertainty, record a statement to that effect and thereupon proceed to entertain and dispose of any suit relating to that property, and its decree in the suit shall have the same effect as if the property were situate within the local limits of its jurisdiction:

Provided that the suit is one with respect to which the court is competent as regards the nature and value of the suit to exercise jurisdiction.

Suits for immovable property situate within jurisdiction of different courts (2) Where a statement has not been recorded under subsection (1), and an objection is taken before an appellate or revisional court that a decree or order in a suit relating to such property was made by a court not having jurisdiction where the property is situate, the appellate or revisional court shall not allow the objection unless in its opinion there was, at the time of the institution of the suit, no reasonable ground for uncertainty as to the court having jurisdiction with respect thereto and there has been a consequent failure of justice.

17. Where a suit is for compensation for wrong done to the person or to movable property, if the wrong was done within the local limits of the jurisdiction of one court and the defendant resides, or carries on business, or personally works for gain, within the local limits of the jurisdiction of another court, the suit may be instituted at the option of the plaintiff in either of the said courts.

18. Subject to the limitations aforesaid, every suit shall be instituted in a court within the local limits of whose jurisdiction-

- (a) the defendant, or each of the defendants where there are more than one, at the time of the commencement of the suit, actually and voluntarily resides, or carries on business, or personally works for gain;
- (b) any of the defendants, where there are more than one, at the time of the commencement of the suit, actually and voluntarily resides, or carries on business, or personally works for gain, provided that in such case either the leave of the court is given or the defendants who do not reside or carry on business, or personally work for gain, as aforesaid, acquiesce in such institution; or
- (c) the cause of action, wholly or part, arises.
- *Explanation I:* Where a person has a permanent dwelling at one place and also a temporary residence at another place, he shall be deemed to reside at both places in respect any cause of action arising at the place where he has such temporary residence.
- *Explanation II*: A corporation shall be deemed to carry on business at its sole or principal office in Tanzania, or, in respect of any cause of action arising at any place where it is, has also a subordinate office, at such place.

Objections to jurisdiction **19.** No objection as to the place of suing shall be allowed by any appellate or revisional court unless such objection was taken in the court of first instance at the earliest possible opportunity and, in all cases where issues are settled, at or before such settlement, and unless there has been a consequent failure of justice.

- (b) on the application to such resident magistrate of a party to the suit and after notice to the parties and after consideration of objections (if any) of any party such resident magistrate may, at any stage before any evidence has been taken in the suit, transfer the suit for trial by himself; or
- (c) of his own motion, such resident magistrate may, at any stage before evidence has been taken in the suit, transfer the suit for trial by himself:

Provided that the exercise of the powers conferred by paragraph (b) or (c) hereof shall be subject to such limitations or conditions, if any, as the Chief Justice shall impose by rules of court and provided further that this section shall not affect the powers of the High Court under section 21.

General power of transfer and withdrawal **21**.-(1) On the application of any of the parties and after notice to the parties and after hearing such of them as desire to be heard, or of its own motion without such notice, the High Court may at any stage-

- (a) transfer any suit or other proceeding pending before it for trial or disposal to any court subordinate to it and competent to try or dispose of the same; or;
- (b) withdraw any suit or other proceeding pending in any court subordinate to it, and-
 - (i) try or dispose of the same;
 - (ii) transfer the same for trial or disposal to any court subordinate to it and competent to try or dispose of the same; or
 - (iii) retransfer the same for trial or disposal to the court from which it was withdrawn.

(2) Where any suit or proceeding has been transferred or withdrawn under subsection (1), the court which thereafter tries such suit may, subject to any special directions in the case of an order of transfer, either re-try it or proceed from the point at which it was transferred or withdrawn.

(3) The powers of transfer and withdrawal of suits conferred by this section and section 20 shall be in addition to and not in substitution

Institution of Suits

Institution of **22.** Every suit shall be instituted by the presentation of a plaint or suits in such other manner as any be prescribed.

Summons and Discovery

Summons 23. Where a suit has been duly instituted, a summons may be defedant issued to the defendant to appear and answer the claim and may be served in the manner prescribed.

> 24.-(1) A summons may be sent for service to another court in Tanzania within the local limits of whose jurisdiction the defendant may be believed to be residing.

> (2) The court to which such summons is sent shall, upon receipt thereof, proceed as if it has been issued by such court and shall then return the summons to the court of issue together with the record (if any) of its proceedings with regard thereto.

25. Subject to such conditions and limitations as may be prescribed, the court may, at any time, either of its own motion or on application of any party-

- make such orders as may be necessary or reasonable in all (a) matters relating to the delivery and answering of interrogatories, the admission of documents and facts and the discovery, inspection, production, impounding and return of documents or other material objects producible as evidence;
- issue summonses to person whose attendance is required (b) either to give evidence or to produce documents or such other objects as aforesaid; or
- order any fact to be proved by affidavit. (c)

Summons to **26**. The provisions of sections 23 and 24 shall apply to summonses to give evidence or to produce documents or other material objects.

> 27. The court may compel the attendance of any person to whom a summons has been issued under section 25 and for that purpose may-

- (a) issue a warrant for his arrest;
- attach and sell his property; (b)
- impose a fine upon him not exceeding one thousand (c) shillings; or
- (d) order him to furnish security for his appearance and in

Delivery of Decision

Act No. 2 of 2005 s. 45 208. After the case has been heard, the court shall deliver a decision in open court as soon as possible, but in any case it shall not exceed ninety days of which due notice shall be given to the parties or their advocates, if any.

Interest

Interest on judgment debts

Costs

29. The Chief Justice may make rules prescribing the rate of interest which shall be carried by judgment debts and, without prejudice to the power of the court to order interest to be paid upon to date of judgment at such rates as it may deem reasonable, every judgment debt shall carry interest at the rate prescribed from the date of the delivery of the judgment until the same shall be satisfied.

30.-(1) Subject to such conditions and limitations as may be prescribed and to the provisions of any law from the time being in force, the costs of, and incidental to, all suits shall be in the discretion of the court and the court shall have full power to determine by whom or out of what property and to what extent such costs are to be paid, and to give all necessary directions for the purposes aforesaid; and the fact that the court has no jurisdiction to try the suit shall be no bar to the exercise of such powers.

(2) Where the court directs that any costs shall not follow the event, the court shall state its reasons in writing.

(3) The court may give interest on costs at any rate not exceeding seven percent per annum and such interest shall be added to the costs and shall be recoverable as such.

PART II

EXECUTION

General

31. The provisions of this Code relating to the execution of decrees shall, so far as they are applicable, be deemed to apply to the execution of orders.

Definition of "court which passed a decree"

Application

to orders

32. The expression "court which passed a decree" or words to that effect shall, in relation to the execution of decrees, unless there is any thing repugnant in the subject or context, be deemed to include-

(a) where the decree to be executed has been passed in the exercise of appellate jurisdiction, the court of first instance; and

(b) where the court of first instance has ceased to exist or to have jurisdiction to execute it, the court which, if the suit wherein the decree was passed was instituted at the time of making the application for the execution of the decree, would have jurisdiction to try such suit.

Court by which Decrees may be Executed

33. A decree may be executed either by the court which passed it or by the court to which it is sent for execution.

Courts by which decrees may be executed

Transfer of decree

34.-(1) The court which passed a decree may, on the application of the decree-holder, send it for execution to another court-

- (a) if the person against whom the decree is passed actually and voluntarily resides or carries on business or personally works for gain, within the local limits of the jurisdiction of such other court;
- (b) if such person has no property within the local limits of the jurisdiction of the court which passed the decree sufficient to satisfy such decree and has property within the local limits of the jurisdiction of such other court;
- (c) if the decree directs the sale or delivery of immovable property situate outside the local limits of the jurisdiction of the court which passed it; or
- (d) if the court which passed the decree considers for any other reason, which it shall record in writing, that the decree should be executed by such other court.

(2) The court which passed a decree may of its own motion send it for execution to any subordinate court of competent jurisdiction.

Result of execution proceedings to be certified **35.** The court to which a decree is sent for execution shall certify to the court which passed it the fact of such execution or, where the former court fails to execute the same, the circumstances attending such failure.

Powers of court in executing transferred decree

Precepts

36. The court executing a decree sent to it shall have the same powers in executing such decree as if it had been passed by itself; and all persons disobeying or obstructing the execution of the decree shall be punishable by such court in the same manner as if it had passed the decree and its order in executing such decree shall be subject to the same rules in respect of appeal as if the decree had been passed by itself.

37.-(1) Upon the application of the decree-holder the court which passed the decree may, whenever it thinks fit, issue a precept to any other court which would be competent to execute such decree to attach any property belonging to the judgment debtor and specified in the precept.

(2) The court to which a precept is sent shall proceed to attach the property in the manner prescribed in regard to the attachment of property in execution of a decree:

Provided that no attachment under a precept shall continue for more than two months unless the period of attachment is extended by an order of the court which passed the decree or unless, before the determination of such attachment, the decree has been transferred to the court by which the attachment has been made and the decree-holder has applied for an order for the sale of such property.

Questions to be determined by Court Executing Decree

38.-(1) All questions arising between the parties to the suit in which the decree was passed, or their representative, and relating to the execution, discharge or satisfaction of the decree, shall be determined by the court executing the decree and not by a separate suit.

(2) The court may, subject to any objection as to limitation or jurisdiction, treat a proceeding under this section as a suit or a suit as a proceeding any may, if necessary, order payment of any additional court fees.

(3) Where a question arises as to whether any person is or is not the representative of a party, such question shall, for the purposes of this section, be determined by the court.

Limit of Time for Execution

39.-(1) Where an application to execute a decree, not being a decree granting an injunction, has been made no order for the execution of the same decree shall be made upon any fresh application presented after the expiration of twelve years from–

- (a) the date of the decree sought to be executed; or
- (b) where the decree or any subsequent order directs any payment of money or the delivery of any property to be made at a certain date or at recurring periods, the date of the default in making the payment or delivery in respect of which the applicant seeks to execute the decree.
- (2) Nothing in this section shall be deemed-
- (a) to preclude the court from ordering the execution of a decree upon an application presented after the expiration of the said term of twelve years where the judgment debtor has, by fraud or force, prevented the execution of the decree at some time within twelve years immediately before the date of the application; or
- (b) to limit or otherwise affect the operation of article 183 of the First Schedule to the Indian Limitation Act, as applied to Tanzania.

Transferee and Legal Representatives

40. Every transferee of a decree shall hold the same subject to the equities (if any) which the judgment debtor might have enforced against the original decree-holder.

Legal representative

Transferee

41.-(1) Where a judgment debtor dies before the decree has been fully satisfied, the holder of the decree may apply to the court which passed it to execute the same against the legal representative of the deceased.

(2) Where the decree is executed against such legal representative, he shall be liable only to the extent of the property of the deceased which has come to his hands and has not been duly disposed of; and for the purpose of ascertaining such liability, the court executing the decree may, of its own motion or on the application of the decree-holder, compel such legal representative to produce such accounts as it thinks fit.

Procedure in Execution

Powers of **42.** Subject to such conditions and limitations as may be court to prescribed, the court may, on the application of the decree-holder, order enforce execution of the decreeexecution

- by delivery of any property specifically decreed; (a)
- (b) by attachment and sale or by sale without attachment of any property;
- (c) by arrest and detention in prison;
- (e) in such other manner as the nature of the relief granted may require.

Enforcement **43.**-(1) Where a decree is passed against a party as the legal representative of a deceased person and the decree is for the payment of against legal money out of the property of the deceased, it may be executed by the representative attachment and sale of any such property.

> (2) Where no such property remains in the possession of the judgment debtor and he fails to satisfy the court that he has duly applied such property of the deceased as is proved to have come into his possession, the decree may be executed against the judgment debtor to the extent of the property in respect of which he has failed so to satisfy the court in the same manner as if the decree had been against him personally. Arrest and Detention

44.-(1) A judgment debtor may be arrested in execution of a decree at any hour and on any day and shall, as soon as practicable, be brought before the court, and the court may order his detention:

(d) by appointing a receiver; or

Provided that, for the purposes of making an arrest under this section-

- (a) no dwelling-house shall be entered after sunset and before sunrise;
- (b) no outer door of a dwelling-house shall be broken open unless such dwelling-house is in the occupancy of the judgment debtor and he refuses or in any way prevents access thereto, but when the officer authorised to make the arrest has duly gained access to any dwelling-house, he may break open the door of any room in which he has reason to believe the judgment debtor is to be found; or
- (c) if the room is in the actual occupancy of a woman who is not the judgment debtor and who, according to her religion or local custom, does not appear in public, the officer authorised to make the arrest shall give notice to her that she is at liberty to withdraw and, after allowing a reasonable time for her to withdraw and giving her reasonable facility for withdrawing, may enter the room for the purpose of making the arrest:

And provided further that where the decree in execution of which a judgment debtor is arrested is a decree for the payment of money, and the judgment debtor pays the amount of the decree and the costs of the arrest to the officer arresting him, such officer shall at once release him.

(2) Where a judgment debtor is arrested in execution of a decree for the payment of money and brought before the court, the court shall inform him that he may apply to be declared an insolvent, and that he will be discharged if he has not committed any act of bad faith regarding the subject of the application and if he complies with the provisions of the law of insolvency for the time being in force.

(3) Where a judgment debtor expresses his intention to apply to be declared an insolvent and furnishes security, to the satisfaction of the court, that he will within one month so apply and that he will appear, when called upon, in any proceeding upon the application or upon the decree in execution of which he was arrested, the court shall release him from arrest and, if he fails so to apply and to appear, the court may either direct the security to be realised or commit him as a civil prisoner in execution of the decree.

Subsistence allowance	45 . The Chief Justice may make rules prescribing scales of monthly allowances payable for the subsistence of judgment-debtors.
Detention and release	46 (1) Every person detained as a civil prisoner in execution of a decree shall be so detained-
	 (a) where the decree is for the payment of a sum of money exceeding one hundred shillings, for a period of six months; and

Provided that he shall be released from such detention before the expiration of the said period of six months or six weeks, as the case may be-

- (i) on the amount mentioned in the warrant for his detention being paid to the officer in charge of the prison;
- (ii) on the decree against him being otherwise fully satisfied;
- (iii) on the request of the person on whose application he has been so detained; or
- (iv) on the omission by the person on whose application he has been so detained to pay subsistence allowance:

Provided further that he shall not be released from such detention under clause (ii) or clause (iii) without the order of the court.

(2) A judgment debtor released from detention under this section shall not, merely by reason of his release, be discharged from his debt.

(3) Where a judgment debtor has been released from detention under this section before the expiration of the period of six months or six weeks, as the case may be, for which he was ordered to be detained, and the decree against him has not been fully satisfied he shall, if he was released on the request of the person on whose application he was detained but not otherwise, be liable to be re-arrested under the decree in execution of which he was detained.

(4) A judgment debtor who has been re-arrested under the provisions of subsection (3) of this section shall be detained as a civil prisoner for the remainder of the period of six months or six weeks, as the case may be, for which he would have been detained under the provisions of subsection (1) of this section if he had not been released from such detention under the proviso to that subsection:

Provided that he shall be released from such detention before the expiration of the remainder of the said period of six months or six weeks, as the case may be, in any of the circumstances specified in the first proviso to subsection (1) of this section.

47.-(1) At any time after a warrant for the arrest of a judgment debtor has been issued, the court may cancel it on the ground of his serious illness.

(2) Where a judgment debtor has been arrested, the court may release him if in its opinion he is not in a fit stat of health to be detained as a civil prisoner.

(3) Where a judgment debtor has been committed as a civil prisoner, he may be released-

Release on grounds of illness

- (a) by the officer in charge of the prison in which he is confined, on the ground of the existence of any infectious or contagious disease; or
- (b) by the committing court, or any court to which that court is subordinate, on the ground of his suffering from any serious illness.

(4) A judgment debtor released under this section may be rearrested but the period of his detention as a civil prisoner shall not in the aggregate exceed that prescribed by section 46.

Attachment

Property liable to attachment and sale in execution of decree Act No. 11 of 1976 Sch. **48**.-(1) The following property is liable to attachment and sale in execution of a decree, namely, lands, houses or other buildings, goods, money, banknotes, cheque, bills of exchange, promissory notes, Government securities, bonds or other securities for money debts, shares in a corporation and, save as hereinafter mentioned, all other saleable property, movable or immovable, belonging to the judgment debtor, or over which, or the profits of which, he has a disposing power which he may exercise for his own benefit, whether the same be held in the name of the judgment debtor or by another person in trust for him or on his behalf:

Provided that the following shall not be liable to such attachment or sale, namely-

- (a) the necessary wearing-apparel, cooking vessels, beds and bedding of the judgment debtor, his wife and children, and such personal ornaments as, in accordance with religious usage, cannot be parted with by any woman;
- (b) tools of artisans, and, where the judgment debtor is an agriculturist, his implements of husbandry and such cattle and seed-grain as may, in the opinion of the court, be necessary to enable him to earn his livelihood as such;
- (c) houses and other buildings (with the materials and the sites thereof and the land immediately appurtenant thereto and necessary for their enjoyment) belonging to an agriculturist and occupied by him;
- (d) any land used for agricultural purposes by a village, an Ujamaa Village, a co-operative society, or an individual whose livelihood is wholly dependent upon the use of such land;

- (e) any residential house or building, or part of a house or building occupied by the judgment debtor, his wife and dependant children for residential purposes;
- (f) books of account;
- (g) a mere right to sue for damages;
- (h) the salary of an employee to the extent of-
 - (i) the whole of the salary where it does not exceed one hundred and fifty shillings monthly;
 - (ii) one hundred and fifty shillings monthly where the salary exceeds one hundred and fifty shillings and does not exceed two hundred and fifty shillings and does not exceed two hundred and twenty-five shillings monthly; or
 - (iii) two-thirds of the salary in any other case;
- (i) the expense allowances of any employees;
- (j) an expectancy of succession by survivorship or other merely contingent or possible right or interest;
- (k) a right to future maintenance; or
- (l) any other property declared by any written law not be liable to attachment.
- *Explanation*: The particulars mentioned in classes (f) and (g) are exempt from attachment whether before or after they are actually payable

(2) Subject to the provisions of any written law, nothing in this section shall be deemed to exempt houses and other buildings (which the materials and the sites thereof and the lands immediately appurtenant thereof and necessary for their enjoyment) from attachment or sale in execution of decrees for rent of any such house, building, site or land.

(3) For the purposes of this section-

- "expense allowance" means any sum paid to an employee by an employer which is a bona fide payment to meet an expense incurred or to be incurred by the employee wholly and exclusively in or for the purposes of the performance of the duties of his office or employment or in discharging functions authorised by the employer; and
- "salary" includes any sum of money granted to any employee y an employer other than an expense allowance.

49. -(1) No person executing any process under this Code directing or authorising seizure of movable property shall enter any dwelling-house after sunset and before sunrise.

(2) No outer door of a dwelling-house shall be broken open unless such dwelling-house is in the occupancy of the judgment debtor and he refuses or in any way prevents access thereto, but when the person

Seizure of property in dwelling house executing any such process had duly gained access to any dwelling-house he may break open the door of any room in which he has reason to believe any such property to be.

(3) Where a room in a dwelling-house is in the actual occupancy of a woman who, according to her religion or local custom, does not appear in public, the person executing the process shall give notice to such woman that she is at liberty to withdraw; and, after allowing reasonable time for her to withdraw and giving her reasonable facility for withdrawing, he may enter such room for the purpose of seizing the property, using at the same time every precaution consistent with these provisions, to prevent its clandestine removal.

50.-(1) Where property not in the custody of any court is under attachment in execution of decrees of more courts than one, the court which shall receive or realise such property and shall determine any claim thereto and any objection to the attachment thereof shall be the court of the highest grade, or, where there is no difference in grade between such courts, the court under whose decree the property was first attached.

(2) Nothing in this section shall be deemed to invalidate any proceeding taken by a court executing one of such decrees.

51. Where an attachment has been made, any private transfer or delivery of the property attached or of any interest therein and any payment to the judgment debtor of any debt, dividend or other moneys contrary to such attachment, shall be void as against all claims enforceable under the attachment.

Explanation: For the purposes of this section, claims enforceable under an attachment include claims for the rateable distribution of assets.

Sale

52. Where immovable property is sold in execution of a decree and such sale has become absolute, the property shall be deemed to have vested in the purchaser from the time when the property is sold and not from the time when the sale becomes absolute.

53.-(1) No suit shall be maintained against any person claiming title under a purchase certified by the court in such manner as may be prescribed on the ground that the purchase was made on behalf of the plaintiff or behalf of someone through whom the plaintiff claims.

(2) Nothing in this section shall bar a suit to obtain a declaration that the name of any purchaser certified as aforesaid was inserted in the certificate fraudulently or without the consent of the real purchaser, or interfere with the right of a third person to proceed against that property,

Distribution of Assets

Proceeds of execution sale to be rateably distributed among decreeholders **54.-**(1) Where assets are held by a court and more persons than one have, before the receipt of such assets, made application to the court for the execution of decrees for the payment of money passed against the same judgment debtor and have not obtained satisfaction thereof, the assets, after deducting the costs of realisation, shall be rateably distributed among all such persons:

Provided that-

- (a) where any property is sold subject to a mortgage or charge, the mortgagee or incumbrancer shall not be entitled to share in any surplus arising from such sale;
- (b) where any property liable to be sold in execution of a decree is subject to a mortgage or charge, the court may with the consent of the mortgagee or incumbrancer, order that the property be sold free from the mortgage or charge, giving to the mortgagee or incumbrancer the same interest in the proceeds of the sale as he had in the property sold;
- (c) where any immovable property is sold in execution of a decree ordering its sale for the discharge of an incumbrance thereon, the proceeds of sale shall be applied-
 - (i) in defraying the expenses of the sale;
 - (ii) in discharging the amount due under the decree;
 - (iii) in discharging the interest and principal moneys due on subsequent incumbrance (if any); and,
 - (iv) rateably among the holders of decrees for the payment of money against the judgment debtor who have, prior to the sale of the property, applied to the court which passed the decree ordering such sale for execution of such decrees and have not obtained satisfaction thereof.

(2) Where all or any of the assets liable to be rateably distributed under this section are paid to a person not entitled to receive the same, any person so entitled may sue such person to compel him to refund the assets.

(3) Nothing in this section affects any right of the Government.

Resistance to Execution

Resistance to execution

55. Where the court is satisfied that the holder of a decree for the possession of immovable property or that the purchaser of immovable property sold in execution of a decree has been resisted or obstructed in

obtaining possession of the property by the judgment debtor or some person on his behalf and that such resistance or obstruction was without any just cause, the court may, at the instance of the decree-holder or purchaser, order the judgment debtor or such other person to be detained as a civil prisoner for a term which may extend to thirty days and may further direct that the decree-holder or purchaser be put into possession of the property.

PART III

INCIDENTAL PROCEEDINGS

Commissions

Power of court to issue commissions	56 . Subject to such conditions and limitations as may be prescribed, the court may issue a commission-	
	(a) to examine any person;

Commission to another court **57.**–(1) A commission for the examination of any person may be issued to any court (other than the High Court) in Tanzania having jurisdiction in the place in which the person to be examined resides.

(2) Every court receiving a commission for the examination of any person under subsection (1) shall examine him or cause him to be examined pursuant thereto, and the commission, when it has been duly executed, shall be returned together with the evidence taken under it to the court from which it was issued, unless the order for issuing the commission has otherwise directed, in which case the commission shall be returned in terms of such order.

Letter of request 58. In lieu of issuing a commission, the court may issue a letter request to examine a witness residing at any place outside Tanzania.

Commissions issued by foreign courts of the examination of witnesses shall apply to commissions issued by for the examination of persons residing in Tanzania

PART IV

SUITS IN PARTICULAR CASES

Suits against Public Officers

Exemption from arrest and personal

60. In a suit instituted against a public officer in respect of any act purporting to be done by him in his official capacity-

appearance of public officers

- (a) the defendant shall not be liable to arrest nor his property to attachment otherwise than in execution of a decree; and
- (b) where the court is satisfied that the defendant cannot absent himself from his duty without detriment to the public service, it shall exempt him from appearing in person.

Suits by Aliens and Foreign States

When aliens **61.**-(1) Alien enemies residing in Tanzania with the permission of the Government and alien friends, may sue in the courts of Tanzania.

(2) No alien enemy residing in Tanzania without such permission, or residing in a foreign country, shall sue in any of such courts.

62.(1) A foreign State which has been recognised by the Government of Tanzania may sue in any court of Tanzania if the object of the suit is to enforce a private right vested in the head of such State or in any officer of such State in his public capacity.

2) Every court shall take judicial notice of the fact that a foreign State has or has not been recognised by the Government of Tanzania.

Interpleader

63. Where two or more persons claim adversely to one another the same debt, sum of money or other property, movable or immovable, from another person who claims no interest therein other than for charges or costs and who is ready to pay or deliver it to the rightful claimant, such other person may institute a suit of interpleader against all the claimants for the purpose of obtaining a decision as to the person to whom the payment or delivery shall be made and of obtaining indemnity for himself:

Provided that where any suit is pending in which the rights of parties can properly be decided, no such suit of interpleader shall be instituted.

PART V

SPECIAL PROCEEDINGS

Arbitration

Arbitration Cap. 15

64. Save in so far as is otherwise provided by the Arbitration Act, or by any other law for the time being in force, all references to arbitration, whether by an order in a suit or otherwise, and all proceedings thereunder shall be governed by the provisions contained in the Second Schedule.

Special Case

Power to state 65. Where any person agrees in writing to state a case for the opinion of the court, then the court shall try and determine the same in the manner prescribed.

Suits relating to Public Matters

66.-(1) In the case of a public nuisance, the Attorney-General or two or more persons having obtained the consent in writing of the Attorney-General, may institute a suit, though no special damage has been caused, for a declaration and injunction or for such other relief as may be appropriate to the circumstances of the case.

(2) Nothing in this section shall be deemed to limit or otherwise affect any right of suit which may exist independently of its provisions.

PART VI SUPPLEMENTAL PROCEEDINGS

68. In order to prevent the ends of justice from being defeated the court may, subject to any rules in that behalf-

- (a) issue a warrant to arrest the defendant and bring him before the court to show cause why he should not give security for his appearance, and if he fails to comply with any order for security commit him as a civil prisoner;
- (b) direct the defendant to furnish security to produce any property belonging to him and to place the same at the disposal of the court or order the attachment of any property;

69. (1) Where, in any suit in which an arrest or attachment has been effected or a temporary injunction granted under section 68-

- (a) it appears to the court that such attachment or injunction was applied for on insufficient grounds; or
- (b) the suit of the plaintiff fails and it appears to the court that there was no reasonable or probable ground for instituting the same,

the defendant may apply to the court and the court may, upon such application, award against the plaintiff by its order such amount, not exceeding two thousand shillings, as it deems a reasonable compensation to the defendant for the expense or injury caused to him.

(2) An order determining any such application shall bar any suit for compensation in respect of such arrest, attachment or injunction.

PART VII

APPEALS

Appeals from Decrees

70.-(1) Save where otherwise expressly provided in the body of this Code or by any other law for the time being in force, an appeal shall lie to the High Court from every decree passed by a court of a resident magistrate or a district court exercising original jurisdiction.

(2) An appeal may lie from an original decree passed *ex parte*.

(3) No appeal shall lie from a decree passed by the court with the consent of the parties.

71. Where any party aggrieved by a preliminary decree does not appeal from such decree, he shall be precluded from disputing its correctness in any appeal which may be preferred from the final decree.

72.-(1) Where an appeal is heard by a Bench of two or more judges, the appeal shall be decided in accordance with the opinion of such judges or of the majority (if any) of such judges.

74.-(1) An appeal shall lie to the High court from the following orders of the District Courts, Resident Magistrate's Courts and any other tribunal, the decisions of which are appellable to the High Court, and save as otherwise expressly provided in this code or by any law for the time being in force from no other order-

- (a) an order superseding an arbitration where the award has not been completed within the period allowed by the court;
- (b) an order on an award stated in the form of a special case;
- (c) an order modifying or correcting an award;
- (d) an order filing or refusing to file an agreement to refer to arbitration;
- (e) an order staying or refusing to stay a suit where there is an agreement to refer to arbitration;
- (f) an order filing or refusing to file an award in an arbitration without the intervention of the court;
- (g) an order under section 69;
- (h) an order under any of the provisions of this Code imposing a fine or directing the arrest or detention as a civil prisoner of any person except where such arrest or detention is in execution of a decree; or
- (i) any order made under rules from which an appeal is expressly allowed by rules.

(2) Notwithstanding the provisions of subsection (1), no appeal shall lie against or be made in respect of any preliminary or interlocutory decision or order of the District Court, Resident Magistrate's Court or any

MISCELLANEOUS PROVISIONS

83.-(1) Women who, according to their religion or local custom, do not appear in public shall, when appearing or required to appear in court pursuant to any process issued by the court, be accorded such facilities for maintaining their privacy as may be reasonable and practicable.

(5) Subject to the provisions of section 22 of the Law of Limitation Act, the proceedings as against any person added as defendant shall be deemed to have begun only on the service of the summons.

(4) An order granting leave to present a third party notice shall contain directions as to the period within which such notice may be presented and as to such other matters as the court may think just.

(d) if the third party is the Attorney-General, the court shall, on the application for directions of the defendant presenting the third party notice, fix a date of which notice shall be given to the Attorney-General and on which the court may make any order, upon such terms as it may direct as to costs or otherwise, which it could make under the provisions of rule 18 or may enter such judgment against the third party as the nature of the suit may require.

(2) The court may at any time set aside or vary a judgment entered against a third party pursuant to the provisions of sub-rule (1) on such terms as it may think just.

20. The court may decide all questions of costs between a third party and other parties to the suit, and may make such orders as to costs as it may think just.

21. Subject to the provisions of rules 14, 15, 16, 17, 18 and 19, the provisions of this Code and the provisions of the Law of Limitation Act in relation to a third party notice and to proceedings begun thereby shall apply as if–

22. A third party served with a third party notice shall have the same right to present a third party notice against some other party not a party to the suit as if he were a defendant in that suit.

23. Where in any suit a defendant claims against another defendant in the same suit (hereinafter referred to as "the co-defendant")-

- (a) any contribution or indemnity;
- (b) any relief or remedy relating to or connected with any subject matter of the suit and substantially the same as a relief or remedy claimed by the plaintiff against the defendant,

such defendant may present a third party notice against the co-defendant in the same manner and subject to the same conditions as if the codefendant were a third party and the same procedure shall be adopted for the determination of the claims made against the co-defendant as if the codefendant were a third party.

1. Every suit shall, as far as practicable, be framed so as to afford ground for final decision upon the subjects in dispute and to prevent further litigation concerning them.

2A. [Omitted]

2.-(1) Every suit shall include the whole of the claim which the plaintiff is entitled to make in respect of the cause of action; but a plaintiff may relinquish any portion of his claim in order to bring the suit within the jurisdiction of any court.

(2) Where a plaintiff omits to sue in respect of, or intentionally relinquishes, any portion of his claim, he shall not afterwards sue in respect of the portion so omitted or relinquished.

(3) A person entitled to more than one relief in respect of the same cause of action may sue for all or any of such reliefs; but if he omits, except with the leave of the court, to sue for all such reliefs, he shall not afterward sue for any relief so omitted.

Explanation: For the purposes of this rule an obligation and a

collateral security for its performance and successive claims arising under the same obligation shall be deemed respectively to constitute but one cause of action.

3.-(1) Save as otherwise provided, a plaintiff may unite in the same suit several causes of action against the same defendant, or the same defendants jointly; and any plaintiffs having causes of action in which they are jointly interested against the same defendant or the same defendants jointly may unite such causes of action in the same suit.

(2) Where causes of action are united, the jurisdiction of the court as regards the suit shall depend on the amount or value of the aggregate subject matters at the date of instituting the suit.

4. No cause of action shall, unless with the leave of the court, be joined with a suit for the recovery of immovable property, except-

- (a) claims for mesne profits or arrears of rent in respect of the property claimed or any part thereof;
- (b) claims for damages for breach of any contract under which the property or any part thereof is held; or
- (c) claims in which the relief sought is based on the same cause of action:

Provided that nothing in this rule shall be deemed to prevent any party in a suit for foreclosure or redemption from asking to be put into possession of the mortgaged property.

5. No claim by or against an executor, administrator or heir, as such shall be joined with claims by or against him personally, unless the last-mentioned claims are alleged to arise with reference to the estate in respect of which the plaintiff or defendant sues or is sued as executor, administrator or heir, or such as he was entitled to, or liable for, jointly with the deceased person whom he represents.

6. Where it appears to the court that any causes of action joined in one suit cannot be conveniently tried or disposed of together, the court may order separate trials or make such other order as may be expedient.

7. All objections on the ground of misjoinder of causes of action shall be taken at the earliest possible opportunity and in all case where issues are settled, at or before such settlement, unless the ground of objection has subsequently arisen, and any such objection not so taken shall be deemed to have been waived.

3.-(1) Processes served on the recognised agent of a party shall be as effectual as if the same had been served on the party in person, unless the court otherwise directs.

(2) The provisions for the service of process on a party to a suit shall apply to the service of process on his recognised agent.

4. The court may require any advocate claiming to act on behalf of any party who has not appeared in person or by his recognised agent to produce, within such time as may be reasonable, a written authority signed by such party or his recognised agent authorising the advocate to act on behalf of such party.

5. Any process served on the advocate of any party or left at the office or ordinary residence of such advocate, and whether the same is for the personal appearance of the party or not, shall be presumed to be duly communicated and made known to the party whom the advocate represents and, unless the court otherwise directs, shall be as effectual for

ORDER IV

INSTITUTION OF SUITS

1.-(1) Every suit shall be instituted by presenting a plaint to the court or such officer as it appoints in that behalf and, where the suit is instituted against the Government, delivering a copy of the plaint to the Attorney-General.

(2) Every plaint shall comply with the rules contained in Order VI and VIII, so far as they are applicable.

(3) No suit shall be instituted in the Commercial Division of the High Court concerning a commercial matter which is pending before another court or tribunal of competent jurisdiction or which falls within the competency of a lower court.

(4) It shall not be mandatory for a commercial case to be instituted in the Commercial Division of the High Court.

(5) Notwithstanding the provisions of Rule 10 of the High Court Registries Rules, and without prejudice to the exception under subrule (1) of Rule 7 of the High Court Registries Rules, all preliminary steps in the Commercial Division, including the decision as to whether or not the suit concerns a commercial case shall be determined by a judge and such suit shall not come up for mention except for the judge to make a rescheduling order in respect of the case.

2. The court shall cause the particulars of every suit to be entered in a book to be kept for the purpose and called the register of civil suits; and such entries shall be numbered in every year according to the order in which the plaints are presented.

3. A Judge or Magistrate in Charge of the Court shall within four days after the institution of a suit cause it to be assigned to a specific Judge or Magistrate.

ORDER V **ISSUE AND SERVICE OF SUMMONS**

1. When a suit has been duly instituted, a summons may be issued to the defendant at the time when the suit is assigned to a specific judge or magistrate pursuant to the provisions of rule 3 of Order IV-

- to appear and answer the claim on a day to be specified (a) therein (hereinafter referred to as a summons to appear); or
- (b) if the suit is instituted in a court other than the High Court and the court so determines, to file, in accordance with subrule (2) of rule 1 of Order VIII, a written statement of defence to the claim (hereinafter referred to as a summons to file a defence):

Provided that no summons shall be issued under this rule when the defendant has appeared at the presentation of the plaint, has proved his identity to the satisfaction of the court and has admitted the plaintiff's claim:

Provided also that no summons shall be issued under this rule to the Attorney-General-

- (i) except on the application of the plaintiff made not less than the fourteen days after the suit has been duly instituted; and
- unless the court is satisfied that a request made by the (ii) Attorney-General for a further and better statement of the nature of the claim, or for further and better particulars of any matter stated in the plaint, has been complied with or that no such request has been made.

2. Every summons shall be signed by the Judge or Magistrate or such officer as may be appointed by the Chief Justice in that behalf and shall be sealed with the seal of the court.

3. Every summons shall be accompanied by a copy of the plaint and copies of other documents as may be prescribed by the Chief Justice for the information of the defendant regarding the future conduct of the suit.

4. A summons to appear issued by a court other than the High Court shall direct that the defendant shall produce on the day fixed for his appearance-

- (a) all documents in his possession or power upon which he intends to rely in supporting his case; and
- (b) all witnesses upon whose evidence he intends to rely in support of his case.

13.-(1) In a suit relating to any business or work against a person who does not reside within the local limits of the jurisdiction of the court from which the summons is issued, service on any manager or agent who, at the time of service personally carries on such business or work for such person within such limits, shall be deemed good service.

(2) For the purpose of this rule the master of a ship shall be deemed to be the agent of the owner or charterer.

21.-(1) Where the court is satisfied that to require a summons to be served on a defendant in the ordinary manner or by substituted service may cause undue delay and that the summons may more conveniently be served by post, the court may order that the summons be served by post.

(2) Where a summons has been sent to a defendant by post and the court is satisfied that under the provisions of rule 30 the service may be deemed to have been duly effected, the summons shall be deemed to have been served on the defendant as effectively as if it had been served on him personally.

(3) Where service is by post the court shall fix such time for appearance of the defendant as the case may require.

ORDER VI PLEADING GENERALLY

Pleading

1. "Pleading" means a plaint or a written statement of defence (including a written statement of defence filed by a third party) and such other subsequent pleadings as may be presented in accordance with rule 13 of Order VIII.

2.-(1) Where any pleading is presented to the court the party presenting the pleading shall-

- (a) in the case of plaint, present to the court such additional number of copies of the plaint as there may be defendants to enable the court to serve a copy of the plaint on each of the defendants; and
- (b) in the case of any other pleading–
 - (i) prior to the presentation of the pleading, serve or cause to be served on each of the other parties to the suit a copy of such pleading; or
 - (ii) at the time of such presentation present to the court such additional number of copies of the pleading as there may be other parties to the suit who have not been served with them in accordance with provisions of subparagraph (i), and the court shall cause to be served on each of such parties a copy of such pleading.

(2) A party to a suit shall be deemed to have been served with a copy of a pleading under the provisions of subparagraph (b) of sub-rule (1) where such copy is served on the person who has entered appearance on behalf of such party or on his advocate.

3. Every pleading shall contain, and contain only, a statement in a concise form of the material facts on which the party pleading relies for his claim or defence, as the case may be, but not the evidence by which they are to be proved, and shall, when necessary, be divided into paragraphs, numbered consecutively; and dates, sums and numbers may be expressed in figures.

Particulars to be given where necessary

4. In all cases in which the party pleading relies on any misrepresentation, fraud, breach of trust, willful default, or undue influence and in all other case in which particulars may be necessary to substantiate any allegation, such particulars (with dates and items if necessary) shall be stated in the pleading.

Further and better statements or particulars 5. A further and better statement of the nature of the claim or defence or further and better particulars of any matter stated in any pleading may in all cases be ordered, upon such terms, as to costs and

Departure	7. No pleading shall, except by way of amendment, raise any new ground of claim or contain any allegation of fact inconsistent with the previous pleadings of the party pleading the same.

Where a contract is alleged in any pleading, a bare denial of the same by the opposite party shall be construed only as a denial in fact of the express contract alleged or of the matters of fact from which the same may be implied, and not as a denial of the legality or sufficiency in law of such contract.

(2) Where a summons to file a defence has been issued and the defendant wishes to defend the suit, he shall, within twenty-one days of the date of service of the summons upon him present to the court a written statement of his defence:

Provided that the Court may, within twenty-one days of expiration of the prescribed period, grant an extension of time for presentation of the written statement of defence on application by the defendant.

2. The defendant must raise by his pleading all matters which show the suit not be maintainable, or that the transaction is either void or voidable in point of law, and all such grounds of defence as, if not raised, would be likely to take the opposite party by surprise, or would raise issues of fact not arising out of the plaint, as, for instance, fraud, limitation, release, payment, performance, or facts showing illegality.

3. It shall not be sufficient for a defendant in his written statement to deny generally the grounds alleged by the plaintiff, but the defendant must deal specifically with each allegation of fact of which he does not admit the truth, except damages.

4. Where a defendant denies an allegation of fact in the plaint, he must not do so evasively, but answer the point of substance. Thus, if it is alleged that he received a certain sum of money, it shall not be sufficient to deny that he received that particular amount, but he must deny that he received that sum or any part thereof or else set out how much he received. And if an allegation is made with diverse circumstances, it shall not be sufficient to deny it along with those circumstances.

5. Every allegation of fact in the plaint, if not denied specifically or by necessary implication, or stated to be not admitted in the pleading of the defendant, shall be taken to be admitted except as against a person under disability:

> Provided that the court may in its discretion require any fact so admitted to be proved otherwise than by such admission.

- there is any other sufficient cause for extending the time, in (c) which case the court may extend the time for making such application for such period as it thinks fit.

(2) In such case the plaintiff may (subject to the law of limitation) bring a fresh suit.

Where the court has adjourned the hearing of the suit *ex parte* and the defendant, at or before such hearing, appears and assigns good cause for his previous non-appearance, he may, upon such terms as the court may direct as to costs or otherwise, be heard in answer to the suit as if he had appeared on the day fixed for his appearance.

8. Where the defendant appears and the plaintiff does not appear when the suit is called on for hearing, the court shall make an order that the suit be dismissed unless the defendant admits the claim, or part thereof, in which case the court shall pass a decree against the defendant upon such admission and, where part only of the claim has been admitted, shall dismiss the suit so far as it relates to the remainder.

9.-(1) Where a suit is wholly or partly dismissed under rule 8, the plaintiff shall be precluded from bringing a fresh suit in respect of the same cause of action, but he may apply for an order to set the dismissal aside and, if he satisfies the court that there was sufficient cause for his non-appearance when the suit was called on for hearing, the court shall make an order setting aside the dismissal upon such terms as to costs or

Where a plaintiff or defendant who has been ordered to appear in person does not appear in person or who is without sufficient cause to the satisfaction of the court for failing so to appear, he shall be subject to all the provisions of the foregoing rules applicable to plaintiffs and defendants, respectively, who do not appear.

3. The substance of the examination shall be reduced to writing by the judge or magistrate and shall form part of the record.

On an application for leave to deliver interrogatories, the particular interrogatories proposed to be delivered shall be submitted to the court and in deciding upon such application, the court shall take into account any offer which may be made by the party sought to be interrogated to deliver particulars, or to make admission, or to produce documents relating to the matters in question, or any of them, and leave shall be given as to such only of the interrogatories submitted as the court shall consider necessary either for disposing fairly of the suit or for saving costs.

3. In adjusting the costs of the suit, inquiry shall, at the instance of any party, be made into the propriety of exhibiting such interrogatories; and if it is the opinion of the taxing officer or of the court, either with or without an application for inquiry, that such interrogatories have been exhibited unreasonably, vexatiously, or at improper length, the cost occasioned by the said interrogatories and the answer thereto shall be paid in any event by the party in fault.

4. Where any party to a suit is a corporation or a body of persons, whether incorporated or not, empowered by law to sue or be sued, whether in its own name or in the name of any officer or other person, any opposite party may apply for an order allowing him to deliver interrogatories to any member or officer of such corporation or body, and an order may be made accordingly.

5. Any objection to answering any interrogatory on the ground that it is scandalous or irrelevant or not exhibited *bona fide* for the purpose of the suit, or that the matters inquired into are not sufficiently material at that stage, or on any other grounds, may be taken in the affidavit in answer.

6. Any interrogatories may be set aside on the ground that they have been exhibited unreasonably or vexatiously, or struck out on the ground that they are prolix, oppressive, unnecessary or scandalous; and any application for this purpose may be made within seven days after service of the interrogatories.

Where any person interrogated omits to answer, or answers insufficiently, the party interrogating may apply to the court for an order requiring him to answer, or to answer further, as the case may be and an order may be made requiring him to answer or answer further, either by affidavit or by *viva voce* examination, as the court may direct:

Provided that discovery shall not be ordered when and so far as the court shall be of opinion that it is not necessary either for disposing fairly of the suit or for saving costs:

Provided also that discovery shall not be ordered where there is produced to the court a certificate under the hand of a Minister that, in his opinion, discovery, either generally or in relation to a certain document or a certain class of documents, would be injurious to the public interest.

11. The affidavit to be made by a party against whom such order as is mentioned in rule 10 has been made, shall specify which (if any) of the documents therein mentioned he objects to produce.

12. It shall be lawful for the court, at any time during the pendency of any suit to order the production, by any party thereto upon oath, of such of the documents in his possession or power, relating to any matter in question in such suit, as the court shall think right; and the court may deal with such documents when produced, in such manner as shall appear just:

Provided that production shall not be ordered of a document where any enactment or rule of law authorises or requires the withholding of the document on the ground that the disclosure of the document would be injurious to the public interest.

Inspection of documents referred to in pleadings or affidavits 13. Every party to a suit shall be entitled at any time to give notice to any other party in whose pleadings or affidavits reference is made to any document, to produce such document for the inspection of the party giving such notion or his advocate, and to permit him or them to take copies thereof; and any party not complying with such notice shall not afterwards be at liberty to put any such document in evidence on his behalf in such suit unless he shall satisfy the court that such document relates only to his own title, he being a defendant to the suit or that he had some other cause or excuse which the court shall deem sufficient for not complying with such notice, in which case the court may allow the same to be put in evidence on such terms as to costs and otherwise as the court shall think fit.

Time for inspection when notice given 14. The party to whom such notice is given shall, within ten days from the receipt of such notice, deliver to the party giving the same a notice stating a time within three days from the delivery thereof at which the documents, or such of them as he does not object to produce, may be inspected at the office of his advocate, or in the case of banker's books or other books of account or books in constant use for the purpose of any trade or business, at their usual place of custody, and stating which (if any) of the documents he objects to produce, and on what ground.

15. (1) Where the party served with notice under rule 14 omits to give such notice of a time for inspection or objects to give inspection or offers inspection elsewhere than at the office of his advocate the court may, on the application of the party desiring it, make an order for inspection in such place and in such manner as it may think fit:

Provided that the order shall not be made when and so far as the court shall be of opinion that it is not necessary either for disposing fairly of the suit or for saving costs.

(2) Any application to inspect documents, except such as are referred to in the pleadings, particulars or affidavits of the party against whom the application is made or disclosed in his affidavits of documents, shall be founded upon an affidavit showing of what documents inspection is sought, that the party applying is entitled to inspect them and that they are in the possession or power of the other party. The court shall not make such order for inspection of such documents when and so far as the court shall be of opinion that it is not necessary either for disposing fairly of the suit or for saving costs.

(3) Notwithstanding anything contained in this rule, an order for inspection of documents shall not be made where there is produced to the court a certificate under the hand of a Minister that in his opinion, inspection would be injurious to the public interest.

(3) The court may, on the application of any party to a suit at any time, and whether an affidavit of documents shall or shall not have already been ordered or made, make an order requiring any other party, other than the Attorney-General to state by affidavit whether any one or more specific documents, to be specified in the application, is or are, or has or have at any time been in his possession or power; and, if not then in his possession when he parted with the same and what has become thereof.

(4) An application made under sub-rule (3) shall be made on an affidavit stating that in the belief of the deponent the party against whom the application is made has, or has at some time had, in his possession or power the document or documents specified in the application and that they relate to the matters in question in the suit or to some of them.

17. Where the party from whom discovery of any kind or inspection is sought objects to the same or any part thereof the court may, if satisfied that the right to the discovery or inspection sought depends on the determination of any issue or question in dispute in the suit, or that for any other reason it is desirable that any issue or question in dispute in the suit should be determined before deciding upon the right to the discovery or inspection, order that such issue or question be determined, first, and reserve the question as to the discovery or inspection.

Notice of admission of case 1. Any party to a suit may give notice, by his pleading or otherwise in writing, that he admits the truth of the whole or any part of the case of any other party.

2. Either party may call upon the other party to admit any document, saving all just exceptions; and in case of refusal or neglect to admit after such notice, the costs of proving any such documents shall be paid by the party so neglecting or refusing, whatever the result of the suit may be, unless the court otherwise directs and no costs of proving any document shall be allowed unless such notice is given except where the omission to give the notice is, in the opinion of the court, a saving of expense.

Notice admit facts to **3.** Any party may, by notice in writing, at any time not later than nine days before the day fixed for the hearing, call on any other party to admit, for the purposes of the suit only, any specific fact or facts mentioned in such notice; and in case of refusal or neglect to admit the same within six days after service for such notice, or within such further time as may be allowed by the court, the costs of proving such fact or facts shall be paid by the party so neglecting or refusing, whatever the result of the suit may be, unless the court otherwise directs:

> Provided that any admission made in pursuance of such notice is to be deemed to be made only for the purposes of the particular suit, and not as an admission to be used against the party on any other occasion or in favour of any person other than the party giving the notice:

> Provided also that the court may at any time allow any party to amend or withdraw any admission so made on such terms as may be just.

> 4. Any party may at any stage of a suit, where admissions of fact have been made either on the pleading, or otherwise, apply to the court for such judgment or order as upon such admissions he may be entitled to, without waiting for determination of any other question between the parties; and the court may upon such application make such order, or give

such judgment, as the court may think just.

Affidavit of 5. An affidavit of the advocate or his clerk, of the due signature of signature any admission made in pursuance of any notice to admit documents or facts, shall be sufficient evidence of such admission, if evidence thereof is required.

PRODUCTION, IMPOUNDING AND RETURN OF DOCUMENTS

Documentary **1.**-(1) The parties or their advocates shall produce, at the first evidence to be hearing of the suit, all the documentary evidence of every description in produced at their possession or power, on which they intend to rely and which has not first hearing G.N. No. 375 already been filed in court, and all documents which the court has ordered to be produced.

> (2) The court shall receive the document so produced provided that they are accompanied by an accurate list thereof prepared in such form as the High Court directs.

2. No documentary evidence in the possession or power of any party which should have been, but has not been, produced in accordance with the requirements of rule 1 shall be received at any subsequent stage of the proceedings unless good cause is shown to the satisfaction of the court for the non-production thereof; and the court receiving any such evidence shall record the reasons for so doing.

3. The court, may at any stage of the suit reject any document which it considers irrelevant or otherwise inadmissible, recording the grounds of such rejection.

4.-(1) Subject to the provisions of the sub-rule (2), there shall be endorsed on every document which has been admitted in evidence in the suit the following particulars, namely-

- (a) the number and title of the suit;
- (b) the name of the person producing the document;
- the date on which it was produced; and (c)
- (d) a statement of its having been so admitted;

(e) and the endorsement shall be signed or initialed by the judge or magistrate.

(2) Where a document so admitted is an entry in a book, account or record, and a copy thereof has been substituted for the original under rule 5, the particular aforesaid shall be endorsed on the copy and the endorsement thereon shall be signed or initialed by the judge or magistrate.

5.-(1) Save in so far as is otherwise provided by the Evidence Act, where a document admitted in evidence in the suit is an entry in a letterbook or a shop-book or other account in current use, the party on whose behalf the book or account is produced may furnish a copy of the entry.

(2) Where such a document is an entry in a public record produced from a public office or by a public officer, or an entry in a book or account belonging to a person other than a party on whose behalf the book or account is produced, the court may require a copy of the entry to be furnished-

- (a) where the record, book or account is produced on behalf of a party, then by that party; or
- (b) where the record, book or account is produced in obedience to an order of the court acting of its own motion, then by either or any party.

(3) Where a copy of an entry is furnished under the provisions of this rule, the court shall, after causing the copy to be examined, compared and certified in manner mentioned in rule 17 of Order VII, mark the entry and cause the book, account or record in which it occurs to be returned to the person producing it.

6. Where a document relied on as evidence by either party is considered by the court to be inadmissible in evidence, there shall be endorsed thereon the particulars mentioned in clauses (a), (b) and (c) of sub-rule (1) of rule 4 together with a statement of its having been rejected, and the endorsement shall be signed or initialed by the Judge or magistrate.

7.-(1) Every document which has been admitted in evidence, or a copy thereof where a copy has been substituted for the original under rule 5, shall form part of the record of the suit.

(2) Documents not admitted in evidence shall not form part of the record and shall be returned to the persons respectively producing them.

Provided also that no document shall be returned which, by force of the decree, has become wholly void or useless.

(2) On the return of a document admitted in evidence, a receipt shall be given by the person receiving it.

10.-(1) The court may of its own motion, and may in its discretion upon the application of any of the parties to a suit, send for, either from its own records or from any other court, the record of any other suit or proceeding, and inspect the same.

(2) Every application made under this rule shall (unless the court otherwise directs) be supported by an affidavit showing how the record is material to the suit in which the application is made, and that the applicant cannot without unreasonable delay or expense obtain a duly authenticated copy of the record or of such portion thereof as the applicant requires, or that the production of the original is necessary for the purposes of justice.

(3) Nothing contained in this rule shall be deemed to enable the court to use in evidence any document which under the law of evidence would be inadmissible in the suit.

11. The provisions herein contained as to documents shall, as far as may be, apply to all other material objects producible as evidence.

ORDER XIV SETTLEMENT OF ISSUES AND DETERMINATION OF SUIT ON ISSUES OF LAW OR ON ISSUES AGREED UPON

Framing of issues

1.-(1) Issues arise when a material proposition of fact or law is affirmed by one party and denied by the other.

(2) Material propositions are those propositions of law or fact which plaintiff must allege in order to show a right to sue or a defendant must allege in order to constitute his defence.

(3) Each material proposition affirmed by one party and denied by the other shall form the subject of a distinct issue.

(4) Issues are of two kinds-

- (a) issues of fact; and
- (b) issues of law.

(5) At the first hearing of the suit the court shall, after reading the plaint and the written statements, if any, and after such examination of the parties as may appear necessary, ascertain upon what material proposition of fact or of law the parties are at variance, and shall thereupon proceed to frame and record the issues on which the right decision of the case appears to depend.

(6) Nothing in this rule requires the court to frame and record issues where the defendant at the first hearing of the suit makes no defence.

2. Where issues both of law and of fact arise in the same suit, and the court is of opinion that the case or any part thereof may be disposed of on the issues of law only, it shall try those issues first, and for that purpose may, if it thinks fit, postpone the settlement of the issues of fact until after the issues of law have been determined.

3. The court may frame the issues from all or any of the following materials-

- (a) allegations made on oath by the parties, or by any person present on their behalf, or made by the advocates of such parties;
- (b) allegations made in the pleadings or in answers to interrogatories delivered in the suit;
- (c) the contents of documents produced by either party.

4. Where the court is of opinion that the issues cannot be correctly framed without the examination of some person not before the court or without the inspection of some document not produced in the suit, it may adjourn the framing of the issues to a future day, and may (subject to any law for the time being in force) compel the attendance of any person or the production of any document by the person in whose possession or

5.-(1) The court may at any time before passing a decree amend the issues or frame additional issues on such terms as it thinks fit; and all such amendments or additional issues as may be necessary for determining the matters in controversy between the parties shall be so made or framed.

(2) The court may also, at any time before passing a decree, strike out any issues that appear to it to be wrongly framed or introduced.

6. Where the parties to a suit are agreed as to the question of fact or of law to be decided between them, they may state the same in the form of an issue, and enter into an agreement in writing that, upon finding of the court in the affirmative or the negative of such issue-

- (a) a sum of money specified in the agreement or to be ascertained by the court, or in such manner as the court may direct, shall be paid by one of the parties to the other of them, or that one of them shall be declared entitled to some right or subject to some liability specified in the agreement;
- (b) some property specified in the agreement and in dispute in the suit shall be delivered by one of the parties to the other of them; or as that other may direct; or
- (c) one or more of the parties shall do or abstain from doing some particular act specified in the agreement and relating to the matter in dispute.

7. Where the court is satisfied, after making such inquiry as it deems proper–

- (a) that the agreement was duly executed by the parties;
- (b) that they have a substantial interest in the decision of such question as aforesaid; and
- (c) that the same is fit to be tried and decided,

it shall proceed to record and try the issue and state its finding or decision thereon in the same manner as if the issue had been framed by court and shall, upon the finding or decision on such issue, pronounce judgment according to the terms of the agreement; and, upon the judgment so pronounced, a decree shall follow.

DISPOSAL OF THE SUIT AT FIRST HEARING

Where a summons to appear has been issued by a court other than the High Court and either party fails without sufficient cause to produce the evidence on which he relies, the court may at once pronounce judgment, or may, if it thinks fit, after framing and recording issues, adjourn the suit for the production of such evidence as may be necessary for its decision upon such issues.

ORDER XVI

SUMMONING AND ATTENDANCE OF WITNESSES

1. At any time after the suit is instituted, the parties may obtain, on application to the court, or to such officer as it appoints in this behalf, summonses to whose attendance is required either to give persons evidence or to produce documents.

2.-(1) The party applying for a summons shall, before the summons is granted and within a period to be fixed, pay into court such sum of money as appears to the court to be sufficient to defray the traveling and other expenses of the person summoned in passing to and from the court in which he is required to attend, and for one day's attendance.

(2) In determining the amount payable under this rule the court may, in the case of any person summoned to give evidence as an expert, allow reasonable remuneration for the time occupied both in giving evidence and in performing any work of an expert character necessary for the case.

(2) Where it is necessary to detain the person summoned for a longer period than one day the court may, from time to time, order the party at whose instance he was summoned to pay into court such sum as is sufficient to defray the expenses of his detention for such further period and, in default of such deposit being made, may order such sum to be levied by attachment and sale of the movable property of such party; or the court may discharge the person summoned without requiring him to give evidence or may both order such levy and discharge such person.

5. Every summons for the attendance of a person to give evidence or to produce a document shall specify the time and place at which he is required to attend and also whether his attendance is required for the purpose of giving evidence or to produce a document or for both purposes; and any particular document which the person summoned is called on to produce shall be described in the summons with reasonable accuracy.

6. Any person may be summoned to produce a document without being summoned to give evidence; and any person summoned merely to produce a document shall be deemed to have complied with the summons if he causes such document to be produced instead of attending personally to produce the same.

7. Any person present in court may be required by the court to give evidence or to produce any document then and there in his possession or power.

Provided that the court shall not require a person to produce a document where any enactment or rule of law authorises or requires the withholding of the document on the ground that the production of the document would be injurious to the public interest.

(3) In lieu of or at the time of issuing such proclamation, or at any time afterwards, the court may in its discretion, issue a warrant, either with or without bail, for the arrest of such person, and may make an order for the attachment of his property to such amount as it thinks fit, not exceeding the amount of the costs of attachment and of any fine which may be imposed under rule 12.

11. Where, at any time after the attachment of his property, such person appears and satisfies the court-

- (a) that he did not, without lawful excuse, fail to comply with the summons or intentionally avoid service; and
- (b) where he has failed to attend at the time and place named in a proclamation issued under the rule 10, that he had no notice of such proclamation in time to attend,

In any case, not otherwise provided for in which no application is made or step taken for a period of three years by either party with a view to proceeding with the suit, the court may without notice order the suit to be struck out for want of prosecution, and after such an order has been made shall give notice of the order on the court notice board, but in such case the plaintiff may, subject to the law of limitation, bring a fresh suit.

ORDER XVIII

HEARING OF SUIT AND EXAMINATION OF WITNESSES

6. Where any question put to a witness is objected to by a party or to his advocate, and the court allows the same to be put, the judge or magistrate shall take down the question, the answer, the objection and the name of the person making it, together with the decision of the court thereon.

Decree when set-off allowed and appeal from decree relating to setoff **19.-**(1) Where the defendant has been allowed a set-off against a claim of the plaintiff, the decree shall state what amount is due to the plaintiff and what amount is due to the defendant, and shall be for the recovery of any sum which appears to be due to either party.

(2) Any decree passed in a suit in which a set-off is claimed shall be subject to the same provisions in respect of appeal to which it would have been subject if no set-off had been claimed.

(3) The provisions of this rule shall apply whether the set-off is admissible under rule 6 of Order VIII or otherwise.

21.-(1) The rate of interest on every judgment debt from the date of delivery of the judgment until satisfaction shall be seven *per centum* per annum or such other rate, not exceeding twelve *per centum* per annum, as the parties may expressly agree in writing before or after the delivery of the judgment or as may be adjudged by consent:

Provided that in the case of a judgment debt subsisting on the first day of July, 1964, the provision of this rule shall apply thereto as if there were substituted for the words "delivery of judgment" the words "on the first day of July, 1964".

(2) For the purposes of this rule-

"judgment" in suits relating to mortgages of immovable property means the final decree; and

"judgment debt" means-

- (a) the principal sum;
- (b) any interest adjudged on such principal sum for any period prior to the institution of the suit; and
- (c) any interest adjudged on such principal sum for the period between the institution of the suit and the delivery of the judgment.

ORDER XXI

EXECUTION OF DECREES AND ORDERS

Payment under Decree

Modes of paying money under decree and the paid as follows, namely-

(a) into the court whose duty it is to execute the decree;

- (b)out of court to the decree-holder: or
- otherwise as the court which made the decree directs. (c)

(2) Where any payment is made under paragraph (a) of sub-rule (1), notice of such payment shall be given to the decree-holder.

Payment out of court to decree-holder

2.-(1) Where any money payable under a decree of any kind is paid out of court or the decree is otherwise adjusted in whole or in part to the satisfaction of the decree-holder, the decree-holder shall certify such payment or adjustment to the court whose duty it is to execute the decree and the court shall record the same accordingly.

(2) The judgment debtor also may inform the court of such payment or adjustment and apply to the court to issue a notice to the decree-holder to show cause, on a day to be fixed by the court, why such payment or adjustment should not be recorded as certified; and if, after service of such notice, the decree-holder fails to show cause why the payment or adjustment should not be recorded as certified, the court shall record the same accordingly.

(3) A payment or adjustment, which has not been certified or recorded as aforesaid, shall not be recognized by any court executing the decree.

Satisfaction **2A.** Where a decree contains any order in favour of any person against the Government or against an officer of the Government as such, the the provisions of section 15 of the Government Proceedings Act, shall apply in relation to satisfaction of the order, in lieu of the provisions of rules 3 to 110 of this Order.

The court to which a decree is so sent shall cause such copies and certificates to be filed, without any further proof of the decree or order for execution, or of the copies thereof, unless the court, for any special reasons to be recorded under the hand of the judge or magistrate, requires such proof.

7. Where such copies are so filed, the decree or order may, if the court to which it is sent is the court of a resident magistrate, be executed by such court or be transferred for execution to any subordinate court of competent jurisdiction.

8. Where the court to which the decree is sent for execution is the
 ^{bf} High Court, the decree shall be executed by such Court in the same
 ^y manner as if it had been passed by such Court in the exercise of its ordinary original civil jurisdiction.

Application for Execution

Application for execution 9. When the holder of a decree desires to execute it, he shall apply to the court which passed the decree or to the officer (if any) appointed in this behalf, or if the decree has been sent under the provisions herein before contained to another court then to such court or to the proper officer thereof.

10.-(1) Where a decree is for the payment of money the court may, on the oral application of the decree-holder at the time of the passing of the decree, order immediate execution thereof by the arrest of the judgment debtor, prior to the preparation of a warrant if he is within the precincts of the court.

(1A) Where an order has been made for payment of money under the Law of Marriage Act, the court may, on an oral application of the person in whose favour such order is made, order the enforcement of the order by the arrest of the judgment debtor or by the attachment of the judgment debtor's salary.

(2) Save as otherwise provided by sub-rule (1) or sub-rule (1A), every application for the execution of a decree shall be in writing, signed and verified by the applicant or by some other person proved to the satisfaction of the court to be acquainted with the facts of the case, and shall contain in a tabular form the following particulars, namely-

(a) the number of the suit;

(b) the names of the parties;

- (d) whether any appeal has been preferred from the decree;
- (e) whether any, and (if any) what, payment or other adjustment of the matter in controversy has been made between the parties subsequently to the decree;
- (f) whether any, and (if any) what, previous applications have been made for the execution of the decree, the dates of such applications and their results;
- (g) the amount with interest (if any) due upon the decree or other relief granted thereby, together with particulars of any cross-decree, whether passed before or after the date of the decree sought to be executed;
- (h) the amount of the costs (if any) awarded;
- (i) the name of the person against whom execution of the decree is sought; and
- (j) the mode in which the assistance of the court is required, whether-
 - (i) by the delivery of any property specifically decreed;
 - (ii) by the attachment and sale, or by the sale without attachment, of any property;
 - (iii) by the arrest and detention in prison of any person;
 - (iv) by the appointment of a receiver; or
 - (v) otherwise, as the nature of the relief granted may require.

(3) The court to which an application is made under sub-rule (2) may require the applicant to produce a certified copy of the decree.

11. Where an application is made for the attachment of any movable property belonging to a judgment debtor but not in his possession, the decree-holder shall annex to the application an inventory of the property to be attached, containing a reasonably accurate description of the same.

12.-(1) Where an application is made for the attachment of any immovable property belonging to a judgment debtor, it shall contain at the foot-

- (a) a description of such property sufficient to identify the same and, in case such property can be identified by a title number under the Land Registration Act, such title number; and
- (b) a specification of the judgment debtor's share or interest in

Application for attachment of movable property not in judgment debtor's possession

Application for attachment of immovable property to contain certain particulars such property to the best of the belief of the applicant, and so far as he has been able to ascertain the same.

(2) Where an application is made for the attachment of any land of which an estate has been registered under the Land Registration Act, the court may require the applicant to produce an official search issued under section 97(2) of that Act relating to that land.

13.-(1) Where a decree has been passed jointly in favour of more persons that one, any one or more of such persons may, unless the decree imposes any condition to the contrary, apply for the execution of the whole decree for the benefit of them all or, where any of them has died, for the benefit of the survivors and the legal representatives of the decreased.

(2) Where the court sees sufficient cause for allowing the decree to be executed on an application made under this rule, it shall make such order as it deems necessary for protecting the interests of the persons who have not joined in the application.

Application for execution by transferee of decree 14. Where a decree or, if a decree has been passed jointly in favour of two or more persons, the interest of any decree-holder in the decree, is transferred by assignment in writing or by operation of law, the transferee may apply for execution of the decree to the court which passed it, and the decree may be executed in the same manner and subject to the same conditions as if the application were made by such decree-holder:

Provided that, where the decree or such interest as aforesaid has been transferred by assignment, notice of such application shall be given to the transferor and the judgment debtor, and the decree shall not be executed until the court has heard their objections (if any) to its execution:

Provided also that, where a decree for the payment of money against two or more persons has been transferred to one of them, it shall not be executed against the others.

Procedure on receiving application for execution of decree **15**.-(1) On receiving an application for the execution of a decree as provided by rule 10, sub-rule (2), the court shall ascertain whether such of the requirements or rules 10 to 12 as may be applicable to the case have been complied with; and, if they have not been complied with, the court may reject the application, or may allow the defect to be remedied then and there or within a time to be fixed by it.

(2) Where an application is amended under the provisions of subrule (1), it shall be deemed to have been an application in accordance with law and presented on the date when it was first presented.

(3) Every amendment made under this rule shall be signed or initialed by the judge or magistrate.

(4) When the application is admitted, the court shall enter in the proper register a note of the application and the date on which it was made and shall, subject to the provisions hereinafter contained, order execution

Execution in case of cross-decrees

16.-(1) Where applications are made to a court for the execution of cross-decrees in separate suits for the payment of two sums of money passed between the same parties and capable of execution at the same time by such court, then-

- (a) if the two sums are equal, satisfaction shall be entered upon both decrees; and
- (b) if the two sums are unequal, execution may be taken out only by the holder of the decree for the larger sum and for so much only as remains after deducting the smaller sum, and satisfaction for the smaller sum shall be entered on the decree for the larger sum as well as satisfaction on the decree for the smaller sum.

(2) This rule shall be deemed to apply where either party is an assignee of one of the decrees and as well in respect of judgment debts due by the original assignor as in respect of judgment debts due by the assignee himself.

- (3) This rule shall not be deemed to apply unless-
- (a) the decree-holder in one of the suits in which the decrees have been made is the judgment debtor in the other and each party fills the same character in both suit; and
- (b) the sums due under the decrees are definite.

(4) The holder of a decree passed against several persons jointly and severally may treat it as a cross-decree in relation to a decree passed against him singly in favour of one or more of such persons.

17. Where application is made to a court for the execution of a decree under which two parties are entitled to recover sums of money from each other, then-

- (a) if the two sums are equal, satisfaction for both shall be entered upon the decree; and
- (b) if the two sums are unequal, execution may be taken out only by the party entitled to the larger sum and for so much only as remains after deducting the smaller sum, and satisfaction for the smaller sum shall be entered upon the decree.

20.-(1) Where an application for execution is made–

(a) more than one year after the date of the decree; or

(b) against the legal representative of a party to the decree,

the court executing the decree shall issue a notice to the person against whom execution is applied for requiring him to show cause on a date to be fixed why the decree should not be executed against him:

Provided that no such notice shall be necessary in consequence of more than one year having elapsed between the date of the decree and the application for execution if the application is made within one year from the date of the last order against the party against whom execution is applied for, made on any previous application for execution, or in consequence of the application being made against the legal representative of the judgment debtor, if upon a previous application for execution against the same person the court has ordered execution to issue against him.

(2) Nothing in subrule (1) shall be deemed to preclude the court from issuing any process in execution of a decree without issuing the notice thereby prescribed if, for reasons to be recorded, it considers that the issue of such notice would cause unreasonable delay or would defeat the ends of justice.

Procedure after issue of notice

21.-(1) Where the person to whom notice is issued under rule 20 does not appear or does not show cause to the satisfaction of the court why the decree should not be executed, the court shall order the decree to be executed.

(2) Where such person offers any objection to the execution of the decree, the court shall consider such objection and make such order as it thinks fit.

Process for Execution

22.-(1) When the preliminary measures (if any) required by the

Notice to show cause against execution in certain cases foregoing rules have been taken, the court shall, unless it sees cause to the contrary, issue its process for the execution of the decree.

(2) Every such process shall bear the date of the day on which it is issued and shall be signed by the judge or magistrate or such officer as the court may appoint in this behalf and shall be sealed with the seal of the court and delivered to the proper officer to be executed.

(3) In every such process a day shall be specified on or before which it shall be executed.

23.-(1) The officer entrusted with the execution of the process shall endorse thereon the day on, and the manner in, which it was executed, and, if the latest day specified in the process for the return thereof has been exceeded, the reason of the delay, or, if it was not executed, the reason why it was not executed, and shall return the process with such endorsement to the court.

(2) Where the endorsement is to the effect that such officer is unable to execute the process, the court shall examine him touching his alleged inability, and may, if it thinks fit, summon and examine witnesses as to such inability, and shall record the result.

Stay of Execution

24.-(1) The court to which a decree has been sent for execution shall, upon sufficient cause being shown, stay the execution of such decree for a reasonable time, to enable the judgment debtor to apply to the court by which the decree was passed or to any court having appellate jurisdiction in respect of the decree or the execution thereof, for an order to stay execution or for any other order relating to the decree or execution which might have been made by such court of first instance or appellate court if execution had been issued thereby, or if application for execution had been made thereto.

(2) Where the property or person of the judgment debtor has been seized under an execution, the court which issued the execution may order the restitution of such property or the discharge of such person pending the result of the application.

(3) Before making an order to stay execution or for the restitution of property or the discharge of the judgment debtor, the court may require such security from, or impose such conditions upon, the judgment debtor as it thinks fit.

25. No order of restitution or discharge under rule 24 shall prevent the property or person of a judgment debtor from being retaken in execution of the decree sent for execution.

26. Any order of the court by which the decree was passed, or of such court of appeal as aforesaid, in relation to the execution of such decree, shall be binding upon the court to which the decree was sent for

Where a suit is pending in any court against the holder of a decree of such court, on the part of the person against whom the decree was passed the court may, on such terms as to security or otherwise as it thinks fit, stay execution of the decree until the pending suit has been decided.

Mode of Execution

Decree for payment of money **28.** Every decree for the payment of money, including a decree for the payment of money as the alternative to some other relief, may be executed by the detention as a civil prisoner of the judgment debtor or by the attachment and sale of his property, or by both.

Decree for specific movable property **29.**-(1) Where the decree is for any specific movable, or for any share in a specific movable, it may be executed by the seizure, if practicable, of the movable or share, and by the delivery thereof to the party to whom it has been adjudged, or to such person as he appoints to receive delivery on his behalf, or by the detention as a civil prisoner of the judgment debtor or by the attachment of his property, or by both.

(2) Where any attachment under sub-rule (1) has remained in force for six months, if the judgment debtor has not obeyed the decree and the decree-holder has applied to have the attached property sold, such property may be sold and out of the proceeds the court may award to the decree-holder, in cases where any amount has been fixed by the decree to be paid as an alternative to delivery of movable property, such amount, and, in other cases, such compensation as it thinks fit, and shall pay the balance (if any) to the judgment debtor on his application.

(3) Where the judgment debtor has obeyed the decree and paid all costs of executing the same which he is bound to pay, or where, at the end of six months from the date of the attachment, no application to have the property sold has been made, or if made, has been refused, the attachment shall cease.

Decree for specific performance, for restitution of conjugal rights, or for an injunction **30.-**(1) Where the party against whom a decree for the specific performance of a contract, or, subject to rule 31, for restitution of conjugal rights, or for an injunction, has been passed, has had an opportunity of obeying the decree and has willfully failed to obey it, the decree may, save as otherwise provided by any law for the time being in force, be enforced by his detention as a civil prisoner, or by the attachment of his property or by both.

(2) Where the party against whom a decree for specific performance or for an injunction has been passed is a corporation, the

decree may be enforced by the attachment of the property of the corporation or, with the leave of the court, by the detention as civil prisoners of the directors or other principal officers thereof, or by both attachment and detention.

(3) Where any attachment under sub-rule (1) or sub-rule (2) has remained in force for one year, if the judgment debtor has not obeyed the decree and the decree-holder has applied to have the attached property sold, such property may be sold; and out of the proceeds the court may award to the decree-holder such compensation as it thinks fit, and shall pay the balance (if any) to the judgment debtor on his application.

(4) Where the judgment debtor has obeyed the decree and paid all costs of executing the same which he is bound to pay, or where, at the end of the one year from the date of the attachment, no application to have the property sold has been made, or if made has been refused, the attachment shall cease.

(5) Where a decree for the specific performance of a contract or for an injunction has not been obeyed, the court may, in lieu of or in addition to all or any of the processes aforesaid, direct that the act required to be done may be done so far as practicable by the decree-holder or some other person appointed by the court, at the cost of the judgment debtor, and upon the act being done the expenses incurred may be ascertained in such manner as the court may direct and may be recovered as if they were included in the decree.

31.-(1) A decree for the restitution of conjugal rights shall not be enforced by detention as a civil prisoner.

(2) Where the decree holder is the wife, the court may, save as may otherwise be provided in any law for the time being in force, enforce the decree by making an order that in the event of the decree not being obeyed within such period as may be fixed in this behalf, the judgment debtor shall make to the decree-holder such periodical payments as may be just, and, if it thinks fit, require that the judgment debtor shall, to its satisfaction, secure to the decree-holder such periodical payments.

(3) The court may from time to time vary or modify any order made under sub-rule (2) for the periodical payment of money, either by altering the times of payment or by increasing or diminishing the amount, or may temporarily suspend the same as to the whole or any part of the money so ordered to be paid, and again revive the same, either wholly or in part as it may think just.

(4) Any money ordered to be paid under this rule may be recovered as though it were payable under a decree for the payment of money.

Decree for execution of

32.-(1) Where a decree is for the execution of a document or for the endorsement of a negotiable instrument and the judgment debtor

Execution of decrees for restitution of conjugal rights document or endorsement of negotiable instrument

neglects or refuses to obey the decree, the decree-holder may prepare a draft of the document or endorsement in accordance with the terms of the decree and deliver the same to the court.

(2) The court shall thereupon cause the draft to be served on the judgment debtor together with a notice requiring his objections (if any) to be made within such time as the court fixes in this behalf.

(3) Where the judgment debtor objects to the draft, his objections shall be stated in writing within such time, and the court shall make such order approving or altering the draft, as it may think fit.

(4) The decree-holder shall deliver to the court a copy of the draft with such alterations (if any) as the court may have directed and the judge or magistrate or such officer as may be appointed in this behalf shall execute the document so delivered.

(5) The execution of a document or the endorsement of a negotiable instrument under this rule may be in the following form, namely-

"C.D., Judge/or magistrate of the Court of(or the case may be), for A.B., in a suit by E.F. against A.B."

and shall have the same effect as the execution of the document or the endorsement of the negotiable instrument by the party ordered to execute or endorse the same.

(6) The document or negotiable instrument so executed or endorsed shall thereupon be delivered to the decree-holder.

Decree for delivery of immovable property **33.**-(1) Where a decree is for the delivery of any immovable property, possession thereof shall be delivered to the party to whom it has been adjudged or to such person as he may appoint to receive delivery on his behalf and, if necessary, by removing any person bound by the decree who refuses to vacate the property.

(2) Where a decree is for the joint possession of immovable property, such possession shall be delivered by affixing a copy of the warrant in some conspicuous place on the property and proclaiming the substance of the decree by such means as are used locally to make public pronouncements.

(3) Where possession of any building or enclosure is to be delivered and the person in possession, being bound by the decree, does not afford free access, the court, through its officers, may after giving reasonable warning and facility to any woman not appearing in public according to her religion or local custom to withdraw, remove or open any lock or bolt or break open any door or do any other act necessary for putting the decree-holder in possession.

Decree for delivery of immovable property when in occupancy of **34.** Where a decree is for the delivery of any immovable property in the occupancy of a tenant or other person entitled to occupy the same and not bound by the decree to relinquish such occupancy, the court shall order delivery to be made by affixing a copy of the warrant in some

conspicuous place on the property and proclaiming to the occupant the substance of the decree by such means as are used locally to make public pronouncements.

Arrest and Detention in Prison

35.-(1) Notwithstanding anything in these rules, where an application is for the execution of a decree for the payment of money by the arrest and detention as a civil prisoner of a judgment debtor who is liable to be arrested in pursuance of the application, the court may, instead of issuing a warrant for his arrest, issue a notice calling upon him to appear before the court on a day to be specified in the notice and show cause why he should not be committed to prison.

(2) Where appearance is not made in obedience to the notice, the court shall, if the decree-holder so requires, issue a warrant for the arrest of the judgment debtor.

36. Every warrant for the arrest of a judgment debtor shall direct the officer entrusted with its execution to bring him before the court with all convenient speed, unless the amount which he has been ordered to pay, together with the interest thereon and the costs (if any) to which he is liable, be sooner paid.

37.-(1) A court which has issued a warrant for the arrest of a judgment debtor may, by telegram, request any district court within the area of whose jurisdiction the judgment debtor is believed to be, to arrest him and cause him to be taken under escort to the court which issued the warrant.

- (2) A telegram sent under the provisions of sub-rule (1) shall state-
- (a) the number and title of the case;
- (b) the full name of the judgment debtor and the place where he is believed to be;
- (c) the amount of money upon payment of which the judgment debtor may be released;
- (d) that the person applying for arrest has given security for the expenses and the transport of the judgment debtor and his escort to the court which issued the warrant; and
- (e) the date when the warrant of arrest was issued.

(3) On receipt of a telegram sent in accordance with the provisions of this rule, the court to which it is addressed shall issue a provisional warrant in accordance with the particulars contained in the telegram and shall cause the same to be executed.

Subsistence **38.**-(1) No judgment debtor shall be arrested in execution of a decree unless and until the decree-holder pays into court such sum as the

Request for arrest by telegram judge or magistrate thinks sufficient for the subsistence of the judgment debtor from the time of his arrest until he can be brought before the court.

(2) Where a judgment debtor is committed to prison in execution of a decree, the court shall fix for his subsistence such monthly allowance as he may be entitled to according to the scales fixed under section 45 or, where no such scales have been fixed, as it considers sufficient with reference to the class to which he belongs.

(3) The monthly allowance fixed by the court shall be supplied by the party on whose application the judgment debtor has been arrested by monthly payments in advance before the first day of each month.

(4) The first payment shall be made to the proper officer of the court for such portion of the current month as remains unexpired before the judgment debtor is committed to civil prison, and the subsequent payments (if any) shall be made to the officer in charge of the prison.

(5) Sums disbursed by the decree-holder for the subsistence of the judgment debtor in prison shall be deemed to be costs in the suit:

Provided that the judgment debtor shall not be detained in prison or arrested on account of any sum so disbursed.

Proceedings on appearance of judgment debtor in obedience to notice or after arrest **39**.-(1) Where a judgment debtor appears before the court in obedience to a notice issued under rule 35, or is brought before the court after being arrested in execution of a decree for the payment of money and it appears to the court that the judgment debtor is unable from poverty or other sufficient cause to pay the amount of the decree or, if that amount is a payable by installment, the amount of any installment thereof, the court may, upon such terms (if any) as it thinks fit, make an order disallowing the application for his arrest and detention, or directing his release, as the case may be.

(2) Before making an order under sub-rule (1), the court may take into consideration any allegation of the decree-holder touching any of the following matters, namely-

- (a) the decree being for a sum for which the judgment debtor was bound in any fiduciary capacity to account;
- (b) the transfer, concealment or removal by the judgment debtor of any part of his property after the date of the institution of the suit in which the decree was passed, or the commission by him after that date of any other act of bad faith in relation to his property, with the object or effect of obstructing or delaying the decree-holder in the execution of the decree;
- (c) any undue preference given by the judgment debtor to any of his other creditors;
- (d) refusal or neglect on the part of the judgment debtor to pay the amount of the decree or some part thereof when he has, or since the date of the decree has had, the means of paying it;

(e) the likelihood of the judgment debtor absconding or leaving the jurisdiction of the court with the object or effect of obstructing or delaying the decree-holder in the execution of the decree.

(3) While any of the matters mentioned in sub-rule (2) are being considered, the court may, in its discretion, order the judgment debtor to be detained as a civil prisoner or leave him in the custody of an officer of the court, or release him on his furnishing security, to the satisfaction of the court, for his appearance when required by the court.

(4) A judgment debtor released under this rule may be re-arrested.

(5) Where the court does not make an order under sub-rule (1), it shall cause the judgment debtor to be arrested if he has not already been arrested and, subject to the other provisions of this Code, commit him to prison.

Attachment of Property

Examination of judgment debtor as to his property

40. Where a decree is for the payment of money the decree-holder may apply to the court for an order that-

- (a) the judgment debtor;
- (b) in the case of a corporation, any officer thereof; or
- (c) any other person,

be orally examined as to whether any or what debts are owing to the judgment debtor and whether the judgment debtor has any and what other property or means of satisfying the decree; and the court may make an order for the attendance and examination of such judgment debtor, or officer or other person, and for the production of any books or documents.

41. Where a decree directs an inquiry as to rent or mesne profits or any other matter, the property of the judgement debtor may, before the amount due from him has been ascertained, be attached as in the case of an ordinary decree for the payment of money.

Attachment of movable property, other than agricultural produce, in possession of judgment debtor

Attachment in

case of decree

for rent or

matter, amount of which to be subsequently determined

42. Where the property to be attached is movable property, other than agricultural produce, in the possession of the judgment debtor, the attachment shall be made by actual seizure and the attaching officer shall keep the property in his own custody or in the custody of one of his subordinates, and shall be responsible for the due custody thereof:

Provided that, when the property seized is subject to speedy and natural decay, or when the expense of keeping it in custody is likely to exceed its value, the attaching officer may sell it at once. Attachment of agricultural produce

43. Where the property to be attached is agricultural produce, the attachment shall be made by affixing a copy of the warrant of attachment–

- (a) where such produce is a growing crop, on the land on which such crop has grown; or
- (b) where such produce has been cut or gathered, on the place in which it is deposited,

and another copy on the outer door or some other conspicuous part of the house in which the judgment debtor ordinarily resides or, with the leave of the court, on the outer door or on some other conspicuous part of the house in which he carries on business or personally works for gain or in which he is known to have last resided or carried on business or personally worked for gain; and the produce shall thereupon be deemed to have passed into the possession of the court.

Provisions as to agricultural produce under attachment

44.-(1) Where agricultural produce is attached, the court shall make such arrangements for the custody thereof as it may deem sufficient and, for the purposes of enabling the court to make such arrangements, every application for the attachment of a growing crop shall specify the time at which it is likely to be fit to be cut or gathered.

(2) Subject to such conditions as may be imposed by the court in this behalf either in the order of attachment or in any subsequent order, the judgment debtor may tend, cut, gather and store the produce and do any other act necessary for maturing or preserving it; and if the judgment debtor fails to do all or any of such acts the decree-holder may, with the permission of the court and subject to the like conditions, do all or any of them either by himself or by any person appointed by him in this behalf, and the costs incurred by the decree-holder shall be recoverable from the judgment debtor as if they were included in, or formed part of, the decree.

(3) Agricultural produce attached as a growing crop shall not be deemed to have ceased to be under attachment or to require re-attachment merely because it has been severed from the soil.

(4) Where an order for the attachment of a growing crop has been made at a considerable time before the crop is likely to be fit to be cut or gathered, the court may suspend the execution of the order for such time as it thinks fit, and may, in its discretion, make a further order prohibiting the removal of the crop pending the execution of the order of attachment.

(5) A growing crop which from its nature does not admit of being stored shall not be attached under this rule at any time less than twenty days before the time at which it is likely to be fit to be cut or gathered.

Attachment of debt, share and other property not in possession of judgment **45.-**(1) In the case of–

- (a) a debt not secured by a negotiable instrument;
- (b) a share in the capital of a corporation;
- (c) other movable property not in the possession of the

judgment debtor, except property deposited in, or in the custody of, any court,

the attachment shall be made by a written order prohibiting-

- (i) in the case of the debt, the creditor from recovering the debt and the debtor from making payment thereof until the further order of the court;
- (ii) in the case of the share, the person in whose name the share may be standing from transferring the same or receiving any dividend thereon;
- (iii) in the case of the other movable property except as aforesaid, the person in possession of the same from giving it over to the judgment debtor.

(2) A copy of such order shall be fixed on some conspicuous part of the court-house, and another copy shall be sent in the case of the debts, to the debtor, in the case of the share, to the proper officer of the corporation, and, in the case of the other movable property (except as aforesaid), to the person in possession of the same.

(3) A debtor prohibited under item (i) of sub-rule (1) may pay the amount of his debt into court, and such payment shall discharge him as effectually as payment to the party entitled to receive the same.

Attachment of share in movables in the share of the judgment debtor in movable property belonging to him and another as co-owner, the attachment shall be made by a notice to the judgment debtor prohibiting him from transferring the share or interest or charging it in any way.

Attachment of salary **47.-(1)** Where the property to be attached is the salary of an employee, the court may order that the amount shall be withheld from such salary either in one payment or by monthly installments as the court may direct; and, upon notice of the order to the employer of the said employee, or in the case of a Government servant, to the paying authority, the employer or the paying authority or other person whose duty it is to disburse such salary, as the case may be, shall withhold and remit to the court the amount due under the said order, or the monthly installments, as the case may be.

(2) An order attaching the salary of an employee may be made by the court whether the employee or the employer or the paying authority or other person, as the case may be, is or is not within the local limits of the court's jurisdiction.

(3) Where the attachable proportion of such salary is already being withheld and remitted to a court in pursuance of a previous and unsatisfied order of attachment, the employer or, in the case of a Government servant, the paying authority shall forthwith return the subsequent order to the court issuing it with a full statement of all the particulars of the existing attachment.

debtor

(4) For the purposes of this rule-

"paying authority" means the Assistant Paymaster-General or such other officer as may be appointed as paying authority for any Government servant or any particular class of Government servant;

"employee" includes a Government servant;

"employer" includes the Government.

Attachment of partnership property **48**. (1) Save as otherwise provided by this rule, property belonging to a partnership shall not be attached or sold in execution of a decree other than a decree passed against the firm or against the partners in the firm as such.

(2) The court may, on the application of the holder of a decree against a partner, make an order charging the interest of such partner in the partnership property and profits with payment of the amount due under the decree, and may, by the same or a subsequent order, appoint a receiver of the share of such partner in the profits (whether already declared or accruing) and of any other money which may be coming to him in respect of the partnership, and direct accounts and inquiries and make an order for the sale of such interest or other order as might have been directed or made if a charge had been made in favour of the decreeholder by such partner, or as the circumstances of the case may require.

(3) The other partner or partners shall be at liberty at any time to redeem the interest charged or, in the case of a sale being directed, to purchase the same.

(4) Every application for an order under sub-rule (2) shall be served on the judgment debtor and on his partners or such of them as are within Tanzania.

(5) Every application made by any partner of the judgment debtor under sub-rule (3) shall be served on the decree-holder and on the judgment debtor, and on such of the other partners as do not join in the application and as are within Tanzania.

(6) Service under sub-rule (4) or sub-rule (5) shall be deemed to be service on all the partners, and all orders made on such applications shall be similarly served.

Execution of decree against firm, execution may be granted-

- (a) against any property of the partnership;
- (b) against any person who has appeared in his own name under rule 6 or rule 7 of Order XXIX, or who has admitted on the pleading that he is, or who has been adjudged to be, a partner;
- (c) against any person who has been individually served as a partner with a summons and has failed to appear:

Provided that nothing in this subrule shall be deemed to limit or otherwise affect the provisions of section 247 of the Indian Contract Act, 1872 as formerly applied to Tanzania and saved by section 228 of the Law of Contract Act.

(2) Where the decree-holder claims to be entitled to cause the decree to be executed against any person other than such a person as is referred to in sub-rule (1), paragraphs (b) and (c), as being a partner in the firm, he may apply to the court which passed the decree for leave, and where the liability is not disputed, such court may grant such leave, or where such liability is disputed, may order that the liability of such person be tried and determined in any manner in which any issue in a suit may be tried and determined.

(3) Where the liability of any person has been tried and determined under sub-rule (2), the order made thereon shall have the same force and be subject to the same conditions as to appeal or otherwise as if it were a decree.

Attachment of negotiable instruments **50**. Where property is a negotiable instrument not deposited in a court, nor in the custody of a public officer, the attachment shall be made by actual seizure and the instrument shall be brought into court and held subject to further orders of the court.

51. Where the property to be attached is in the custody of any court or public officer, the attachment shall be made by a notice to such court or officer, requesting that such property and any interest or dividend becoming payable thereon may be held subject to the further orders of the court from which the notice is issued:

Provided that, where such property is in the custody of a court, any question of title or priority arising between the decree-holder and any other person, not being the judgment debtor, claiming to be interested in such property by virtue of any assignment, attachment or otherwise, shall be determined by such court.

Attachment of decrees

52.-(1) Where the property to be attached is a decree, either for the payment of money or for sale in enforcement of a mortgage or charge, the attachment shall be made-

- (a) if the decree was passed by the same court, then by order of such court; or
- (b) if the decree sought to be attached was passed by another court, then by the issue to such other court of a notice by the court which passed the decree sought to be executed, requesting such other court to stay the execution of its decree unless and until-
 - (i) the court which passed the decree sought to be executed cancels the notice; or
 - (ii) the holder of the decree sought to be executed or his

Attachment of property in custody of court or public officer judgment debtor applies to the court receiving such notice to execute its own decree.

(2) Where a court makes an order under paragraph (a) of sub-rule (1), or receives an application under item (ii) of paragraph (b) of the said sub-rule, it shall, on the application of the creditor who has attached the decree or his judgment debtor, proceed to execute the attached decree and apply the net proceeds in satisfaction of the decree sought to be executed.

(3) The holder of a decree sought to be executed by the attachment of another decree of the nature specified in sub-rule (1) shall be deemed to be the representative of the holder of the attached decree and to be entitled to execute such attached decree in any manner lawful for the holder thereof.

(4) Where the property to be attached in the execution of a decree is a decree other than a decree of the nature referred to in sub-rule (1), the attachment shall be made by a notice by the court which passed the decree sought to be executed, to the holder of the decree sought to be attached, prohibiting him from transferring or charging the same in any way; and, where such decree has been passed by any other court, also by sending to such other court a notice to abstain from executing the decree sought to be attached until such notice is cancelled by the court from which it was sent.

(5) The holder of a decree attached under this rule shall give the court executing the decree such information and aid as may reasonably be required.

(6) On the application of the holder of a decree sought to be executed by the attachment of another decree, the court making an order of attachment under this rule shall give notice of such order to the judgment debtor bound by the decree attached; and no payment or adjustment of the attached decree made by the judgment debtor in contravention of such order after receipt of notice thereof, either through the court or otherwise, shall be recognised by any court so long as the attachment remains in force.

53.- (1) Where the property is immovable, the attachment shall be made by an order prohibiting the judgment debtor from transferring or charging the property in any way, and all persons from taking any benefit from such transfer or charge.

(2) The order shall be proclaimed at some place on or adjacent to such property by such means as are used locally to make public pronouncements and a copy of the order shall be fixed on a conspicuous part of the property and then upon a conspicuous part of the court-house.

Removal of attachment after satisfaction of decree

Attachment of

immovable

54. Where-

- (a) the amount decreed with costs and all charges and expenses resulting from the attachment of any property are paid into court;
- (b) satisfaction of the decree is otherwise made through the

court or certified to the court; or

(c) the decree is set aside or reversed,

the attachment shall be deemed to be withdrawn, and, in the case of immovable property, the withdrawal shall, if the judgment debtor so desires, be proclaimed at his expense, and a copy of the proclamation shall be affixed in the manner prescribed by rule 53.

55. Where the property attached is current coin or currency notes the court may, at any time during the continuance of the attachment, direct that such coin or notes or a part thereof sufficient to satisfy the decree be paid over to the party entitled under the decree to receive the same.

56. Where any property has been attached in execution of a decree, but by reason of the decree-holder's default the court is unable to proceed further with the application for execution, it shall either dismiss the application or for any sufficient reason adjourn the proceedings to a future date and upon the dismissal of such application the attachment shall cease.

Investigation of Claims and Objections

57.-(1) Where any claim is preferred to, or any objection is made to the attachment of, any property attached in execution of a decree on the ground that such property is not liable to such attachment, the court shall proceed to investigate the claim or objection with the like power as regards the examination of the claimant or objector and in all other respects, as if he was a party to the suit:

Provided that no such investigation shall be made where the court considers that the claim or objection was designedly or unnecessarily delayed.

(2) Where the property to which the claim or objection applies has been advertised for sale, the court ordering the sale may postpone it pending the investigation of the claim or objection.

58. The claimant or objector must adduce evidence to show that at the date of the attachment he had some interest in, or was possessed of, the property attached.

59. Where upon the said investigation the court is satisfied that for the reason stated in the claim or objection such property was not, when attached, in the possession of the judgment debtor or of some person in trust for him, or in the occupancy of a tenant or other person paying rent to him, or that, being in the possession of the judgment debtor at such time, it was so in his possession, not on his own account or as his own

Disallowance 60. Where the court is satisfied that the property was at the time it was attached, in the possession of the judgment debtor as his own property and not on account of any other person, or was in the possession of some other person in trust from him, or in the occupancy of a tenant or other person paying rent to him, the court shall disallow the claim.

> **61.** Where the court is satisfied that the property is subject to a mortgage or charge in favour of some person not in possession, and thinks fit to continue the attachment, it may do so, subject to such mortgage or charge.

Saving of **62**. Where a claim or an objection is preferred, the party suits to against whom an order in made may institute a suit to establish the right establish right which he claims to the property in dispute, but, subject to the result of to attached such suit, if any, the order shall be conclusive.

Sale Generally

63. Any court executing a decree may order that any property attached by it and liable to sale, or such portion thereof as may seem necessary to satisfy the decree, shall be sold, and that the proceeds of such sale, or a sufficient portion thereof, shall be paid to the party entitled under the decree to receive the same.

Save as otherwise prescribed, every sale in execution of a **64**. decree shall be conducted by an officer of the court or by such other person as the court may appoint in this behalf, and shall be made by public auction in the manner prescribed.

65.-(1) Where any property is ordered to be sold by public auction in execution of a decree, the court shall cause a proclamation of the intended sale to be made in the language of such court.

(2) The proclamation shall be drawn up after notice to the decreeholder and the judgment debtor and shall state the time and place of sale, and specify as fairly and accurately as possible-

- (a) the property to be sold;
- (b) the rent (if any) payable in respect of the property;
- any incumbrance to which the property is liable; (c)
- the amount for the recovery of which the sale is ordered; (d)

(3) Every application for an order for sale under this rule shall be accompanied by a statement signed and verified in the manner hereinbefore prescribed for the signing and verification of pleadings and containing, so far as they are known to or can be ascertained by the person making the verification, the matters required by sub-rule (2) to be specified in the proclamation.

(4) For the purpose of ascertaining the matters to be specified in the proclamation, the court may summon any person whom it thinks necessary to summon and may examine him in respect to any such matters and require him to produce any document in his possession or power relating thereto

66. -(1) Every proclamation shall be made and published, as nearly as may be, in the manner prescribed by rule 53, sub-rule (2).

(2) Where the court so directs, such proclamation shall also be published in the *Gazette* or in a local newspaper, or in both, and the costs of such publication shall be deemed to be costs of the sale.

(3) Where property is divided into lots for the purpose of being sold separately, it shall not be necessary to make a separate proclamation for each lot, unless property notice of the sale cannot, in the opinion of the court, otherwise be given.

67. Save in the case of property of the kind described in the proviso to rule 44, no sale hereunder shall, without the consent in writing of the judgment debtor, take place until after the expiration of at least thirty days in the case of immovable property, and of at least fifteen days in the case of movable property, calculated from the date on which the copy of the proclamation has been affixed on the court-house of the judge or magistrate ordering the sale.

68. (1) The court may, in its discretion, adjourn any sale hereunder to a specified day and hour, and the officer conducting any such sale may in his discretion adjourn the sale, recording his reason for such adjournment:

Provided that, where the sale is made in, or within the precincts of, the court-house, no such adjournment shall be made without the leave of the court.

(2) Where a sale is adjourned under sub-rule (1) for a longer period than seven days, a fresh proclamation under rule 66 shall be made, unless the judgment debtor consents to waive it.

(3) Every sale shall be stopped if, before the lot is knocked down, the debt and costs (including the costs of the sale) are rendered to the officer conducting the sale, or proof is given to his satisfaction that the

Adjournment or stoppage of sale amount of such debt and costs has been paid into the court which ordered the sale.

Defaulting purchaser answerable for loss on resale

Decree-holder not to bid for or buy property without permission **69.** Any deficiency of price which may happen on a re-sale by reason of the purchaser's default, and all expenses attending such re-sale, shall be certified to the court by the officer or other person holding the sale and shall, at the instance of either the decree-holder or the judgment debtor, be recoverable from the defaulting purchaser under the provisions relating to the execution of a decree for the payment of money.

70.-(1) No holder of a decree in execution of which property is sold shall, without the express permission of the court, bid for or purchase the property.

(2) Where a decree-holder purchases with such permission, the purchase money and the amount due on the decree may, subject to the provisions of section 54, be set off against one another, and the court executing the decree shall enter up satisfaction of the decree in whole or in part accordingly.

(3) Where a decree-holder purchases, by himself or through another person, without such permission, the court may, if it thinks fit, on the application of the judgment debtor or any other person whose interests are affected by the sale, by order set aside the sale; and the costs of such application and order, and any deficiency of price which may happen on the re-sale and all expenses attending it, shall be paid by the decreeholder.

Restriction on bidding or purchase by officer **71.** No officer or other person having any duty to perform in connection with any sale shall, either directly or indirectly, bid for, acquire or attempt to acquire any interest in the property sold.

Sale of Movable Property

Sale of agricultural produce for the property to be sold is agricultural produce, the sale shall, save as otherwise provided by any law for the time being in force, be held–

- (a) if such produce is a growing crop, on or near the land on which such crop has grown; or
- (b) if such produce has been cut or gathered, at or near the place in which it is deposited:

Provided that, the court may direct the sale to be held at the nearest place of public resort, if it is of opinion that the produce is thereby likely to sell to greater advantage.

- (2) Where, on the produce being put up for sale-
- (a) a fair price, in the estimation of the person holding the sale, is not offered for it; and
- (b) the owner of the produce or a person authorised to act in his behalf applies to have the sale postponed till the next day or, if a market is held at the place of sale, the next marketday,

the sale shall be postponed accordingly and shall be then completed, whatever price may be offered for the produce.

73. (1) Where the property to be sold is a growing crop and the crop from its nature admits of being stored but has not yet been stored, the day of the sale shall be so fixed as to admit of its being made ready for storing before the arrival of such day, and the sale shall not be held until the crop has been cut or gathered and is ready for storing.

(2) Where the crop from its nature does not admit of being stored, it may be sold before it is cut and gathered and the purchaser shall be entitled to enter on the land and to do all that is necessary for the purpose of tending and cutting or gathering it.

Sale by public auction

74. Where the property to be sold is a negotiable instrument or a share in a corporation the court may, instead of directing the sale to be made by public auction, authorise the sale of such instrument or share through a broker.

75. (1) Where movable property is sold by public auction the price of each lot shall be paid at the time of sale or as soon after as the officer or other person holding the sale directs, and in default of payment the property shall forthwith be re-sold.

(2) On payment of the purchase money, the officer or other person holding the sale shall grant a receipt for the same and the sale shall become absolute.

(3) Where the movable property to be sold is a share in goods

belonging to the judgment debtor and a co-owner, and two or more persons, of whom one is such co-owner, respectively, bid the same sum for such property or for any lot, the bidding shall be deemed to be the bidding of the co-owner.

Irregularity not to vitiate sale, but any person injured may sue

Delivery of

property, debts and shares **76.** No irregularity in publishing or conducting the sale of movable property shall vitiate the sale; but any person sustaining any injury by reason of such irregularity at the hand of any other person may institute a suit against him for compensation or (if such other person is the purchaser) for the recovery of the specific property and for compensation in default of such recovery.

77.-(1) Where the property sold is movable property of which actual seizure has been made, it shall be delivered to the purchaser.

(2) Where the property sold is movable property in the possession of some person other than the judgment debtor, the delivery thereof to the purchaser shall be made by giving notice to the person in possession prohibiting him from delivering possession of the property to any person except the purchaser.

(3) Where the property sold is a debt not secured by a negotiable instrument or is a share in a corporation, the delivery thereof shall be made by a written order of the court prohibiting the creditor from receiving the debt or any interest thereon, and the debtor from making payment thereof to any person except the purchaser, or prohibiting the person in whose name the share may be standing from making any transfer of the share to any person except the purchaser, or receiving payment of any dividend or interest thereon, and the manager, secretary or other proper officer of the corporation from permitting any such transfer or making any such payment to any person except the purchaser.

Transfer of negotiable instruments and shares

78.-(1) Where the execution of a document or the endorsement of the party in whose name a negotiable instrument or a share in a corporation is standing is required to transfer such negotiable instrument or share, the judge or magistrate or such officer as he may appoint in this behalf may execute such document or make such endorsement as may be necessary, and such execution or endorsement shall have the same effect as an execution or endorsement by the party.

(2) The execution of a document or the endorsement of a negotiable instrument may be in the following form, namely:

A.B. by C.D., Judge/or magistrate of the court of

(or as the case may be), in a suit by E.F. against A.B."

(3) Until the transfer of such negotiable instrument or share the court may, by order, appoint some person to receive any interest or dividend due thereon and to sign a receipt for the same; and any receipt so signed shall be as valid and effectual for all purposes as if the same had

been signed by the party himself.

Postponement of sale to enable judgment debtor to raise amount of decree

81.- (1) Where an order for the sale of immovable property has been made, if the judgment debtor can satisfy the court that there is reason to believe that the amount of the decree may be raised by the mortgage or lease or private sale of such property, or some part thereof, or of any other immovable property of the judgment debtor, the court may, on his application, postpone the sale of the property comprised in the order for sale on such terms and for such period as it thinks proper, to enable him to raise the amount.

(2) In such case the court shall grant a certificate to the judgment debtor authorising him within a period to be mentioned therein, and notwithstanding anything contained in section 51, to make the proposed mortgage, lease or sale:

Provided that, all moneys payable under such mortgage, lease or sale shall be paid not to the judgment debtor, but, save in so far as a decree-holder is entitled to set off such money under the provisions of rule 70, into court:

Provided also that, no mortgage, lease or sale under this rule shall become absolute until it has been confirmed by the court.

(3) .Nothing in this rule shall be deemed to apply to a sale of property directed to be sold in execution of a decree for sale in enforcement of a mortgage of, or charge on, such property.

Deposit by purchaser and re-sale on default **82**.-(1) .On every sale of immovable property the person declared to be the purchaser shall pay immediately after such declaration a deposit of twenty-five *per centum* on the amount of his purchase money to the officer or other person conducting the sale and, in default of such deposit, the property shall forthwith be re-sold.

(2) Where the decree-holder is the purchaser and is entitled to setoff the purchase money under rule 70, the court may dispense with the requirements of this rule.

Time for payment in full of purchasemoney **83**. The full amount of purchase-money payable shall be paid by the purchaser into court before the court closes on the fifteenth day from the sale of the property:

the purchaser shall have the advantage of any set-off to which he may be entitled under rule 70. Procedure in 84. - (a) that a suit must fail by reason of some formal defect; or
- (b) that there are other sufficient grounds for allowing the plaintiff to institute a fresh suit for the subject matter of a suit or part of a claim, it may, on such terms as it thinks fit, grant the plaintiff permission to withdraw from such suit or abandon such part of a claim with liberty to institute a fresh suit in respect of the subject matter of such suit or such part of a claim.

(3) Where the plaintiff withdraws from a suit, or abandons part of a claim, without the permission referred to in sub-rule (2), he shall be liable for such costs as the court may award and shall be precluded from instituting any fresh suit in respect of such subject matter or such part of

paid, the court shall consider which of the parties is most to blame for the litigation.

ORDER XXV SECURITY FOR COSTS

When security for costs may be required from plaintiff **1.-**(1) Where, at any stage of a suit, it appears to the court that a sole plaintiff is, or (when there are more plaintiffs than one) that all the plaintiffs are residing out of Tanzania, and that such plaintiff does not, or that no one of such plaintiffs does, possess any sufficient immovable property within Tanzania other than the property in suit, the court may, either of its own motion or on the application of any defendant, order the plaintiff or plaintiffs, within a time fixed by it, to give security for the payment of all costs incurred and likely to be incurred by any defendant.

(2) Whoever leaves Tanzania under such circumstances as to afford reasonable probability that he will not be forthcoming whenever he may be called upon to pay costs shall be deemed to be residing out of Tanzania within the meaning of sub-rule (1).

Effect of failure to furnish security **2.-**(1) In the event of such security not being furnished within the time fixed, the court shall make an order dismissing the suit unless the plaintiff or plaintiffs are permitted to withdraw therefrom.

(2) Where a suit is dismissed under this rule, the plaintiff may apply for an order to set the dismissal aside and, if it is proved to the satisfaction of the court that he was prevented by any sufficient cause from furnishing the security within the time allowed, the court shall set aside the dismissal upon such terms as to security, costs or otherwise as it thinks fit and shall appoint a day for proceeding with the suit.

(3) The dismissal shall not be set aside unless notice of such application has been served on the defendant.

ORDER XXVI COMMISSIONS

Commissions to Examine Witnesses

1. Any court may in any suit issue a commission for the examination on interrogatories or otherwise of any person resident within the local limits of its jurisdiction who is exempted under this Code from attending the court or who is, from sickness or infirmity, unable to attend it.

2. An order for the issue of a commission for the examination of a witness may be made by the court either of its own motion or on the application, supported by affidavit or otherwise, of any party to the suit or

of the witness to be examined.

Where witness resides within court's jurisdiction within the local limits of the jurisdiction of the court issuing the same may be issued to any person whom the court thinks fit to execute it.

Persons for whose examination court may issue commission

4.-(1) Any court may in any suit issue a commission for the examination of-

- (a) any person resident beyond the local limits of its jurisdiction;
- (b) any person who is about to leave such limits before the date on which he is required to be examined in court; or
- (c) any civil or military officer of the Government who cannot, in the opinion of the court, attend without detriment to the public service.

(2) Such commission may be issued to any court, other than the High Court, within the local limits of whose jurisdiction such person resides, or to any advocate or other person whom the court issuing the commission may appoint.

(3) The court on issuing any commission under this rule shall direct whether the commission shall be returned to itself or to any subordinate court.

5. Where any court to which application is made for the issue of a commission for the examination of a person residing at any place not within Tanzania is satisfied that the evidence of such person is necessary, the court may issue such commission or a letter of request.

6. Every court receiving a commission for the examination of any person shall examine him or cause him to be examined pursuant thereto.

7. Where a commission has been duly executed, it shall be returned, together with the evidence taken under it, to the court from which it was issued, unless the order for issuing the commission has otherwise directed, in which case the commission shall be returned in terms of such order; and the commission and the return thereto and the evidence taken under it shall (subject to the provisions of rule 8) form part of the record of the suit.

8. Evidence taken under a commission shall not be read as evidence in the suit without the consent of the party against whom the same is offered unless-

(a) the person who gave the evidence is beyond the jurisdiction of the court, or dead or unable from sickness or infirmity to

10.-(1) The commissioner, after such local inspection as he deems necessary and after reducing to writing the evidence taken by him, shall return such evidence, together with his report in writing signed by him, to court.

(2) The report of the commissioner and the evidence taken by him (but not the evidence without the report) shall be evidence in the suit and shall form part of the record; but the court or, with the permission of the court, any of the parties to the suit, may examine the commissioner personally in open court touching any of the matters referred to him or mentioned in his report, or as to his report, or as to the manner in which he has made the investigation.

(3) Where the court is for any reason dissatisfied with the proceedings of the commissioner, it may direct such further inquiry to be made as it shall think fit.

13. Where a preliminary decree for partition has been passed, the court may issue a commission to such person as it thinks fit to make the partition or separation according to the rights as declared in such decree.

14.-(1) The commissioner shall, after such inquiry as may be necessary, divide the property into as many shares as may be directed by the order under which the commission was issued and shall allot such shares to the parties and may, if authorised thereto by the said order, award sums to be paid for the purpose of equalising the value of the shares.

(2) The commissioner shall then prepare and sign a report or the commissioner (where the commission was issued to more than one person and they cannot agree) shall prepare and sign separate reports appointing the share of each party and distinguishing each share (if so directed by the said order) by metes and bounds and such report or reports shall be annexed to the commission and transmitted to the court; and the court, after hearing any objections which the parties may make to the report or reports, shall confirm, vary or set aside the same.

(3) Where the court confirms or varies the report or reports it shall pass a decree in accordance with the same as confirmed or varied; but where the court sets aside the report or reports it shall either issue a new commission or make such other order as it shall think fit.

General Provisions

15. Before issuing any commission under this Order, the court may order such sum (if any) as it thinks reasonable for the expenses of the commission to be, within a time to be fixed, paid into court by the party at whose instance or for whose benefit the commission is issued.

16. Any commissioner appointed under this Order may, unless otherwise directed by the order of appointment-

- (a) examine the parties themselves and any witness whom they or any of them may produce and any other person whom the commissioner thinks proper to call upon to give evidence in the matter referred to him;

ORDER XXVII

SUITS BY OR AGAINST MILITARY PERSONNEL

Officers or soldiers who cannot obtain leave may authorise any person to sue or defend for them **1**.-(1) Where any officer or soldier actually serving the Government in a military capacity is a party to a suit, and cannot obtain leave of absence for the purpose of prosecuting or defending the suit in person, he may authorise any person to sue or defend in his stead.

(2) The authority shall be in writing and shall be signed by the officer or soldier in the presence of-

- (a) his commanding officer, or the next subordinate officer, if the party is himself the commanding officer; or
- (b) where the officer or soldier is serving in military staff employment, the head or other superior officer of the officer in which he is employed, such commanding or other officer shall countersign the authority, which shall be filed in court.

(3) When so filed, the countersignature shall be sufficient proof that the authority was duly executed and that the officer or soldier by whom it was granted could not obtain leave of absence for the purpose of prosecuting or defending the suit in person.

Explanation: In this Order the expression "commanding officer"

means the officer in actual command for the time being of any regiment, corps, detachment or depot to which the officer or soldier belongs.

2. Any person authorised by an officer or soldier to prosecute or defend a suit in his stead may prosecute or defend it in person in the same manner as the officer or soldier could do if present; or he may appoint an advocate to prosecute or defend the suit on behalf of such officer or soldier.

3. Processes served upon any person authorised by an officer or soldier under rule 1 or upon any advocate appointed as aforesaid by such person shall be as effectual as if they had been served on the party in person.

ORDER XXVIII SUITS BY OR AGAINST CORPORATIONS

Subscription 1. In suits by or against a corporation, any pleading may be signed and verified on behalf of the corporation by the secretary or by any verification of director or other principal officer of the corporation who is able to depose pleading to the facts of the case.

> 2. Subject to any written law regulating service of process, where the suit is against a corporation, the summons may be served-

- on the secretary, or on any director, or other principal (a) officer of the corporation; or
- by leaving it or sending it by post addressed to the (b) corporation at the registered office or, if there is no registered office, then at the place where the corporation carries on business.

3. The court may, at any stage of the suit, require the personal appearance of the secretary or of any director, or other principal officer of the corporation who may be able to answer material questions relating to attendance of officer of the suit. corporation

SUITS BY OR AGAINST FIRMS AND PERSONS CARRYING ON BUSINESS IN NAMES OTHER THAN THEIR OWN

2.-(1) Where a suit is instituted by partners in the name of their firm, the plaintiffs or their advocate shall, on demand in writing by or on behalf of any defendant, forthwith declare in writing the names and places of residence of all the persons constituting the firm on whose behalf the suit is instituted.

(2) Where the plaintiffs or their advocate fail to comply with any demand made under sub-rule (1), all proceeding in the suit may, upon an application for that purpose, be stayed upon such terms as the court may direct.

(3) Where the names of the partners are declared in the manner referred to in sub-rule (1), the suit shall proceed in the same manner, and the same consequences in all respects shall follow, as if they had been named as plaintiffs in the plaint:

Provided that all the proceedings shall nevertheless continue in the name of the firm.

3. Where persons are sued as partners in the name of their firm, the summons shall be served either-

- (a) upon any one or more of the partners; or
- (b) at the principal place at which the partnership business is carried on, upon any person having, at the time of service, the control or management of the partnership business there,

as the court may direct; and such service shall be deemed good service upon the firm so sued,

whether all or any of the partners are within or without Tanzania:

Provided that, in the case of a partnership which has been dissolved to the knowledge of the plaintiff before the institution of the suit, the summons shall be served upon every person within Tanzania whom it is sought to make liable.

Right of suit on death of partner Cap. 345 **4.**-(1) Notwithstanding anything contained in section 45 of the Law of Contract Act, where two or more persons may sue or be sued in the name of a firm under the foregoing provisions and any of such persons dies, whether before the institution or during the pendency of any suit, it

shall not be necessary to join the legal representative of the deceased as a party to the suit.

(2) Nothing in sub-rule (1) shall limit or otherwise affect any right which the legal representative of the deceased may have-

(a) to apply to be made a party to the suit; or

(b) to enforce any claim against the survivor or survivors.

Notice, in what capacity served **5.** Where a summons is issued to a firm and is served in the manner provided by rule 3, every person upon whom it is served shall be informed by notice in writing given at the time of such service, whether he is served as a partner or as a person having the control or management of the partnership business, or in both characters and, in default of such notice, the person served shall be deemed to be served as a partner.

6. Where persons are sued as partners in the name of their firm, they shall appear individually in their own names, but all subsequent proceedings shall, nevertheless, continue in the name of the firm.

7. Where a summons is served in the manner provided by rule 3 upon a person having the control or management of the partnership business, no appearance by him shall be necessary unless he is a partner of the firm sued.

8. Any person served with summons as a partner under rule 3 may appear under protest, denying that he is a partner, but such appearance shall not preclude the plaintiff from otherwise serving a summons on the firm and obtaining a decree against the firm in default of appearance where no partner has appeared.

9. This Order shall apply to suits between a firm and one or more of the partners therein and to suits between firms having one or more partners in common; but no execution shall be issued in such suits except by leave of the court, and, on an application for leave to issue such execution, all such accounts and inquiries may be directed to be taken and made and directions given as may be just.

ORDER XXX SUITS BY OR AGAINST TRUSTEES, EXECUTORS AND ADMINISTRATORS

Representatio n of beneficiaries in suits concerning property vested in trustees, etc

Joinder of trustees, executors and administrators 1. In all suits concerning property vested in a trustee, executor or administrator, where the contention is between the persons beneficially interested in such property and a third person, the trustee, executor or administrator shall represent the persons so interested, and it shall not ordinarily be necessary to make them parties to the suit, but the court may, if it thinks fit, order them or any of them to be made parties.

2. Where there are several trustees, executors or administrators, they shall all be made parties to a suit against one or more of them:

Provided that the executors who have not proved their testator's will, and trustees, executors and administrators outside Tanzania, need not be made parties.

ORDER XXXI SUITS BY OR AGAINST MINORS AND PERSONS OF UNSOUND MIND

Minor to sue by next friend

1. Every suit by a minor shall be instituted in his name by a person who in such suit shall be called the next friend of the minor.

Where suit is instituted without next friend, plaint to be taken off the file 2.- (1) Where a suit is instituted by or on behalf of a minor without a next friend, the defendant may apply to have the plaint taken off the file with costs to be paid by the advocate or other person by whom it was presented.

(2) Notice of such application shall be given to such person and the court, after hearing his objections (if any), may make such order in the matter as it thinks fit.

Guardian for the suit to be appointed by court for minor defendant **3.**-(1) Where the defendant is a minor, the court, on being satisfied of the fact of his minority, shall appoint a proper person to be guardian for the suit for such minor.

(2) An order for the appointment of a guardian for the suit may be obtained upon application in the name and on behalf of the minor or by the plaintiff.

(3) The application shall be supported by an affidavit verifying the fact that the proposed guardian has no interest in the matters in controversy in the suit adverse to that of the minor and that he is a fit person to be so appointed.

(4) No order shall be made on any application under this rule except upon notice to the minor and to any guardian of the minor appointed or declared by an authority competent in that behalf or, where there is no such guardian, upon notice to the father or other natural guardian of the minor or, where there is no father or other natural guardian, to the person in whose care the minor is, and after hearing any objection which may be urged on behalf of any person served with notice under this sub-rule.

(5) A person appointed under this rule to be a guardian for a suit shall, unless his appointment is terminated by retirement, removal or death, continue as such for the purposes of all the proceedings arising out of the suit including proceedings in execution of a decree.

4.-(1) Any person who is of sound mind and has attained majority may act as next friend of a minor or as his guardian for the suit, provided that the interest of such person is not adverse to that of the minor and that he is not, in the case of a next friend, a defendant, or, in the case of a guardian for the suit, a plaintiff.

(2) Where a minor has a guardian appointed or declared by a competent authority, no person other than such guardian shall act as the next friend of the minor or be appointed his guardian for the suit unless the court considers, for reasons to be recorded, that it is for the minor's welfare that another person be permitted to act or be appointed, as the case may be.

(3) No person shall without his consent be appointed guardian for the suit.

(4) Where there is no other person fit and willing to act as guardian for the suit, the court may appoint any of its officers to be such guardian and may direct that the costs to be incurred by such officer in the performance of his duties as such guardian shall be borne either by the parties or by any one or more of the parties to the suit, or out of any fund in court in which the minor is interested, and may give directions for the repayment or allowance of such costs as justice and the circumstances of the case may require.

5. (1) Every application to the court on behalf of a minor, other than an application under rule 10, sub-rule (2), shall be made by his next friend or by his guardian for the suit.

(2) Every order made in a suit or on any application before the court in or by which a minor is in any way concerned or affected, without such minor being represented by a next friend or guardian for the suit, as the case may be, may be discharged and, where the advocate of the party at whose instance such order was obtained knew, or might reasonably have known, the fact of such minority, with costs to be paid by such advocate.

6.-(1) A next friend or guardian for the suit shall not, without the next friend or leave of the court, receive any money or other movable property on behalf guardian for

(2) Where the next friend or guardian for the suit has not been appointed or declared by competent authority to be guardian of the property of the minor or, having been so appointed or declared, is under any disability known to the court to receive the money or other movable property, the court shall, if it grants him leave to receive the property, require such security and give such directions as will, in its opinion, sufficiently protect the property from waste and ensure its proper application.

7.-(1) No next friend or guardian for the suit shall, without the leave of the court expressly recorded in the proceedings, enter into any agreement or compromise on behalf of a minor with reference to the suit in which he acts as next friend or guardian.

(2) Any such agreement or compromise entered into without the leave of the court so recorded shall be voidable against all parties other than the minor.

8.-(1) Unless otherwise ordered by the court, a next friend shall not retire without first procuring a fit person to be put in his place and giving security for the costs already incurred.

(2) The application for the appointment of a new next friend shall be supported by an affidavit showing the fitness of the person proposed, and also that he has no interest adverse to that of the minor.

9.-(1) Where the interest of the next friend of a minor is adverse to that of the minor or where he is so connected with a defendant whose interest is adverse to that of the minor as to make it unlikely that the minor's interest will be properly protected by him, or where he does not do his duty, or during the pendency of the suit, ceases to reside within Tanzania or for any other sufficient cause, application may be made on behalf of the minor or by a defendant for his removal; and the court, if satisfied of the sufficiency of the cause assigned, may order the next friend to be removed accordingly and make such other order as to costs as it thinks fit.

(2) Where the next friend is not a guardian appointed or declared by an authority competent in this behalf and an application is made by a guardian so appointed or declared, who desires to be himself appointed in the place of the next friend, the court shall remove the next friend unless it considers, for reasons to be recorded by it, that the guardian ought not to be appointed the next friend of the minor, and shall thereupon appoint the applicant to be next friend in his place upon such terms as to the costs already incurred in the suit as it thinks fit.

10.-(1) On the retirement, removal or death of the next friend of a minor, further proceedings shall be stayed until the appointment of a next friend in his place.

(2) Where the advocate of such minor omits, within a reasonable time, to take steps to get a new next friend appointed, any person interested in the minor or in the matter in issue may apply to the court for the appointment of one, and the court may appoint such person as it thinks fit.

11.-(1) Where the guardian for the suit desires to retire or does not do his duty, or for any other sufficient cause, the court may permit such guardian to retire or may remove him, and may make such order as to costs as it thinks fit.

(2) Where the guardian for the suit retires, dies or is removed by the court during the pendency of the suit, the court shall appoint a new guardian in his place.

12.-(1) A minor plaintiff or a minor not a party to a suit on whose behalf an application is pending shall, on attaining majority, elect where he will proceed with the or applicant suit or application.

(2) Where he elects to proceed with the suit or application, he shall apply for an order discharging the next friend and for leave to proceed in his own name.

(3) The title of the suit or application shall in such case be corrected so as to read henceforth thus–

"A.B., late a minor, by C.D., his next friend, but now having attained majority".

(4) Where he elects to abandon the suit or application he shall, if a sole plaintiff or sole applicant, apply for an order to dismiss the suit or application on repayment of the costs incurred by the defendant or opposite party or which may have been paid by his next friend.

(5) Any application under this rule may be made *ex parte*, but no order discharging a next friend and permitting a minor plaintiff to proceed in his own name shall be made without notice to the next friend.

Where minor co-plaintiff attaining majority desires to repudiate suit 13.-(1) Where a minor co-plaintiff on attaining majority desires to repudiate the suit, he shall apply to have his name struck out as co-plaintiff; and the court, if it finds that he is not a necessary party, shall dismiss him from the suit on such terms as to costs or otherwise as it thinks fit.

(2) Notice of the application shall be served on the friend, on any co-plaintiff and on the defendant.

(3) The costs of all parties of such application and of all or any proceedings theretofore had in the suit, shall be paid by such persons as the court directs.

Course to be followed by minor plaintiff or applicant on attaining majority

(4) Where the applicant is a necessary party to the suit the court may direct him to be made a defendant.

Unreasonable **14.-**(1) A minor on attaining majority may, if a sole plaintiff, apply that a suit instituted in his name by his next friend be dismissed on the ground that it was unreasonable or improper.

> (2) Notice of the application shall be served on all the parties concerned; and the court, upon being satisfied of such unreasonableness or impropriety, may grant the application and order the next friend to pay the costs of all parties in respect of the application and of anything done in the suit, or make such other order as it thinks fit.

15. The provisions contained in rules 1 to 14, so far as they are applicable, shall extend to persons adjudged to be of unsound mind and to person who though not so adjudged are found by the court on inquiry, by reason or unsoundness of mind or mental infirmity, to be incapable of protecting their interests when suing or being sued.

ORDER XXXII

SUITS RELATING TO MORTGAGES OF IMMOVABLE PROPERTY

Parties to **1.**-(1). Subject to the provisions of this Code, all persons having an interest either in the mortgage, security or in the right of redemption GN No. 256 shall be joined as parties to any suit relating to the mortgage: of 2005

Provided that-

- a mortgagee may sue without being joined as party to a suit (a) and
- (b) a prior mortgagee need not be joined in a suit to redeem as subsequent mortgage.

(2) In a suit for redemption, if the plaintiff succeeds, the court shall pass a decree (referred to in this Code as "preliminary decree")-

- ordering that an account be taken of what will be due to the (a) defendant for principal and interest on the mortgage, and for his costs of the suit (if any) awarded to him on the day next hereinafter referred to; or
- (b) declaring the amount so due at the date of such decree; and directing-(c)
- - that if the plaintiff pays into court the amount so due on a (i) day within six months from the date of declaring in court the amount so due, to be fixed by the court, the defendant shall deliver up to the plaintiff, or to such persons as he appoints, all documents in his possession or power relating to the mortgaged property, and shall, if so required, retransfer the property to the plaintiff free from the mortgage and from all incumbrances created by the defendant or any person claiming under him, or, where

the defendant claims by derived title, by those under whom he claims, and shall, if necessary, put the plaintiff in possession of the property; and

(ii) that, if such payment is not made on or before the day to be fixed by the court, the plaintiff shall, on the passing of a final decree, be debarred from all right to redeem or that the mortgaged property be sold.

3.-(1) Where, on or before the day fixed, the plaintiff pays into court the amount declared due as aforesaid, together with such subsequent costs as are mentioned in rule 5, the court shall pass a decree-

- (a) ordering the defendant to deliver up the documents which under the terms of the preliminary decree he is bound to deliver up; and
- (b) if so required, ordering him to retransfer the mortgaged property as directed in the said decree; and
- (c) if necessary ordering him to put the plaintiff in possession of the property.

(2) Where such payment is not so made, the court shall, on application made in that behalf by the defendant, pass a decree that the plaintiff and all persons claiming through or under him be debarred from all right to redeem the mortgaged property and also, if necessary, ordering the plaintiff to put the defendant in possession of the property.

(3) On the passing of a decree under sub-rule (2) the debt secured by the mortgage shall be deemed to be discharged.

(4) Where such payment is not so made, the court shall, on application made in that behalf by the defendant, pass a decree that the mortgaged property or a sufficient part thereof be sold and that the proceeds for the sale (after defraying thereout the expenses of the sale) be paid into court and applied in payment of what is found due to the defendant, and that the balance (if any) be paid to the plaintiff or other persons entitled to receive the same.

(5) The court may, upon good cause shown and upon such terms (if any) as it thinks fit from time to time postpone the day fixed for payment.

4. Notwithstanding anything hereinbefore contained, if it appears, upon taking the account referred to in rule 2, that, nothing is due to the defendant or that he has been overpaid, the court shall pass a decree directing the defendant, if so required, to retransfer the property and to pay the plaintiff the amount which may be found due to him; and the plaintiff shall, if necessary, be put in possession of the mortgaged property.

5. In finally adjusting the amount to be paid to a mortgagee in case of a redemption, the court shall, unless the conduct of the mortgagee

> 6. Where property is mortgaged for successive debts to successive mortgagees, any mesne mortgagee may institute a suit to redeem the interests of the prior mortgagees and to foreclose the rights of those that are posterior to himself and of the mortgagor.

7. Where any property the sale of which is directed under this Order is subject to a prior mortgage, the court may, with the consent of the prior mortgagee, direct that the property be sold free from the same, giving to such prior mortgagee the same interest in the proceeds of the GN. No. 256 sale as he had in the property sold.

> **8**.-(1) The proceeds shall be brought into court and applied in the following order of priority:

- in the payment of all expenses incidental to the sale or (a) expenses properly incurred in any attempted sale;
- (b) in payment of whatever is due to the prior mortgagee on account of the prior mortgage, and of costs, properly incurred in connection therewith;
- in payment of all interest due on account of the mortgage in (c) consequence whereof the sale was directed, and of the costs of the suit in which the decree directing the sale was made;
- (d) in payment of the principal money due on account of that mortgage; and
- (e) the residue (if any) shall be paid to the person proving himself to be interested in the property sold or, if there are more such persons than one, then to such persons according to their respective interests therein or upon their joint receipt.

(2) Nothing in this rule or in rule 7 shall be deemed to affect the powers conferred by section 63 of the Land Registration Act.

9. In a suit for delivery of possession of mortgaged land to the mortgagee by the mortgagor or by any other person in or alleged to be in possession of the property, the court may, if it is satisfied that the plaintiff has the right to such possession, pass a decree directing the defendant to deliver possession of such property to the plaintiff

11. All the provisions contained in this Order which apply to a mortgage shall, so far as may be, apply to mortgages and liens by deposit of title deeds and to statutory charges.

ORDER XXXIII INTERPLEADER

Plaint in interpleader suits 1. In every suit of interpleader the plaint shall, in addition to other statements necessary for plaints, state-

- (a) that the plaintiff claims no interest in the subject matter in dispute other than for charges or costs;
- (b) the claims made by the defendants severally; and
- (c) that there is no collusion between the plaintiff and any of the defendants.

2. Where the thing claimed is capable of being paid into court, or placed in the custody of the court, the plaintiff may be required to so pay or place it before he can be entitled to any order in the suit.

3. Where any of the defendants in an interpleader suit is actually suing the plaintiff in respect of the subject matter of such suit, the court in which the suit against the plaintiff is pending shall, on being informed by the court in which the interpleader suit has been instituted stay the proceedings as against him; and his costs in the suit so stayed may be provided for in such suit; but if, and in so far as, they are provided for in that suit, they may be added to his costs incurred in the interpleader suit.

- **4.**-(1) At the first hearing the court may-

6. Where the suit is properly instituted the court may provide for the costs of the original plaintiff by giving him a charge on the thing claimed or in some other effectual way.

ORDER XXXIV SPECIAL CASE

Power to state case for court's opinion **1.**-(1) Parties claiming to be interested in the decision of any question of fact or law may enter into an agreement in writing stating such question in the form of a case for the opinion of the court and providing that, upon the finding of the court with respect to such question-

- (a) a sum of money fixed by the parties or to be determined by the court shall be paid by one of the parties to the other of them;
- (b) some property, movable or immovable, specified in the agreement, shall be delivered by one of the parties to the other of them; or
- (c) one or more of the parties shall do, or refrain from doing some other particular act specified in the agreement.

(2) Every case stated under this rule shall be divided into consecutively numbered paragraphs and shall concisely state such facts and specify such documents as may be necessary to enable the court to decide the question raised thereby.

2. Where the agreement is for the delivery of any property, or for the doing, or the refraining from doing, any particular act, the estimated value of the property to be delivered, or to which the act specified has reference, shall be stated in the agreement.

3.-(1) The agreement, if framed in accordance with the rules hereinbefore contained, may be filed in the court which would have jurisdiction to entertain a suit the amount or value of the subject matter of which is the same as the amount or value of the subject matter of the agreement.

(2) The agreement, when so filed, shall be numbered and registered as a suit between one or more of the parties claiming to be interested as plaintiff or plaintiffs, and the other or the others of them as defendant or defendants and notice shall be given to all parties to the

agreement other than the party or parties by whom it was presented.

Parties to be subject to court's jurisdiction 4. Where the agreement has been filed, the parties to it shall be subject to the jurisdiction of the court and shall be bound by the statement contained therein.

Hearing and disposal of case

5.-(1) The case shall be set down for hearing as a suit instituted in the ordinary manner, and the provisions of this Code shall apply to such suit so far as the same are applicable.

(2) Where the court is satisfied, after examination of the parties, or after taking such evidence as it thinks fit-

- (a) that the agreement was duly executed by them;
- (b) that they have a bona fide interest in the question stated therein; and
- (c) that the case is fit to be decided,

it shall proceed to pronounce judgment thereon in the same way as in an ordinary suit; and upon the judgment so pronounced a decree shall follow.

ORDER XXXV

SUMMARY PROCEDURE

1. This Order shall, where the plaintiff desires to proceed in accordance with the Order, apply to-

- (a) suits upon bills of exchange (including cheques) or promissory notes;
- (b) suits for the recovery of income tax; and
- (c) suits arising out of mortgages, whether legal or equitable, for-
 - (i) payment of monies secured by mortgage;
 - (ii) delivery of possession of the mortgaged property to the mortgagee by the mortgagor or by any other person in or alleged to be in possession of the mortgaged property;
 - (iii) redemption; or
 - (iv) retransfer or discharge;
- (d) suits by the Tanzania Electric Supply Company Limited for the recovery of meter rents, charges for the supply of electricity and other charges (including any tax) connected with or incidental to the supply of electricity to any consumer;
- (e) suits for the recovery of rent, interest or other debts due to the Republic, the Government or any local government authority;
- (f) suits for the recovery of possession of any immovable property including any building or other premises where the right of the person seeking to recover such possession is not

restricted by the provisions of the Rent Restriction Act, and suit for the recovery of rent, mesne profits or damages for unlawful occupation in respect of such immovable property, building or premises; and

(g) suits for the recovery of possession of any immovable property from a lessee under a financial lease agreement where under a financial lease agreement where under such agreement the lessee has no right of ownership over the property leased to him.

2.-(1) Suits to which this Order applies shall be instituted by presenting a plaint in the usual form but endorsed "Order XXXV: Summary Procedure" and the summons shall inform the defendant that unless he obtains leave from the court to defend the suit, a decision may be given against him and shall also inform him of the manner in which application may be made for leave to defend.

(2) In any case in which the plaint and summons are in such forms, respectively, the defendant shall not appear or defend the suit unless he obtains leave from the judge or magistrate as hereinafter provided so to appear and defend; and, in default of his obtaining such leave or of his appearance and defence in pursuance thereof, the allegations in the plaint shall be deemed to be admitted, and the plaintiff shall be entitled-

(a) where the suit is a suit, referred to in paragraph (a), (b) or
(d) of rule 1 or a suit for the recovery of money under a mortgage and no other relief in respect of such mortgage is claimed, to a decree for any sum not exceeding the sum mentioned in the summons, together with interest at the rate specified (if any) and such sum for costs as may be prescribed, unless the plaintiff claims more than such fixed sum, in which case the costs shall be ascertained in the ordinary way, and such decree may be executed forthwith;

(b) Where the suit arises out of a mortgage and is for delivery of possession, redemption, discharge or transfer to a decree in a accordance with the provisions of Order XXXII and other provisions of this Code and such decree may, subject to exercise by the court of such powers as it may have, unless it is a preliminary decree, be executed forthwith;

(c) where the suit is for the recovery of possession of any immovable property, building or premises or for payment of rent, mesne profits or damages for unlawful occupation of such immovable property, building or premises, to a decree for possession and for payment of rent, mesne profits or damages as claimed.

- (b) if practicable, inserting copies of those documents in a sealed envelope addressed to 'the occupiers' through the letter box; or
- (c) placing stakes in the land in places where they are clearly visible and attaching to each stake copies of the plaint and any affidavits sworn in support thereof in a sealed envelop addressed to 'the occupiers'.

9. In any proceeding under this Order the court may order the bill or note on which the suit is founded to be forthwith deposited with an officer of the court and may further order that all proceedings shall be stayed until the plaintiff gives security for the costs thereof.

10 The holder of every dishonoured bill of exchange or promissory note shall have the same remedies for the recovery of the expenses incurred in noting the same for non-acceptance or non-payment, or otherwise, by reason of such dishonour, as he has under this Order for the recovery of the amount of such bill or note.

11. Save as provided by this Order, the procedure in suits under this order shall be the same as the procedure in suits instituted in the ordinary manner.

Provided that no person shall be detained in prison under this rule in any case for a longer period than six months, nor for a longer period than six weeks when the amount or value of the subject matter of the suit does not exceed one hundred and fifty shillings-

Provided also that no person shall be detained in prison under this rule after he has complied with such order.

(b) that the defendant threatens, or intends to remove or dispose of his property with a view to defraud his creditors,

the court may by order grant a temporary injunction to restrain such act or make such other order for the purpose of staying and preventing the wasting, damaging, alienation, sale, loss in value, removal or disposition of the property as the court thinks fit, until the disposal of the suit or until further orders:

Provided that an order granting a temporary injunction shall not be made against the Government, but the court may in lieu thereof make an order declaratory of the rights of the parties.

Injunction to restrain repetition or continuance of breach G.Ns. Nos. 376 of 1968; 508 of 1991 **2.**-(1) In any suit for restraining the defendant from committing a breach of contract or other injury of any kind, whether compensation is claimed in the suit or not, the plaintiff may, at any time after the commencement of the suit and either before or after judgment, apply to the court for a temporary injunction to restrain the defendant form committing the breach of contract or injury complained of, or any breach of contract or injury of a like kind arising out of the same contract or relating to the same property or right:

Provided that no application shall be made for a temporary injunction where the defendant is the Attorney-General but, in such case, the plaintiff may apply to the court for an order declaratory of the rights of the parties.

(2) In case of disobedience or of breach of any such terms, the court granting an injunction may order the property of the person guilty of such disobedience or breach to be attached and may also order such person to be detained as a civil prisoner for a term not exceeding six months, unless in the meantime the court directs his release.

(3) No attachment under this rule shall remain in force for more than one year, at the end of which time, if the disobedience or breach continues, the property attached may be sold, and out of the proceeds the court may award such compensation as it thinks fit, and shall pay the balance, if any, to the party entitled thereto.

3. In addition to such terms as the keeping of an account and giving security, the court may by order grant injunction under rule 1 or rule 2 and such order shall be in force for a period specified by the court, but not exceeding six months:

Provided that the court granting the injunction may, from time to time extend such period for a further period which in the aggregate shall not exceed one year, upon being satisfied, on the application of the holder of such court injunction that the applicant has diligently been taking steps to settle the matter complained of and such extension sought is in the interest of justice, necessary or desirable.

4. The court shall in all cases, before granting an injunction, direct notice of application for the same to be given to the opposite party, except where it appears that the giving of such notice would cause undue delay and that the object of granting the injunction, would thereby be defeated.

5. Any order for an injunction may be discharged, or varied, or set aside by the court on application made thereto by any party dissatisfied with such order.

6. An injunction directed to a corporation is binding not only on the corporation itself, but also on all members and officers of the corporation whose personal action it seeks to restrain.

to 7. The court may, on the application of any party to a suit, order order interim the sale, by any person named in such order, and in such manner and on sale G.N. 9.- (1) An application by the plaintiff for an order under rule 6 or rule 7 may be made after notice to the defendant at any time after institution of the suit.

(2) An application by the defendant for a like order may be made after notice to the plaintiff at any time after appearance.

ORDER XXXVIII APPOINTMENT OF RECEIVERS

Appointment of receivers

1.-(1) Where it appears to the court to be just and convenient, the court may, by order, do any of the following-

- (a) appoint a receiver of any property, whether before or after decree;
- (b) remove any person from the possession or custody of the property;
- (c) commit the property to the possession, custody or management of the receiver;
- (d) confer upon the receiver all such powers, as to bringing and defending suits and for the realisation, management, protection, preservation and improvement of the property, the collection of the rent and profits thereof, the application

and disposal of such rents and profits, and the execution of documents as the owner himself has, or such of those powers as the court thinks fit.

(2) Nothing in this rule shall authorise the court to remove from the possession or custody of property any person whom any party to the suit has not a present right so to remove.

Remuneration of receiver 2. The court may by general or special order fix the amount to be paid as remuneration for the services of the receiver.

Duties of receiver

3. Every receiver so appointed shall-

- (a) furnish such security (if any) as the court thinks fit, duly to account for what he shall receive in respect of the property;
- (b) submit his accounts at such periods and in such form as the court directs;
- (c) pay the amount due from him as the court directs; and
- (d) be responsible for any loss occasioned to the property by his willful default or gross negligence.

Enforcement of receiver's duties 4.-Where a receiver-

- (a) fails to submit his accounts at such periods and in such form as the court directs;
- (b) fails to pay the amount due from him as the court directs; or
- (c) occasions loss to the property by his willful default or gross negligence,

the court may direct his property to be attached and may sell such property, and may apply the proceeds to make good any amount found to be due from him or any loss occasioned by him, and shall pay the balance (if any) to the receiver.

ORDER XXXIX APPEALS FROM ORIGINAL DECREES

Form of appeal, contents of memorandum and attachments **1**.-(1) Every appeal shall be preferred in the form of a memorandum signed by the appellant or his advocate and presented to the High Court (hereinafter in this Order referred to as "the Court") or to such officer as it appoints in this behalf and the memorandum shall be accompanied by a copy of the decree appealed from and (unless the Court dispenses therewith) of the judgment on which it is founded.

(2) The memorandum shall set forth, concisely and under distinct heads, the grounds of objection to the decree appealed from without any argument or narrative; and such grounds shall be numbered consecutively. Grounds which may be taken on appeal

2. The appellant shall not, except by leave of the Court, urge or be heard in support of any ground of objection not set forth in the memorandum of appeal; but the Court, in deciding the appeal, shall not be confined to the grounds of objection set forth in the memorandum of appeal or taken by leave of the court under this rule:

Provided that the Court shall not rest its decision on any other ground unless the party who may be affected thereby has had a sufficient opportunity of contesting the case on that ground.

Rejection or amendment of memorandum **3**.(1) Where the memorandum of appeal is not drawn up in the manner hereinbefore prescribed, it may be rejected, or be returned to the appellant for the purpose of being amended within a time to be fixed by the Court or be amended then and there.

(2) Where the Court rejects any memorandum it shall record the reasons for such rejection.

(3) Where a memorandum of appeal is amended, the judge, or such officer as he appoints in this behalf, shall sign or initial the amendment.

4. Where there are more plaintiffs or more defendants than one in a suit, and the decree appealed from proceeds on any ground common to all the plaintiffs or to all the defendants, any one of the plaintiffs or of the defendants may appeal from the whole decree, and thereupon the Court may reverse or vary the decree in favour of all the plaintiffs or defendants, as the case may be.

Stay of Proceedings and of Execution

5.-(1) An appeal shall not operate as a stay of proceedings under a decree or order appealed from except so far as the Court may order, nor shall execution of a decree be stayed by reason only of an appeal having been preferred from the decree but the Court may, for sufficient cause, order the stay of execution of such decree.

(2) Where an application is made for stay of execution of an appealable decree before the expiration of the time allowed for appealing therefrom, the court which passed the decree may, on sufficient cause shown, order the execution to be stayed.

(3) No order for stay of execution shall be made under sub-rule (1) or sub-rule (2) unless the High Court or the court making it is satisfied-

(a) that substantial loss may result to the party applying for stay of execution unless the order is made;

One of several plaintiffs or defendants may obtain reversal of whole decree where it proceeds on ground common to all

Stay by Appellate Court or by court which passed the decree

- (b) that the application has been made without unreasonable delay; and
- that security has been given by the applicant for the due (c) performance of such decree or order as may ultimately be binding upon him.

(4) Notwithstanding anything contained in sub-rule (3), the court may make an *ex parte* order for stay of execution pending the hearing of the application.

6.- (1) Where an order is made for the execution of a decree from which an appeal is pending, the court which passed the decree shall, on sufficient cause being shown by the appellant, require security to be taken for the restitution of any property which may be or has been taken in execution of the decree or for the payment of the value of such property and for the due performance of the decree or order of the court or the Court may, for like cause, direct the court which passed the decree to take such security.

(2) Where an order has been made for the sale of immovable property in execution of a decree, and an appeal is pending from such decree, the sale shall, on the application of the judgment debtor to the court which made the order, be stayed on such terms as to giving security or otherwise as the court thinks fit until the appeal is disposed of.

7. No such security as is mentioned in rules 5 and 6 shall be required from the Government or, where the Government has undertaken the defence of the suit, from any public officer sued in respect of an act alleged to be done by him in his official capacity.

8. The powers conferred by rules 5 and 6 shall be exercisable where an appeal may be or has been preferred not from the decree but from an order made in execution of such decree.

Procedure on Admission of Appeal

Registration 9. Where a memorandum of appeal is admitted, the Court or the proper officer of the Court shall endorse thereon the date of presentation and shall register the appeal in a book, to be known as the Register of Appeal, and kept for the purpose.

> **10.**-(1) The Court may in its direction, either before the respondent is called upon to appear and answer or afterwards on the application of the respondent, demand from the appellant security for the costs of the appeal,

11.-(1) The Court, after sending for the record if it thinks fit so to do, and after fixing a day for hearing the appellant or his advocate and hearing him accordingly if he appears on that day, may dismiss the appeal without sending notice to the court from whose decree the appeal is preferred and without serving notice on the respondent or his advocate.

(2) If on the day fixed or any other day to which the hearing may be adjourned the appellant does not appear when the appeal is called on for hearing the Court may make an order that the appeal be dismissed.

(3) The dismissal of an appeal under this rule shall be notified to the court from whose decree the appeal is preferred.

12.-(1) Unless the Court dismisses the appeal under rule 11, it shall fix a day for hearing the appeal.

(2) Such day shall be fixed with reference to the current business of the Court, the place of residence of the respondent, and the time necessary for the service of the notice of appeal, so as to allow the respondent sufficient time to appear and answer the appeal on such day.

13.- (1) Where the appeal is not dismissed under rule 11, the Court shall send notice of the appeal to the court from whose decree the appeal is preferred.

(2) The court receiving such notice shall send with all practicable despatch all material papers in the suit, or such papers as may be specially called for by the Court.

(3) Either party may apply in writing to the court from whose decree the appeal is preferred, specifying any of the papers in such court of which he requires copies to be made and copies of such papers shall be made at the expense of, and given to, the applicant.

Publication and service of notice of day for hearing of appeal

14.-(1) Notice of the day fixed under rule 12 shall be fixed in the Court, and a like notice shall be sent by the Court to the court from whose decree the appeal is preferred, and shall be served on the respondent or on his advocate acting for him in the Court in the manner provided for the service on a defendant of a summons; and all the provisions applicable to

High Court to give notice to court whose decree appealed from; and other requirements summons and to proceedings with reference to the service thereof shall apply to the service of such notice.

(2) Instead of sending the notice to the court from whose decree the appeal is preferred, the Court may itself cause the notice to be served on the respondent or his advocate; and the provisions of sub-rule (1) shall apply to such service.

Contents of 15.- The notice to the respondent shall declare that if he does not appear in the Court on the day so affixed, the appeal will be heard ex parte.

Procedure on Hearing

16.-(1) On the day fixed, or on any other day to which the hearing may be adjourned, the appellant shall be heard in support of the appeal.

(2) The Court shall then, if it does not dismiss the appeal at once, hear the respondent against the appeal, and in such case the appellant shall be entitled to reply.

17.-(1) Where on the day fixed or on any other day to which the hearing may be adjourned, the appellant does not appear when the appeal is called on for hearing, the Court may make an order that the appeal be dismissed.

(2) Where the appellant appears and the respondent does not appear, the appeal shall be heard *ex parte*.

18. Where on the day fixed, or on any other day to which the hearing may be adjourned, it is found that the notice to the respondent has not been served in consequence of the failure of the appellant to deposit, within the period fixed, the sum required to defray the cost of serving the notice, the Court may make an order that the appeal be dismissed:

Provided that no such order shall be made although the notice has not been served upon the respondent, if on any such day the respondent appears when the appeal is called on for hearing.

19. Where an appeal is dismissed under sub-rule (2), of rule 11 or rule 17 or rule 18, the appellant may apply to the Court for the readmission of the appeal; and, where it is proved that he was prevented by any sufficient cause from appearing when the appeal was called on for hearing or from depositing the sum so required, the Court shall re-admit the appeal on such terms as to costs or otherwise as it thinks fit.

Upon hearing, respondent may object to decree as if he had preferred separate appeal preferred, but who has not been made a party to the appeal, is interested in the result of the appeal, the Court may adjourn the hearing to a future day to be fixed by the Court and direct that such person be made a respondent.

21. 22.- (1) Any respondent, though he may not have appealed from any part of the decree, may not only support the decree on any of the grounds decided against him in the court below, but take any crossobjection to the decree which he could have taken by way of appeal, provided he has filed such objection in the Court within one month from the date of service on him or his advocate of notice of the day fixed for hearing the appeal, or within such further time as the Court may see fit to allow.

(2) The cross-objection shall be in the form of a memorandum and the provisions of rule 1, so far as they relate to the form and contents of the memorandum of appeal, shall apply thereto.

(3) Unless the respondent files with the objection a written acknowledgement from the party who may be affected by such objection or his advocate, of having received a copy thereof, the Court shall cause a copy to be served, as soon as may be after the filing of the objection, on such party or his advocate at the expense of the respondent.

(4) Where, in any case in which any respondent has under this rule filed a memorandum of objection, the original appeal is withdrawn or is dismissed for default, the objection so filed may nevertheless be heard and determined after such notice to the other parties as the Court thinks fit.

Remand of case by High Court 23. Where the court from whose decree an appeal is preferred has disposed of the suit upon a preliminary point and the decree is reversed in appeal, the Court may if it thinks fit, by order remand the case and may further direct what issue or issues shall be tried in the case so remanded, and shall send a copy of its judgment and order to the court form whose decree the appeal is preferred, with directions to re-admit the suit under its original number in the register of civil suits, and proceed to determine the suit; and the evidence (if any) recorded during the original trial shall, subject to all just exceptions, be evidence during the trial after remand.

Where evidence on record sufficient, **24.** Where the evidence upon the record is sufficient to enable the Court to pronounce judgment, the Court may, after re-settling the issues, if necessary, finally determine the suit, notwithstanding that the judgment

Where the court from whose decree the appeal is preferred has omitted to frame or try any issue, or to determine any question of fact, which appears to the Court essential to the right decision of the suit upon the merits, the Court may, if necessary, frame issues and refer the same for trial to the court from whose decree the appeal is preferred, and in such case shall direct such court to take the additional evidence required; and such court shall proceed to try such issues and shall return the evidence to the Court together with its findings thereon and the reasons therefor.

26.-(1) The evidence and findings shall form part of the record in the suit; and either party may, within a time to be fixed by the Court, present a memorandum of objections to any finding.

(2) After the expiration of the period so fixed for presenting such memorandum the Court shall proceed to determine the appeal.

27.-(1) The parties to an appeal shall not be entitled to produce additional evidence, whether oral or documentary, in the Court, but if-

- (a) the court from whose decree the appeal is preferred has refused to admit evidence which ought to have been admitted; or
- (b) the Court requires any document to be produced or any witness to be examined to enable it to pronounce judgment, or for any other substantial cause,

the Court may allow such evidence or document to be produced, or the witness to be examined.

(2) Wherever additional evidence is allowed to be produced by the Court, the Court shall record the reason for its admission.

Mode of taking additional evidence

Judgment, when and where pronounced 28. Wherever additional evidence is allowed to be produced, the Court may either take such evidence or direct the court from whose decree the appeal is preferred, or any other subordinate court, to take such evidence and to send it, when taken, to the court.

29. Where additional evidence is directed or allowed to be taken, the Court shall specify the points to which the evidence is to be confined, and record on its proceedings the points so specified. Judgment in Appeal.

30. The Court, after hearing the parties or their advocates and referring to any part of the proceedings to which reference may be considered necessary, shall pronounce judgment in open Court, either at

once or on some future day of which notice shall be given to the parties or their advocates.

31. The judgment of the Court shall be in writing and shall state–

- (a) the points for determination;
- (b) the decision thereon;
- (c) the reasons for the decisions; and
- (d) where the decree appealed from is reversed or varied, the relief to which the appellant is entitled,

and shall at the time that it is pronounced be signed and dated by the judge or by the judges concurring therein.

What judgment may direct **32.** The judgment may be for confirming, varying or reversing the decree from which the appeal is preferred or, if the parties to the appeal agree as to the form which the decree in appeal shall take or as to the order to be made in appeal, the Court may pass a decree or make an order accordingly.

Power High Court of **33**. The Court shall have power to pass any decree and make any order which ought to have been passed or made and to pass or make such further or other decree or order as the case may require, and this power may be exercised by the Court notwithstanding that the appeal is as to part only of the decree and may be exercised in favour of all or any of the respondents or parties, although such respondents or parties may not have filed any appeal or objection.

Dissent to be recorded 34. Where the appeal is heard by more judges than one, any judge dissenting from the judgment of the Court shall state in writing the decision or order which he thinks should be passed on the appeal, and may state his reasons for the same.

Date and contents of decree 35.-(1) The decree of the Court shall bear the date of the day on which the judgment was pronounced.

(2) The decree shall, contain the number of the appeal, the names and descriptions of the appellant and respondent and a clear specification of the relief granted or other adjudication made.

(3) The decree shall also state the amount of costs incurred in the appeal, and by whom, or out of what property, and in what proportion such costs and the costs in the suit are to be paid.

(4) The decree shall be signed and dated by the judge or judges who passed it:

Provided that where there are more Judges than one and there is a difference of opinion among them, it shall not be necessary for any judge

- (i) an order under rule 34 of Order XXI on an objection to the draft of a document or of an endorsement;
- (j) an order under rule 72 or rule 92 of Order XXI setting aside or refusing to set aside a sale;
- (k) an order under rule 9 of Order XXII refusing to set aside the abatement of dismissal of a suit;
- (1) an order under rule 10 of Order XXII giving or refusing to give leave;
- (m) an order under rule 3 of Order XXIII recording or refusing to record an agreement, compromise or satisfaction;
- (n) an order under rule 2 of Order XXV rejecting an application

for an order to set aside the dismissal of a suit;

- (o) an order under rule 3 or rule 8 of Order XXXII refusing to extend the time for the payment of mortgage-money;
- (p) orders in interpleader-suits under rule 3, rule 4 or rule 6 of Order XXXIII;
- (q) an order under rule 3, rule 4 or rule 7 of Order XXXVI;
- (r) an order under rule 1, rule 2, rule 4 or rule 9 of Order XXXVII;
- (s) an order under rule 1 or rule 4 of Order XXXVIII;
- (t) an order of refusal under rule 19 of Order XXXIX to readmit, or under rule 21 of Order XXXIX to re-hear, an appeal;
- (u) an order under rule 23 of Order XXXIX remanding a case, where an appeal would lie from the decree of the High Court;
- (v) an order under rule 4 of Order XLII granting an application for review.

2. The rules of Order XXXIX shall apply, so far as may be, to appeals from orders.

ORDER XLI REFERENCE

1. Where, before or on the hearing of a suit in which the decree is not subject to appeal or where, in the execution of any such decree, any question of law or usage having the force of law arises, on which the court trying the suit or appeal, or executing the decree, entertains reasonable doubt, the court may, either of its own motion or on the application of any of the parties, draw up a statement of the facts of the case and the point on which doubt is entertained and refer such statement with its own opinion on the point for the decision of the High Court.

The court may either stay the proceedings or proceed in the case notwithstanding such reference, and may pass a decree or make an order contingent upon the decision of the High Court on the point referred; but no decree or order shall be executed in any case in which such reference is made until the receipt of a copy of the judgment of the High Court upon the reference.

and who, from the discovery of new and important matter or evidence which, after the exercise of due diligence, was not within his knowledge or could not be produced by him at the time when the decree was passed or order made, or on account of some mistake or error apparent on the face of the record, or for any other sufficient reason, desires to obtain a review of the decree passed or order made against him, may apply for a review of judgment to the court which passed the decree or made the order.

(2) A party who is not appealing from a decree or order may apply for a review of judgment notwithstanding the pendency of an appeal by some other party except where the ground of such appeal is common to the applicant and the appellant, or when, being respondent, he can present to the appellate court the case on which he applies for the review.

To whom application for review may be made

2. An application for review of a decree or order of a court, other than the High Court, upon some ground other than the discovery of such new and important matter or evidence as is referred to in rule 1 or the existence of a clerical or arithmetical mistake or error apparent on the face of the decree, shall be made only to the magistrate who passed the decree

or made the order sought to be reviewed; but any such application may, if the magistrate who passed the decree or made the order has ordered notice to issue under paragraph (b) of the proviso to sub-rule (2) of rule 4.

3. The provisions as to the form of preferring appeal shall apply, *mutatis mutandis*, to applications for review.

4.- (1) Where it appears to the court that there is not sufficient ground for a review, it shall reject the application.

(2) Where the court is of opinion that the application for review should be granted it shall grant the same: Provided that-

> (a) no such application shall be granted without previous notice to the opposite party, to enable him to appear and be heard in support of the decree or order, a review of which is applied for; and

> (b) no such application shall be granted on the ground of discovery of new matter or evidence which the applicant alleges was not within his knowledge, or could not be adduced by him when the decree or order was passed or made, without strict proof of such allegation.

5.- (1) Where the judge or judges, or any one of the judges, who passed the decree or made the order, a review of which is applied for, continues or continue attached to the court at the time when the application for a review is presented, and is not or are not precluded by absence or other cause for a period of six months next after the application from considering the decree or order to which the application refers, such judge or judges or any of them shall hear the application, and no other judge or judges of the court shall hear the same.

(2) For the purposes of this rule and rule 6, "judge" includes a magistrate.

6.-(1) Where the application for a review is heard by more than one judge and the Court is equally divided, the application shall be rejected.

(2) Where there is a majority, the decision shall be according to the opinion of the majority.

7.- (1) An order of the Court rejecting the application shall not be appealable; but an order granting an application may be objected to on the ground that the application was-

(2) Where the application has been rejected in consequence of the failure of the applicant to appear, he may apply for an order to have the rejected application restored to the file and where it is proved to the satisfaction of the court that he was prevented by any sufficient cause from appearing when such application was called on for hearing, the court shall order it to be restored to the file upon such terms as to costs or otherwise as it thinks fit and shall appoint a day for hearing the same.

(3) No order shall be made under sub-rule (2) unless notice of the application has been served on the opposite party.

- (b) to order that a suit be dismissed under Order IX, rules 2, 3 and 5;
- (c) to make an order or give judgment on admissions under order XII, rule 4;
- (d) to sign decrees under Order XX, rule 7;
- (e) to admit, reject or allow the amendment of an application for execution of a decree under Order XXI, rule 15;
- (f) to issue notice under Order XXI, rule 20;

Powers of Registrars

- (g) to order that a decree be executed under Order XXI, rule 21;
- (h) to issue process for execution of a decree under Order XXI, rule 22;
- (i) to stay execution, restore property, discharge judgmentdebtors and require and take security under Order XXI, rule 24;
- (j) if there is no judge at the place of registry, to issue a notice to show cause and to issue a warrant of arrest under Order XXI, rule 35;
- (k) if there is no judge at the place of registry, to order attendance, examination and production under Order XXI, rule 40; and
- (l) to order that an agreement, compromise or satisfaction be recorded under Order XXIII, rule 3.

(2) Every application to the Court made under this Code shall, unless otherwise provided, be made by a chamber summons supported by affidavit:

Provided that the Court may where it considers fit to do so, entertain an application made orally or, where all the parties to a suit consent to the order applied for being made, by a memorandum in writing signed by all the parties or their advocates, or in such other mode as may be appropriate having regard to all the circumstances under which the application is made.

(2) The court fee chargeable for such service shall be paid within a time to be fixed before the process is issued.

4. All orders, notices and other documents required by this Code to be given to or served on any person shall be served in the manner provided for the service of summons.

5.-(1) The Registrar of the High Court may by telegram, notify any officer of the court of any order made by the High Court and direct him to take such steps as may be necessary to give effect to the order.

(2) A telegram sent under the provisions of sub-rule (1) shall

- (a) the number and title of the proceeding;
- (b) the substance of the order; and
- (c) the action required to be taken.

(3) On receipt of a telegram sent in accordance with the provisions of this rule the officer to whom it is addressed shall act in accordance with the directions given to him.

(2) If, within seven clear days after such notice has been served or such further time as the court may in each case allow, no arbitrator or no umpire is appointed, as the case may be, the court may, on application by the party who gave the notice and after giving the other party an opportunity of being heard, appoint an arbitrator or umpire or make an order superseding the arbitration, and in such case shall proceed with the suit.

6. Every arbitrator or umpire appointed under rule 4 or rule 5 shall have the like powers as if his name had been inserted in the order of reference.

7.-(1) The court shall issue the same processes to the parties and witnesses whom the arbitrator or umpire desires to examine, as the court may issue in suits tried before it.

(2) Persons not attending in accordance with such process, or making any other default, or refusing to give their evidence, or guilty of any contempt to the arbitrator or umpire during the investigation of the matters referred, shall be subject to the like disadvantages, penalties and punishments, by order of the court on the representation of the arbitrator or umpire, as they would incur for the like offences in suits tried before the court.

8. Where the arbitrators or the umpire cannot complete the award within the period specified in the order, the court may, if it thinks fit, either allow further time, and from time to time, either before or after the expiration of the period fixed for the making of the award, enlarge such period or may make an order superseding the arbitration, and in such case shall proceed with the suit.

(c) where an objection to the legality of the award is apparent upon the face of it.

Grounds for setting aside award

^r **15.**-(1) An award remitted under rule 14 becomes void on failure of the arbitrator or umpire to reconsider it; but no award shall be set aside except on one of the following grounds, namely-

- (a) corruption or misconduct of the arbitrator or umpire;
- (b) either party having been guilty of fraudulent concealment of any matter which he ought to have disclosed or of willfully misleading or deceiving the arbitrator or umpire;
- (c) the award having been made after the issue of an order by the court superseding the arbitration and proceeding with the suit or after the expiration of the period allowed by the court or being otherwise invalid.

(2) Where an award becomes void or is set aside under sub-rule (1) the court shall make an order superseding the arbitration and in such case shall proceed with the suit.

Judgment to be according to award 16.-(1) Where the court sees no cause to remit the award or any of the matters referred to arbitration for re-consideration in the manner aforesaid, and no application has been made to set aside the award or the court has refused such application, the court shall, after the time for making such application has expired, proceed to pronounce judgment according to the award.

(2) Upon the judgment so pronounced a decree shall follow and no appeal shall lie from such decree except in so far as the decree is in excess of, or not in accordance with, the award.

ORDER OF REFERENCE ON AGREEMENTS TO REFER TO ARBITRATION

Application to file in court agreement to refer to arbitration **17**.-(1) Where any persons agree in writing that any difference between them shall be referred to arbitration, the parties to the agreement or any of them may apply to any court having jurisdiction in the matter to which the agreement relates, that the agreement be filed in court.

(2) The application shall be in writing and shall be numbered and registered as a suit between one or more of the parties interested or claiming to be interested as plaintiff or plaintiffs, and the others or other of them as defendants or defendant if the application has been presented by all the parties or, if otherwise, between the applicant as plaintiff and the other parties as defendants.

(3) On such application being made, the court shall direct notice thereof to be given to all the parties to the agreement, other than the applicants, requiring such parties to show cause, within the time specified in the notice, why the agreement should not be filed.

(4) Where no sufficient cause is shown, the court shall order the agreement to be filed, and shall make an order of reference to the arbitrator appointed in accordance with the provisions of the agreement or, if there is no such provision and the parties cannot agree, the court may appoint an arbitrator.

Stay of suit where there is an agreement to refer to arbitration to

18. Where any party to any agreement to refer to arbitration, or any person claiming under him, institutes any suit against any other party to the agreement, or any person claiming under him, in respect of any matter agreed to be referred, any party to such suit may, at the earliest possible opportunity and in all cases where issues are settled at or before such settlement, apply to the court to stay the suit; and the court, if satisfied that there is no sufficient reason why the matter should not be referred in accordance with the agreement to refer to arbitration, and that the applicant was, at the time when the suit was instituted and still remains, ready and willing to do all things necessary to the proper conduct of the arbitration, may make an order staying the suit.

Provisions applicable to proceedings under rule 17 **19.** The provisions of rules 17 and 18, so far as they are consistent with any agreement filed under rule 17, shall be applicable to all proceedings under the order of reference made by the court under that rule and to the award and to the decree following thereon.

ARBITRATION WITHOUT THE INTERVENTION OF A COURT

Filling award in matter referred to arbitration without intervention of court **20**.-(1) Where any matter has been referred to arbitration without the intervention of a court, and an award has been made thereon, any person interested in the award that the award be filed in court.

(2) The application shall be in writing and shall be numbered and registered as a suit between the applicant as plaintiff and the other parties as defendants.

(3) The court shall direct notice to be given to the parties to the arbitration, other than the applicant, requiring them to show cause within a time specified, why the award should not be filed.

Filing and enforcement of such award **21**.-(1) Where the court is satisfied that the matter has been referred to arbitration and that an award has been made thereon and where no ground such as is mentioned or referred to in rule 14 or rule 15 is proved, the court shall order the award to be filed and shall proceed to pronounce judgment according to the award.

(2) Upon the judgment so pronounced a decree shall follow, and no appeal shall lie from such decree expect in so far as the decree is in excess of or not in accordance with the award.
