

Randy Hale's web site, www.halegallery.com, is all about his paintings — each individual one of them.

Accompanying each mountain and waterscape, city scene and portrait is a charming description of what the place, person or moment means to him. The watercolors themselves are remarkably fresh and spontaneous, with vivid colors and soft edges that lend a whimsical, magical air.

In person, Randy is as direct and engaging as his artwork. Many know him as current president of the Colorado Watercolor Society, which he calls a "great priority" in his busy life. He exhibits in regional and national shows and is represented by the Cargo Gallery in Manitou Springs and Paradise Found on the Caribbean island of St. Maarten.

His paintings also hang in private and corporate collections worldwide. Most of his work is done on commission. He's well enough known in St Maarten that an agent pre-sells his paintings to stores and businesses there.

It's unusual activity for a man with a full-time job managing services and installations for The Home Depot. Randy deals with some 300 service partners and thousands of installations daily, not to mention follow-up customer service, yet calls his position "my part-time job!" His passion and priority is placed on painting.

Previously, a career in industrial design had consumed Randy, jetting him around the world to manage restaurant fabrications on crushing deadlines. He had no interest in painting until 2003, when he returned to a more settled life in his native Colorado. Like an athlete who had been out of training, Randy worked back into the watercolor fine art he had loved as a student. It was a welcome change from the tight, client-driven renderings professionally. he did "Watercolor has become my passion and keeps me sane." he says.

Working from home on his day job lets Randy structure time to include painting. "My office is in my studio; my ideas for paintings never more than a stretch away," he explains. "Nevertheless, I keep my focus on customer service issues from dawn to dusk, though I admit that it's nice not to have someone looking over my shoulder. The demands of my work run 24/7, but I do manage to fit in time for painting on weekends as well as handling CWS board work, all in and

around the constant buzzing of my blackberry."

Spontaneity is important to Randy's art. He works fast and joyously, turning out a finished watercolor almost every week. His best advice on painting is to "have no fear, because to be tentative is to fail. Remember that there's nothing you can do in watercolor that can't be fixed. If you work on good paper you can drench a painting in water and practically start over."

As for the future, Randy Hale has his sights set about four years over the horizon when he hopes to be painting full-time. He'd like to put more interpretation into his work, pushing composition, color and design elements in more abstract ways. CWS projects also loom large, including development of the society's web site, expanding our members' newsletter, and hosting the next WFWS national exhibition here in Colorado. Randy is grateful to CWS for providing the camaraderie of a group with shared priorities. "I've become friends with and learned from some top artists," he says. "They've helped me break rules and take new roads."

About Jean Grastorf

Jean Grastorf, AWS, NWS, TWSA is a graduate of The Rochester Institute of Technology with further studies at the School of Ceramics at Alfred, NY. She is an elected member of numerous watercolor societies. She has served on the Board of Directors of the American Watercolor Society as well as the Jury of Submissions and Jury of Awards. Her work appears in watercolor books and magazines and she is the author of "Pouring Light, Layering Transparent Watercolor" which was released in November 2005 by North Light.

Among her awards are the Don Dennis Memorial, the Walser Greathouse Medal and the Elsie and David Wu Ject -Key Award from the AWS. Also the Gold Award from the Florida Watercolor Society, the First Award from the Southern Watercolor Society and the National Watercolor Society. She is represented in the permanent collections of Florida International University, the National Watercolor Society, Tropicana Corporation, Raymond James Financial Corporation and the Neville Public Museum of Brown County.

Often retained as a juror and lecturer, Jean has taught for watercolor societies throughout the country including Alaska and Hawaii and overseas in Greece and the Caribbean for the University at Sea. In her workshop, Jean demonstrates the use of poured watercolor washes to create the illusion of light falling on, through and around objects, while at the same time retaining the beauty of the white paper. She creates new and exciting ways to approach the art of watercolor, demonstrating new ways of balancing "chaos" and "control".

34th Annual Western Federation of Watercolor Societies Exhibition MAY 1 – 31, 2009

Robert Burridge was an Industrial Designer. After 25 years in the business, he left the corporate world to paint full time in 1989. Today his paintings are sold in galleries worldwide, including California's Bay Area, Sedona, Raleigh, Maryland, Hawaii and on Cruise Ships. Burridge is a national juror for many art organizations, as well as a college and national workshop instructor. He is the honorary President of the International Society of Acrylic Painters and Signature Member of both the Philadelphia Watercolor Society and ISAP. His honors include the prestigious Franklin Mint award and the Crest Medal for Achievement in the Arts, previously awarded to Picasso, John Singer Sargent and Georgia O'Keefe.

Hollywood is another venue for Bob's work; he created 12 huge paintings for the movie "Dean Quixote." His work hangs in the permanent collections of international embassies, corporate galleries, art colleges, as well as television and the entertainment industry.

Burridge says "art should be an uplifting experience for both the painter and the art buyer. For me, painting is one of the luxurious examples celebrating artistic talent and all that is wonderful about life, and especially its quirkiness."

Burridge's studio is located in California's central coast in the San Luis Obispo wine country.

ENTRY REQUIREMENTS

- 1. The artist must be a member of one of the societies in the Western Federation of Watercolor Societies (WFWS) and may enter through one society only.
- 2. Work must be original and completed within the last two years. All work must be water media on paper or yupo presented in a primarily aqueous manner. Water media includes watercolors, acrylics, inks, gouache, casein, egg tempera, watercolor pencils and watercolor crayons. Collage materials must be painted by the artist with water media. Non water based media may be integrated into a primarily aqueous painting as a minor element (20% or less of the surface). No copies of another artist's work or recognizable use of another's copyrighted intellectual property will be accepted. Paintings must not have been shown in any WFWS, national or international exhibition.
- 3. Size/Weight Limitations:

Maximum frame size 46" x 46" Minimum image size 10" x 14" Maximum weight 40 lbs

- 4. Entries will be submitted digitally, either as an email attachment or on a CD enclosed with your entry. CDs will not be returned. Using photo editing software, set color to RGB and the longest dimension to1200 pixels. Crop the images so that only the painting shows. Format should be jpeg. The Title of your painting will be the name of the file. If the Title is long you may use the first few words. Use your judgment. Be sure to include the extension .jpg. If sending by email, include your name and phone number in the body of the email.
- 5. Accepted works must be ready to hang with simple frames, Plexiglas (no glass), matted neutrally in white, off white or grey. Single colored liners are acceptable. Mat width should be a minimum of 3" all around. Floated work should also have a 3" minimum border to frame. Wire supports only, taut, with taped ends, placed 1/5 of frame height down from the top. Use clean mat board or form core as backing material.

- 6. No price changes will be accepted. **PAINTINGS MUST BE FOR SALE** and available for the duration of the show. A 30% commission will go to SDWS.
- 7. Submission will be rejected if it does not conform to information provided with entry. The juror's decision is final. Permission is assumed by SDWS to reproduce accepted artwork for the catalog and promotional uses. Failure to provide accepted artwork will result in the artist being ineligible to enter WFWS for the following two exhibitions.

FEES – Make checks payable to: The Colorado Watercolor Society.

One entry is \$25, \$5 additional each for up to 2 more entries. Only one painting per artist will be accepted. Entry fees are non-refundable. All entrants will receive a full color catalog. Additional catalogs may be purchased from SDWS for \$15.

IF ACCEPTED - Accepted paintings must be shipped by the artist with pre-paid return. A handling fee of \$50 will be required. Detailed instructions for labeling and shipping will be included with notification of acceptance.
