The Pennsylvania Department of Agriculture is pleased to submit to the General Assembly an annual report for the period January 1, 2009

through December 31, 2009, in accordance with Section 14.4 of Act 149 of 1988 (the Agricultural Area Security Law).

In the 22 years since the authorizing legislation became effective, Pennsylvania's Farmland Preservation Program has permanently preserved over 433,000 acres of farmland. Act 149 provides for permanent preservation of agricultural land through the purchase of conservation easements from qualifying farmers. The Pennsylvania program is first in the nation in the number of acres preserved and is continuing to preserve farmland at a rate greater than any other state.

(b) Public notice .--

- (1) The board or court, as applicable, shall provide notice of the public hearing in a newspaper of general circulation on at least two different dates prior to the hearing. Each notice shall provide information regarding topic, location and time of the public hearing and a contact number for interested persons to call for additional information.
- (2) The board or court, as applicable, shall send a copy of the notice of the public hearing to the governing body of the municipality where the group-based home provider is located.
- (c) Definition.--As used in this section, the term "group-based home provider" means a private residential facility that houses inmates with prerelease status or individuals who are on probation or parole.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, the Interbranch Commission on Juvenile Justice has concluded its extensive investigation and public hearings. Its report is chilling in its depiction of calculated corruption and compelling in its call to action. Judge Cleland and the other commission members have rendered superb service to the cause of quality justice in the Commonwealth. Thankfully, their individual efforts have not ended, because they will be advocates for change believed necessary.

Their diligence needs to be matched by follow-through on the part of all three branches of State government. By starkly detailing the breakdown of the system, by casting the net far and wide for reform recommendations, and by reaching agreement on 20 categories of recommended changes, the commission made it very hard for any part of State government to be indifferent to the situation.

As we all know, our offices are inundated with reports on every subject imaginable. If there is one that qualifies as a "must read," this is the one. In answering questions about how a good system could go so wrong, Judge Cleland used powerful words: "greed," "incompetence," "intimidation," "abdication of...responsibilities." There was a conspiracy of corruption led by two judges, there was a conspiracy of silence within the courthouse, and there was a conspiracy of acceptance within too much of our community. Indisputable is that assembly-line injustice adversely affected over 6,000 children and their families.

There is a lesson here about the moral bankruptcy that can result from overzealous and mindless application of zero-tolerance policies. Policies from which judgment is subtracted turn out less than just. Without functioning checks, there is no balance. Out-of-whack data reported from Luzerne County should have had red flags waving and alarm bells going off. Numbers do not self-indict. Someone in a position of responsibility has to analyze the data and challenge what does not seem right. The collapse of ethics and oversight was so complete that it was left to a Philadelphia-based advocacy group, the Juvenile Law Center, to raise objections and ultimately trigger an investigation.

There are implications in every direction. For instance, steps must be taken to insure that crime victims are not victimized again by the remedies for corruption. Our constitutional responsibility to establish a fair system of justice warrants action. We may not adopt every one of these recommendations, or we may do them in waves, or we may choose to change beyond what the commission has recommended. But we must consider and decide what we will do to compensate for the breakdown in justice, to prevent a repetition, and to restore public confidence. The people of Luzerne County, the juvenile advocacy community, and the broad swath of Pennsylvanians who care deeply about quality justice all have high expectations that action will be forthcoming.

For the Senate, the hearing of the Committee on Judiciary set for tomorrow by Senator Greenleaf is a quick and appropriate start. A recent editorial cartoon drew a parallel between the disastrous oil leak in the Gulf of Mexico and the Luzerne County "kids for cash" scandal. One is an environmental catastrophe, the other a civic catastrophe. There is a horrible stain on a juvenile justice system that was highly regarded nationally. Thus, injustice has also been visited on the highly capable and highly ethical individuals devoting their professional lives to juvenile justice. We talk a great deal about doing things to help kids. This is our

chance to make a difference, to protect kids in the manner juvenile justice is meant to.

Although said in another time for another purpose, the words of Martin Luther King, Jr., have meaning here: quote, "Injustice anywhere is a threat to justice everywhere." The excellent work of the interbranch commission and the substantial reform recommendations it produced give us a way to prevent the incredible injustices in Luzerne County from threatening the juvenile justice system everywhere in the Commonwealth.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I, too, rise on behalf of the Senate Democratic Caucus and join the gentlewoman in her comments that were made with respect to the manner by which the interbranch commission addressed the very, very important issues that have developed in Luzerne and the concern about making certain that those issues do not repeat themselves throughout the rest of this Commonwealth.

I really want to give my thanks to the individual commission members who put a lot of time and effort into understanding and appreciating and recognizing how valuable their assignment was and, as I said, put the time and effort in to make certain that they understood the various issues that were before them as it relates to how we carry out justice with respect to our juvenile individuals who find themselves appearing before our courts.

Mr. President, the manner by which this was achieved, I think, is also important for us to recognize. It was work that was done by men and women who came together from different angles or different aspects of the process and understanding of the juvenile justice system to be able to work together in a very deliberative fashion. They came out with a set of broad-based recommendations for the branches of government to begin to implement. I share Senator Baker's concern and hope and belief that we will ultimately have the opportunity to put into place or implement a number of these recommendations.

But most importantly, though, I think that we should be cognizant of the process by which we arrived at the recommendations, thank the individuals who participated in that process, and look to a similar type of process to help us serve in ways in which we can address a number of issues that may come before this General Assembly in years to come.

So I want to commend everyone for their efforts, Senator Baker, in particular, for the role that she played in really getting this thing to this point in time. But, as was indicated, our work is not done, and I look forward to working with her and Senator Musto and many of my colleagues in the Committee on Judiciary--Senator Greenleaf and Senator Leach--as we move forward in this process. Again, we want to stand up and say we support the work that has been done and to thank those individuals who served, and we look forward to the task ahead.
