INTRODUCTION

All non-Lockheed Martin employees requiring access to Lockheed Martin owned, leased or operated facilities in the United States to conduct work must undergo a Background Investigation (BI).

BI's are run through First Advantage Contractor Advantage solution. The results of the BI will be compared to our Lockheed Martin Access Standards. Compliancy with the Access Standard will determine if the contractor may be sent to a Lockheed Martin facility.

The following document will guide vendor companies through the registration process.

Contractor Advantage



The Contractor Screen program is a proactive security initiative to identify and reduce security risk and enhance the security standards and safety of LM personnel and facilities.

Any Contractor, a non-employee of LM, who requires physical access to a LM owned, leased or operated facilities in the United States to conduct work is required to partake in the program. This includes all "Resident Visitor(s)" and "Nonresident Visitor(s)".

Contractors are responsible for using Contractor Advantage to perform screening on ALL of their employees who are within scope of the Lockheed Martin program.

Using results from an independent third party Background Investigation (BI), Contractor Screening confirms compliance with access standards of physical site access for Contractors BEFORE they arrive at LM facilities.

Compliance with the Access Standards must be determined prior to gaining physical access to any LM facility.

Process Overview



Step 1 – Register to Use Contractor Advantage

Step 2 – Add Persons to Roster *

Step 3 – Order Screens for Employees *

Step 4 – Review Employees' Compliance *

 Contractor as well as Lockheed Martin Personnel at entry points will be able to see the results of the BI. No guesswork or delays due to potential denials at the gate.



- 3. Complete all Registration fields, remember ID and password.
