Convening County, Court & Justice Leaders: A Framework for Cross-System Collaboration

The Convening County, Court & Justice Leaders: A Framework for Cross-System Collaboration is supported by the <u>National Association of Counties</u> (NACo), <u>Rulo Strategies</u>, and <u>Praxis Consulting</u>, with funding from the <u>State Justice Institute</u>.

Introduction

Maintaining safe and secure communities is one of the most important functions of county governments. Counties are involved in almost every aspect of the justice system. As an example, counties operate 91 percent of all jails in the United States and support more than 3,000 local police and sheriff's departments. County jails provide supervision and services to the 11 million people who cycle through jails each year. Counties are also integral to America's community health systems, including behavioral health services that provide substance use and mental health treatment to justice-involved individuals and their families. Effective collaboration between the county, the local court system, justice system partners, and community-based organizations can improve the lives of a community's most vulnerable residents and make it easier for people to access the services they need. The *Convening County, Court & Justice Leaders: A Framework for Cross-System Collaboration* initiative is designed to support court and county leaders as they partner to establish local strategic priorities and align resources to achieve their justice and public safety goals.

This initiative is offered at a key point in time when local governments across the country are planning for how they will use federal funds available under the American Rescue Plan (ARP). These funds provide a unique opportunity to better understand the needs and opportunities in one's community and enhance the justice system's capacity to increase public safety and improve people's lives. Communities with varying justice strategic planning experience and capacity are encouraged to apply. Examples of solutions include innovative and/or proven practices for reducing rates of eviction; increasing services for crime victims and their families; enhancing community violence interventions; implementing mobile crisis services, behavioral health support and diversion programs; creating pretrial release and post-incarceration reentry services; and other approaches.

Opportunity and Objectives

The Convening County, Court & Justice Leaders: A Framework for Cross-System Collaboration initiative will support up to 10 counties with an interest in working together to achieve better outcomes, enhance justice systems, and improve public safety. More specifically, this is an opportunity for counties, courts, and justice system partners to identify and prioritize local needs, consider evidence-based approaches (e.g., policies, practices, programs) to









address these challenges, and develop strategies and align resources for bringing about system improvements. The initiative will provide opportunities to:

- 1. Establish a collaborative and sustainable relationship between county leaders, judges, and justice stakeholders.
- 2. Participate in a structured and facilitated process of identifying gaps and prioritizing strategies and solutions to address key local justice issues.
- 3. Learn from subject-matter experts and peers from other jurisdictions about evidence-based approaches and other innovative strategies.
- 4. Learn about how ARP dollars and other federal funding can be leveraged to increase access to justice, reduce the number of individuals with mental health and substance use disorders involved in the justice system, enhance community trust, and reduce reliance on incarceration.

At the conclusion of the initiative, participating counties will have created and begun to implement a written implementation plan addressing their top justice-related priorities.

Participating counties will receive expert facilitation and technical assistance over the course of the project at no cost to them. We anticipate each county will use the expertise and assistance offered through this initiative in different ways based on their unique needs. There is no direct funding offered to sites selected through this opportunity.

Benefits for Participants

Selected counties will engage in the following starting January 2022 through December 2022:

- Technical Assistance: A liaison will be assigned to each site to assist in identifying and prioritizing local justice activities based on a shared understanding of the community's needs and evidence-based practices. Cross-site support will be provided by the initiative's project leads, including experts from NACo, Rulo Strategies, and Praxis Consulting.
- One Virtual Kick-off and Three Peer Exchanges: The project leads will
 host one virtual kick-off event and three virtual peer learning
 opportunities, one each quarter. These exchanges will last approximately
 2 hours each and will be hosted by NACo. The peer exchanges will provide
 sites the opportunity to network with, and learn from, county officials,
 judges, and other justice system partners participating in the initiative.
- **Showcasing Site Results:** Selected sites will be featured in a nationally disseminated toolkit and other publications to showcase progress, accomplishments, and lessons learned.

Focus of the Initiative

Each selected site will identify and work on their justice-related priorities over the course of

the project period and develop and begin to implement strategies to address existing gaps, needs, or opportunities. Examples of potential priorities can be found in the application. Selected sites will work on the justice-related issues that are of greatest priority to their community. This may include a focus on adult, juvenile, and/or family populations that interface with the criminal, civil, family, juvenile, or probate courts and justice partners.

Desired Applicant Criteria

The initiative's project leads will select up to 10 sites that are diverse in jurisdictional size, geographic spread, population density, and justice-related priorities. The project leads anticipate that the selected sites will have varying degrees of demonstrated justice planning capacity. Priority will be given to jurisdictions committed to making systemic changes rather than those focused solely on implementing specific programs. Interested applicants need to identify and engage a minimum of four cross-system stakeholders within their community that support this project. Each stakeholder needs to demonstrate their dedication to this project (e.g., meet regularly, allocate staff to participate in related activities, etc.) (see *Applicant Selection Criteria* below).

As part of their application, jurisdictions must identify:

- One or more justice-related priorities that will be the focus of your local strategic planning efforts that you would like assistance with from subject matter experts. Applicants who have not identified their priorities and want to use this project to assess needs/gaps and identify their top priority area for improvement are also eligible to apply.
- A minimum of four (4) individuals who are committed to engaging in this
 opportunity. One (1) of these individuals should be an elected county
 official (county commissioner, supervisor, executive, etc.) and one of these
 individuals should be a local judge. Applicants are strongly encouraged to
 engage additional partners, as appropriate.

The specific composition of each applicant's team may vary across sites. It is recommended that the local team include diverse leadership aligned with the priorities your team identified or is considering.

Required Letters of Commitment

As part of the application process, communities must provide a letter of commitment from an elected county official (county commissioner, supervisor, executive, etc.), a judge (preferably a leadership judge), and a minimum of two (2) additional entities appropriate for the focus of your local priorities. Applicant letters of commitment should reference their agreement to the following:

Provide local leadership for the initiative from county government (a

county elected official such as a commissioner, supervisor or executive) and the judiciary (a judge). It is anticipated that these two entities will co-lead the project at the local level. Each site will also identify a local project coordinator.

- Convene regular local planning meetings that will occur at least once every four to six weeks for a minimum of six months to a maximum of 12 months to complete a written implementation plan that addresses local justice-related priorities.
- Participate in ongoing communication with their site liaison throughout the course of the 12-month initiative. The site liaison will assist the local project coordinator in convening local stakeholders, facilitating local meetings, identifying technical assistance needs, coordinating training resources, and developing the final written plan.
- Actively engage in the virtual kick-off and three virtual peer exchanges (approximately 2 hours each). Further details about dates and times will be provided to communities selected to participate.

Applicants are also required to submit a form letter signed by the state court administrator or his or her designee. A copy of this form can be found <u>here</u>.

Applicant Selection Criteria

Up to 10 counties will be selected to participate in this 12-month project based on the following criteria:

- 1. Commitment and capacity to hold regular local convenings that will occur at least once every four to six weeks for a minimum of six months, up to a maximum of 12 months, to develop and begin implementation on a local plan.
- 2. Commitment to consistently engage in the technical assistance and peer learning activities over 12 months, expressed via a letter of commitment from county elected leadership and the judiciary. Preference will be given to sites with demonstrated support from the Chief Judge/Presiding Judge.
- 3. Strength and clarity of the application.
- 4. Demonstrated collaboration of county agencies and their judicial partners and cross-sector composition of proposed local planning team.
- 5. Demonstrated need and potential to benefit from technical assistance.

Required letters of commitment

In addition to the application above, please submit a minimum of four (4) letters of commitment from relevant agencies, including a letter from a county elected official/board member, a letter from at least one judge AND the letter signed by the state court administrator or designee. The letters of commitment must include the following information:

- The individual's name who will be a part of the planning effort on behalf of the court, county, or agency.
- A statement of commitment:
 - a. to participate in regular local convenings that will occur at least once every four to six weeks for a minimum of six months up to a maximum of 12 months.
 - b. to complete a written implementation plan, based on county and court cross-system collaboration, that outlines priorities and activities within 12 months of project initiation.
 - c. that the project team's co-leads will participate in up to four virtual convenings of the 10 sites selected. These meetings will be approximately 2 hours in length.
