PROCEDURAL MOTION

APPROVAL OF LIST OF APPOINTMENT OF MEMBERS TO SELECT AND SECTORAL COMMITTEES

Yes Hon. Hamisi Musa Mwidani, Chairperson Committee on Selection and the Leader of Majority.

The Leader of Majority (Hon. Mwidani): Mr. Speaker Sir i move a Motion, approval of list of appointment of Members to Select and Sectoral Committees. That pursuant to Standing Orders 152, 153, 185, 186, 187, 188 and 191, this House resolves to approve the list of Members nominated by County Assembly Parties and recommended by the Committee on Selection to the County Assembly Select and Sectoral Committees. Mr. Speaker I would like to call Hon. Amriya to second the Motion.

The Deputy Speaker (Hon. Fadhili Mwalimu): Yes Hon. Amriya, use your microphone.

Hon. Amriya Juma: I arise to second Mr. Speaker.

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Members I now propose a question that...

[Interruption]

Hon. Kitula: Point of order Mr. Speaker.

The Deputy Speaker (Hon. Fadhili Mwalimu): Let me propose a question first. I now propose a question that the Motion by Hon. Hamisi Musa Mwidani on appointment of Select and Sectoral Committees be considered in this Honourable House in the same terms as moved.

[Question proposed and agreed to]

Yes Hon. Kitula, what was the point of order?

Hon. Kitula: Mheshimiwa Spika hili ni Bunge ambalo linalindwa na sheria. Mheshimiwa Spika kwanza ningependa kutoa shukrani kwa Taarifa ambayo amefanya Mheshimiwa Kiranja wa Bunge kwamba sisi tumeweza kutolewa katika Kamati mbalimbali pamoja na Waheshimiwa wanne ambao tumekuwa na jukumu letu la kutenda kikatiba kuhakikisha kwamba wananchi wa Mombasa wanapata huduma ilio haki lakini kwa kuwa Chama kimeona jukumu tunalofanya halistahili ndio hatua wamechukua tunasema ya kwamba Mwenyezi Mungu ndio atatuelekeza pale twafaa kuelekea.

Lengine Mheshimiwa Spika sheria yetu ya Kanuni za Bunge; Kiongozi wa Wengi Bungeni ameweza ku *lay Paper* hapa na leo hii hii ameleta *Procedural Motion* ambayo inasema, *approval of list of appointment of Members to Select and Sectoral Committees*. Mheshimiwa Spika Kanuni za Bunge nambari 153 na nitakusomea Mheshimiwa Spika, ‘*There shall be a Select Committee to be designated Selection Committee consisting the Leader of Majority party who shall be the Chairperson, the Leader of Minority Party not less than 11 and not more than 19 Members who shall be nominated by County Assembly Parties and approved by the County Assembly*’.

Mheshimiwa Spika kinachostahili kwanza ilikuwa ni barua kutoka Chama cha ODM, *Paper* ambayo iko hapo katika Meza yetu iwe ni barua kutoka vyama alafu baadae sisi kama wanachama tuweze kupitisha ile hoja ya kuweza kuunda ile Kamati ya Uteuzi alafu baadae Kamati ya Uteuzi waende wakae alafu watuletee katika Bunge wale Wanakamati wameweza kuchagua kuweza kuhudumia katika Kamati mbalimbali, lakini leo hii Kamati ya Uteuzi haijakaa tayari *Procedural Motion*, yaani tunapitisha kitu leo leo...

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Kitula the Motion in place has been forwarded by the Chairperson, Selection Committee so it means the Selection Committee is there and they have sat and that is why the Motion has seen the doors of the County Assembly, whatever you have said in my opinion... all the steps have been followed.

Hon. Kitula: Mheshimiwa Spika itakuwa ni kinyume na sheria, saa hii ndio *Paper* imekuwa *laid* hapa utaniambia kwamba *Selection Committee* wamekaa hapa wakachagua Wanakamati saa hii, saa hii Mheshimiwa Spika?

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Kitula it is not just something of today, the Selection Committee sat, they know when they sat and they proposed this list that is before this Honourable House.

Hon. Kitula: Mheshimiwa Spika sasa nafikiri hujaniskia vizuri, watakaa vipi kabla haijapitishwa kwenye Bunge! Mheshimiwa Spika lazima ipitishwe kwenye Bunge alafu baadae waje kuamua vipi wameweza kuchagua Kamati, *Paper* leo ndio wanapitisha *Select Committee* alafu wao wamekaa kabla kuwapitisha katika Bunge hili ilikuwa inastahili kwamba wamepitishwa katika Bunge alafu wakae wachague Wanakamati.

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Kitula...

[*Interruption*]

Just a minute Hon. Samba you will talk! I think you know we had Committees in place and the Selection Committee was in place and it was the one that brought the names of these Committees that we had and it is the same Selection Committee that has brought forward the names that are to be debated today in this Honourable House. Let Hon. Samba speak first then you will.

Hon. Samba: Thank you Mr. Speaker. The Honourable concerned let me take you through this book; you see when it comes to Committees it lies within the party and the party decisions are always final.

Honourable, my Colleague if you go to the Society of Clerks at Table Kenya (SOCCAT) model County Assembly Committee Manual this is a core Committee manual 2018, (34) it indicates discharge of a Member from a Committee and states that, *'the Assembly nominated a Member to a Select Committee may give notice in writing to the Speaker that the Member is to be discharged from a Select Committee, the discharge of a Member takes an effect upon the receipt of the Speaker of the Notice, any vacancy occasioned by resignation or removal for a Member in a Select Committee should be filled in 14 days of the vacancy'*, that is Committee manual document. Thank you Hon. Speaker.

Hon. Kitula: Ahsante sana Mheshimiwa Spika. Nafikiri Mheshimiwa Samba hajanielewa; nimesema nimekubali kutolewa katika Kamati kulingana na uamuzi wa Kiranja wa Bunge, hiyo iwe wazi nimekubali utaratibu umefuatwa vilivyo lakini langu ni kuhusu zile Kamati zimewezwa kupangwa hapa. Mheshimiwa Spika umesema Kamati ya Uteuzi imekaa, mimi ni Mwanachama wa Kamati ya Uteuzi, Mheshimiwa Faith yuko hapa ni Mwanachama wa Kamati ya Uteuzi hatujawahi kukaa kama Kamati ya Uteuzi. Barua imetumwa leo hapo ni kwamba sisi tumetolewa katika Chama iko kuanzia leo lakini kitambo ina maana mimi nilikuwa nahudumu katika Kamati ya Uteuzi na sijaitwa...

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Kitula you were sitting in the Selection Committee as a Chief Whip and the moment you were discharged as a Chief Whip in this Honourable House Hon. Junior Wambua replaced you in that Committee. Hon. Members the Motion is on the floor and it is you to debate and Hon. Kitula as I said earlier the Committees were in place and the Motion to approve Membership was brought to this House more than six months and hence a Motion can be brought on the same issue Pursuant to Standing Order 46 (1).

Hon. Kitula: Mheshimiwa Spika nafikiri hili ni Bunge la sheria; itakuwa ni vibaya kwanza Kamati ya Uteuzi sio jukumu lao kuunda *Sectoral Committee* chini ya Kanuni za Bunge 191 tuko na Makatibu hapo wataweza kukusaidia Kamati ya Uteuzi haiwezi kuunda Kamati ya *Sectoral Committee*. Mheshimiwa Spika tuna sheria zinazolinda Bunge hili...

[Interruption]

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Kitula Sectoral Committee, these are the names brought by the Party; the Assembly Parties proposed the names.

Hon. Kitula: Yes.

The Deputy Speaker (Hon. Fadhili Mwalimu): So what is the argument?

Hon. Kitula: The argument is Sectoral Committees *inaundwa na Kamati ya House Business ikiwa imeweza kuwasiliana na Chama cha kisiasa lakini haikufanyika hivyo. Sasa leo barua inaletwa na Kamati ya Uteuzi ambapo leo ndio tunapitisha hao Memba ambapo leo hata Memba wengine hatuna hizo orodha kujua kama mimi haki yangu kuhudumu kwa hizo Sectoral Committees kama Mwanachama lakini vile vile lazima tufuate sheria Mheshimiwa Mwenyekiti, Kanuni ya Bunge 191 hata Katibu anaweza kutusomea iko wazi...*

[*Interruption*]

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Kitula are you arguing on the Party's discharge letter or what are you arguing on?

Hon. Kitula: Mheshimiwa Mwenyekiti nimesema sina tetesi kuhusiana na *discharge* yetu katika Chama, mimi nateta na sheria vile zinafuatwa kuunda hizi Kamati, sheria haijafuatwa vilivyo na hili ni Bunge la sheria tufuate sheria kama Kanuni za Bunge hata hapa Kiongozi wa Wengi Bungeni amenukuu Kanuni za Bunge lakini je akizisoma hizi Kanuni za Bunge amezifuata vile zilivyo na uko na Makatibu ambao wanaweza kukusaidia...

The Deputy Speaker (Hon. Fadhili Mwalimu): Yes Hon. Ibrahim? Hon. Ibrahim is up.

[*Laughter*]

Hon. Omondi: I do not understand Mr. Speaker; this debate is turning to be the Speaker and Hon. Kitula, is it a conversation taking place in this Honourable House or? Mr. Speaker there are rules that are supposed to be guiding us because am seeing it is just a conversation between the Speaker and one Hon. Kitula...

[*Interruption*]

Hon. Kitula: Mheshimiwa Spika!

The Deputy Speaker (Hon. Fadhili Mwalimu): Hon. Kitula you are out of order! Let Hon. Ibrahim... Hon. Kitula let Hon. Ibrahim finish first, let Hon. Ibrahim finish first then Hon...let Hon. Ibrahim proceed. Yes Hon. Ibrahim?

Hon. Omondi: Mr. Speaker Hon. Kitula is becoming too much argumentative in this Honourable House, and I do not feel it is good for this House. Mr. Speaker Hon. Kitula stood on a Point of Order and indeed you have stated clearly and informed him but what I fail to understand it is becoming a conversation between the Speaker and Hon. Kitula! We are missing out, they are issues that we are supposed to deal with Mr. Speaker, so can you rule on that so that we can continue. Thank you.

Under the same issue I think we are not yet or three years have not finished since we commenced the [??] of sitting in this Honourable House since inauguration of this Assembly. I think three years have not yet elapsed and on the same note there is nowhere that is indicated that the same Members are not supposed to serve in that Committee. Even if it has stated the terms or limit of serving in that Committee but it has not stated the same Members cannot continue serving that Committee.

Yes Hon. Hamisi, proceed. Yes Hon. Hatimy?

Hon. Mohamed Hatimy: Ahsante Mheshimiwa Spika. Mheshimiwa Spika nafikiri hii ni Nyumba ya sheria na taarifa ambayo nataka kutoa ni kusema kuwa mtu asije akaanza kupotosha watu, sisi tunaangalia Bunge kuu vile wanavyokwenda na sisi ndio tunavyokwenda hata kwenye sheria ya Ukatuzi ukisoma kuhusu Kanuni za Bunge inatakikana iende sambamba na Bunge kuu katika kufanya marekebisho fulani.

Kwanza kabisa Mheshimiwa Mwenyekiti nashukuru Mungu ambaye amenijaalia kupata nafasi hii, nimehudumu kama Mwenyekiti wa Kamati ya Mazingira na Kamati mbali mbali za Bunge, narudisha shukran zangu za dhati kwa Mwenyezi Mungu ambaye alinijaalia nafasi hiyo kuhudumu katika kipindi cha miaka mitatu. Kwanza kabisa nimejifunza nini kuwa Mwenyekiti wa Mazingira, alama zangu, tajriba niliyoipata katika hicho kiti Mheshimiwa. Nawashukuru Chama kwa sababu waliweza kunipatia nafasi hii Mheshimiwa Mwenyekiti kwa muda wa miaka mitatu, napenda kuwashukuru Wanakamati wenza wangu wa Mazingira ambao tumeshirikiana na wao katika jukumu hili la kuweza kuhakikisha kuwa Kamati yetu ya Mazingira inawajibika. Nawashukuru sana Waheshimiwa mumeweza kunipatia sapoti yenu nikiwa na Naibu Mheshimiwa Feddies pamoja na Wanachama wote wa Mazingira kwa mchango wenu na *sapoti* yenu ambayo mumeweza kunipatia na Mungu atawabariki, nawatakia kila la kheir.

Nafasi ya pili Mheshimiwa Mwenyekiti mimi kama Mwenyekiti wa Mazingira singeweza kufaulisha jukumu hili kama si Makarani ambao nilishirikiana nao katika Kamati yangu ya Mazingira na Kamati mbali mbali. Wengi huwa hawawatambui Makarani wetu wa Bunge lakini wana mchango mkubwa wa kuhakikisha kuwa Waheshimiwa wanaweza kuwajibikia na kuweza kujua mikakati na michango ya Kamati inaenda namna gani.
