

Covid-19 Plan-demic: Forwarding An Elite Agenda

As everyone already knows, the main news story around the world right now is the spread and impact of the Coronavirus (aka Covid-19) which has led to lockdowns in countries all around the world and the introduction of new emergency legislations and de-facto martial law in many places. Whilst we are currently in the middle of this event and therefore lacking the ability to look back on it with hindsight we can only speculate as to what the reality of this situation is. In this post I present my hypothesis. Is this virus natural or man-made? Is this crisis just happening or has it been made to happen with an agenda in mind? Those who know anything about this site will probably not be surprised to hear that I would lean towards the latter and in this post I'm going to lay out exactly why.

Many theories are being presented for possible motives behind the Covid-19 pandemic. One being a deliberate crashing of the global economy in order to restructure it in line with the elite's New World Order plans. A variant on this idea is that the global economy was due a massive crash anyway due to the corrupt nature of the financial system and a pandemic like the one we're seeing now serves as an excuse to blame the situation on a virus rather than the human beings responsible for what would be an inevitable financial meltdown that was always coming. Other theories involve the idea that 5G is involved in all this. 2020 is the year of the big roll out of 5G around the world and many have had concerns about the technology's potential negative impact on human health. While the virus could be real enough, could it also be being used as a patsy to take the blame when the more sensitive among us start to develop negative reactions to the new technology as 2020 progresses? Another theory is that we are looking at a form of "slave training" or "compliance training" by the global elite. Are they seeing how far people can be pushed in terms of giving up some basic freedoms? Could they also be setting a precedent for future events in which

the dictatorial clampdown will go even further and become more permanent? All these things need to be considered in my opinion. The other issue is mandatory vaccination. Once the vaccine for Covid-19 is ready the public will no doubt line up around the block to receive it willingly, but will this crisis result in a scenario whereby certain vaccinations become compulsory for everyone if they ever want to have a normal life with access to public spaces and the ability to travel or work etc? Not only would this be a massive boon for the pharmaceutical cartels but could, potentially, have a more sinister goal behind it, something which I'll come to later.

Whilst this post will be very lengthy and I may have to drift away from coronavirus in order to provide some context, stick with me and hopefully the relevance will become apparent as in situations such as this I believe that context is everything. Simply focusing on coronavirus itself doesn't teach us anything about exactly where we are in history, something which is fundamental to understanding the bigger picture. To grasp the true reality of the Coronavirus outbreak we need to understand the hidden hierarchy in the world which is not the same thing as the political one. So that's where we'll start.

The Hidden Controllers:

Those familiar with the general position of this blog will know that it is my contention that our world is run by a combine of Freemasonic forces and Jewish banking elites who I suspect are connected to a messianic Jewish cult known as Frankists or Sabbatean-Frankists. This cult is obsessed with the Jewish esoteric tradition known as the Cabala (Kabbalah) which I believe to also be important within Freemasonry — especially at the higher levels. The goal of this Masonic-Frankist force is world rule from Jerusalem in line with Jewish and biblical prophecies. This is born out of the notion of Jews being "God's chosen people" and the aim is to gather the Jews in Israel, rebuild Solomon's temple (The Third Temple), and have their Messiah declare a world government in which the non-Jews serve as a slave class in line with Talmudic beliefs and biblical prophesies such as those in the book of Isaiah. As we'll see, the prophesies in question may in fact be Satanic/Luciferian prophesies inserted into Judaism by those who sought to

hide themselves within the religion and use it, along with its unwitting followers, to advance a long-term cabalistic agenda of world control with the Sabbatean and Frankist cults being expressions of this Satanic/Luciferian force.

To understand our current plight it is useful to have at least a basic understanding of the Frankists before moving on. A brief summary of this subject is given in the book <u>1666: Redemption Through Sin</u> by Robert Sepehr, which I will quote below, especially for those who may be familiar with the ideas about <u>The Illuminati</u> but who are still unfamiliar with the Frankists and their connection to the Order. Sephr writes:

Most people have heard of Jesus Christ, considered by Christian followers to be the Messiah who lived over 2000 years ago. But very few people have ever heard of Sabbatai Zevi, who declared himself to be the Messiah in 1666. He amassed a following of over one million believers, half the world's Jewish population during the 17th century, by proclaiming that redemption was available through acts of sin.

Considered a heretic by many of his contemporary Rabbis, nonetheless, his fame extended far and wide. Sabbatai's adherents planned to abolish many of the ritualistic observances, because, according to the Talmud, in the Messianic time there would no longer be holy obligations. Fasting days became days of feasting and rejoicing. Sexual promiscuity, adultery, incest and religious orgies were encouraged and practiced by Sabbateans.

After Sabbati Zevi's death in 1676, his philosophy would be continued, and expanded on, by his Kabbalist successor Jacob Frank. Frankism, a religious movement of the 18th and 19th centuries, centered on the leadership of the Messiah claimant Jacob Frank. He, like Zevi, would perform strange acts that violated traditional religious taboos, such as eating fats that were forbidden by Jewish dietary laws, ritual sacrifice, promoting orgies and sexual immorality.

Jacob Frank would eventually enter into an alliance formed by Adam Weishaupt and Meyer Amshel Rothschild called the Order of the Illuminati. The objectives of this organization was to undermine the world's religions and power structures, in an effort to usher in a utopian era of global

communism covertly ruled by their hidden hand: the New World Order. Using secret societies, such as the Freemasons, their agenda has played itself out over the centuries, staying true to the script. Opposition is handled by a near total control of the world's media, academic opinion leaders, politicians and finance. While still considered a conspiracy theory to many, more people are waking up each day to the reality that this is not just a theory, but a true conspiracy

Robert Sepehr's description of The Illuminati/Frankist agenda as being one of "global communism" will not surprise those who are already familiar with the Masonic role in the French Revolution and the Masonic/Jewish roll in Bolshevism. The Illuminati of which he writes very much continues today (having hidden itself within the upper levels of Freemasonry after being outlawed by the Bavarian authorities) and so does their agenda. Of course, times change and the old Communism model seems to have now been evolved into what many refer to as a Technocracy model, but it's still all

about the enslavement of the masses by the few.

The Sabbatean movement of Sabbatai Zevi would go on to worm its way into the Islamic world in the form of the Donmeh. In his article, <u>Jews & Templars:</u> <u>The Untold Story</u>, hidden history researcher, Michael Tsarion explains:

Sabbatai Zevi was the leader of a Luciferian sect which originally hid itself behind the veil of Judaism. After Zevi himself was arrested and brought before Sultan Mehmed IV, he saved his miserable life by converting to Islam. This fact is mentioned by most writers on Zevi.

What is not mentioned is the fact that his many wealthy Jewish disciples throughout the Levant and Europe followed suit, converting en masse to Islam. These converts are known as the Domneh.

From their new hiding place, acting as bone fide Moslems, they were able to continue their subversive activities. In other words, many sects, families and individuals in the Middle East and Europe who appear Islamic on the surface are in actuality Sabbateans committed to the overthrow of established institutions. This should provide us with great insight given the recent rise of radical Islam.

Zevi's Successor Jacob Frank would go on to advocate for a similar infiltration in regards to Catholicism. In his article, <u>The influence of Sabbatean Frankism On The World</u>, Thomas Muller writes:

The Frankist "believer" had an inverted, deceptive belief system. One must not appear to be as they really are. The last belief justified its followers' pursuit of the double lives they led. One could appear to be a religious Jew on the outside and, in reality, be a Frankist. The Dönmeh officially converted to Islam but remained (hidden) crypto-Jews. Similarly so, the many Frankists who officially converted to Catholicism.

The Illuminati would engage in its own infiltration operation in regards to Freemasonry, becoming a driving force after the 1782 freemasonic <u>Congress Of Willhelmsbad</u>. In his article, <u>Zeroing In On Illuminist Secret Societies</u>, Russ Winter of <u>winterwatch.net</u> describes the convergence of The Illuminati, Freemasonry and Frankism:

The Masonic secret society structure was used to mask and organize Illuminism, especially after the Congress of Wilhelmbad in 1782 merged the Masonic lodges with Illuminism and Rothschild Sabbattean-Frankists to carry out Step 1, the French Revolution.

In <u>another piece</u> he explains:

...the union between the secret societies of Illuminism and Freemasonry was sealed in 1782 at the Congress of Wilhelmbad. The other movement that was brought forth at the Congress was pro-Semitism, or the emancipation of the Jews. This, of course, included opening up the Masonic Lodges to them. The Illuminism headquarters was relocated to Frankfurt at the same time. Curiously, this new movement corresponded with the rise of the Sabbattean-Frankist influenced and wealthy House of Rothschild, as well as the Jewish Oppenheimer, Wertheimer, Schuster, Spreyer and Stern families in Frankfurt.

There are those within Judaism who have attempted to sound the alarm about the Frankists. One such person was Rabbi Marvin Antelman, author of two volumes on the subject. In <u>1666: Redemption Through Sin</u>, Robert Sepehr quotes Antelman on the connection between The Illuminati and Frankist "Messiah," Jacob Frank. Sepehr writes:

In his classic book, To Eliminate the Opiate (Vol. 2), Rabbi Marvin S. Antelman explains where Jacob Frank's got his financing:

Frankfurt at the time was the headquarters of the Jesuit, Adam Weishaupt, founder of the Illuminati, as well as Rothschild Brothers' financial empire. This is worth repeating: Frankfurt was the birthplace of both the Illuminati and the Rothschild empire. When Jacob Frank entered the city, the alliance between the two had already begun. Weishaupt provided the conspiratorial resources of the Jesuit Order, while the Rothschilds contributed the money. What was missing was a means to spread the agenda of the Illuminati and that the Frankists added with their network of agents throughout the Christian and Islamic worlds. Jacob Frank became instantly wealthy because he was given a nice handout by Mayer Amshel Rothschild of Frankfurt. [EPUB p22, quoting Antelman]

On the subject of Illuminati founder, Adam Weishaupt Sepehr writes:

May 1, 1776 was the formal date that Adam Weishaupt officially founded the Orden der Perfektibilisten (The Order of Perfectibilists), also known as the Illuminati of Bavaria. Weishaupt was the son of a Jewish Kabbalist Rabbi in Bavaria, but educated by the Jesuits who converted him to Catholicism after his father died when he was five. He eventually became a priest, but defected and formed an alliance with Lord Meyer Rothschild who financed the Illuminati agenda. [EPUB p23]

On the infiltration of Masonry Sepehr writes:

In 1777, the Illuminati began to co-operate with all the Masonic lodges (especially the Grand Orient) with the purpose of infiltrating them. Even the Duke of Brunswick, Grand Master of Germany, said in 1794 that the Illuminati controlled the Masonic lodges. In time, the Illuminati won control of every Masonic order in the world. When Weishaupt became a member of the Grand Orient, Mayer Amschel Rothschild (1743-1812), the founder of the Rothschild dynasty, provided the financial backing for the lodge, according to the British historian Nesta Webster. According to Rabbi Marvin Antelman, Rothschild convinced Weishaupt to accept the Frankist doctrine, and afterward financed the Illuminati. He aimed to fulfill the Frankist plot of

subverting the world's religions, and the Zionist objective of instituting a global government which would be ruled by a King from Jerusalem.

In Latin, Lucifer literally means 'Light-bearer'. As its name implied, members of the Illuminati possessed the 'Light of Lucifer'. They believed that people who possessed it were truly enlightened and capable of governing. Their avowed purpose and goal was the establishment of a "Novus Ordo Seclorum" - a New World Order, or One World Government, ruled by it's capital in Jerusalem. [EPUB p24]

He goes on to explain:

The Illuminati moved freely within the many secret societies of the time seeking to utilize the liberal ideology of Freemasonry as a bait for those who lacked knowledge of its true purposes

"All Illuminati are Freemasons but far from all Freemasons are Illuminati," stated Professors Cosandey and Renner from Munich in their testimonies in April, 1785, implying that only a minority ever reached the highest mystery degrees. Adam Weishaupt himself wrote: "The [Masonic] Lodge shall be our nursery garden. All those who are not suited to the work shall remain in the Masonic Lodge and advance in that without knowing anything of the further system. [EPUB p28]

The Solar Cult:

Anyone familiar with the subject of conspiracies and secret societies will be aware of the use of solar symbolism within occult orders. Those who study this area will know that clearly there is something very important about the sun and light to these esotericists, as well as some sort of goddess tradition which seems to have been important within various secret societies throughout history. As Sepehr points out, Lucifer means Light-Bearer. Are we looking at a solar cult at work, Luciferians for wont of a better word? Lucifer has also been equated with Venus and seems to have some connection to ancient Solar worship. In his book *Transhumanism: The History Of A Dangerous Idea*, researcher of hidden history, David Livingstone, writes about the ancient tradition of the "dying god." He explains:

Worshipped throughout the ancient Middle East, but under different names depending on the locale, the dying-god was identified with the Sun, who dies at the Winter Solstice and resurrects at the Spring Equinox, or Easter. His goddess-spouse was Venus, the "morning star," though the two could be confused as dual aspects of the same god. The Latin name for Venus was Lucifer. [PDF p19]

The aforementioned statement by the Duke Of Brunswick, Masonic Grand Master of Germany, which Sepehr refered to, was a call by the Duke for the disbandment of Freemasonry due to his belief that the order was in the hands of a solar cult, which he suspected to be The Illuminati. The Duke stated the following in 1794:

"I have been convinced that we, as an order, have come under the power of some very evil occult order, profoundly versed in Science, both occult and otherwise, though not infallible, their methods being black magic, that is to say, electromagnetic power, hypnotism, and powerful suggestion. We are convinced that the order is being controlled by some Sun Order, after the nature of the Illuminati, if not by that order itself."




Figure 3: Solar imagery - Scottish-Rite Freemasonry HQ, Washington DC

Livingstone connects the origins of the cabala to the solar cult of the dying god. He writes:

An early example of the dying-god cult was when in Egypt the Israelites learned of the worship of the Egyptian dying-god named Osiris, who was the origin of the incident of the Golden Calf, and which so angered Moses that he broke the tablets of the Ten Commandments. After they entered Palestine, the Jews continued to worship the dying-god in the form of Baal, as he was known to the Canaanites. According to Deuteronomy 18:9-10:

When you have come into the Land which the Lord, your God, is giving you, you shall not learn to imitate the abominations of the people there. Let there not be found among you anyone who immolates his own son or daughter in the fire, nor a fortune-teller, soothsayer, charmer, diviner orcaster of spells, nor anyone who consults ghosts and spirits or seeks oracles form the dead. Anyone who does such things is an abomination to the Lord. [PDF p19]

He continues:

According to the Bible, God punished the Jews for these offences and sent against them first the Assyrians, and then the Babylonians, who took them into captivity during the first half of the sixth century BC. However, instead of

reforming their ways, mystically-inclined Jews reformulated the teachings of Judaism by creating what is known as the Kabbalah, which represents the cooptation of the dying god cult, along with elements of Babylonian magic, astrology and numerology. [PDF p20]

Note: It is worth pointing out that it is from this same period of the Babylonian captivity that we get the Babylonian <u>Talmud</u> with all its distain and hatred for the goyim (i.e. non-Jews). Could the term goyim actually mean anyone who is not an initiate of the Solar Cult? Do the Luciferian elites understand the hidden meaning?

In his book, <u>Terrorism And The Illuminati</u>, Livingstone states his belief that the world conspiracy:

...is affiliated with a lore of occult knowledge that dates back to at least the sixth century BC. This lore begins with a heresy, known as Kabbalah, which disguises itself as Jewish but is a pact to seek world domination, and the eradication of religion in favour of the worship of Lucifer.

The goal devised by these Kabbalists has since been the installation of their "messiah" as world leader, who, according to their interpretation of the Bible, is to be of the line of King David. Since that time, to preserve this purported lineage, until the advent of their expected leader, these Luciferians have been carefully intermarrying amongst each other, and have included among them many of the leading figures of history. [PDF p22]

The Sixth Century BC is the period in which the "mystically-inclined Jews" - that Livingstone described earlier in relation to the development of the Cabala - were in Babylon. Livingstone goes on to explain:

The Kabbalah was devised in the sixth century BC, as an aberration of Judaism, which combined Babylonian magic and astrology. It was from this point onward that the Bible was compiled, and evidently underwent some corruption in order to incorporate the new teachings. [PDF p23]

If Livingstone's position was to be correct, the prophesies which the elite hope to fulfill could more accurately be thought of not so much as "Jewish" prophesies, but the prophesies of a hidden Cabalistic Solar/Luciferian religion with goals of world domination, a cult which adopts many masks, a

key one of which being Judaism, as well as its most notorious Cabalistic offshoots, Sabbateanism and Frankism.

Livingstone later writes:

In Babylon, these heretical Jews, who refused to purge their religion of pagan influences, instead added to them the adopted practices of Babylonian magic. However, knowing that magic was forbidden in Judaism, they rejected the God of Israel, choosing instead to honor Lucifer, who they identified with the traditional enemy of the Hebrew faith, Baal. In order not to reveal their apostasy, they disguised their hidden faith as an "interpretation" of the religion, a cult now known as the Kabbalah. [PDF p30]

Borrowing from Jewish themes, therefore, these Kabbalists would seek world domination by arguing that they were preparing the world for the coming of the Messiah, and merely aiding God in bringing about His promise to institute them as rulers of the world. Having rejected the Jewish faith, however, they did not await the real Messiah, but would seek to establish their own ruler, who they would falsely claim as messiah, who would aid them in implementing the global acceptance of their occult creed. [PDF p31]

Another theory, along similar lines to Livingstone but not quite the same, is espoused by researcher Michael Tsarion in his two-volume work, *The Irish Origins Of Civilisation*. Tsarion claims that the Jewish religion was, from the very beginning, the creation of a solar cult in Egypt which worshipped the sun god known as Aten or Aton. He posits that the pharaoh Akhenaten, who made the worship of Aton the state religion and forbade the worship of other gods, and who was ultimately overthrown in a rebellion, is actually the prototype for the Biblical Moses. Tsarion believes that the Exodus of Jewish slaves from Egypt is a false history and cover narrative for the expulsion of Akhenaton and his cadre of followers and that it is they who went on to become the various Israelite tribes. Tsarion makes the claim that the elites and high priests of the cult of Aton concocted the Jewish religion to cover-up their own history as tyrants in Egypt and to present a history of being little more than lowly slaves with Akhenaten (Moses) portrayed as a hero leading them to freedom rather than a defeated dictator. He also alleges that the humiliation of their overthrow in Egypt is the driving force behind Atonist's

plans for ultimate control of the entire world. Tsarion believes that Aton was based on the Egyptian god known as Set (the rival to the god Osiris which Livingstone mentions above) who Akhenaten elevated to the level of a Solar deity. It is a group of hard-core Atonitst from within the House of Judah, along with the priestly class known as the Levites, which Tsarion believes is responsible for the Biblical and Talmudic texts and most importantly the prophesies contained within. According to Tsarion, Cabalist Luciferianism is Atonism. He also alleges that this Atonist cult would go on to develop the Christian religion also as a means of conquering Western populations. The blurb on the back of volume two of Tsarions *Irish Origins Of Civilisation* explains the basics:

Those writers and investigators who have accused Adam Weishaupt, Albert Pike, Giuseppe Mazzini, Adriano Lemmi, and other Illuminati grand masters of being "Luciferians" would do well to acknowledge the ancient roots of this ideology so beloved of the cultists they expose. The origin of Luciferianism is Atonism. And the master masons of the world would much prefer it if this fact was never openly revealed. They prefer people to connect their god Lucifer with the horned devils and tempting demons of Christian lore. That kind of distracting error serves to obscure the complexion and nature of their bizarre doctrine. The initiated insider is the one to whom Lucifer's true nature is revealed. He is the one to be exalted by knowledge. After his blindfold is removed before the alter, it is he who will be illuminated and enlightened by the radiance of Lucifer, or more correctly, of Aton.

Yahweh (or Jehova) was, and is, merely a rescripting of Aton – god of the worlds solar cults. He was born and raised at Heliopolis and Armana...

Yahweh (Aton) is venerated by the Freemasons and Knights Templar under the pseudonym Jabulon, that is a composite word made from three gods – Yahweh, Baal, and On. The Freemasonic Order of the Illuminati was founded on May 1st because of this day's significance in Solar Cult ritual. As Pike himself wrote, in his Morals and Dogma, the pagan festival of May Day was a "festival in honor of the sun" It is this Egyptian Atonism that the camouflage of Freemasonry conceals.

Note: The similarity in terms of imagery between the above image and that inside the Freemason Temple in figure 4 is strikingly apparent.

In his article, <u>Jews & Templars: The Untold Story</u>, Tsarion writes of the Egyptian Cult of Set:

The Setians were later known as Atonists, and later still, in the scriptures, as Israelites and Judites, with the mysterious Levites being the supreme echelon ruling the rest. These "tribes" were related to many later cults, societies and dynasties, including the Babylonian Gaonim, who later reappear as the Freemasons and Black Nobility.

Speaking of obfuscation and misdirection, Eventually the Levite nobility had a brainstorm. They decided to give Set a makeover. They transmogrified him into Yahweh or Jehovah. From this point official Jewish history begins.

He continues:

...In masculine form he was the god of fire, destruction, plague and wastelands. This fits perfectly with the imagery of Yahweh presented in Mosaic texts, brooding atop Sinai, a god of deserts, thunder, lightning and wrath, sender of plagues, famine and genocide - a perfect god to terrify and edify the ignorant masses. The Setian imagery is unmistakable despite the camouflage.

After explaining that some of the Atonists expelled from Egypt went onto

become the Levites and then later a group called the Gaonim, Tsarion writes:

It is the Gaonim who, while still ensconced in the Levant, conceived and established what we know today as the religion of Judaism. The religious tenets customized for the common man were and are based on the Ten Commandments and Mosaic Law. However, as the Exilarchs of the Gaonate knew, there was a secret Oral Tradition transmitted from Jehovah (Set-Aton) on Mount Sinai (Great Pyramid) to the seventy elders. This Oral Law has nothing to do with ordinary religious Jews. It is the secret "Levitical" doctrine disclosed by the Setian-Atonist sorcerers to their closest disciples, and has been executed through the centuries by Gaonim, Freemasons, Rosicrucians, Sabbateans, Illuminists, and many other sects and societies established by those same servants.

He goes on to explain that:

The Jews as we know them are the inheritors of archaic occult traditions. The more obvious motifs and tropes of their religion serve as wardrobe concealing ancient traditions preserved and understood by the highest cadre within Judaism and Freemasonry. After a lifelong study one becomes aware of these secret traditions and their meaning, and how all religious motifs were appropriated and cannibalized by later parties.

Tsarion later points out that there is a difference between "exoteric" and "esoteric" Judaism:

So let's be clear: in regards the Jewish race and religion we are dealing with two separate classes, castes and traditions - one exoteric and one esoteric. Indeed, Aton (or more correctly Set-Apophis) was primarily and originally a privately worshiped god. (One god for the elect, one for the unwashed masses.)

Tsarion suggests that the word for the number ten comes from the word Aten and is the symbolic meaning behind 10 Downing Street with its solar window design and lion door-knocker. On his *Irish Origins of Civilisation* website he reproduces a chapter of his book looking at Atonist Symbolism which is well worth taking the time to go through (see here). He writes:

Number Ten (Aten/Aton) Downing St, London. The rose window above the door contains eight panes symbolizing the sun. There are eight solar flames and one Martian arrow representing the sign of Aries and Mars, planet of war. The knocker is styled as an Atonist lion. The same symbols can be seen on the portal of the Council on Foreign Relations in New York City.

Note: Akhenaten was sometimes <u>portrayed</u> as a sphinx (lion) and there is also the concept of the <u>Lion of Judah</u> which relates to the House of Judah. Also keep the name "Rose Window" in mind when we get to the Rosicrucian secret society later.

Whilst we are dealing with events far in the past and we can't know the exact details the prevalence of solar symbolism within Freemasonry and other secret societies connected to the New World Order project, as well as their penchant for Cabbalism, suggests that something took place along the lines of what Livingstone and Tsarion are suggesting, i.e.: that adherents to some sort of Solar Cult schooled themselves in the art of Babylonian mysticism as well as other ancient mystery school teachings, developed what came to be known as Cabalism, and is probably responsible for the prophesies within the Bible and Talmud which modern initiates of the Solar

Cult are today working to bring to fulfilment - utilising many unwitting Jews (via the prophesies) and gentiles (via freemasonry and secret societies) in the process. In other words; the Messianic aspect to Judaism may be the work of Luciferian authors, whether through corrupt insertions into the biblical texts or wholesale fabrications and inventions, and this corruption inevitably works its way into the Jewish Talmud. This would suggest that in the minds of the Solar Cult initiates it is they who are the true "Chosen people" that are destined to rule. All this ultimately leads us to Zionism.

Zionism, Freemasonry & The Temple:

One of the key movements in the agenda to bring about global world rule from Jerusalem is Zionism: the movement to bring about the Jewish state of Israel which was achieved in 1948. But the Zionist project is far from finished and making Jerusalem the Capital of Israel (and eventually the world) and rebuilding Solomon's Temple is very much part of the agenda. Whilst many view Zionism as a purely political movement nothing could be further from the truth. The whole idea is to pro-actively bring about fulfilment of certain prophesies. The Sabbatean-Frankists would adopt a form of Cabala known as <u>Lurianic Kabbalah</u> after its creator, Rabbi Isaac Luria (1534–1572) which inspired them to be proactive when it came to prophesy fulfilment. As the late conspiracy researcher, Jim Marrs explained in his book <u>The Illuminati:</u> The Secret Society That Hijacked The World:

The new interpretations taught in the Lurian Cabala are thought by some scholars to provide the spiritual justification for proactive Zionism that eventually led to the creation of Israel. [p124]

David Livingstone explains in <u>Terrorism And The Illuminati</u>:

Luria initiated a new interpretation of the role of the Kabbalah in preparation for the arrival of the messiah. In Luria's system, all being is said to have been in exile, that is, separated from God, since the very beginning of creation, and the task of restoring everything to its proper order is the specific role of the Jewish people. The final redemption, however, cannot be achieved merely through the advent of the Messiah, but must be brought about historically, through a long chain of actions that prepare the way. Essentially, the important notion that was transmitted to the Kabbalists was

this, that they must not merely await the fulfillment of prophecy with regards to the coming of the Messiah, and the restoration of the Jewish people in the Promised Land. Rather, they ought to work actively to prepare for his appearance. First, this meant manipulating the course of fate through the use of magic, and finally, of preparing the necessary political and moral circumstances to receive his coming, that is, a New World Order. [PDF p130]

Jerusalem and the rebuilding of Solomon's Temple are important within Freemasonry too. Many Mason's believe that their organisation has a connection to the old Knights Templar and view themselves as the modern incarnation of that Order. The Templars are known to have had reverence for the Temple and to have parked themselves on the old Temple site in Jerusalem – hence the name Templars. In his book, <u>The Occult And Subversive Movements</u>, Dr Kerry Bolton explains the following:

The basis of Masonic allegory is the rebuilding of the Temple of Solomon in Jerusalem. The fact that this is also the goal of Messianic Zionists. The Al Aqsa Mosque, the third holiest place for Islam, stands where the Temple once stood, is problematic and today has major consequences for the peace of the world. Nonetheless, the rebuilding of the Temple is an allegoric reflection of the aim of establishing Jerusalem as the capital of a Universal Republic. Whether this aim comes from Templar origins or Freemasonry does not concern us here; the concern is in regard to the practical fulfillment of this legend.

The creation of Israel was a seminal event for Masonry and for the Counter-Tradition. Of the Masonic interests in Israel, an Italian newspaper reported in 1993 that 'a celebration of political Masons was held in Jerusalem'. Tellingly entitled, 'Israel: There is a Pact Between Politicians and Masons', the article stated:

The ceremony was attended by the Mayor of Jerusalem, Teddy Kollek, as well as by the Askenazi Chief Rabbi, Israel Meier Lau. Kollek told the gathered Masons, 'You do a great honour to Jerusalem. This is natural, considering that King Solomon was the great builder of the temple, which is at the roots of the Masonic idea, and that his workmen were the first Masons'.

The purpose of the Knights Templar was to re-construct the Temple of

Solomon. The building of the Temple of Solomon and its re-construction are the core of the ritual and the doctrines of Freemasonry, as Jerusalem's Mayor mentioned. Jerusalem is considered the centre of the world by both Masonry and Messianic Judaism. [p283]

In his latest book, <u>The Trigger: The Lie That Changed The World</u>, which looks at the events of <u>9/11</u> and the wider conspiracy of the Frankists, conspiracy researcher, David Icke, writes:

Ultra-Zionism, a relatively modern phenomenon, wants to replace the Al Aqsa Mosque on what Jews call Temple Mount in Jerusalem with a rebuilt 'Solomon's Temple'. You might look at the Jewish connection and say, well, I can see why they would want that. But, hold on. Rebuilding' Solomon's Temple' on that spot has also been the goal of the Knights Templar secret society since it was established in the 12th century. One of the major symbols of Freemasonry which emerged in its present form centuries ago are the twin pillars said to have been at the entrance to 'Solomon's Temple.' Ultra-Zionism is part of a far bigger and more ancient picture and agenda than it appears to be and the body of Jewish people are to this day its unknowing pawns. [PDF p34]

The symbolism of the "twin pillars" was in our faces clear as day with the 9/11 event in the form of the twin towers. The secret society conspirators often inject their symbolism into events. If we are dealing with a Solar Cult then the use of a "corona" virus to create the current crisis would be rather apt as 'corona' is a solar term and therefore hints at some sort of preplanned script. As does the fact that the published genome sequence for Covid-19 ends with the letter A repeated thirty three times. Thirty three is an important number within Freemasonry with the 33rd degree being the highest official degree within the Scottish-Rite system. The motto of the 33rd degree is "Ordo Ab Chao," meaning order out of chaos. The presence of the number 33 at the end of the genome could be masonic signalling, a wink and a nod to signify that this is a masonic project. Incidentally, the word 'Solomon' may also be a solar reference, beginning as it does with the syllable 'sol.'

Like the Sabbatean-Frankists, Freemasonry also seems to be cabalistic in nature as researcher into secret societies, Jordan Maxwell points out in his book, *Matrix Of Power*:

Freemasonry, once it is totally dissasembled, and you look at all the parts, is nothing more than eclectic Judaism, it is not Judaism at all, but a form of Judaism that is using Judaic symbols and emblems. So, it is not actually Jewish, but is based on the old Cabalistic system. [p26]

Author and Researcher, Juri Lina, in his book on Freemasonry, <u>Architects Of Deception</u>, writes:

The Old Testament is the basis of the masonic rituals. The American masonic cabbalist Albert Pike stated: "All real masonic lodges owe their secrets and symbols to the Cabbala. Only the Cabbala confirms the union between the common and the heavenly world. It is the key to the present, the past, and the coming." As the leader of world freemasonry Pike knew what he was talking about. [PDF p110]

Lina also writes:

Masonic leaders have often brought in rabbis to correctly interpret the

symbols of freemasonry and cabbalist mysticism in order to initiate the higher-ranking brothers in an elitist religious doctrine. [PDF 111]

He goes on to state:

The freemasons whole-heartedly believe that certain magic phenomena help them to manipulate humanity. If freemasons did not blindly believe this, they would never be permitted to rise in the ranks. This is odd, considering that the freemasons claim to be rationalists whose highest ideal is reason. [PDF 113]

Adam Wishaupt, founder of The Illuminati is a good example of someone with this magical mindset. Robert Sepehr explains:

When Adam Weishaupt formed the Order of the Illuminati, he arranged the timing of key events by Kabbalistically arranging numbers in a manner which would add to numbers of greatest occult significance. For example, he chose May 1, because May, the fifth month added to the first day, equals six. Weishaupt chose 1776, because the four numbers of this year add up to 21 (1+7+7+6=21). Further, the sacred number 6+21=27 was another number with occult Kabbalistic "power", because it is formed by multiplying 3x9. Weishaupt carefully chose this date because he believed that even the greatest plan would be doomed to failure if it was not carried out at the most numerically advantageous time.

Note: Whether the reader personally believes in magic, numerology or astrology is irrelevant. The question about the scientific reality of occult power is redundant as the conspiratorial cabal I'm writing about here is of a particular mindset that does believe in such things and views it as the key to their success. They believe they know something the rest of us don't and they intend to keep it that way, hence the promotion of "reason" and "rationalism" to the general population, particularly within academia. They believe they are keeping humanity ignorant of certain forces and therefore giving themselves the edge.

Symbolism:

Pyramid symbolism will be very familiar to those who study the subject of conspiracy and secret societies. The most notorious example is the

unfinished pyramid on the one dollar bill with its detached capstone radiating light and containing the all-seeing eye.

Whilst there are many interpretations of what the pyramid symbol on the dollar bill represents (and there likely are layers of meaning) an obvious one is that the capstone and all-seeing eye represent the illuminated elite and their solar deity whilst the bottom section represents the ignorant mass of humanity, i.e. the profane and uninitiated slaves. It probably also symbolises their unfinished project (The New World Order). The shape of this bottom section is known as a trapezoid. What's interesting about this symbolism in regards to Covid-19 is the building chosen by the UK government to build London's largest make-shift hospital to house coronavirus patients. The building is an exhibition centre known as the Excel Centre but is now being referred to as NHS Nightingale and has been kitted out with 4000 hospital beds. As you can see from the picture below, the entrance to the building is a large glass trapezoid. Is this more Masonic signalling like the thirty three As at the end of the coronavirus genome sequence? Of course, being a trapezoid it is missing the capstone, therefore the symbolic message is that this building is for the plebs... it's where they will go to suffer during this plan-demic.






Figure 9: NHS Nightingale Hospital

Conspiracy researchers have noticed that when the Star Of David (aka Seal of Solomon) is drawn over the dollar bill pyramid the six points of the star highlight the letters M-A-S-O-N.

The Frankists were known as the cult of the all-seeing eye. In his article, <u>The Influence of Sabbatean-Frankism On The World</u>, Thomas Muller of winterwatch.net writes:

Jacob Frank, one of history's nastiest men, encountered the Sabbatian Dönmeh while he was a traveling salesman in Turkey in 1750. He refined the concept of the Messiah, declared himself so, and urged members of the movement to sin as the means to salvation. It was called the "cult of the all-seeing eye."

The all-seeing eye symbol is often used in politics. Below are two images, one from the EU and another from Russia, with stylised eye logos in the background. The Masonic/Frankist force is active behind even supposedly "rival" nations and geopolitical blocs.

More Masonic/Cabalistic symbolism comes in the form of the rainbow symbolism attached to the coronavirus outbreak. Emerging from Italy and spread on social media people around the world (mostly children) have been taking part in the trend of drawing rainbows and sticking them up on the windows of their houses supposedly as a sign of hope. *The Sun* reports:

Why are people putting rainbow pictures in their windows?

In a nutshell, rainbow pictures have been placed in windows to cheer up passers by.

These pictures are meant to offer a message of hope to the public during the coronavirus lockdown.

They have primarily been drawn by children urging people to keep positive, with rainbows showing that the sun follows heavy rainfall.

The article explains:

The rainbow pictures started in Italy, with the slogan "andra tutto benne" ("everything will be alright") spreading quickly across the country.

It has since been adopted in the United States, Canada, Spain, and now the UK with people looking to inspire with their beautiful coloured pictures.




Figure 14: The rainbow meme sweeping the world

I wish it were so benign. The rainbow is actually the arch, which is a common symbol used in freemasonry.




Figure 15: Arch symbolism in Freemasonry

One <u>site</u> looking at occult symbolism explains:

Throughout history arches have plaid an important part in architecture that can be traced back to the Ishtar gate in ancient Babylon, the classical Roman Arch, and the pointed Gothic Arch. One of the most famous modern day architectural arches is the St. Louis Gateway Arch, which was built to symbolize the Royal Arch Degree of Freemasonry.

The Arch is also sometimes represented as a rainbow. For example, the Grand Royal Arch Chapter of the York Rite depicts the arch as rainbow. In Genesis 9:13 God established the rainbow as a sign of His covenant never to destroy the world with a flood again. The New Age Movement has taken the rainbow and adopted it as their own symbol. The rainbow symbolizes the bridge between man and the Great Universal Mind, in the final analysis, Lucifer.

The extremist Messianic Jewish organisation Chabad Lubavich <u>explains</u> on its website:

The Zohar (I:72b) states that the rainbow is one of the signs of the future redemption.

Commentators note that the rainbow indicates the purification and refinement that the world underwent by means of the Flood. Before the Flood the clouds were very coarse, thus preventing a reflection of sunlight. Thereafter, however, the clouds became more refined; they reflected sunlight, thus bringing about a rainbow.

This, then, is the connection between the rainbow and the future redemption: The entire world will attain the peak of refinement with the coming of Moshiach.

The <u>Zohar</u> is a cabbalistic text of particular importance to the Frankists and the <u>Moshiac</u> is the prophesised Jewish Messiah. More on the Moshiac later but for now it's important to note that the Jewish theologian who wrote the above words is quoting cabala and connecting the rainbow to the concept of future redemption and the coming of the Jewish Messiah. This will be of relevance later.

The rainbow is, of course, tied in with the story of Noah and the flood. Noah ties in with the Noahide religion which Chabad Lubavich is currently trialling and experimenting with on poor communities in places like the Phillipines. This "religion" is for non-Jews and is aimed at instilling a belief in Jews as a higher caste and spiritually superior. These non-Jewish Jew worshippers are to be known as Noahides (for more on this see here). This is all in line with the prophesies of Isaiah which speak of a time when Jews will be viewed as "priests of Yahweh" and "ministers of our God" (Isaiah 61:6).

Rainbow symbolism is, of course, widely used within LGBT circles, the promotion of which is part of the elite's agenda to attack the family unit and overturn traditional norms (see here and here). Given the rainbow's connection to the concept of redemption and that the Sabbatean-Frankists hold to a "redemption through sin" ideology in order to bring about the prophesies, the use of the rainbow in this regard has to be considered as deliberate and symbolic.

There is also a Freemasonic organisation called <u>The International Order Of The Rainbow For Girls</u>. The logo for this organisation features an arch, rainbow colours, a pyramid and a masonic handshake.

The Saturn Connection:

The cult that runs our world also seems to have an obsession with Saturn. Some conspiracy researchers, such as David Icke, believe that Saturn is not a planet but a 'brown dwarf star' and that it may at one time have been much closer to the Earth than at present. He argues that Saturn is the real solar deity worshipped by the Cabbalistic elite. Whilst the brown dwarf theory is difficult to prove there certainly are traditions which speak of Saturn as "the primeval Sun" and "the best Sun" and there does seem to be a lack of distinction between the Sun and Saturn in some ancient mythologies (for more see here).

Above we saw the six pointed "Star Of David" imposed over the pyramid. In the occult world there is the Talisman of Saturn which has a five pointed star on one side and a six pointed star on the other.




Figure 17: The Talisman of Saturn

The flag of Israel contains the six pointed star while much communist iconography uses the five pointed star.

Within Cabala/Kabbalah there is the concept of 'Ein Sof' which deals with the nature of 'God.' In his book <u>Putin's Reign Of Terror: The Permanent Revolution In Our Time</u>, researcher into the Jewish connection to the world conspiracy, Christopher Jon Bjerknes, connects this concept to Saturn who, in Greek mythology, was Kronos. Whilst Bjerknes uses the term Jews, keep in mind what we've already learned regarding Judaic beliefs being a creation of a cabalist Solar Cult. Also keep in mind the motto of the 33rd degree of Freemasonry, i.e. Order Out of Chaos. He writes:

The Cabbalah incorporates the Greek mythology of Kronos, whereby "chaos" becomes a supernatural element which affords the Jews the opportunity to remold the material world into the form they seek. The Greeks believed that Kronos devoured his children in order to prevent their rebellion against him. Kronos also controlled the force of chaos and aether, which the Jews employ as the power of the ein soph. Kronos is Saturn, which Ptolemy set in the seventh heaven. For the Jews, Saturn is the seat of their Jewish god. This abstract notion becomes concrete in the communists' quest for permanent revolution and war to destroy any and all "counter-revolution", which is more accurately defined as any resistance to Jewish messianic rule.

The Six pointed Star of David is the symbol for Saturn. It depicts a triangle pointed up and a triangle pointed down, as above, so below. Just as the

Jews' jealous god rules the heavens above, so the Jews seek to rule the earth below. Just as the jealous Jewish god plans to exterminate all other gods in the heavens above, so the Jews plan to exterminate the Gentiles on Earth below. [p15]

He goes on to explain that:

Jews use communism as a force of chaos, of Kronos, of Saturn, to conjure up the divine energy of their creator god, so that they can impart fundamental changes to society and the Earth which favour Jews and no one else.

One thing we do know about Cabalists is that astrology is a part of their mystical thinking. In astrology Saturn appears to represent attributes that aspiring tyrants may seek to embody. One astrology website points out that "Saturn is often associated with our fathers or father/authority figures" and is "associated with restriction and limitation". When the Illuminati engineered their Bolshevik Revolution in Russia using Freemason and Jewish operatives such as Lenin and Trotsky (real name Bronstein), they used the astrological symbol for Saturn as the flag of the Soviet Union, albeit in a stylised manner.

Of the Soviet flag Bjerknes writes:

Kronos was identified with agriculture, as is Jacob, the father of Israel and the Jews in the Hebrew Bible. The communists first employed the symbol of the plow and changed it to the sickle, in conformity with their worship of Kronos, of Saturn, and the use of the sickle to harvest the Gentiles and castrate the power of Gentile society, just as Kronos castrated uranus with a sickle. [p16]

And in *Matrix of Power* Jordan Maxwell explains:

Saturn was always pictured as black, incidentally. The ancients assigned black to Saturn, for whatever reason, and the symbol for Saturn was the sickle, like the Russian sickle, and on the tip of the sickle there was a cross. And if you go to the library today, you will see that the astronomical symbol for the planet Saturn was a sickle, with a cross on top.

Michael Tsarion in <u>Jews & Templars: The Untold Story</u> connects the solar deity Set/Aton to Saturn in an astrological sense:

Set is the basis for the Christian Satan. The word Satan means "opposer," the original meaning of which was astrological. Satan is considered the "Fallen One." Again this simply refers to the southern zone of the heavens and the stars that fall below the horizon into the so-called underworld of Amenta or Hades. Set was the equivalent of Kronos, Saturn, Ahriman and Apophis - lords of the underworld. It is possible that the worship of the planet Saturn is a degraded variant of Set worship. It is interesting that the Jewish Sabbath refers to Saturday or Saturn's Day.

Note: It is interesting that if one puts an 'S' at the beginning of Aten/Aton we get Saten or Saton (Saturn?). And the syllable "Set" is very similar to "Sat," put "urn" at the end and we get Set-urn.

Of the founder of the Sabbatean cult, Sabbatai Zevi, Wikipedia explains:

His name literally meant the planet Saturn, and in Jewish tradition "The reign of Sabbatai" (The highest planet) was often linked to the advent of the Messiah.

The Jewish Sabbath (i.e. holy day) is Saturday (Saturn-day). Researcher David Talbot explains in his piece <u>Saturn: The Ancient Sun God</u>:

Many ancient nations commemorated the era before the fall, the harmonious condition of the "first time," by designating one day of the week as a holy day, the Sabbath. But is it significant that originally the Hebrew Sabbath, the seventh day of the week, was the day of Saturn? So was the seventh and most sacred day of the Babylonian and Phoenician weeks. For the Romans this commemorative day was Saturni dies, "Saturn's day." The same day passed into the Anglo-Saxon calendar as the "day of Seater [Saturn]," which, became our own Saturday.

Note: Christianity's holy day is Sunday which, although a different day, is still a solar reference (Sun-day). Intersting also that Saturn's Day was the holy day in Babylon where, as I mentioned earlier, the Cabala seems to have its origins.

Talbot also writes:

Here is a remarkable fact: though numerous figures of the Universal

Monarch are translated conventionally as the "sun" god, the celestial power invoked by the world's first religions is not the body we call [the] sun today. In fact the star-worshippers specifically distinguished it from our Sun by calling it best sun, the primeval sun, the central sun.

Many have noted the close similarity between the words Saturn and Satan. Kronos, who was a god of time and is where we get the phrase "old father time" was depicted as an old man with a white beard. This is often how God has been portrayed in art and imagery throughout the centuries. Another character portrayed in the same manner is Santa, whose name is an anagram of Satan. Christmas itself seems to be based on a combination of the Festival Of Sol Invictus (The Unconquered Sun) and Saturnalia, a late December Roman gift-giving festival in honour of the god Saturn. This Saturnian aspect to the Solar Religion is likely the true origin of what we call Satanism. As we've seen, the term Lucifer has been associated with Venus (the goddess aspect to the solar cult) and also light and knowledge, but there are those who connect Lucifer directly with Satan. Craig Heimbichner in his book, Blood On The Alter writes:

The name Lucifer is derived from Jerome's Latin Vulgate translation of Isaiah 14:12: "Quomodo cecidisti de caelo, Lucifer, qui mane oriebaris?" (How art though fallen from Heaven thou Lucifer, son of the morning?) Patristic tradition taught that Satan had another name before his fall, which the Church Fathers denominated as "Light Bearer," and which Jerome rendered into Latin literally, as "Lucifer" (luc / lux + fer [bearing). In the original Hebrew he is called the "shining one," to whom Nebuchadnezzar and all other tyrannical kings of the earth who are idolatrously worshipped, are compared. Therefore the masonic identification with Lucifer is an attempt to invoke the supernatural force that energises tyrannical rule. [p59]

Whilst a definitive meaning of the term Lucifer may be the subject of debate by researchers the concepts of Saturn (Satan) and Lucifer both appear to be of high importance within the cabalistic cult. Therefore the Masonic/Frankist force can, in my opinion, be justifiably described as Satanic and Luciferian. And while the distinction between the Sun and Saturn also seems to be unclearly defined, the evidence points to there being something both Solar and Saturnian about this hidden religion that rules our world from behind

the scenes.

The Moshiac:

The term Moshiac is a reference to the prophesised Jewish (Luciferian/Satanic?) Messiah who will one day rule as World King from Jerusalem. It is said that he will be of the line of King David and therefore also King Solomon of Solomon's Temple fame. Chabad Lubavich <u>states</u> of the Moshiac on it's website:

One of the principles of Jewish faith enumerated by Maimonides is that one day there will arise a dynamic Jewish leader, a direct descendant of the Davidic dynasty, who will rebuild the Temple in Jerusalem, and gather Jews from all over the world and bring them back to the Land of Israel.

All the nations of the world will recognize Moshiach to be a world leader, and will accept his dominion. In the messianic era there will be world peace, no more wars nor famine, and, in general, a high standard of living.

A high standard of living for whom I wonder? The chosen people? What will life be like for the Noahides? The mentality of "chosen-ness" and supremacy is very real among Messianic Jews as was expressed by one of Israel's top Rabbis, the late Ovadia Yosef, who once <u>stated</u> during a sermon:

"Goyim were born only to serve us. Without that, they have no place in the world; only to serve the People of Israel."

He also said the following:

"Why are gentiles needed? They will work, they will plow, they will reap. We will sit like an effendi and eat."

"With gentiles, it will be like any person: They need to die, but God will give them longevity. Why? Imagine that one's donkey would die, they'd lose their money. This is his servant. That's why he gets a long life, to work well for this Jew."

Yosef was far from just some fringe Rabbi, his funeral was the <u>largest in Israeli history</u> with some 800,000 mourners lining the streets of Jerusalem. At the time the US Ambassador to Israel, Dan Shapiro, <u>described</u> Yosef as "a

spiritual leader to hundreds of thousands, if not more." This is the supremacist mentality that exists within Judaism and is likely a legacy of the attitudes of the Solar Cult initiates who believe it is they who are who chosen ones. A "high standard of living" is unlikely to extend to the non-chosen slaves under the rule of the Luciferian Moshiac.

This Messiah/Moshiac does not appear to be the same character as the second coming of Jesus Christ that the Christians are waiting for but is more analogous to the Anti-christ figure within the Christian <u>Book Of Revelation</u>. Researcher into hidden history and occult orders, David Livingstone, expressed his view during an <u>interview</u> that the powers-that-be intend to bring about the scenario described in *Revelation*. When asked if the elites actually believe in the prophesies laid out in *Revelation* he responded:

"I actually believe that they are trying to deliberately fulfill the Book Of Revelations, not because they believe it's a Christian book but because they believe it's a Kabbalistic book."

If *Revelation* is, as Livingstone suggests, a Kabbalistic book, the fact that it is part of the Christian cannon (i.e. New Testament) and not the Jewish is suggestive of the possibility that the Solar Cult is the common source for both Religions. We know that a key figure behind the mainstream acceptance and codification of the Christian religion, Constantine the Great, was a member of a solar cult called <u>Sol Invictus</u> (the unconquered Sun). As to whether the Solar Cult initiates within the two religions work as one or operate as rival branches is the subject of debate within conspiracy circles. Is there one hierarchy hiding behind many masks (Vatican, Judaism, Secret Societies etc)? Or does the Solar Cult vie for power among itself with rivalries and alliances having taken place over the centuries?

There is certainly much evidence to support the notion of Christianity as a religion patterned off of sun worship and some researchers believe that Saturn symbolism can also be found. More information on this solar connection to Christianity should be easy enough to find online so I won't go into it here, however, a look at the conspiratorial history of Europe in particular is suggestive of an alliance between secret societies and Jews against the Roman Church. This does give the appearance that we may be

looking at two rival branches of the Solar Cult. Perhaps – and this is just a theory - there is disagreement over which solar deity is to be favoured with the 'Jewish side' favouring Saturn, and the 'Vatican side' - whilst still having reverence for Saturn (God) – also believing the Sun (Jesus) to be of equal importance. This would fit with the standard narrative of the Jews rejecting Jesus as the Messiah whilst the Christians view God and Jesus as different and yet the same. We've already seen that the holy day in Judaism is Saturnday whilst for Christians it's Sun-day. The character of Jesus certainly seems to be an anthropomorphised version of the Sun when one looks into the symbolism and he is known as the Son (Sun) of God. It is also he who arrives on a cloud and defeats the Anti-Christ at the end of *Revelation*. Do we have two cabalistic Solar religions following the same basic agenda but with different ideas about who the Messiah or "Sun King" will be? Or... given that in order for the events of *Revelation* to occur in the first place someone would have to bring about an Anti-Christ figure (Moshiac), does this hint at the possibility that both 'sides' are necessary to drive the narrative forward and, therefore, are perhaps run from the top by the same cabal (with only the lower ranks believing the rivalry to be genuine)? Could the ultimate coup de tat be the crowning of a world ruler in the form of a staged "second coming of Christ" who defeats the Moshiac? There are those within conspiracy research who point to the Vatican as the headquarters of the global conspiracy, could they be right? Have they been allowing their own Catholic edifice to gradually crumble away in recent centuries in preparation for a new era in which the Solar/Saturnian religion becomes the new world religion with a "Solar Christ" at the helm? Or did the Solar Cultists behind Christianity simply know from looking at the Jewish prophesies exactly what their opponents would do over time, and so added *Revelation* to the New Testament to spell out their own intention as to how it would all end? This last scenario would therefore suggest a genuine rivalry.

There are many questions that the lay person such as myself can only ask but not answer. What's important to keep in mind is that the religions of Judaism and Christianity - as the public understands them - are nothing more than masked versions of much older pagan belief systems involving the worship of the Sun and/or Saturn. The higher-ups within these religions will not be idiots and will know the full picture. If I know it they certainly do.

Their mission is to work towards ensuring that their hidden religion one day openly reigns supreme, believing that their Cabalistic practices will help them make it so.

Note: A useful video on the solar connection to Christianity by Jordan Maxwell can be found below. It is worth pointing out that while Maxwell traces the origin of Christanity back to the cult of the Egyptian sun god Amen-Ra, Michael Tsarion's thesis in *The Irish Origins of Civilisation* is that Christianity is actually Atonist. He alleges that the Cult of Aton is expert at appropriating and cannibalizing other traditions for their own use. Tsarion claims that Atonists created Christianity in league with Roman elites as a means to gain power in new lands and as Maxwell points out in the video the creation of Christianity was in many ways a political move and needed to incorporate many traditions in order to be inclusive enough to succeed.

Whilst I'm undecided on what to make of the apparent divisions and rivalries that we see when looking at the history of religion and secret societies one researcher who takes the view that many of these divisions are manufactured is Michael Tsarion who writes in <u>Jews & Templars: The Untold Story:</u>

A close study of secret societies shows that at the top level of the architecture of control there are no "Jews" or "Jesuits." The supreme Setian-Atonist cabal divide their deputized legions into two or more factions, as many as are required for the geopolitical and psychological great game of divide and rule to proceed and succeed.

Jew or Christian, Protestant or Catholic, Capitalist or Communist, Republican or Democrat, Conservative or Labor, Right Wing or Left Wing - it is primarily a case of Opposames working toward a common objective. It is vital that seasoned researchers realize and confirm this fact.

To understand the history of our world is to understand the origin of destructiveness. Chaos and social upheaval occur by design. The origin of sociopolitical havoc can be traced, as we see here, to the reign of Akhenaton and his ancestors. The Setians are destroyers through and through. Destruction is their hallmark and footprint. We need to recognize it historically and prehistorically. Once we correctly identify the true agents and fomenters of world chaos, we cease placing the blame where it does not belong.

Regardless of how united the adepts of the Solar Cult are, the prophesy of an Anti-Christ within the Christian *Book of Revelation* seems to compliment the Jewish narrative of the arrival of a figure who will become world ruler. This has the effect of ensuring that followers of both religions will do very little to stop the events coming to pass believing their own religion's prophesies to be coming true. If we are looking at a united cabal at the very highest level then this may be the real con-job being played on the public. The return of the Christ may be the part of *Revelation* that was never intended to happen, but is simply designed to pacify the Christian world during the critical endgame period and allow the Moshiac to seize total control.

Birth Pangs of The Moshiac:

In my blog post, *Know More News: Birth Pangs Of The Jewish Messiah*, I highlight a segment of a discussion between host, Adam Green of *Know More News* and researcher Christopher Jon Bjerknes. In the discussion Bjerknes brings up a concept within Judaism known as the birth pangs of the Messiah. These "birth pangs" are supposed to be the events and scenarios which precede the arrival of the Moshiac. Bjerknes states during the discussion:

"It means that there will be a period before the rise and the coming of the Messiah in which there will be great turmoil..."

He goes on to explain:

"When a woman gives birth she goes through pain so they believe that in order for the Messiah to be born the whole world has to go through pain and

they predicted that children would turn against their parents, there would be wars worldwide, there would be famine, there would be disease, culture would fall apart, all societies would lose their morality and perversion would become prevalent. All the things that we see happening today are exactly what were predicted to be the birth pangs of the Moshiach. And we know that in many instances the same forces are behind promulgating and imposing those corruptions and those wars on us, so it seems that they're following a plan and that they are deliberately doing this. And they also had prophesies that have come true about the idea that science would become much greater, knowledge would become greater, but the scholars and the prophets would disappear so that all of this technology and science would become a danger instead of a benefit to mankind."

Does this describe where we are now in our history? Note Bjerknes' comment that "they are deliberately doing this." That is your Sabbatean-Frankist proactive Zionism for you, rooted in Luric Kabbalah. Look into the recent wars and conflicts, particularly since 9/11, and you'll find that they were engineered by Zionists to benefit one particular nation – Israel (see here and here). Meanwhile children have turned against their elders via the climate-change psyop, on the cultural front we've descended into chaos and Left/Right "culture wars," we now have disease on the rampage in the form of Covid-19, science and technology is being used to advance techniques of tracking, monitoring and enslavement, and as for perversion and the loss of morality that is self evident in the modern era. Anyone think that someone might be setting the stage for the Moshiac? See the Green/Bjerknes clip below (Bitchute link here):

The Chabad Lubavich website has this to say in a piece titled <u>The Time</u> <u>immidiately Before The Mashiac</u>:

The time appointed by G-d for the Messianic redemption is a closely guarded secret. Nonetheless, we are offered many hints to recognize its proximity: when certain conditions come about, await the imminent coming of Mashiach.

Most of these conditions are quite disturbing, clearly displaying a situation of

the very "bottom of the pit." One major source describes the world-condition in those days as follows: increase in insolence and impudence; oppressing inflation; unbridled irresponsibility on the part of authorities; centers of learning will turn into bawdy houses; wars; many destitutes begging, with none to pity them; wisdom shall be putrid; the pious shall be despised; truth will be abandoned; the young will insult the old; family-breakup with mutual recriminations; impudent leadership.

Other sources add: lack of scholars; succession of troubles and evil decrees; famines; mutual denunciations; epidemics of terrible diseases; poverty and scarcity; cursing and blaspheming; international confrontations nations provoking and fighting each other. In short, it will be a time of suffering that will make it look as if G-d were asleep. These are the birthpangs of Mashiach, bearable only in anticipation of the bliss that follows them.

Note: By "bliss" I'm assuming he means that everything will be alright... or as they say in Italian "andra tutto benne," i.e. the very motto that began the rainbow craze (a symbol which is connected to future redemption and the coming Moshiac according to the Zohar). I wonder if this "bliss" will be for everyone or just the chosenites.

An Israeli Health Minister recently alluded to the arrival of the Messiah when asked if the lock down restrictions in Israel would last until the end of Passover. The Minister, Yakov Litzman, <u>responded</u>:

"God forbid! We are praying and hoping that Messiah will arrive before Passover as it is a time of our redemption. I am sure that the Messiah will come by Passover and save us the same way God saved us during the Exodus and we were freed. The Moshiach will come and save us all."

Whilst I don't believe the "Messiah" is coming as soon as the Minister would like, the Moshiac's arrival is all part of the final stages of the elite's agenda.

So let's take note of where we are before we continue. We have a convergence of Frankists and Illuminized Freemasons who are steeped in esoteric cabbalistic traditions. This force has a Messianic vision and designs on the world which include world rule from Jerusalem and rebuilding Solomon's Temple (Solar/Saturn Temple?). So how might all this tie in with

an idea such as mandatory vaccination? We might find a clue to that with a monument known as the Georgia Guidestones.

The Georgia Guidestones:

In the article, <u>Sinister Sites: The Georgia Guidestones</u>, by the researcher who goes by the name Vigilan Citizen, the author writes:

The Georgia Guidestones is an enigmatic granite monument situated in Elbert County, Georgia. Also known as the American Stonehenge, the gigantic structure is almost 20 feet high and is made of six granite slabs, weighing in total 240,000 pounds. The most astonishing detail of the monument is however not its size but the message engraved on it: Ten rules for an "Age of Reason". These guides touch upon subjects that are associated with the "New World Order", including massive depopulation, a single world government, the introduction of a new type of spirituality, etc. The authors of those rules have requested to remain totally anonymous and, until now, their anonymity has been duly preserved. However, this mysterious group left a text explaining the reasoning behind the rules, a text that was not discussed online before. With this new information, the purpose behind the Guidestones becomes very clear, leaving little room for hypotheses. The Guidestones describe the ideal world, as envisioned by occult Secret Societies. The monument is, therefore, proof of an existing link between secret societies, the world elite and the push for a New World Order.

Made of Pyramid blue granite, the Georgia Guidestones are meant to withstand the test of time and to communicate knowledge on several levels: philosophically, politically, astronomically, etc. It consists of four major stone blocks, which contain ten guides for living in eight languages: English, Spanish, Swahili, Hindi, Hebrew, Arabic, Chinese, and Russian. A shorter message is inscribed at the top of the structure in four ancient languages' scripts: Babylonian, Classical Greek, Sanskrit, and Egyptian hieroglyphs. It is important to note that those last four ancient languages are of great importance in the teachings of occult mystery schools, such as the Freemasons and the Rosicrucians, organizations I will discuss later.

I recommend people read the full article but the ten rules inscribed on the

monument are the following:

- 1. Maintain humanity under 500,000,000 in perpetual balance with nature.
- 2. Guide reproduction wisely improving fitness and diversity.
- 3. Unite humanity with a living new language.
- 4. Rule passion faith tradition and all things with tempered reason.
- 5. Protect people and nations with fair laws and just courts.
- 6. Let all nations rule internally resolving external disputes in a world court.
- 7. Avoid petty laws and useless officials.
- 8. Balance personal rights with social duties.
- 9. Prize truth beauty love seeking harmony with the infinite.
- 10. Be not a cancer on the earth Leave room for nature Leave room for nature.

Vigilant Citizen goes on to point out:

As you can see, the guidelines call for a drastic reduction of the world population, the adoption of new a world language, the creation of a world court and vague allusions to eugenics. In other words, a blueprint for a New World Order.

Let's briefly dive in to rule number 6: the notion of a world court. In 1962 the arch-Zionist and first Prime Minister of Israel, David Ben-Gurion, gave an interview to *Look* magazine in which he stated his belief that Israel would be the seat of the "supreme court of mankind." He was asked how he saw the world 25 years in the future (i.e. in 1987). His <u>response</u> was the following:

"With the exception of the USSR as a federated Eurasian state, all other continents will become united in a world alliance, at whose disposal will be an international police force. All armies will be abolished, and there will be no more wars.... In Jerusalem, the United Nations (a truly United Nations) will build a Shrine of the Prophets to serve the federated union of all continents; this will be the seat of the Supreme Court of Mankind, to settle all controversies among the federated continents, as prophesied by Isaiah."

Whilst Ben-Gurion's timescale may be off what's important to understand is the vision itself (of Jerusalem housing a world court) and even more important his reference to the prophesies of Isaiah. French researcher Laurent Guyenot writes of the Isaiah prophesies in his book on Judaism, *From Yahweh To Zion*. He explains:

The prophetic dream of Israel—nightmare of the nations—is very clearly a supremacist and imperial project. There is indeed, in Isaiah, the hope of world peace, when the peoples of the earth "will hammer their swords into ploughshares and their spears into sickles. Nation will not lift sword against nation, no longer will they learn how to make war" (Isaiah 2:4). But that day will only come when all nations pay homage to Zion. In those glorious days, says Yahweh to his people in Second Isaiah, kings "will fall prostrate before you, faces to the ground, and lick the dust at your feet," whereas Israel's oppressors will "eat their own flesh [and] will be as drunk on their own blood" (49:23–26); "For the nation and kingdom that will not serve you will perish, and the nations will be utterly destroyed" (60:12); "Strangers will come forward to feed your flocks, foreigners be your ploughmen and vinedressers; but you will be called 'priests of Yahweh' and be addressed as 'ministers of our God.' You will feed on the wealth of nations, you will supplant them in their glory" (61:5–6); "You will suck the milk of nations, you will suck the wealth of kings" (60:16). [PDF p47]

So the Zionist vision is, as Guyenot points out, an imperial one in which all nations will bow down to Zion (Israel). The goyim (i.e. non-jews) will view Jews as "Priests of Yahweh" and "ministers of our God." This largely fits with the concept of the Noahide religion that I mentioned earlier which the Jewish messianic organisation Chabad Lubavich is currently cultivating and which seeks to inculcate a belief within gentiles that Jews are spiritually superior.

It is also interesting to note that Jerusalem would get itself a lavish Supreme Court Building in 1992, paid for by the Zionist (and probably Frankist)
Rothschild family. The building is full of esoteric and masonic symbolism. For more on this see Vigilant Citizen's article, <u>Sinister Sites: Israel's Supreme</u>
<u>Court</u>. The building comes complete with a pyramid on the roof.

Whilst the language used in the Guidestones' 10 Commandments is designed to appeal to some sense of universal brotherhood and reason, make no mistake, this is a control agenda. The flowery language is used to ensnare much like all despots throughout history have dressed their manifestos up as being in the best interests of all with the promise of some sort of utopia. We see similar language in the UN's 2030 Sustainable Development Goals project which seeks to use environmental and "social justice" issues to "transform our world." I've covered the environmental/climate change aspect to the control agenda several times on this blog (here, here & here) and I have no doubt we're looking at a masonic project which ties in to the establishment of a technocratic system of control of people and resources. The environmental agenda very much ties into commandment number 10 of the Guidestones "Be not a cancer on the earth – Leave room for nature – Leave room for nature."

Commandment number 8 states "Balance personal rights with social duties." This coronavirus situation is certainly helping to inculcate an attitude within the populace whereby they are willing to put aside their freedoms as a form of social duty. But it's commandment number 1 that is most alarming when it comes to the issue of compulsory vaccination of the general public. The Commandment states "Maintain humanity under 500,000,000 in perpetual balance with nature."

Such a drastic lowering of the population would require some method of culling. Whilst a virus with a high kill rate could be difficult to control, a virus with just enough potency and hype around it to frighten the global population into accepting compulsory mass vaccination could provide the opportunity to give the elites access to people's bloodstreams (and therefore their physical health) via a vaccination program. In this scenario the vaccine is the weapon of depopulation and not the virus, which is merely a psychological/propaganda weapon. In 2013 the UK's Channel 4 aired a drama series entitled *Utopia*, the plot of which involved a powerful cabal who intended to sterilise humanity using a vaccine which was to be given to the public in response to a deadly virus known as "Russian flu." Could this show have been a case of what many refer to as "predictive programming?" We have also had the 2006 movie *Children of Men* which is set in a near future where humanity has mysteriously lost the ability to reproduce. Could a future vaccine for coronavirus be designed to create sterility, or even worse, cause some kind of deadly mystery illness, perhaps with a delayed effect so no one makes the connection with the vaccine? Even if the connection is apparent the response from official dom would only have to be "Whoops! Well it was an emergency. We didn't have time for all the normal testing procedures." This is speculation of course, but if the aim of the elite is depopulation, as the Guidestones suggest, they have to do it somehow and I wouldn't put it past them to use this method at all. Maybe it won't be the coronavirus vaccine but another vaccine to come in the future once the precedent for compulsory vaccination has been set. This coronavirus event could all be a rehearsal and a conditioning of the global citizenry for things to come. Even without having to make a vaccine compulsory they could make it almost impossible to live without it should the unvaccinated be denied certain rights such as access public transport, public buildings, workplaces etc.

It's interesting to note that the country that claims to be furthest along in the production of a Covid-19 vaccine is, lo and behold, Isreal. *Jerusalem Post* reports:

Israeli scientists are on the cusp of developing the first vaccine against the novel coronavirus, according to Science and Technology Minister Ofir Akunis.

If all goes as planned, the vaccine could be ready within a few weeks and available in 90 days, according to a release. "Congratulations to MIGAL [The Galilee Research Institute] on this exciting breakthrough," Akunis said. "I am confident there will be further rapid progress, enabling us to provide a needed response to the grave global COVID-19 threat," Akunis said, referring to the disease caused by the novel coronavirus.

Lead scientist for the project Dr. Chen Katz explained that the research into a vaccine using a poultry coronavirus similar to Covid-19 began prior to the outbreak, something he describes as "pure luck" in giving his Israeli team a head start:

Let's call it pure luck," he said. "We decided to choose coronavirus as a model for our system just as a proof of concept for our technology." But after scientists sequenced the DNA of the novel coronavirus causing the current worldwide outbreak, the MIGAL researchers examined it and found that the poultry coronavirus has high genetic similarity to the human one, and that it uses the same infection mechanism, which increases the likelihood of achieving an effective human vaccine in a very short period of time, Katz said.

Whilst those behind the Guidestones are anonymous, the company which manufactured the monnument did produce a pamphlet (written by persons unknown) to go along with it. Vigilant Citizen quotes the pamphlet at length which opens with the following paragraph:

It is very probable that humanity now possesses the knowledge needed to establish an effective world government. In some way that knowledge must be widely seeded in the consciousness of all mankind. Very soon the hearts of our human family must be touched and warmed so we will welcome a global rule of reason.

I would, again, recommend the article to read the rest of what the pamphlet contains. Vigilant Citizen concludes that those behind the Guidestones and the authors of the pamphlet are "either Freemasons, Rosicrucians or another hermetic Secret Society."

The Rosicrusian Connection:

The Rosicrusian Order was a secret society that preceded the Freemasons. It was a forerunner of masonry and represented the same underground stream of occult and esoteric beliefs in which freemasonry would become embroiled. Regarding the term 'Rosicrucian' *Encyclopedia Brittanica* explains:

Rosicrucian, member of a worldwide brotherhood claiming to possess esoteric wisdom handed down from ancient times. The name derives from the order's symbol, a rose on a cross, which is similar to the family coat of arms of Martin Luther. Rosicrucian teachings are a combination of occultism and other religious beliefs and practices, including Hermeticism, Jewish mysticism, and Christian gnosticism. The central feature of Rosicrucianism is the belief that its members possess secret wisdom that was handed down to them from ancient times.

Note: "Jewish mysticism" is just another way of saying Cabala. So here we go again.

On the dissaperance of the order Encyclopedia Britannica states:

It declined dramatically in the 18th century, however, a victim of the skepticism and rationalism of the Enlightenment, though some Rosicrucian

ideas survived in speculative Freemasonry.

Ironically - or more likely intentionally - Rosicrucianism helped spur the very Enlightenment period to which the order fell victim. But by then the job was done in terms of striking a major blow against the old order (i.e. church dogma and monarchical rule) and opening the door to new ideas and philosophies. With esoteric knowledge no doubt meant to be in very few hands anyway, the decline of Rosicrucianism in terms of membersip was probably not a sign of defeat at all. The cabalistic core likely continued, and just as the Illuminati survived the crackdown on their order by injecting their ideas and agendas into freemasonry, so it no doubt was with the earlier Rosicrucians.

Encyclopedia Britannica points out that a revival of the order would later occur – born out of Freemasonry - which has lasted up until the present, with a presence in the US:

In the 19th century, new Rosicrucian societies appeared as part of a general occult revival that took place in Europe and the United States. The first, the Rosicrucian Fraternity, was established in San Francisco in 1858 by the American spiritualist and abolitionist Pascal Beverly Randolph (1825–75). Several groups, such as the Societas Rosicruciana in Anglia and the Societas Rosicruciana in Civitatibus Foederatis, founded in England in 1866 and 1880, respectively, emerged out of Freemasonry.

Later Rosicrucian orders would follow and there will be much bleed through in terms of membership between Rosicrucianism and Freemasonry. The reason why many suspect a Rosicrucian connection to the Guidestones is due to the fact that the only name we are given in regards to who might be responsible for commissioning the monument is the pseudonym R.C. Christian. Vigilant Citizen explains:

R.C. Christian is a clear reference to Christian Rosenkreuz whose English name is Christian Rose Cross, the legendary founder of the Rosicrucian Order. Some might say that the resemblance between R.C. Christian and Christian Rose Cross is the result of an odd coincidence. As we will see, it is however only one of the MANY references to Rosicrucianism associated with the monument. This is only one piece of the puzzle, but an important piece

nonetheless.

VC goes on to state:

The Rosicrucians are known for publishing three Manifestos, published at the beginning of the 17th century: Fama Fraternitatis Rosae Crucis, Confessio Fraternitatis and Chymical Wedding of Christian Rosenkreutz.

These anonymous works, surrounded by mystery, cryptically introduced the general public to the Rosicrucian philosophy, while announcing a great transformation of the political and intellectual landscape of Europe. The Age of Enlightenment soon followed, accompanied by the fall of feudal Monarchies. The Georgia Guidestones seem to accomplish the same functions as the Rosicrucian manifestos, by calling for an important world transformation and maintaining a climate of mystery.




Figure 27: Rosicrucian manifesto Confessio Fraternitatis

The Guidestones appear to be a Rosicrucian/Masonic monument announcing their intentions to the general public. The fact that a monument can be erected on public land without the public being told who is behind it is also somewhat suspicious. Vigilant Citizen concludes the piece stating:

The Georgia Guidestones are a modern-day Rosicrucian manifesto calling for (or announcing) a drastic change in the way the world is managed. The monument is of great importance in the understanding of the forces covertly

shaping today and tomorrow's world. It materializes into stone the crucial link between secret societies, the world elite and the agenda for a New World Order. The push for a world government, population control, and environmentalism are issues that are today discussed on a daily basis in current events. They were not in 1981 when the Guidestones were erected. Can we say that great progress was made?

Many of the rules of the Guidestones do make sense for the preserving of Earth on a long-term basis. But between the idealistic words of the Guidestone's authors and the actual way these policies would be applied on the masses — by power-hungry and greedy politicians — there is a world of difference. Reading between the lines, the Guidestones require from the masses the loss of many personal liberties and to submit to heightened governmental control on many social issues … not to mention the death of 92.5% of the population…and probably not those of the "elite". Is the concept of a democracy "by and for the people", as idealized by the Founding Fathers a mere illusion, a temporary solution until the introduction of a totalitarian world government? Why are the world's citizens not being consulted in a democratic matter? I guess it is easier for the elites to manufacture consent through mass media. But maybe it won't work on everybody…

So it appears that with Rosicrucianism we are looking at the same Cabalistic stream of knowledge that has weaved its way through history to eventually become embodied by the Freemasons, The Illuminati and the Sabbaten-Frankists. If the Guidestones are the handiwork of modern day Rosicrucians, we've already seen that there is probably very little difference between such groups and Freemasonry.

With the deeper and more esoteric stuff out of the way I'm now going to run through a few other aspects to the Covid-19 plan-demic which I feel are worth mentioning.

The Economy:

Around the time of the 2008 crash there were economists who warned that another even larger crash would inevitably occur in the near future should the financial system not reform radically. One question that immediately

comes to mind then is that if such a crash was due, and given that the public would expect heads to roll this time, could the elites at the top of the global banking system have engineered a pandemic as a way to put the blame onto a virus in order to get off scott-free themselves? My personal view is that I wouldn't put it past them.

Whilst the notion of the bankers reacting to an inevitable event is interesting many conspiracy researchers have been warning for a long time of a global crash much more deliberate and long on the drawing board as part of a strategy to re-engineer the economic system to suit globalist aims. What happens in terms of how the global economy will look after this event is yet to be seen but one thing is for certain, the public is going to get fleeced by the elites who own the banking system. The lock-downs we are seeing are causing governments to throw massive amounts of money at the "problem" supposedly to help keep afloat businesses forced to close and secure their worker's incomes. In the UK the government is planning to cover 80 percent of wages for those currently forced to stop work and isolate. Similar plans have been formulated to help the self-employed and other countries are making moves along similar lines, albeit in their own way. Whilst many view this as a positive move, the fact that the pandemic is actually a plan-demic and being deliberately orchestrated means that the "rescue packages" for employers and workers are little more that daylight robbery by the international banking cabal which is headed up by the very Masonic/Frankist elites I have been writing about. Countries locked down by Covid-19 are staring down the barrel of massive government debt in the aftermath as the bankers will want their money back plus interest. Governments aren't simply pulling this money out of thin air. They will borrow it from banks who pull it out of thin air and then demand interest. In his book *The Biggest Secret*, David Icke explains that the banking sytem:

...is based on creating money that doesn't exist and lending it to people and businesses in return for interest. This creates enormous debt for governments, businesses and the general population, and you therefore control them. Vital to this has been to allow bankers to lend money they do not have. It works like this. If you or me have a million pounds, we can lend a million pounds. Very simple. But if a bank has a million pounds it can lend ten

times that and more, and charge interest on it. If even a fraction of the people who theoretically have 'money' deposited in the banks went today to remove it, the banks would slam the doors in half an hour because they do not have it. Money in the bank is a myth, another confidence trick. When you go into a bank and ask for a loan, the bank does not print a single new note nor mint a single new coin. It merely types the amount of the loan into your account. From that moment you are paying interest to the bank on what is no more than figures typed on a screen. However, if you fail to pay back that non-existent loan, the bank can come along and quite legally take your wealth that does exist, your home, land, car, and possessions, to the estimated value of whatever figure was typed onto that screen. [PDF p221]

Due to the nature of how money is created and loaned by the banks, all the government borrowing that will be taking place to deal with the economic impact of the coronavirus lock-downs will amount to little more than a giant looting operation by the bankers, their corporate cronies, and their puppet politicians. Taxes will rise, austerity will be imposed, there will be inflation (or even hyperinflation), and state assets will be up for grabs. Government debt is debt to the bankers and paid to them by the general public.

The situation was excellently summed up by independent radio host, Richie Allen, in a recent YouTube monologue. Allen stated:

"The foundation of the entire conspiracy is the system of finance operated on planet Earth in 2020. Shadowy men, mostly men, and a few women... they are very very few in number. They get to decide who (in terms of individually), what (in terms of countries) are given money, capital, finance to operate. They don't give that money out of their own back pocket. They invent that money out of thin air the instant the loan is approved. They haven't given anything of their own, they've made it up, then they've said "you've got to pay us back but you've also got to pay us some interest. We've got to make something out of it. You've got to pay for the privilege of borrowing our money." The problem is... fractional reserve banking 101: the principle has been created out of thin air but not the interest, meaning society, countries, individuals are forever in debt chasing their tails with no chance of ever being in the black. The debt worsens year in year out nationally and individually. That's when the banks say "right, you can't pay

us so you're going to have to force austerity on your citizens and you're going to have to sell off the family jewels." And the family jewels are the items of real value in any country, and you know what they are... water, your transport infrastructure, land. This is the conspiracy and given the opportunity to educate every man, woman and child in the world to only one fact and one fact only that would be it... because everything else falls into place when you understand that."

Another aspect to this is the fact that such an economic crisis could be used as an excuse to introduce Universal Basic Income (UBI). This is where the government of a country pays it citizens a basic amount of money each month to cover basic expenses regardless of whether they work or not. If enough jobs disappear from the economy as a result of the economic downturn such a scheme could be considered more seriously than it has been until now. Of course, while many may cheer at the notion of receiving free money UBI will have the effect of making many people dependent on the state for their very survival, which may well be the idea. They will have to do as they are told and jump through every hoop required in order to remain eligible for their money.

This current crisis could also be used to advance the agenda for a cashless society. Paying for items by card is being heavily encouraged right now due to the possibly of spreading the virus via the handling of cash and many businesses are currently only accepting electronic forms of payment. Could cash be about to go out of the window?

The Lethality Of Covid-19:

There is also much scepticism about just how deadly Covid-19 actually is when compared to similar viruses such as the flu. Whilst many elderly and already sick people have died during the outbreak we have no clear data on how many people died OF the virus or simply WITH the virus. One way to know would be to examine the overall mortality rate by country for the year 2020 and compare it to previous years (this could also be broken down by month or week). If the results show no significant spike in deaths then the hysteria by governments and media will look rather suspicious. Of course, the politicians will no doubt claim that the imposed lock-downs and "social"

distancing" measures were responsible for averting disaster. They will play the heroes after overseeing the take down of their own countries' economies due to a virus that may actually be no worse than a bad flu. What data we do have suggests there has not been a severe spike in overall mortality so far and there are many ways to present data to create the appearance of a virus being worse than it is (see here, here, here and here). Many experts in the field of epidemiology and medicine question the severity of Covid-19 and the draconian reactions to the virus, although you wouldn't know it from watching the TV news (see here, here, and here, and here).

When comparing the overall number of deaths for 2020 we also need to have those numbers broken down by cause of death. As people die all the time of illnesses such as heart disease, cancer, strokes etc we can assume that people haven't stopped dying of such things simply because Covid-19 is doing the rounds. Therefore if we were to find a significant drop in such deaths compared to, say, the previous ten years, then we can assume that something isn't quite right with the numbers. Whilst there will be those who would claim that the disparity was due to the fact that such afflicted persons caught Covid-19 and it sped up their deaths, the fact that those deaths would have been expected anyway statistically means we will not know for certain whether such people actually were finished off by the virus or whether they were simply infected when they died of other things. It also wouldn't tell us whether or not a bad flu season could have had a similar effect on such people. Of course, we don't have the stats on any of this yet but such an outcome would give us a clue as to just how the numbers could be cooked by those who might have the intent to do so. But this is only speculation at this point. I highlight this issue only to point out that this is the sort of data that the public needs to demand when 2020 comes to an end so that we can properly assess the severity of the situation.

One man who has been following this area from the beginning is researcher Jon Rappoport who has written many articles questioning what we are being told about the current virus outbreak. Two particular articles on the Italian outbreak are useful for understanding how a situation can be made to appear worse than it is (see here and here) An Italian government health advisor, Walter Ricciardi, has stated that "only 12 pecent of death certificates have shown a direct causality from coronavirus." The Telegraph in its article, Why Have So Many Coronavirus Patients Died In Italy? quotes Ricciardi:

According to Prof Walter Ricciardi, scientific adviser to Italy's minister of health, the country's mortality rate is far higher due to demographics - the nation has the second oldest population worldwide - and the manner in which hospitals record deaths.

The article quotes Ricciardi as saying:

"The way in which we code deaths in our country is very generous in the sense that all the people who die in hospitals with the coronavirus are deemed to be dying of the coronavirus."

"On re-evaluation by the National Institute of Health, only 12 per cent of death certificates have shown a direct causality from coronavirus, while 88

per cent of patients who have died have at least one pre-morbidity - many had two or three," he says.

The article goes on:

This does not mean that Covid-19 did not contribute to a patient's death, rather it demonstrates that Italy's fatality toll has surged as a large proportion of patients have underlying health conditions.

James Corbett in his excellent article, <u>Things you CANNOT Say About</u> Coronavirus writes:

OK, so you still insist on taking these phony baloney numbers seriously? Then let's take another looks at that <u>Italian report</u> on those dying with (not of) Covid-19.

The report tells us that the median age of those who have been pronounced dead with (not of) Covid-19 is 78. To put that number in perspective, the average life expectancy in Italy is 82.8.

That means those who are dying with (not of) the disease are within years of reaching the average life expectancy (and, let's not forget, they are also suffering in the vast majority of cases from at least two other diseases). I venture to say that a similar panic could be raised about just about any viral disease in circulation if it was being reported in the same way as this coronavirus is being reported.

John Rapporport has also questioned the reliability of the PCR tests which have been used as the main diagnostic tool for Covid-19, which he believes are unreliable and generate many 'false-positives' (see here). Rappoport was recently on *The Richie Allen Show* to discuss Covid-19. He is more than aware of how this situation can - and likely is - being used as a way for the elite to exert their dominance over the public. He concludes the interview by stating:

"If the clamp-down that is coming is going to be obvious, more obvious than even now, if it's just going to be a brutal force exerted directly against the populous from sources which are obvious to anybody then yes, there's going to be considerable resistance. So, the implication is that this would need to come in a way that bamboozles and befuddles people so that they don't see it for what it is. And here we have it, folks. The virus! This is a way of weaving a story that looks and sounds true to the uninitiated and demands the very consequences that would otherwise be attained by brute force... and that's what's going on."

There have been numerous sceptical citizen sleuths who have been heading down to their local hospitals with their phone cameras to find out if the picture being painted by the media of over-run and over-stretched hospitals dealing with floods of coronavirus patients is even true. What they find seems to be the opposite. Some of these rather quiet hospitals are in New York City which is supposed to be a Covid-19 hot zone. This prompted Russ Winter of winterwatch.net to remark:

So much for the narrative that New York City is so overwhelmed that they need Army Corp of Engineers to build a special facility at Javitts Center.

No doubt there will be hospitals which are seeing a lot of coronavirus patients but given that many members of the public have seen and filmed

hospitals which are less than busy during this pandemic, could it be that covid-19 patients are all being herded into certain hospitals giving the impression that the crisis is worse that it is? We know that most of the fatalities involve people who are elderly and often have more than one serious underlying health issue. Could many of these already old and sick patients have also fallen victim to a bad flu outbreak in which they would have likely died in a more spread out manner across more hospitals or even at home? If that was the case we'd likely never have heard about a single one of them. The terms "died having contracted the coronavirus" and "died having tested positive for Covid-19" are common refrains for news anchors when covering daily death tolls but do such phrases tell us anything about the actual lethality of the virus? Or are they just used to give the viewers at home a certain impression about the lethality of it?

Whilst it's important to question the information we are being given about the virus, ultimately the issue of whether the virus is as deadly or as widespread as governments and media claim is a side issue to what should be the main question which is: are we looking at a naturally occurring outbreak or an orchestrated event to manipulate the public and pursue an agenda?

Event 201 and ID2020:

In the past on this blog I've raised the <u>issue</u> of drills and training exercises taking place in which the scenarios involved eerily coincide with real events that occur. We often see this phenomenon with terrorist events and mass shootings. In many cases they occur at the exact same time as the real event and other times they seem to foreshadow one that is about to happen. In the case of the Covid-19 outbreak we find such an exercise named *Event 201*. The exercise was organised by the John Hopkins University for Health Security. This is currently the go to source for the mainstream media in terms of reporting on the statistics related to Covid-19 infections and deaths worldwide. The scenario envisioned a pandemic involving a novel coronavirus and took place in October 2019, shortly before the outbreak in China.

An article from The Metro explains:

A shocking 65 million people were killed within 18 months of a pandemic outbreak in a simulation created by public health experts two months before the outbreak of coronavirus.

A global panel of experts created the hypothetical pandemic to assess how ready the world is for such an outbreak. They met in October for the Event 201 exercise organised by the John Hopkins University Centre for Health Security. So far, coronavirus has not been declared a pandemic.

The aim was to determine how national governments, public health bodies and the private sector could work together to respond to a hypothetical pandemic 'with potentially catastrophic consequences'. In the simulation, as well as millions of people worldwide dying of the disease, there were cases in every country in just six months, it caused a global financial crisis and ruined the travel and tourism industry.

John Hopkins University has obviously dismissed the notion that the exercise was related in any way to the Covid-19 outbreak. But if there was some connection what would we expect them to say? Make of this story what you will. It's worth pointing out that John Hopkins University ran the exercise in

partnership with World Economic Forum and the Bill and Melinda Gates Foundation. So we're looking at globalists here. Bill Gates is well known for his advocacy of mass-vaccination programs.

The World Economic Forum comes up again in regards to a program called *ID2020*. In his article, *The Coronavirus COVID-19 Pandemic: The Real Danger is "Agenda ID2020"* Peter Koenig writes:

What is the infamous ID2020? It is an alliance of public-private partners, including UN agencies and civil society. It's an electronic ID program that uses generalized vaccination as a platform for digital identity. The program harnesses existing birth registration and vaccination operations to provide newborns with a portable and persistent biometrically-linked digital identity. GAVI, the Global Alliance for Vaccines and Immunization, identifies itself on its website as a global health partnership of public and private sector organizations dedicated to "immunization for all". GAVI is supported by WHO [World Health Organisation], and needless to say, its main partners and sponsors are the pharma-industry.

The ID2020 Alliance at their 2019 Summit, entitled "Rising to the Good ID Challenge", in September 2019 in New York, decided to roll out their program in 2020, a decision confirmed by the WEF [World Economic Forum]in January 2020 in Davos. Their digital identity program will be tested with the government of Bangladesh. GAVI, the Vaccine Alliance, and "partners from academia and humanitarian relief" (as they call it), are part of the pioneer party.

Is it just a coincidence that ID2020 is being rolled out at the onset of what WHO calls a Pandemic? — Or is a pandemic needed to 'roll out' the multiple devastating programs of ID2020?

After expressing similar concerns to the ones I raised earlier regarding forced vaccination as a means of population reduction, Koenig writes:

Another hypothesis, at this point only a hypothesis, but a realistic one, is that

along with the vaccination – if not with this one, then possibly with a later one, a nano-chip may be injected, unknown to the person being vaccinated. The chip may be remotely charged with all your personal data, including bank accounts – digital money. Yes, digital money that's what "they" are aiming at, so you really have no control any more over your health and other intimate data, but also over your earnings and spending. Your money could be blocked, or taken away – as a 'sanction' for misbehavior, for swimming against the stream. You may become a mere slave of the masters. Comparatively, feudalism may appear like a walk in the park.

He continues:

We are moving towards a totalitarian state of the world. This is part of Agenda ID2020 – and these steps to be implemented now – prepared since long, including by the coronavirus computer simulation at Johns Hopkins in Baltimore on 18 October 2019, sponsored by the WEF and the Bill and Melinda Gates Foundation.

Bill Gates, one of the chief advocates of vaccinations for everybody, especially in Africa – is also a huge advocate of population reduction. Population reduction is among the goals of the elite within the WEF, the Rockefellers, Rothschilds, Morgens – and a few more. The objective: fewer people (a small elite) can live longer and better with the reduced and limited resources Mother Earth is generously offering.

In his article, <u>Bill Gates and the Mark of the Geek</u> Thomas Muller of winterwatch.net writes of Gates' participation in an "ask me anything" session on *Reddit* about coronavirus. He writes:

"Eventually, we will have some digital certificates to show who has recovered or been tested recently or when we have a vaccine who has received it," Gates said.

The quantum-dot tattoos involve piercing the flesh with soluble sugar-based micro-needles. The needles contain a vaccine and fluorescent copper-based "quantum dots" embedded inside bio-compatible, micron-scale capsules. After the micro-needles dissolve under the skin, they leave the encapsulated quantum dots in a pattern that's easy to read and identify a person as having received a vaccination.

He goes on to highlight Gates' use of the Masonic number 33:

The Geek says if you don't shut down minimally impacted areas, then the epidemic spreads 33% a day. Yes, 33. You can't make this stuff up. In 2018, Mr. Predicto estimated 33 million deaths from a pandemic.

Gates is a big-time operative for the elites globalist plans, as are many other super wealthy "philanthropists". Muller continues:

In 2009, Gates attended a highly secretive meeting in the heart of New York City with other billionaire plutocrats and formed the Good Club. The names of some of the members are familiar figures: Bill Gates, George Soros, Warren Buffett, Oprah Winfrey, David Rockefeller and Ted Turner. There are others, too, namely business giant Eli Broad. A central theme of the discussion was "overpopulation.

Besides vaccines and overpopulation, Gates is a front man pushing other sketchy causes, such as GMOs and global warming. Yet, it's quite difficult to find criticism or negative commentary on him. There are few topics or people more protected by the sistema on the Internet and in the Lugenpresse.

Will the elites seek to use the Covid-19 pandemic as leverage for the introduction of this digital ID system which stores a person's medical and financial data and will no doubt be the end of the road for physical money? Will an individual one day have to certify their vaccination history in order to go about their lives and access public spaces freely? I'm sure Bill Gates will take his best shot at making such a scenario a reality. If the public consents to such schemes it will bring us one giant leap closer to the Big Brother society long planned by the global elite. I'll repeat what Christopher Jon Bjerknes said about the birth pangs prophesies related to the Moshiac:

"And they also had prophesies that have come true about the idea that science would become much greater, knowledge would become greater, but the scholars and the prophets would disappear so that all of this technology and science would become a danger instead of a benefit to mankind."

5G and Coronavirus:

I've <u>mentioned</u> previously on this blog the concerns over the safety of the new 5G wireless internet technology. 5G is necessary for the elites to implement their technocratic agenda which includes constant monitoring of the population and their resource usage. 5G will notably increase the

amount of data that can be transmitted and will be the technology that underpins the creation of the "Internet of Things" and the "smart cities" where just about everything is connected to the internet.

The website *5gappeal.eu*, which calls for a moratorium on the technology signed by many doctors and scientist, explains that:

5G signifies "5th generation" wireless technology. It is said to provide faster and higher transmission capacity. It includes Internet of Things (IoT), driverless cars, and faster video streaming.

5G will massively increase the microwave and millimeter wave radiation in our environment. It will also use new frequencies that are not evaluated by experts independent from industry as to their safety.

5G will include the higher millimeter wave frequencies, previously used for crowd control for instance. The millimeter waves do not travel easily through buildings so 5G will require millions of new "small cell" antennas.

The idea that the roll-out of this technology could be halted because of

health concerns will no doubt be unacceptable to the tyrants seeking to enslave us. Whilst we already live in a sea of microwave radiation due to the wireless systems we already use, 5G is set to take this to a new level and introduce new frequencies into the mix. This pandemic, therefore, coming as it has at the very time that 5G is starting to 'go live' in many parts of the world, does have the potential to act as a cover for those who experience the negative effects of the technology and start to become unwell. Who is going to believe they are sick because of 5G when there's Covid-19 on the loose? Especially as the symptoms experienced by those whose health has been negatively impacted by wireless technologies are often described as "flu like." 5Gappeal.eu describes the symptoms connected with wireless frequencies:

The EUROPA EM-EMF Guideline 2016 states that "there is strong evidence that long-term exposure to certain EMFs is a risk factor for diseases such as certain cancers, Alzheimer's disease, and male infertility...Common EHS (electromagnetic hypersensitivity) symptoms include headaches, concentration difficulties, sleep problems, depression, lack of energy, fatigue, and flu-like symptoms."

Male infertility... hmm. No doubt that helps with depopulation. Of course depression, lack of energy and fatigue could also be written off as being a result of the lockdowns and general anxiety around the whole coronavirus affair. Whilst the pandemic and lockdowns may not go on forever (hopefully), perhaps there is a belief among the elites that most people will eventually adjust to the new energetic environment they find themselves in. In the meantime Covid-19 can be used as the patsy to take the blame for the initial wave of health effects caused by 5G. The more serious and long-term issues such as cancers and Alzheimer's disease — which can't be attributed to the virus - can always be written off as having other causes, something that has been happening for decades already to cover up the many harmful substances in our environment and food products.

The Strange Case of Charles Lieber:

This next piece of information I'm going to cover may well have no connection to Coronavirus at all, but on the other hand, it could. It involves

the arrest of a Jewish-American scientist called Charles Lieber who was arrested for being involved in a secret nanoscience project with the Chinese. The project was considered an Intelligence Concern by the US and Lieber was arrested for lying about his involvement. What might be of relevance to Covid-19 is the fact that whatever Lieber was up to, he was doing it at Wuhan University, the city where the outbreak began. *NPR* reports:

Charles Lieber, the chair of Harvard University's Department of Chemistry and Chemical Biology, has been arrested and criminally charged with making "false, fictitious and fraudulent statements" to the U.S. Defense Department about his ties to a Chinese government program to recruit foreign scientists and researchers.

The Justice Department says Lieber, 60, lied about his contact with the Chinese program known as the Thousand Talents Plan, which the U.S. has previously flagged as a serious intelligence concern. He also is accused of lying about about a lucrative contract he signed with China's Wuhan University of Technology.

In an affidavit unsealed Tuesday, FBI Special Agent Robert Plumb said Lieber, who led a Harvard research group focusing on nanoscience, had established a research lab at the Wuhan university — apparently unbeknownst to Harvard.

It seems unclear what Lieber was working on during his time in Wuahan but according to the *NPR* article he seems to have been well paid:

The arrangement between Lieber and the Chinese institution spanned "significant" periods of time between at least 2012 and 2017, according to the affidavit. It says the deal called for Lieber to be paid up to \$50,000 a month, in addition to \$150,000 per year "for living and personal expenses."

Lieber was also awarded more than \$1.5 million by WUT and the Chinese government to establish a research lab and conduct research at WUT," the document states.

Of course there may be no significance to this at all but I feel the connection between this top Harvard biologist and clandestine research activities based in Wuhan perhaps warranted a mention. Fact checking sites (like this one)

play down the notion of Lieber having any connection to Covid-19, and they may be right, but they know as little as the rest of us when it comes to exactly what went on inside Lieber's \$1.5 million research lab in Wuhan.

Bilogical Research, Espionage, and the Possible Origins of Covid-19:

The Lieber case leads us into the murky underworld of scientific research into viruses involving China, the United States and even Israel. The true origins of Covid-19 are still unclear but could it have originated in a lab and been released either intentionally or accidentally? Given that it appears to be being used to advance the long-term agenda of the elite my personal suspicion would be the latter. Whatever the answer, whether we are looking at the US or Chinese funding for such research Wuhan seems to be a key location.

In his article, *The Coronavirus and the Culture War*, Catholic academic, Dr. E. Michael Jones covers this subject of covert research and espionage. He points out that the Wuhan Institute of Virology, an institution housing a P4 bio-lab "capable of storing, studying, or engineering Pathogen Level 4 microbes like the coronavirus" is located 8.6 miles from the epicentre of the coronavirus outbreak. He goes on to explain:

The Wuhan Institute of Virology was at the center of a web of top-secret biological warfare research and academic espionage that stretched around the world. In 2013 two Chinese virologists were caught stealing and smuggling some of the most deadly viruses on earth from the National Microbiology Lab in Winnipeg, Canada's only Pathogen Level 4 virology laboratory, back to Wuhan, where both smugglers, virologist Dr. Xiangguo Qui and biologist Dr. Keding Cheng, were involved in China's biological warfare program.[8] According to ZeroHedge, "the couple is responsible for infiltrating Canada's NML with many Chinese agents as students from a range of Chinese scientific facilities directly tied to China's Biological Warfare Program, including the Wuhan Institute of Virology and the Center for Disease Control and Prevention in Chengdu Military Region."[9]

One of the bioweapons stolen from the Winnipeg lab was the coronavirus, which had arrived at the NML on May 4, 2013 for experimentation on animals. "It is from this stash of reserves," Sir Adrian Bond writes: "that the

coronavirus was stolen and smuggled by Dr. Qui, Dr. Cheng, and by alleged Chinese Biological Warfare Program agents recruited from the Wuhan Institute of Virology who were disguised as virology students at the University of Manitoba."[10]

Jones goes on to cover Charles Lieber and his connection to Israel. He continues:

Other universities were also involved in the global bioweapons smuggling ring. In late January 2020, FBI agents arrested Charles Lieber, chairman of Harvard's Department of Chemistry and Chemical Biology. Lieber was "charged with lying about his role in a Chinese talent recruitment program" and then was released from custody on January 30, but only after posting a \$1 million cash bond. [11] According to the Boston Globe, Lieber "lied about his links to the Wuhan Institute of Virology" [12] after China paid him hundreds of thousands of dollars to arrange not only for smuggling bioweapons but hiring the smugglers.

Lieber, who is Jewish,[13] was considered a flight risk because of his ties to Israel, causing authorities to demand that both he and his wife surrender their passports. Lieber is one of the founders of the bio-tech firm Nanosys, which is affiliated with Hebrew University in Jerusalem.[14] According to the indictment, "Prosecutors say Lieber agreed to conduct research, publish articles and apply for patents on behalf of China's Wuhan University of Technology in exchange for \$50,000 per month and about \$150,000 in living expenses. He also received \$1.5 million to establish a research lab at the Chinese university. . . . Authorities say Lieber hid his involvement in the program from Harvard and told federal investigators in 2018 that he had never been asked to participate in the program."[15] Lieber's arrest followed the federal government's growing concern over China's efforts to steal U.S. research and technology, as manifested in programs like the Thousand Talents Plan...

He goes on:

According to a Facebook post, two Chinese "students" working as research assistants were also arrested after one of them, who was actually a lieutenant in the Chinese Army, was apprehended at Logan Airport while

trying to board a flight to China while smuggling 21 vials of "Sensitive Biological Samples" on to the plane in his luggage.[17] Lieber's connection with Wuhan and the "student's" method of smuggling lend credence to the claim that the coronavirus escaped accidentally into the population there.

Jones then writes about American funded biological research taking place at the Wuhan Institute of Virology:

On the other hand, the production of those bioweapons was nothing if not deliberate and paid for by the United States government. Professor Zhengli, Senior Scientist and Principal Investigator at the Wuhan Institute of Virology for the past 20 years, was the recipient of millions of dollars from USAID and other agencies "of grant funding for the express purpose of researching and experimenting with coronaviruses—often receiving numerous, overlapping grants for the same time period."[18]

The U. S. government, in other words, outsourced its bioweapons program to China by providing Prof. Zhengli with a \$665,000 grant from the National Institute of Health for a study named The Ecology of Bat Coronaviruses and the Risk of Future Coronavirus Emergence (NIAID R01 AI1 10964). Four days after issuing that grant, on January 10, 2014, Prof. Zhengli received an additional \$559,500 grant from the United States Agency of International Development for a research study entitled Emerging Pandemic Threats PREDICT 2_China (Project No. AID-OAA-A-14—00102).[19]

If the United States government paid for the weaponization of coronavirus in bats, it did so with some eventual use in mind, which means that it could have been planning an attack. In many ways, the ideal place to unleash an attack on China would be from one of its own laboratories, because by launching it in Wuhan the United States could hold the Chinese accountable for the attack which the U.S. had launched.

In the final analysis, Sir Adrian Bond, whose article we have been citing, concludes that "the likeliest source of origin for Coronavirus 2019-nCoV is the Wuhan National Biosafety Laboratory at the Wuhan Institute of Virology," but he is unable to decide whether "there may be concerted efforts to conceal the precise nature of the virus, its source, and the parties responsible, or that, at worst, the dissemination of the epidemic coronavirus

is intentional."[20]

Jones concludes his section on the possible origins of the virus writing:

As Sir Adrian's conclusion shows, focusing on the virus leads to more questions than answers at this stage of the game. Even if everyone agreed with the war metaphor, no one could explain how biological warfare gets conducted in our day if he confined himself to the minutiae of biological warfare. COVID-19 is a weapon; it is not a strategy. And that fact leads us to conclude that the question of whether COVID-19 is a natural occurrence or a bioweapon is irrelevant. After military martial law was declared, the big question: "Is the coronavirus real or is it being used as a pretext for a manufactured crisis?"

The Rise of China:

On the subject of China there is one point that needs to be addressed as this "crisis" has led to the notion that the release and spread of Covid-19 is some sort of Chinese plot to wreck the US economy and those of its Western allies. If that was to be the case then it is important to understand that China didn't just "become" an economic rival to the US, it was MADE into one by agents of the force that I am trying to highlight in this post. James Corbett of corbettreport.com produced an excellent podcast on this subject some years ago in which he goes into exactly how this was done and by whom. I highlighted this podcast in a previous post titled <u>China and the Elite</u>. In the podcast Corbett explains:

"... this economic marvel of China over the past decade did not spring out of nowhere. It is the end result of what has been happening for decades, as part of agreements that were reached decades before that, so we have to understand this deeper level of what's going on to understand what's happening at the surface level, and that I think gives further bolstering to our argument, that what's happening is not the 2D surface reality of nation states pitted against each other but the 3D hierarchical reality of the 'super gophers' at the top, puppeteering the system whereby they can play nation states against each other to create a global governmental system that will ultimately be this merger of capitalism and socialism, this 'Red Capitalism' or whatever they want to call it — of course it will not be called 'Red Capitalism',

it will not be called anything like that – but we're seeing the merger of these systems in various ways."

One of these "super gophers" involved in the build-up of China was former US Secretary of State Henry Kissinger (the main architect behind Nixon's opening up of China in 1972) and a key organisation was the <u>Trilateral Commission</u>, a group of elite banking, business, and political figures. James Corbett has often espoused the notion that the elites may desire to shift the world over to a Chinese/Eastern led economic model and if something like that should emerge as a result of all this then it's important to point the finger at the real culprits and not simply at "the Chinese" as if they are somehow an independent entity. China as we know it is someone's creation. As Corbett once said in an <u>interview</u> on the subject "choosing teams in a fake game is not going to get you anywhere."

China is currently pursuing an imperialist economic project in the form of the <u>One Belt One Road</u> initiative which essentially involves creating the infrastructure for major trade routes from China to Europe and has the potential to turn many countries along the way into economic captives. So the Chinese economic build-up process is far from over. One country getting into bed with the Chinese on this project is, unsurprisingly, Israel. *The Hudson Institute* website <u>reports</u> on a 2017 visit to China by Israeli PM Benjamin Netanyahu stating that:

In a joint statement after the visit, Netanyahu and Xi pledged increased cooperation in areas including "air-pollution control, waste management, environmental monitoring, water conservation and purification, as well as high-tech fields." The statement also announced plans to create "a global technology center" and other joint projects in the area of innovation, with a standing invitation to Chinese companies to join in a variety of infrastructure projects within Israel itself. For his part, Netanyahu also expressed interest in Israel's joining China's massive multi-billion-dollar One Belt One Road project, and in signing a free-trade agreement between the two countries.

Strikingly, the joint statement said very little about the usual Middle East political issues—this, despite China's recent announcement of its by no means Israel-friendly "Four-Point Peace Plan" between Israel and the Palestinians. Instead, Netanyahu cordially encouraged China's quest "to assume its rightful place . . . on the world stage," adding that, for this effort, "We are your perfect junior partner. . . . I believe this is a marriage made in heaven."

So much for America's greatest friend and ally. But then it's all a farce anyway. Israel has been selling US technological secrets to China for decades but the US political class is a captured entity enslaved by Zionism and Christian Zionism and therefore does nothing. Behind the scenes Israel has always served as a back door into the West for the Russia/China communist alliance (the collapse of the Soviet Union was a KGB deception) which itself is a creation of the Masonic/Frankist force that also dominates the West. As Corbett said it's all "a fake game." Israel collaborating with china on technological projects is not surpising considering Israel is rapidly becoming a leading country in the fields of tech and AI, something Netanyahu likes to boast about whilst invoking the prophesies of Isaiah.

China has been used by the elite as a testing ground for the evolution from Communism into Technocracy. It is the model for the Technocratic hell that the elites intend to institute globally. Author of the book <u>Technocracy Rising</u>, Patrick Wood writes in his article <u>China Is A Technocracy</u>:

Thanks to early members of the Trilateral Commission, China was brought out of its dark ages Communist dictatorship and onto the world stage. Furthermore, the Trilateral Commission orchestrated and then facilitated a massive transfer of technology to China in order to build up its non-existent infrastructure.

He goes on to add:

It has been widely noted that China was initially brought into the mainstream of global trade by Trilateral Commission co-founder Zbigniew Brzezinski. As a failed Communist dictatorship, China was a blank slate with over 1.2 billion citizens under its control. However, Chinese leadership knew nothing about capitalism and free enterprise, and Brzezinski made no effort

to teach them about it. Instead, he planted seeds of Technocracy.

Once diplomatic relations were normalized with China, global corporations connected to the Trilateral Commission rushed in to build infrastructure, factories, educational facilities, financial centers, etc. In the 20-year period from 1980 to 2000, a transformation took place that was considered nothing short of an economic miracle; but it was not of China's doing. Rather, it can be fully attributed to the masters of Technocracy within the ranks of the Trilateral Commission.

He continues:

Today's China is a scientific dictatorship nightmare. With 600 million facial recognition cameras to be installed by 2020, China will have one monitoring camera for every seven citizens and facial recognition Artificial Intelligence software to instantly locate, identify and track everyone. In short, China is totally obsessed with surveillance and absolute control over its population using state-of-the-art technology.

Wood goes on to list the many ways in which, in his view, China has transcended Communism and become a Technocracy such as social credit scoring of induvials and companies, genetic engineering, Artificial Intelligence, 5G, Internet of Things etc.

He concludes the article stating:

The list goes on, but the evidence supports the analysis: China is a full-blown Technocracy and it is the first of its kind on planet earth, thanks to the clever manipulation and support of Western elites like the Trilateral Commission. Furthermore, its intentional Technocracy is spreading like a cancer to other nations, including India, Asia, Europe, Africa and South America. The combined population of China and India alone represents over 36 percent of world population; by comparison, the number of people living under Marxist-style governments is very small.

In conclusion, the clear and present danger to world domination is not any kind of Marxist derivative, but rather neo-authoritarian Technocracy. Living under such a system will be far more oppressive and painful than Socialism, Communism or Fascism.

Technocracy is the 21st century expression of the Communist agenda of the Illuminati and China is their test case. It may well be that they have designs on making China the dominant economic power in the near future and Covid-19 may be used as the excuse to introduce Technocratic policies to the rest of the world. Whilst there is the possibility of the merger of systems that Corbett mentioned, we also can't rule out the possibility that the elites may intend to bring the West into war with China and Russia. Out of the ashes of a World War III scenario they may hope to declare a world government, perhaps even introducing their "Moshiac" to the world as the peacemaker.

The man who helped begin this project to make China an economic superpower, Henry Kissinger, <u>said</u> the following during a 2017 speech at Columbia University:

"China's Belt and Road Initiative, in seeking to connect China to Central Asia and eventually to Europe will have the practical significance of shifting the world's centre of gravity from the Atlantic to the Pacific and will involve the cultures of Eurasia, each of whom will have to decide what relationship to this region they will see, and so will the United States"

He also said:

"It is said by many scholars that never before has a power grown in one region as China is doing and that its interaction will lead to tensions and maybe even war. We do not have this choice. That would be a road to the disaster and would do to the world what World War II did to Europe."

It sounds like he's saying that if the world resists China's rise to economic dominance we'll have to have a war instead. Kissinger happens to be Jewish and has been known to use the phrase "birth pangs" in reference to globalism (see the Green/Bjerknes <u>video</u> on the *Birth Pangs of The Moshiac*). While he feigns concern about a war to his audience, in all likelihood if war is what best fits the prophesies then that's probably what he wants. As the Chabad Lubavich site <u>said</u> about the time immediately before the Moshiac:

...lack of scholars; succession of troubles and evil decrees; famines; mutual denunciations; epidemics of terrible diseases; poverty and scarcity; cursing

and blaspheming; international confrontations nations provoking and fighting each other. In short, it will be a time of suffering that will make it look as if G-d were asleep.

Social Engineering:

A key area that needs to be covered regarding the coronavirus psyop is social engineering, something which the ruling cabal are expert at. For a long time they have been studying the human creature and the numerous drives and impulses that can be played on to direct the herd in a desired direction. In the case of coronavirus we are talking about fear and panic but other psychological impulses that can be played on by manipulators include things such as guilt, shame, envy, pleasure, and sexual drives.

One organisation involved in the elite's network of social engineers is the Tavistock Institute set up in England after World War One to study the psychological effects of shellshock. Over time it would become a key institution of social control and culture creation. Jim Keith, author of the excellent book <u>Mass Control: Engineering Human Consciousness</u> explains:

Initially run by British military intelligence officer Major John Rawlings [Reese], from its inception Tavistock was intended as a coordinating center for planetary social control using "psychological shock troops," a term coined by Reese. These shock troops in white lab coats have fanned out across the planet, infiltrating organizations in order to implement policies deemed productive by the organization's strategists.

At core Tavistock consists of Freemasonic British intelligence agents collaborating with the hydra heads of world psychiatry to achieve two goals:

- (1) A one world order where the nation state has been abolished and a single totalitarian control center established.
- (2) The simultaneous psychological control of the world, or, using their term, "societry." Even the official literature of Tavistock is candid in admitting its broad world mind control orientation.

In 1932 German psychologist Kurt Lewin, one of the creators of the American OSS intelligence network, precursor to the CIA – took over the steering of Tavistock from Reese. Lewin was an early proponent of the use of trauma for

reprogramming both individuals and societies, his modus operandi possibly more than merely an analogue of the Freemasonic dictum "Ordo Ab Chao," meaning "order out of chaos." [p30]

Note: Lewin was also a big player within the <u>Frankfurt School</u>, a Jewishheavy Marxist institution and another key organisation, along with Tavistock, involved in the cultural programming of the masses. This organisation brought us our modern day identity politics, political correctness and cultural Marxism. I would go more into the Frankfurt School but this post is long enough already.




Figure 32: The Frankfurt School, like Tavistock, is part of the elite agenda of social manipulation

Keith goes on to explain that a key Tavistock approach to manipulating subjects is "Future Shock" which involves using trauma to regress a target individual or group so that they become ripe for reprogramming. He goes on to quote Tavistock luminary, Dr. William Sargent who's words are very relevant amid the current coronavirus panic. Keith writes:

Dr. William Sargent of the Tavistock Institute, reported to have been at the time working in the CIA's MKULTRA mind control program, in his 1957 book

Battle For The Mind – A Physiology of Conversion and Brain-Washing elaborated on Lewin's theories by stating:

"Various beliefs can be implanted in many people after brain function has been sufficiently disturbed by accidentally or deliberately induced fear, anger, or excitement. Of the results caused by such disturbances, the most common one is temporarily impaired judgement and heightened suggestibility. It's various group manifestations are sometimes classed under the heading of "herd instinct," and appear most spectacularly in wartime, during severe epidemics, and in all similar periods of common danger, which increase anxiety and so individual and mass suggestibility." [p31]

Well there you have it straight from a Tavistock expert himself. Fear impairs judgement and makes people sitting ducks for those who might want to reprogram their thinking. These people have studied us and know how to push our buttons to make us do as they desire. Their understanding of the human psyche will go much deeper than even you or I could imagine.

Keith goes on to describe how Tavistock has fanned itself out throughout the United States:

Spreading out from Tavistock, agents have been present at the creation of institutional centers such as the Stanford Research Institute's Center for Advanced Behavioural Sciences, the Sloan School at MIT, the Wharton School of Finance and Business Administration at the University of Pennsylvania, the Institute for Social Research at the University of Michigan, and other locations. The Tavistock network has also influenced and penetrated such groups as Esalen, the RAND Corporation, the Hudson Institute, and the Heritage Foundation. [p32]

Keith goes on:

A key thrust of Tavistock has been accomplished by the National Training Laboratories, sponsoring group "encounter" or "sensitivity" programs involved in breaking down an individual's personality and reconstructing it along lines agreeable to the group – a microcosmic intervention intended to gradually bring about the macrocosm of the New World Order. It is estimated that millions of persons have been put through this type of "processing," including most of America's corporate leaders and officials from the State Department, the Navy, the Department of Education, and the National Education Association. [p32]

Note: This is reminiscent of the activities of an organisation in the UK called <u>Common Purpose</u> which runs training courses for "future leaders" within various key societal institutions. Unfortunately this is another sinister organisation I don't have time to go into.

Keith continues:

Although touted as a tool for personal and organizational liberation, sensitivity programs are also an effective tool for control along the lines the group leader desires, as has been effectively demonstrated through the use of similar methods in cultic groups such as those of Charles Manson and Jim Jones. [p32]

In his excellent article, <u>The Tavistock Method of Brainwashing and Social</u>
<u>Psychiatry</u>, which looks at Kurt Lewin, Tavistock, and The Frankfurt School,
Russ Winter explains:

Lewin's claim to fame was group think, or group dynamics. He was the

inventor of sensitivity training, or attack training. In other words, you gather a group of people, assign a group leader, identify the stronger-willed people in the group and hammer them into silence or submission through ostracism and shaming.

He continues:

The key to a Lewinite brainwashing group is the creation of a controlled environment in which stress is introduced to redo individuals' belief structures. Using peer pressure from other group members, the individual is "cracked," and a new personality emerges with new values. The degrading experience causes the person to deny that any change has taken place. In that way, an individual is brainwashed without the victim knowing what has taken place

This is also called the Gestalt Method. It tries to steamroller over structuralist psychology, which is more about introspection, self-awareness, one's actual identity, objective truths and drawing on time-tested traditions. The Tavistock and Levin methods are about "unfreezing" or dismantling that existing "mind set." Defense mechanisms (aka traditional thoughts) have to be bypassed and washed away. It is replaced with moral relativism. Once the subject is suitably confused, there is a transition or refreezing.

In other words, they understand the ins and outs of gaining compliance. First they induce shock, fear, trauma etc. Then they take advantage of an emotionally imbalanced state of mind to bypass the rational thought process and implant new ideas, values, and behaviours. Those more resistant may well cave to peer-pressure. Keep all of this in mind when watching the sensationalised coverage of the pandemic on the 24 hour rolling news channels with their constant running death toll and reports designed to heighten fear and anxiety. Keep it in mind when they wheel out political leaders, monarchs and - most importantly in the case of the Covid-19 pandemic – experts and advisers before the cameras to tell you what's going on and how you should be reacting and behaving during this event. The use of demonising and "shaming" those who are deemed to not be in compliance with "the new rules" has been a key feature of this whole coronavirus/lockdown situation. And also keep in mind that Technocracy is

all about stealing power from the people and placing it into the hands of experts and authority figures.

Winter concludes his piece – which was written in 2019 before this current coronavirus crisis – by stating:

Something extremely important at the moment is that this Tavistockian Crime Syndicate is licking its chops for social and economic convulsions on a global-scale, followed by depressions, as a softening-up technique for bigger things to come, namely creating masses of people all over the world who will become its "welfare" recipients and plantation dwellers of the future.

The Tavistock operatives also understand the power of popular culture to influence thinking so we must also be wary of the influence of celebrities during all this and also movies and television shows which have been made to subtly instil certain attitudes and behaviours in response to certain types of crises. I'm thinking about films like Contagion with its 'saviour vaccine' narrative or the numerous zombie movies instilling a deep seated fear of encountering the infected monsters roaming the streets. An event such as this will have been a long time in the works and much psychological preparation will have been worked into the "entertainment" we have consumed over the years or even decades.

The blurb on the back of Jim Keith's book, *Mass Control*, sums up the plight of the average citizen in regards to entertainment and news media:

Here stands the New Man. His conception of reality is a dance of electronic images fired into his forebrain, a gossamer construction of his masters, designed so that he will not under any circumstances perceive the actual. His happiness is delivered to him through a tube or an electronic connection. His God lurks behind an electronic curtain; when the curtain is pulled away we find the CIA sorcerer, the media manipulator.

Understanding that there is an army of experts who are incredibly well versed in psychiatry and psychology at the elite's disposal is key to understanding how they can have the chutzpa to carry off huge psychological operations such as <u>9/11</u> or the current Covid-19 plan-demic.

<u>Clapping for health workers – an exercise in compliance:</u>

One compliance exercise which the public is currently being put through during the coronavirus pandemic is the weekly ritual of going out onto balconies and front doorsteps to collectively clap to show support for the health workers dealing with Covid-19 victims. This is an exercise in bringing

societal pressure to bare upon the individual and manoeuvring them into lockstep with the group using shame, i.e. the threat of having one's very humanity called into question if they don't want to take part in the group ritual and show their gratitude at the pre-designated time. We see a similar thing every year around Armistice Day where anyone who doesn't wear a poppy, especially if appearing on live television, can expect to receive demands to "explain themselves" from an army of social media poppy fascists. This current clapping operation is all about keeping the individual from publicly questioning what's going on out of fear of having the group turn on them with accusations of somehow being disrespectful to, and belittling the efforts of, those working hard to combat the virus. We saw this same mentality with the post 9/11 wars where to question the wars would meet with accusations of being unpatriotic and dispectful to the troops.




Figure 35: An excercise in social compliance. Notice the rainbow and the use of the term 'Angels' with all its biblical connotations

James Corbett, in his article <u>Things You CANNOT Say About The Coronavirus</u> writes:

When 9/11 happened, there was a marked and notable intensification in the propaganda glorifying the American military. Not that such propaganda didn't exist before, but it was nothing like what we've seen since "the day that changed everything." Yes, the hero worship of veterans is one of the hallmarks of the Age of Terror that 9/11 ushered in .

So if this plandemic is the new 9/11, what's the new hero worship? Well, it should be obvious by now: Doctors are the new soldiers. Now we must dutifully show our appreciation for the brave medical workers on the front lines of this new war . . . or face yet more social castigation.

You may have noticed the interesting phenomenon making its way around the world. I call it "The Totally Spontaneous Balcony Applause Phenomenon." Yes, completely out of the blue, all the people under lockdown have decided to show their appreciation for the valiant doctors and nurses in this heroic struggle by going to their balcony at a pre-appointed time and applauding. And no, this totally spontaneous phenomenon is not just occurring in one or two countries. Or three or four countries. But in seemingly every country around the globe.

Just like that. Just out of the blue. Must be something in the zeitgeist, I guess.

He goes on to consider the possibily that the hero worship of medical workers may be used as a means to instil a misplaced trust in such people when the time comes to roll out the vaccine:

Here's my thoughtcrime: I find these displays creepy and off-putting. I find the glorification of doctors and nurses unsettling. Not because I think they are all quacks. Not because I think they are all evil. Not because I am not grateful for the work that (some) doctors do (some of the time). Not because I don't recognize the enormous stress that these doctors and nurses are under right now. But because this socially engineered adoration is going to be used to push an agenda exactly like the glorification of veterans was used to push the militarism agenda of the post-9/11 years.

This time, we are being asked to glorify doctors and nurses because these are

the same trusted experts whose authority cannot be questioned who are going to be giving you the vaccine. You know, The Vaccine. The one that will bring an end to the then 18-month long psychological siege that we are being placed under.

What?? You still question the vaccines? You still dare to defy the authority of these brave doctors and nurses who risked their lives for us? You can't say that, you disgusting conspiracy mongering throughtcriminal, you!

Be honest, you know that this push is coming. And they are getting the public to sign on with all these "spontaneous" balcony applause sessions. So perhaps you'll forgive me for not joining in.

If one wants to show appreciation for those on the medical front-line that's all well and good, but applying societal pressure (let's call it what it is — societal bullying) to bring all people into line in a collectivised ritualistic hero worship of medical practitioners is not the way to do it. In my opinion the applause phenomenon is no more spontaneous and grassroots than the rainbow drawings phenomenon. While human beings are not unknown to guilt trip each other into taking part in activities, the social engineers are experts at seeding and spreading ideas and making them go viral (no pun intended). And in the social media age it's never been easier.

Attacking Conspiracy Theories:

One thing we can expect to see as a result of this situation is an increased stigmatisation of conspiracy theories, especially those related to Covid-19. The messaging service *Whatsapp* (owned by Facebook)has already put a <u>limit</u> on the amount of people users can forward posts to in order to stop the spread of "misinformation" surrounding coronavirus, reducing the number to just one. *Whatsapp* put out a statement saying:

We know many users forward helpful information, as well as funny videos, memes, and reflections or prayers they find meaningful," said WhatsApp. "In recent weeks, people have also used WhatsApp to organize public moments of support for frontline health workers.

However, we've seen a significant increase in the amount of forwarding which users have told us can feel overwhelming and can contribute to the

spread of misinformation. We believe it's important to slow the spread of these messages down to keep WhatsApp a place for personal conversation.

Clearly as far as *Whatsapp* is concerned it's fine to spread shallow nonsense and things which reinforce the official narrative but if users step outside of that boundary they are going to clamp down.

The establishment media and internet giants have thrown a particularly large hissy-fit over theories connecting 5G to Covid-19 which is what prompted the move by Facebook/Whatsapp. This was largely a response to reports of people in the UK setting fire to cell phone masts. *CNBC* reports:

Several cell towers in the U.K. have been set on fire and engineers harassed amid the spread of online conspiracy theories that link 5G technology with the coronavirus pandemic.

Four of Vodafone's mobile phone masts were attacked in the last 24 hours, a spokesperson for the British carrier told CNBC Sunday. It's unclear whether the sites affected were used for 5G.

Whilst there may well be no 5G connection to Covid-19 the fact is that the spread of such ideas would have caused many to investigate the technology for themselves and the claims about its potential harm to human health. Therefore this one had to be nipped in the bud right away.

Expect to see many establishment approved "experts" rolled out to discuss "conspiracy theories" and "conspiracy theorists" during this Covid-19 hysteria. One example was highlighted by radio host, Richie Allen who played on his show a clip from *SKY News* in the UK. The channel brought on a philosophy professor to discuss conspiracy theories. As always in such mainstream anti-conspiracy segments the expert proceeded to belittle conspiracy theorists by using the age old tactic of being smug and patronising, saying little to nothing of any real value, and acting like he understands the minds of conspiracy theorists better than they do themselves (find the clip here.)




Figure 36: Sad but so often true

In his article, <u>Tools for Rebuting the Conspiracy-Theorist, Mental-Illness</u> <u>Gaslighting Slur</u>, Russ Winter writes:

The growth of alternative media has required the development of a whole cottage industry to mentally diagnosis and counterattack the burgeoning population of truthers, who are often labeled "conspiracy theorists" (a CIA term and invention).

Winter goes on to describe the common tactics often used by professional sceptics and mainstream media when broaching the subject of conspiracy theories:

Of course, conspiracy theories are not all created equal. In fact, some are deliberately created as a straw-man tactic to make truthers seem mental. You will see the dishonest tactic of bunching different "wild" or weak theories on the same page as legitimate theories.

Or they will cherry pick weak parts of a conspiracy argument and overplay that hand. I have friends who are on the same page with me on many conspiracies and truths but who seem out there on others. That goes with the territory. Do I dismiss them in general? Absolutely not.

He continues:

I find it curious that those who call conspiracy theorists "mental cases" rarely, if ever, bother to look through our lenses. Do they think this just all comes out of a vacuum? In fact, it's my belief that conspiracy inquirists, or truthers, excel at introspection, a trait strangely lacking in their doubters.

You would think they are some type of "experts" on the "theories." In almost all instances that I have observed, not even remotely. In fact, in one presentation by one of these so called theorist "experts," a trait of the conspiracy theorist is stated to be their attention to details. This is supposed to be a deficiency? Mostly this is gaslighting. Lately, I've seen more of the appeal-to-authority scam, whereby some "expert" from "Yale" is hauled out to pontificate in front of a cadre of cheerleaders.

Another common tactic is the straw man fallacy, or shooting down or even inventing a weak theory or anomaly and then victory dancing a soft-toss debunking. The is common at sites like Metabunk.

Calling anomalies "superficial" is another common tactic. Therefore, it's necessary to focus on large and quick-hitting anomalies.

A common sling at conspiracy realists is to allude to their "doubting" nature and then insert the plastic word "radical" doubters. What does radical even mean? Is that like "deniers"? Personally for me, radical doubter is a label I'm willing to wear. Non-doubters will also use the appeal-to-authority, or "experts" fallacy, quite frequently.

Much of what Winter describes above is what we will see as more and more

people begin to see through this Covid-19 psyop. No doubt such strategies come straight out of the Tavistock playbook.




Figure 37: AARRRGH!!!

Some will dismiss such things while others may become curious. Bill Gates: A Literal Demon From Hell

If I was religious I would consider Bill Gates to be a literal demonic entity. Gates is at the forefront of the promotion of mass-vaccination for everybody as part of the effort to tackle the coronavirus outbreak, something I consider to be an elite engineered psychological operation against the global public with the aim of eventually ushering in a worldwide Technocratic control system. Gates recently stated that mass gatherings may not return until everybody has had the forthcoming Covid-19 vaccine. The website *Lifesite News*, in its article, *Bill Gates: Life won't go back to 'normal' until population 'widely vaccinated'* reports:

In a lengthy <u>interview</u> with CBS This Morning, released on April 2, Gates predicted that people's fear of large public gatherings would be closer to normal "once we have the vaccination," possibly 18 months.

"Our foundation works a lot on diagnostics and vaccines," Gates said.

Vaccine producers are the ones "that can really get things back on track

where we're not worried about large public gatherings."

On the issue of when life will get back to normal Gates went on to say:

"Which activities, like schools, have such benefit and can be done in a way that the risk of transmission is very low? And which activities, like mass gatherings, may be – in a certain sense – more optional? And so until you're widely vaccinated, those may not come back at all."

In a recent article by Robert F. Kennedy Jr. titled, <u>Gates' Globalist Vaccine</u>
<u>Agenda: A Win-Win for Pharma and Mandatory Vaccination</u>, Kennedy writes of Gates:

Vaccines, for Bill Gates, are a strategic philanthropy that feed his many vaccine-related businesses (including Microsoft's ambition to control a <u>global vaccination ID enterprise</u>) and give him dictatorial control of global health policy.

Gates' obsession with vaccines seems to be fueled by a conviction to save the world with technology.

Personally, I'd say Gates' motivations are less about saving anyone or making money and more about technocratic mass-enslavement and depopulation, anyhow, Kennedy goes on to describe the devastation Gates' vaccine programs have wrought around the world. He writes:

Promising his share of \$450 million of \$1.2 billion to eradicate polio, Gates took control of India's National Technical Advisory Group on Immunization (NTAGI), which mandated up to 50 doses (Table 1) of polio vaccines through overlapping immunization programs to children before the age of five. Indian doctors blame the Gates campaign for a devastating non-polio acute flaccid paralysis (NPAFP) epidemic that paralyzed 490,000 children beyond expected rates between 2000 and 2017. In 2017, the Indian government dialed back Gates' vaccine regimen and asked Gates and his vaccine policies to leave India. NPAFP rates dropped precipitously.

In 2017, the World Health Organization (WHO) reluctantly admitted that the global explosion in polio is <u>predominantly vaccine strain</u>. The most frightening epidemics in <u>Congo, Afghanistan</u>, and the <u>Philippines</u>, are all

linked to vaccines. In fact, by 2018, 70% of global polio cases were vaccine strain.

In 2014, the Gates Foundation funded tests of experimental HPV vaccines, developed by Glaxo Smith Kline (GSK) and Merck, on 23,000 young girls in remote Indian provinces. Approximately 1,200 suffered severe side effects, including autoimmune and fertility disorders. Seven died. Indian government investigations charged that Gates-funded researchers committed pervasive ethical violations: pressuring vulnerable village girls into the trial, bullying parents, forging consent forms, and refusing medical care to the injured girls. The case is now in the country's Supreme Court

Many more nefarious examples of Gates supported vaccine operations are covered in Kennedy's article but you get the idea. Now Gates is getting to work on vaccinating everyone in the world against Covid-19.

Gates is also a supporter of *ID2020*, a program designed to create a digital ID to record a person's vaccination history. Thomas Muller of winterwatch.net in his article <u>Bill Gates and the Mark of the Geek</u> writes:

"Eventually, we will have some digital certificates to show who has recovered or been tested recently or when we have a vaccine who has received it," Gates said.

The quantum-dot tattoos involve piercing the flesh with soluble sugar-based micro-needles. The needles contain a vaccine and fluorescent copper-based "quantum dots" embedded inside bio-compatible, micron-scale capsules. After the micro-needles dissolve under the skin, they leave the encapsulated quantum dots in a pattern that's easy to read and identify a person as having received a vaccination.

The program, currently being trialed in Bangladesh, is run by the *ID2020* Alliance and partners include *The Vaccine Alliance* (GAVI), the *Rockefeller Foundation* and *Microsoft*. The program also has support from the World Economic Forum (WEF). The official website <u>states</u>:

The ability to prove who you are is a fundamental and universal human right. Because we live in a digital era, we need a trusted and reliable way to do that both in the physical world and online.

The website *biometricupdate.com* <u>reports</u>:

The program to leverage immunization as an opportunity to establish digital identity was unveiled by ID2020 in partnership with the Bangladesh Government's Access to Information (a2i) Program, the Directorate General of Health Services, and Gavi, according to the announcement.

Digital identity is a computerized record of who a person is, stored in a registry. It is used, in this case, to keep track of who has received vaccination.

It is easy to see how this digital identity could evolve into something more than a vaccine registry. Peter Koenig in his article <u>The Coronavirus COVID-19</u> <u>Pandemic: The Real Danger is "Agenda ID2020"</u> writes:

Another hypothesis, at this point only a hypothesis, but a realistic one, is that along with the vaccination — if not with this one, then possibly with a later one, a nano-chip may be injected, unknown to the person being vaccinated. The chip may be remotely charged with all your personal data, including bank accounts — digital money. Yes, digital money that's what "they" are aiming at, so you really have no control any more over your health and other intimate data, but also over your earnings and spending. Your money could be blocked, or taken away — as a 'sanction' for misbehavior, for swimming against the stream. You may become a mere slave of the masters. Comparatively, feudalism may appear like a walk in the park.

He also writes:

The ID2020 Alliance at their 2019 Summit, entitled "Rising to the Good ID Challenge", in September 2019 in New York, decided to roll out their program in 2020, a decision confirmed by the WEF [World Economic Forum] In January 2020 in Davos. Their digital identity program will be tested with the government of Bangladesh. GAVI, the Vaccine Alliance, and "partners from academia and humanitarian relief" (as they call it), are part of the pioneer party.

Is it just a coincidence that ID2020 is being rolled out at the onset of what WHO calls a Pandemic? – Or is a pandemic needed to 'roll out' the multiple devastating programs of ID2020?

Thomas Muller points out Gates' interest in the subject of overpopulation writing:

In 2009, Gates attended a highly secretive meeting in the heart of New York City with other billionaire plutocrats and formed the Good Club. The names of some of the members are familiar figures: Bill Gates, George Soros, Warren Buffett, Oprah Winfrey, David Rockefeller and Ted Turner. There are others, too, namely business giant Eli Broad. A central theme of the discussion was "overpopulation."

Besides vaccines and overpopulation, Gates is a front man pushing other sketchy causes, such as GMOs and global warming. Yet, it's quite difficult to find criticism or negative commentary on him. There are few topics or people more protected by the sistema on the Internet and in the Lugenpresse.

During a *TED* talk in 2010 Gates spoke of the need to lower the population and stated that this could be achieved "if we do a great job with new vaccines." He said:

"Now if we do a really great job on new vaccines, health care, reproductive health services, we lower that [the population] by perhaps 10 or 15 percent,"

If vaccines are supposed to be about improving health and saving lives then I'm not sure exactly how that is meant to reduce population levels. Maybe you, the reader, know the answer but I find it a rather strange thing to say. See the clip below:

Robert F. Kennedy Jr. had this to say in his article on Gates:

In 2010, when Gates <u>committed \$10 billion</u> to the WHO, he said "We must make this the decade of vaccines." A month later, Gates said in a <u>TED Talk</u> that new vaccines "could reduce population." And, four years later, in 2014, Kenya's Catholic Doctors Association accused the WHO of chemically sterilizing millions of unwilling Kenyan women with a <u>"tetanus" vaccine campaign</u>. Independent labs found a sterility formula in every vaccine tested. After denying the charges, WHO finally admitted it had been developing the sterility vaccines for over a decade. Similar accusations came from <u>Tanzania</u>,

Nicaragua, Mexico, and the Philippines.

In 2013 the UK's *Channel 4* aired a drama series called *Utopia*, the plot of which (*spoiler alert*) involved a powerful hidden cabal looking to depopulate the world using a sterilizing vaccine to be released in response to an engineered virus outbreak (see video below):

Robert Kennedy Jr. concludes his article writing:

The Gates Foundation spends only about \$650 million of its \$5 billion dollar budget on these areas. They say he has diverted agency resources to serve his personal philosophy that good health only comes in a syringe.

In addition to using his philanthropy to control WHO, UNICEF, GAVI, and PATH, Gates funds a private pharmaceutical company that manufactures vaccines and is donating \$50 million to 12 pharmaceutical companies to speed up development of a coronavirus vaccine. In his recent media appearances, Gates appears confident that the Covid-19 crisis will now give him the opportunity to force his dictatorial vaccine programs on all American children – and adults.

On a positive note many people seem to be calling out Gates on his demonic activities. He's been getting a hard time on Instagram apparently. The website *News Punch* reports:

Bill Gates' plan to "save the world" by rolling out a potentially mandatory vaccine for the coronavirus — and suggesting nobody will be allowed to

resume "normal life" without a <u>"digital certificate"</u> to prove they have been vaccinated — is proving extremely unpopular with internet users.

Instagrammers are hitting back against Bill Gates, punishing his posts with thousands upon thousands of angry messages telling him to stop experimenting with the health of "lesser humans" or expect to be charged with "crimes against humanity."

The article goes on to point out that:

Many users also commented on the fact Bill Gates has been deleting the torrent of critical comments from his page.
