RESEARCH AND CREATIVE ACTIVITY:

I. Coping Responses of Spouses of Myocardial Infarction (MI) Patients. California Nurses Foundation W-P 860922. The overall focus of research has been investigating the coping processes of two groups of individuals at risk for ineffective coping and subsequent poor adaptive outcome. These have included the spouses of cardiac patients and subsequently vulnerable populations at risk for HIV infection and other infectious diseases. As delineated in the synopsis of each specific research activity, a complex and sophisticated building of knowledge within each area has been developed.

II. Nyamathi, A., Flaskerud, J. and Lewis, C. Counseling/HIV Testing for At-Risk Minority Women. National Institute on Drug Abuse, DA05565, 1988-1993.

This study was designed to assess the effect of a Specialized and a Traditional nurse counseling program on coping and adaptive outcome of African-American and Latina women at risk for HIV/AIDS (i.e., IDUs or partners of IDUs, etc).

III. Nyamathi, A., Flaskerud, J., Lewis, C. AIDS Program for Addicted/Homeless Minority Women. National Institute on Drug Abuse (NIDA), DA 06719, 1991-1995.

This recently completed four-year (1991-1995) longitudinal study assessed the effect of long-term education and counseling with 232 homeless and drug-addicted women at risk for HIV infection and their 232 supportive persons (SPs). HIV testing was offered at baseline, and at 6- and 12-month follow-ups to all women and their SP's.

IV. Nyamathi, A., Gelberg, L. Decision-Making Regarding Drug Use Among Homeless Women. NIDA, DA 09122, 1994-1997.

The study was designed to determine the etiology, nature, concomitants and consequences of drug abuse by homeless women with a history of recent drug use and seek a scientific basis for decision-making regarding drug use and risky sexual behavior in these women. A quantitative assessment was conducted with 1400 (900 recent drug-dependent and 500 non-drug-dependent) homeless women by nurses and outreach workers of the subjects' ethnicity.

V. Nyamathi, A., Flaskerud, J. Health Promotion Among Homeless Women at Risk for AIDS. National Institute of Mental Health (NIMH). MH52029-01A2, 1994-2000

The goal of this five-year study was to enhance health status among homeless women by conducting a two year longitudinal quasi-experimental study designed to assess the effectiveness of a Peer Mentored Program and a Case Managed Program on subjective and objective measures of risky behaviors, health protecting behaviors, and health outcome of 648 African-American, Latina and White women and 648 significant others (S0s) at risk for AIDS.

VI. Nyamathi, A., Wiley, D. HCV Screening Among Homeless Women and Their Intimate Partners. NIMH. Supplement, MH52029-01A2, 1999-2000.

Dr Nyamathi and colleagues initiated a post-hoc HCV prevalence study that included 884 homeless women and/or their partners. Findings revealed an overall HCV seroprevalence of 22%. Results of multiple logistic regression analysis controlling for clustering within couples indicated that older age and lifetime drug history of IDU independently predicted anti-HCV test positivity (p < .001). A lifetime history of methamphetamine use was also found to independently predict a positive anti-HCV test result (p = .05). Regression results also revealed that IDUs had over 25 times greater odds of having HCV infection than non-IDUs. Also, homeless adults who were on their own before the age of 18 and those homeless for greater than two years were significantly more likely to be HCV-infected than those not reporting these characteristics (Nyamathi et al., 2002). Importantly, homeless adults who reported a history of drug and mental health treatment were more likely to be HCV-infected.

VII. Nyamathi, A., Morisky, D., & Gelberg, L. TB/HIV Risk Reduction with Homeless and Drug Addicted. NIDA, DA11145, 1998-2003.

Currently, Dr. Nyamathi serves as PI in a five-year NIDA-funded grant: TB/HIV Risk Reduction with Homeless and Drug Addicted Persons. This prospective five-year study using a two-group quasi-experimental design will evaluate the effectiveness of a nurse case-managed, incentive-based intervention program focused primarily on compliance with TB prophylactic treatment, and secondarily on HIV risk reduction, with 400 sheltered men and women in the high TB prevalence area of Skid Row in downtown Los Angeles.

VIII. Nyamathi, A., Robbins, W. Assessment of HCV in Semen of HCV-Infected Homeless Men. UCLA School of Nursing Intramural Award, 2000-2001.

In this pilot study, our purpose was to assess and quantify HCV RNA in the seminal fluid of 100 homeless men by means of branched DNA, and by so doing, shed light on whether sexual transmission of HCV is possible, and whether HCV RNA viral load in the semen is associated with HCV viral load in blood plasma and with demographic and behavioral risk factors. Current literature supports the fact that HCV in the semen is observed in less than 5% of participants.

IX. Nyamathi, A., Koniak-Griffin, D. HIV Vaccine Preparedness Among High Risk Homeless. UCLA, School of Nursing Intramural Award, 2002-2003.

For this intramural grant, our goal is to conduct the Phase I in-depth qualitative assessment via focus group methodology with 60 primarily racial-ethnic minorities at high risk for HIV and who reside in low-income apartments, homeless shelters, and run-away youth residence sites. The research aims are to 1) understand the decision-making processes of high risk participants in considering participation in future HIV vaccine trials (HIVVTs); 2) describe their facilitators of and barriers to being retained in future HIVVTs; 3) describe the potential impact of HIVVT participation on risky drug and sexual behavior; 4) revise in a culturally-sensitive and linguistically-appropriate manner the CDC Vaccine Attitude Survey on HIVVT, based on suggestions from focus groups and assistance from a newly formulated Community Advisory Board (CAB); and 5) ascertain recommendations for preparing the high-risk groups to participate in HIVVTs.

X. Nyamathi, A. International Training Grant in Epidemiology Related to AIDS ISM. National Institute of Health Fogarty Supplement. TW00013, 2002-2003.

The purpose of this supplement is to build on well developed linkages between UCLA Fogarty AIDS International Training and Research Programs (AITRP) and the Homeopathy component of the India System of Medicine (ISM) and to extend these linkages to the Ayurvedic program and CCRA. The linkage of UCLA Fogarty AITRP to these programs for traditional therapies will provide opportunities to obtain objective data, relative to their therapeutics and/or as complementary to modern allopathic medicine. A plan will be developed for education and capacity-building programs to include: 1) post doctoral training at UCLA with 2-year in-country follow-up; 2) in country training courses, workshops and consultations, developed and conducted as joint endeavors at UCLA with CCRA and Homeopathy. Similar production and training programs will be developed with the CCRA.

XI. Nyamathi, A., AIDS Prevention with Traditional Systems of Medicine (ISM). AIDS Institute International Activities Core. 2002-2003

In this grant, we propose to conduct a two-phased study in two Indian sites, which contain key Homeopathy Medical colleges and clinical facilities. In Phase I, in-depth qualitative assessments will be conducted by focus group methodology with 40 randomly selected Homeopathy educators as well as 40 randomly selected and currently active Homeopathic practitioners to examine and evaluate their training in terms of HIV education and prevention as well as their delivery of prevention modalities,

especially HIV/AIDS prevention messages. Feedback on a developing ISM Practitioner Survey will be reviewed with each focus group and by a newly created Community (aka Professional) Advisory Board (CAB), representative of leaders in the Homeopathy educational institutions and of active Homeopathy practitioners. Moreover, we will determine the applicability of community-based participatory approaches for the future development and implementation of an AIDS education and prevention training program utilizing Train the Trainer processes. Phase II will pilot test the revised ISM Practitioner Survey, which will have been suitably modified according to the local values and needs of this professional community, with a sample of 30 Homeopathy practitioners. The outcomes in this study will be to gather information on promoting best practices in the future development and implementation of a HIV Education and Prevention program for Homeopathy providers.

XII. Nyamathi, A et al. HBV Prevention for Homeless At-Risk for HBV/HCV/HIV. NIDA. DA016147. 2003-2008

In this prospective four group quasi-experimental design, we will evaluate with approximately 1254 sheltered men and women in the Skid Row area of Los Angeles, the effectiveness of a theoretically-based HBV vaccination intervention focused primarily on completion of the HBV vaccination series and secondarily on HBV/HCV/HIV risk reduction. We will also evaluate the relative cost of each of these programs in terms of completion of HBV vaccination, the cost effectiveness of improving vaccination completion, the cost per seroprotected case, and the cost per infection prevented. Once determined eligible, participants will be randomized by shelter into one of four programs: a Nurse Case Managed Plus Incentive (NCMI) program, a Nurse Case Managed without Incentive (NCM) program (both of which provide tracking), an Incentive with tracking (IT), and an Incentive-Only (I-O) program without tracking. The proposed study is innovative in that the inclusion of an NCMI program, an NCM program, an IT program, and an I-O program will allow us to look at individual effects of nurse case management and incentives separately, the joint effect of both together, and the impact of tracking in terms of completing the HBV vaccination series. Participants in all four programs will receive the 3-series vaccination by trained research nurses at the study clinic over six months, along with either an enhanced HBV/HCV/HIV education program (NCMI and NCM), or a brief HBV/HCV/HIV (IT and I-O) education program. All participants will be assessed at baseline and six- and twelve-month follow-up using a battery of psychosocial, behavioral, health and physical status, as well as HBV, HCV and HIV serostatus measurements. This proposal is focused on assessing the effectiveness of intervention programs promoting the prevention of medical consequences of HBV/HCV/HIV in homeless and drug-abusing populations.

XIII. Nyamathi et al. Alcohol Use Reduction in Methadone Individuals with HCV. National Institute on Alcohol Abuse and Alcoholism (NIAAA). AA015759, 2006-2008

The purpose of two-phased exploratory R21, is to explore a qualitative assessment with 40 opiate maintained (OM) HCV-infected adults, 20 moderate alcohol users and 20 heavy alcohol users, equally divided by gender and readiness to change alcohol use: 1) factors impacting access to alcohol use reduction and health promotion services and free vaccination for HAV/HBV; and 2) strategies that MM staff can use to assist their clients in seeking services. Staff of a MM clinic will also explore the feasibility of providing these services. Phase II will pilot an alcohol use reduction and liver health promotion intervention with 250 eligible, HCV-infected, alcohol-using OM clients receiving MM. Two intervention groups incorporating MI) will provide on-site brief MI (3 sessions) counseling to participants using either one-on-one delivery (MI-Single) or the group-delivery (MI-Group). In addition, each group will be offered the Liver Health Promotion (LHP) program, which includes a 30-minute health promotion education session, referral to a community 12-Step alcohol outpatient program, and an offer for free screening for HAV/HBV, and the HAV/HBV vaccination series, if eligible (defined as being HAV and/or HBV seronegative). A third group, the Usual Care (UC) group will receive the same components offered to the intervention groups except for a time balanced on-site brief 3 session health promotion counseling as opposed to the MI. The short-term goals of the proposed study are to refine strategies that can be fully tested in a large-scale intervention trial. The long-term goals are to contribute to knowledge about promoting alcohol-related health-seeking and treatment completion behaviors in MM clinic settings that serve OM HCV-positive clients, so that population-specific intervention strategies can be developed.

XIV. Nyamathi et al. An Arts Intervention for Drug-Using Homeless Youth - Phase I. NIDA. DA023521, 2008-2011

In this two phased investigation, researchers, homeless youth and staff from a drop-in site frequented by homeless youth, along with our CalArts partners, will participate in the development, pilot testing and evaluation of a youth-centered drug-use and health-promoting intervention program. In Phase I of this R21, a CBPR approach will be utilized with a steering committee to develop a youth-centered drug use and health promoting intervention program, Art Messaging which will be assessed in terms of acceptability via focus group sessions with street youth and subsequently refined based upon homeless youth feedback. In Phase 2, investigators and community partners will conduct a pilot study to explore the acceptability of the Art Messaging program as well as test the impact of the program, compared to a control group, with 128 similar youth in terms of: completion of the program; reduction of risky drug and alcohol use; completion of a HAV/HBV vaccine series; and improvement in knowledge about hepatitis. The short-term goals are to refine strategies that can be fully tested in a large-scale intervention trial. The long-term goals are to contribute to knowledge about promoting innovative and youth-designed drug-related behaviors, and treatment completion in settings where youth congregate.

XV. Nyamathi et al. ASHA HIV Health Promotion Intervention in India. NIMH. MH082662, 2008-2011

In this study, village women in India, living with HIV (WLH), along with researchers from the US, HIV & TB experts from the Indian Council for Medical Research and the AII India Institute for Medical Sciences will plan an intervention designed to support women who are receiving treatment and care for HIV and TB, and to help promote their adjustment to illness and improve their health as it relates to their coping and behavioral responses and physical health outcomes. This intervention, delivered by specially trained village women (ASHAs), will then be tested with WLH to assess how acceptable and effective the intervention might be compared to WLH who receive usual care. We anticipate this three-year study will lead to a culturally tailored intervention that will be tested in a larger study.

XVI. Nyamathi et al., HBV Prevention for Homeless At-Risk for HBV/HCV/HIV. DA016147, NIDA, 2009-2014.

The purpose of this study is to design a program to assist young homeless stimulant-using gay and bisexual homeless men to complete the HAV/HBV vaccine and in reducing drug and sexual activity. We will evaluate the effectiveness of a program, which includes specialized education, and contingency management and tracking with a standard program, including brief education, contingency management and tracking with these young homeless men. This study combines optimal strategies to approach, engage and intervene with a hidden and high-risk population to assess interventions that may prove beneficial in preventing HBV and HAV infections. We will also assess the cost of these programs in terms of completion of the HAV/HBV vaccination series. As Stimulant use threatens to increase risk of exposure to HAV and HBV, particularly among young users who may not yet be HBV-infected, this research is targeted to engage this group in treatment, until they are suitably protected from HBV, and hopefully reduce risk for HCV and HIV as well.

XVII. Nyamathi et al. Health Promotion Coaching Vaccine for Homeless Parolees. NIDA, DA027213, 2009-2014

The purposes of this study are to conduct a prospective, three-group study that randomly assigns recent ex-offenders attending a residential drug treatment program into one of three levels of intensity. Peer coach and nurse-partnered intervention programs were studied, specifically, a peer coach and nurse case managed (PC - NCM) program, (2) peer coaching (PC) program with brief nurse counseling; and (3) a usual care (UC) program with brief peer coaching and nurse counseling in a RCT. The proposed study will assess the effectiveness of three programs on reducing rearrest among recently released homeless ex-offenders at six- and 12-month follow-up.

XVIII. Nyamathi et al. Asha Improving Health and Nutrition of Indian Women with AIDS and Their Children. National Institute of Mental Health, MH098729-01, 2013-2018

The proposed longitudinal study will use a 2x2 factorial design, and randomize 600 Women Living with AIDS (WLA) and their children into four groups: 1) Asha support alone for WLA; 2) Asha support for WLA + nutrition (foodbased) training; 3) Asha support for WLA + food supplementation; and 4) Asha support for WLA + nutrition training + food supplementation. The primary outcome of the intervention is to test the effects of nutrition training and/or food supplementation on primary outcomes of anthropometric parameters and immune status (CD4 levels) of the WLA at 6-, 12and 18-month follow-up; and secondarily on ART adherence, psychological health, nutritional adequacy and lipid status of the WLA.

XIX. Nyamathi et al. Homeless Female Offenders Returning to the Community: Improving Hopeful Futures. National Institute on Drug Abuse. DA035409; 2014 – 2017.

The proposed study will utilize our successful community participatory approach to engage a vulnerable group of women who experience major health and social disparities as a result of incarceration. A gender-sensitive criminogenic needs-focused intervention program designed to reduce and or prevent relapse to drug use, recidivism, and eliminate or prolong number of days to re-incarceration will be examined. We will randomize 130 HFOs participating in one of two residential drug treatment programs to assess the impact of the FEM-CARE or a Health Promotion control program on reduction of drug and alcohol use and recidivism.

XX. Nyamathi et al. Nurse-Led Community Health Worker Adherence Model in 3HP Delivery among Homeless Adults at Risk for TB Infection and HIV. National Institute on Minority Health & Health Disparities. R21- D012696; 4/3/2018-11/30/2019

In this proposal, we will develop and pilot test an innovative, community-based directly observed intervention, including delivery of the 12-dose therapy (3HP; rifapentine [RPT] plus isoniazid [INH]) weekly. We will address critical individual level factors which are potential mechanisms that underlie health disparities in completing TBI treatment among the predominantly minority homeless. We hypothesize that improving these conditions, and promoting health by focused screening for TBI, and early detection and treatment for these vulnerable adults will improve TB treatment completion and prevent future TB disease.

XXI. Nyamathi, et al. Development of a Community-Based HCV Treatment Completion Intervention Among HCV Positive Homeless Adults. National Institute on Minority Health & Health Disparities. R21 – MD013580; 09/20/2019-06/30/2021.

Factors associated with low adherence to hepatitis treatment among homeless adults include untreated mental illness, ongoing drug and alcohol use, unstable housing, and limited access to care. To address these disparities, we will pilot test a theoretically-based innovative model of care, successfully implemented by our team in other vulnerable populations, among HCV-infected homeless persons. Utilizing a community-based delivery approach, a community health worker (CHW), guided by a registered nurse (RN), will deliver a CHW/RN program, with HCV medication treatment delivered using directly observed therapy (DOT) to eligible HCV-infected homeless adults.

XXII. Nyamathi, et al. Exploration of the Impact of Homelessness on Risk for COVID-19 Infection and Substance Use Patterns among Substance-Using Homeless Adults. UCI office of Research Craft-COVID. 06/19/20 – 05/31/2021

This grant aims to examine COVID-19 epidemiology among homeless persons who use substances (HPWUS). HPWUS is among the most vulnerable groups for COVID-19 infections, but little research has been conducted to understand the effect of substance use on SARS-CoV-2 infection onset and progression of CPVOD-19 disease. The findings from this study can inform developing intervention programs to reduce substance use and COVID-19 infections.

XXIII. Nyamathi, et al. UCI- Susan Samueli Integrative Health Institute. Impact of Community-Based Biofeedback Program on Drug Use and Mental Health among People Experiencing Homelessness"

This application aims to refine and pilot test a study focused on providing a critical understanding of the impact of

Heart Rate Variability-Biofeedback (HRV-BF) on homeless and unstably housed adults who have a history of drug and alcohol use, as well as depression during COVID-19 pandemic.
