### From the President

I would like to keep everyone informed on what is going on with the Chamber's Business Development initiatives.

The primary goal of the Business Development Specialist and the Small Business Resource Center is to enable individuals to obtain the necessary guidance, information, and education to start their own small business.



The Chamber provides direct assistance, as well as offering an incubator space and scholarships to these entrepreneurs, which helps to ensure their success.

A secondary goal is to increase the number of successful and expanding businesses and to reduce unemployment, therefore, creating a better way of life for these women and men of the Pocono Mountains region.

The Resource Center and Business Development Specialist have served 2400 individuals (1853 (77%) of them being women) who wanted to open a new business or purchase one, through one-on-one counseling and group workshops since November 1999. From this group more than 292 (12%) of them have actually opened a business or purchased one. Of these new businesses, (191 (65%) of them are women or women were involved). Currently the Chamber is working with 17 more who are in the process of opening their own business or purchasing one. Our Business Development Specialist also has worked closely with more than 780 existing businesses, helping them to survive, expand, grow, refinance, or connect with the right resources.

These businesses have directly created more than 600 meaningful employment opportunities throughout the region.

One of the greatest achievements of the Business Development Specialist in the past three years is assisting businesses to secure financing they needed to start, expand, or survive. Businesses received more than \$400,000 from MetroAction, \$85,000 from NEPA, and \$2,000,000 from local banks.

Outcome Objectives for 2006:

- Increase the number of successful small businesses owned by women at least by 10%.
- Expand the amount of information, educational opportunities, and services available to entrepreneurs.
- Increase the number of people being offered direct help that want to start or expand their businesses within the next year by at least 10%.
