Since the final rule on pipeline operator qualification (OQ) was issued in 2002, there have been several initiatives to facilitate compliance with varying OQ requirements overseen by natural gas utilities and the countless contractors who build gas distribution infrastructure on their behalf. In 2016, the DCA established a task force to investigate whether and how the industry can improve the OQ process and provide more consistency in compliance with operator OQ programs. The DCA OQ Integrity Coalition is now gauging interest of operators and regulators in participating in a pilot program in select states to test whether this updated approach could raise the bar in terms of the integrity of OQ programs while increasing consistency and providing a set of standardized processes. This panel discussion will provide the latest details about the OQ Integrity Program and plans to initiate a pilot.
