Conditions

No written or online reference materials may be used during the exam.

The exams are taken online via the Deltek Learning Zone. Access to the exam is included for all users who have a subscription to use the Deltek Learning Zone. If you are not a subscribed customer, the course can be requested and purchased by following the steps shown on the screen. The exam must be completed in a single session of up to 120 minutes, with up to two attempts to successfully pass the exam.

Maintaining Deltek Costpoint Certification

Certification will be valid for up to 2-years and can be renewed by passing the New Release exam. The exam will be available at least 90-days following the release of new Costpoint training series by Deltek.

Also knowledge of creating and setting up different types of contracts like Cost Plus, Fixed Fee, Milestone, and Time and Material, along with the differences between a Project Labor Category and General Labor Category and the role of the Rate Sequence Table.
