


Oak Grove Area Improvements

- The former sports field #2 and associated parking lot expansion has been de-funded and removed from the CIP project description.
- This design exercise is for the implementation of specific projects. It is NOT a master planning exercise in itself, however the results can be used as the basis for a Master Plan revision.
- The stakeholder group will to assist the City in developing a design that meets the City's and Public's desires for HWP.
- Time is of the essence!






