
Príncipes in DM

- · Base taxonomy only (published by regulators, no changing/extending taxonomies).
- Zip needs to contain http/https folder structure. No need for Arelle
- · Template based (published as Business Content on SMP or generated with template generator)




1. Report for taxonomy



Upload tax (base only)








2. Entry Point activation (Fiori application)


This is a prerequisite step for the Template creator. The application launches a process, which is executed by the Task Engine ("the TE creates an XML that JAVA processes and loads into DB")



Tip: for entry point, do a search on "/mod/" folder



Note: If you randomly pick an entry point, it will fail




Check the Task Monitor




Example of an error (when selecting invalid entry point)








3. Template creator (Fiori application)


Select entry point (from previous step)




3. XBRL instance

NOTE: the XBRL instance is also the document used for the mapping (not like US, where XBRL instance is separate from Data Cache)


3.1 Report type







Upload the structure (xml file created by template creator)




Upload content via Batch tool Adjust the .bat file (created by template creator)




Run batch file (this calls the DM BatchTool.exe) Note: make sure workflow has started





Configuration tab

Note: All relevant information on elements/units, link to taxonomy, scheme name etc. is on this tab This document has, therefore, all meta-data and data for the XBRL generation





Overview of Parameters

"Use integrated plugin version:"

- Always select "latest". Do not get confused that it says something about SP03 or SP05. We are already on SP12, but these values do not get updated ...

Start of Current Period / End of Previous Period / Start of Previous Period:

- You have to fill some dates there. Not import which one, but has to be before "End of Current Period".

End of Current Period:

This is your reference day for reporting. E.g. 31st December 201x. This will go into the XBRL instance.

Entity Schema:

Customer should know. Normally, it will be http://standards.iso.org/iso/17442

Entity ID

Customer will know. Some ID number, each customer will get from the regulator.

Taxonomy Context

Period\report\chapter of where you have uploaded the taxonomy

Truncate open table worksheets after this number of rows:

In open tables, the Excel preview is configured to stop after this number of rows. Reason is that there might be many, many rows inside. However, if the number of rows exceeds the configured value, all rows (including the one from the Excel document) are written to a CSV file.

Number of decimal places for decimal values / monetary values / percentage values

Write, whatever you want – these numbers are ignored.

Precision of monetary values (e.g. "-3" = precision of thousands):

- Important for EBA scenarios.
- Ignored for Solvency II scenarios in those the "decimals" value has to be chosen automatically depending on the size of the reported value.

All other parameters: Default values.




Execution

Data is entered in chapters (excel files). These are the file uploaded in the setup (created by Template Creator or downloaded from SMP


Each file normally has 3 sheets (Presentation /DataLayer / BD1)

Data is "entered" in BD1 (note: in reality, not manually entered – it is some datalink to another DM chapter (or BW data-source) that holds the data.



Once all mapping is complete, the XBRL can be generated. At Report level, use "Create" (like US). This creates task and the Task Engine will execute (check TE Monitor)


Revision has zip files with instance + validation reports + preview files











Analysis of XBRL instance

Within the Excel files, there are (hidden) tags in columns and rows. There is also an EOF marker (nothing beyond the marker gets included in instance)



The chapter names (generated by Template Creator) also have "meaning", these are used in the XBRL instance






An example of the XBRL instance

- · Unit information (from Configuration tab)
- · Context: a combination of Excel tags, Chapter information (note: cell reference G16 visible in XBRL)
- · Entered value

Web preview (Note: can be viewed with IE only)




Excel preview is same - just the Excel file, rather than HMTL files




Validation

DM will generate an Excel file, with three tabs (Details, Consistency, Validation Details=some meta-data (when and who generated etc.)
Consistency= data type + ambiguous data checks
Validation= Formulas / Assertions



Example of Validation check



The report will shows the "rule_id", the details of these are normally explained on website of regulator

Note: some assertion checks can be avoided, see SAP Note 2296488. (only possible since SP06)


2. Massdata

Purpose: performance (for large data entry) NOTE: Not related to Mass Data link in DM !!!

In Template generator – set CSV (tick)




Creates csv files





In Report – Excel links to csv (has just one row)
Data in loaded into CSV (multi-rows), there is no entry in BD sheet!
During XBRL generation, DM processes the one line – but does this for each line in CSV (and thus all data will be included in XBRL instance)





3. PDF option

Introduced in Stack 1200, see https://blogs.sap.com/2018/03/12/dm-stack-1200-available/ Only used for Belgium specific requirements, it encrypts PDF files into the XBRL








In the specified folder, you copy this PDF file, together with the XBRL instance
