NAMING RIGHTS: In 2010, Sun Life Financial entered into a five-year contract with Sun Life Financial for the naming rights to the stadium. The contract will pay \$7.5 million per year for the naming rights.

UPDATE: The University has decided to expand Kenan Memorial Stadium. Alumnus Charlie Loudermilk Sr. made a \$7.5 million commitment that will create "The Loudermilk Center for Excellence," a 150,000-square-foot facility being built on the stadium's east side. The center will serve all of Carolina's nearly 800 student-athletes across 28 sports.

As part of the Kenan Stadium renovation project, the Loudermilk Center is scheduled for completion in September 2011. The \$70 million project is being funded by private gifts and premium seating sales. It will provide new classroom space for athletes, an advanced computer lab, a writing lab, reading rooms, and office space. The facility will also house a new strength and conditioning center for Carolina's Olympic Sports Programs.

NAMING RIGHTS: The university decided to name the stadium after the Kenan family for their generous donations and dedication to the university and its athletic programs.

NAMING RIGHTS: The stadium was officially renamed from Jones Stadium to Jones SBC Stadium in 2000 following major corporate gifts (in excess of \$25 million) from SBC Communications (now AT&T). The stadium was renamed again in 2006 to Jones AT&T Stadium after SBC changed its name to AT&T. The "Jones" in Jones Stadium comes from former Texas Tech President Clifford B. Jones.

The stadium also has served public service purposes over the past year. In May 2011, the first annual Nippert Stadium Steps Challenge took place for Cincinnati students to raise money for underprivileged students in public schools.

NAMING RIGHTS: The stadium was named after Gamble's grandson, James Gamble Nippert. Nippert was a UC football player who was injured during a 1923 game and died as a result of his injuries.

UPDATE: Beginning the week of April 25, 2011, the turf at Rentschler Field was replaced. After eight seasons, the State of Connecticut and UConn decided that it was time for an upgrade. The replacement is the result of regular wear and tear on a football field.

NAMING RIGHTS: The stadium is named after Frederick Brant Rentschler. Rentschler was the founder of the aircraft company Pratt & Whitney, which created revolutionary aircraft engines.

Louisville is in the process of adding 33 luxury suites, 1,750 upscale lodge seats, and an expanded upper deck.

NAMING RIGHTS: Papa John's Pizza founder and CEO John Schnatter, a native of nearby Jeffersonville, Indiana, donated \$5 million for the naming rights to the stadium.

Early estimates are that between 2,500 and 4,000 seats will be added.

On January 1, 2011, Heinz Field hosted the NHL Winter Classic. The game was between the Pittsburg Penguins and the Washington Capitals.

NAMING RIGHTS: H.J. Heinz bought the exclusive naming rights for the Steelers' home field for \$57 million. The deal expires in 2021 and has an average annual payout of \$2.9 million.

UPDATE: Almost half of the \$7.8 million in public money going toward renovating Raymond James Stadium in 2011 will be spent on the luxury suites. The money, which mostly comes from tourist taxes, will pay for new carpeting, furnishings, ice makers, and refrigerators in the 195 suites.

Over the next two years, the Hillsborough County Administrator projects spending nearly \$18.7 million in maintenance and replacement work. This includes nearly \$1.2 million on stadium seats and \$1 million on the sound system. The largest future expenses will be the new scoreboard, estimated at \$7.7 million.

During the summer of 2011, Raymond James hosted Kenny Chesney along with Zac Brown Band and other country groups. Sports Authority netted record profits after the concert, some of which will go toward renovations in the future.

NAMING RIGHTS: Raymond James Financial purchased the naming rights for \$32.5 million over 13 years. Raymond James naming rights extend through 2015.

UPDATE: Because of Boise State's great success over the past five years, Athletic Director Gene Bleymaier has stated there are major plans in the works for renovating Bronco Stadium. The master plan calls for an expansion in many phases from 33,500 to 53,000 seats. Most of the early expansion would be focused on the north end zone, where a two-story complex would be built to house the football offices, weight room, training room, equipment room, and locker room. The facility would replace the Clunky Varsity Center. The project would cost up to \$100 million.
