About the Foster Care Association of Victoria

Foster care is the temporary care of children in the home of trained, assessed and accredited foster carers when they are unable to remain safely with their biological families, for a period of time. These dedicated, volunteer foster carers play an important role in giving these children loving and safe homes and helping to improve the quality of their lives now and into the future.

The Foster Care Association of Victoria's mission is to strengthen foster care in Victoria by enhancing carers' ability to improve the lives of the young people in their care. As the peak body, we are an independent and confidential resource for foster carers, and represent them through our work with government, agencies and getting the voice of carers into the media.

By fundraising for the Foster Care Association, you are enabling it to strengthen over 2400 foster households across Victoria. Our work directly impacts the care provided to the thousands of Victorian children and young people in foster care, enabling carers to better provide a positive and healing environment and to help the children in their care to flourish.

- In 2015/16 there were over 12,450 Victorian children in Out of Home Care, which includes foster care. (Australian Institute of Health and Welfare 2016. Child protection Australia: 2015-16.)
- There are a variety of reasons why children are placed into foster care, including abuse, neglect, extreme poverty, homelessness or family breakdown. Sometimes, the reasons for entry to care are not directly the fault of the child's parents or guardians; inability to secure work or housing, poor health, disability and social isolation and even death can all be key contributors.
- The number of Victorian children reported to child protection authorities for suspected abuse, neglect, maltreatment or family violence has risen by 61% over the last decade. This situation leaves children requiring protection, at risk of not receiving the care they desperately need.
- In 2017, there are 2400 foster carers in Victoria, taking care of over 9,700 children who are in out of home care.
- 53% of foster care households had more than one child placed with them as at 30 June 2016.
- Research has consistently shown that the provision of quality foster care to children in times of need, can vastly improve their future outcomes and greatly reduce their chances of future homelessness, unemployment, mental and physical health concerns, and involvement with the criminal justice system. - Geographically, the spread of carers is relatively even across the State, with slightly more in the south (including Southern Melbourne, Gippsland and Bayside Peninsula) and west (including Western Melbourne, Barwon and Central Highlands) regions.
- Annual operating costs for The Foster Care Association of Victoria are about \$570,000.

Ten Steps to Successful Fundraising (and your checklist)

The following ten steps will help ensure your fundraising activity is as successful as possible.

1. Plan your event or fundraising activity

Decide what you are going to do to raise money. Choose a date for your event, making sure you have plenty of time to plan and promote it.

2. Set your fundraising goal

How much are you hoping to raise? While we encourage our supporters to be ambitious with their targets, we also want to remind you to ensure it is achievable.

- \$100 will welcome new carers and regularly keep Victoria's foster carers informed so they can provide the best care to their foster children.
- **\$230** will ensure a foster carer can be supported through our Carer Support Line when they need it most.
- **\$400** will provide a full day training workshop for a foster carer so they can learn additional skills to best support their foster child/ren.

3. Complete and submit a Request to Fundraise form

It is important to receive the appropriate authority from us before you begin fundraising. This can be achieved by completing a <u>Request to Fundraise</u> form and submitting it to FCAV. (See Appendix A).

4. Create your own online fundraising page

FCAV is registered with GoFundraise (www.GoFundraise.com.au) and Everyday hero (www.everydayhero.com/au) and that means you can easily create your own fundraising page online. See 'Setting up online fundraising' section of this document for more details.

5. Be the first to donate

The phrase 'lead by example' is certainly important when it comes to fundraising. Demonstrate that you believe in what you are doing and the cause you are raising money for by making a donation to your online page. Remember, the first few donations set the scene to what the other donations might be – so aim for a \$50 gift if you can.

6. Reach out to family and friends

Get in contact with your closest friends and family members to ask for a donation. Explain to them what you're doing, and why, and let them know that it is important to you that they support your fundraising efforts for FCAV.

7. Share the news at work

Book in a time to sit down with your boss and ask for their donation. Then have a chat with others in your workplace, in the tea room or the elevator, or better yet, send out an email. Also, if possible, consider asking your employer to match any donations that other employees give you. This is always a great way for a business to show they are socially-minded and boost your fundraising efforts at the same time.

8. Approach local businesses

Get in touch with the businesses you visit regularly, like your accountant, hair dresser, child care centre, cafe, and ask them for a donation to the Foster Care Association of Victorian behalf of Victorian foster families.

9. Spread the word

Sharing your fundraising initiative with as many people as possible will really help you achieve your target. One of the best ways to do this is to spread the word on social media, such as Facebook or Twitter, whatever site you regularly use. Share your fundraising page at least a few times a week and tell people why you've chosen to fundraise for FCAV. You can also send emails out to contacts you have in your address book and we have created an email template for you to use – see Appendix B. If you are hosting an event that is open to the wider community it will be useful to contact your local newspaper. (See Appendix C for media release template.)

10. Follow up and fundraise after your event ends

Sometimes people just haven't donated to your cause because they've forgotten about it or lost track of time. Don't be shy about following people up and sending our gentle reminders.

Once you've held your event or completed your activity be sure to contact everyone that you spoke with originally and let them know how you went. If you are just short of your fundraising target let people know and you may be surprised by a few last donations.







The Foster Case Association is registered with <u>Everyday Hero</u> and <u>GoFundraise</u> as such this makes it super easy for supporters, like you, who want to fundraise because you can do most of it (if not all of it) online.

Make sure your web page has some of you shining through. Add a photograph and, if possible, a video of you telling everyone why you're raising money for the Foster Care Association. This will make it more personal and inspire your friends and family to give.

1. In your browser type in: www.everydayhero.com/au




2. In the search box, type in 'foster care association of vic'. Hit the enter button.



3. You will be taken to the Foster Care Association of Victoria page. Click on 'start fundraising'




4. You will be taken to the following page, to create your Fundraising Page and Account




5. Firstly you give your page a title, pick a \$ target amount.




6. Fill out your personal details and choose to sign up with your Facebook account or your email account.




7. You are now given the option to add a profile picture, write a story about why you are fundraising and share your page with your networks.








8. Here is an example of what your page might look like. You can then share this page with your networks and ask people to donate. You can edit your page by clicking 'Edit this supporter page'.



9. To go behind the scenes and edit your campaign, go to your dashboard by clicking your name in the top right corner of the screen.



Good luck, and call us if you need assistance.



Ideally, if you have set up an online fundraising page through <u>GoFundraise</u> or <u>Everyday Hero</u> this takes out all the worry of having to handle cash donations.

However, some people may still want to donate to you via cheque or cash and you probably don't want to turn them



away. The following provides a basic process for handling cash donations and how to ensure they are received correctly by the Foster Care Association of Victoria.

Online

Funds raised at Go Fundraise and Everyday Hero are processed and forwarded to the Foster Care Association of Victoria Inc.

Offline

All funds raised (not those raised through GoFundraise or Everyday Hero or through the Association's website) need to be forwarded to the Foster Care Association of Victoria within 14 days from the date of your event.

There are a few key points to be noted when fundraising to ensure you comply with any fundraising legislation and you meet the responsibilities of a fundraiser.

- The fundraising activity is your responsibility, which includes the financial and administrative elements, including but not limited to raffles, door knocking, data tracking, event coordination etc.
- Before your fundraising activity can take place please submit a Request to Fundraise form to the Foster Care Association and have your activity authorised.
- Fundraising on behalf of the Foster Care Association requires *Authority to Fundraise* from the organisation. This can be obtained by submitting the Request to Fundraise form.
- You do not need an Authority to Fundraise from us when solely raising funds online e.g. via GoFundraise.
- The use of the Foster Care Association of Victoria name and logo will only be provided once you have been given written authority to fundraise.
- The Foster Care Association of Victoria is an equal opportunity organisation. We
 are not able to accept funds or donations, or requests to fundraise for events or
 from organisations that do not operate within our organisational vision, mission
 and/or values.
- Your fundraising activity must meet the requirements of relevant Australian and State laws and regulations. In Victoria, if you plan to raise more than \$10,000 you need to register as a fundraiser with the Consumer Affairs Victoria (www.consumer.vic.gov.au). For more information visit the Consumer Affairs Victoria's website (https://www.consumer.vic.gov.au/clubs-and-not-forprofits/fundraisers).
- You need to be clear in your dealings with any potential sponsors, supporters and
 the community that your event is not a Foster Care Association of Victoria event.
 However, you can promote your activity as an event supporting the Foster Care
 Association of Victoria, such as 'this event proudly supports the Foster Care
 Association of Victoria'.
- If you intend for your fundraising activity to take place in a public area, remember to check with local council and obtain any required permit, especially if you are handling food and/or alcoholic beverages.

- If required, you will need to ensure appropriate insurance cover is arranged before your fundraising activity. The Foster Care Association of Victoria's insurance policy does not cover activities conducted by other, outside organisations and groups.
- If you are raising money for The Foster Care Association of Victoria through your intermediate charity (e.g. Rotary Australia, Lions Club Australia) you may directly provide your own receipting as appropriate to donors.
- You may not directly provide The Foster Care Association of Victoria branded or authorised receipts as part of you fundraising effort.
- If you require receipts to be issued to your donors, please provide all appropriate information to The Foster Care Association of Victoria for receipts to be issued.
 This must include: date, event, name, address, a contact phone number, and amount donated. This information must be submitted in writing within 10 working days of the event. Receipts will not be issued prior to The Foster Care Association of Victoria receiving the donated funds. Receipt requests must not exceed the total donated amount.
- If your organisation requires a receipt for your fundraising effort, this request must be made in writing within 10 working days of the event. Receipts will not be issued prior to The Foster Care Association of Victoria receiving the donated funds.
