ABSTRACT

The documents in this package focus on the three basic questions raised by Watergate: (1) Should President Nixon have been impeached?; (2) Should he have been prosecuted?; and (3) Should he have been pardoned? These documents do not begin to tell the whole story of Watergate, but they do suggest some of the issues involved. "Suggestions for Further Reading" will help readers sharpen their understanding of Watergate. The documents in this series include: (1) Richard M. 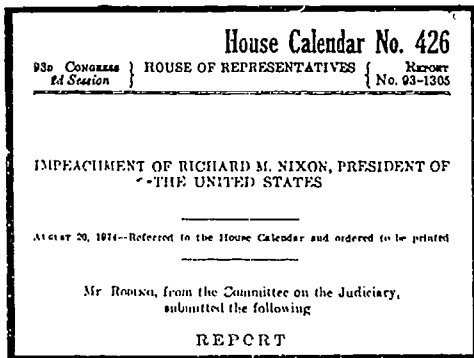



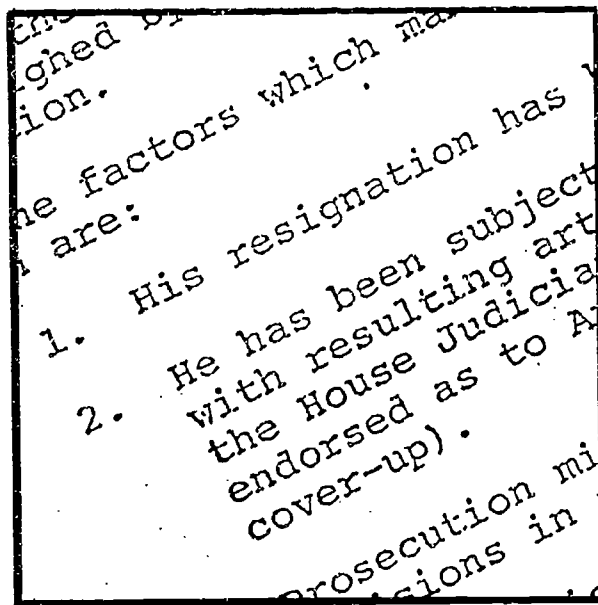

# ● Introduction

## A Historical Context for these Documents

In August 1974 Richard M. Nixon became the first American President ever to resign his office, a direct result of events known as "Watergate." The episode began June 17, 1972, when five burglars were arrested at the Democratic National Committee Headquarters in the Watergate office building in Washington, DC. The burglars had in their possession documents linking them with the Committee to Re-Elect the President. Nevertheless, the Nixon administration dismissed the episode as a "third-rate burglary," and Nixon was reelected by a landslide in November. Suspicions about Watergate persisted, however, and ultimately all branches of government became involved in investigations and decisions.

News reporters, particularly Bob Woodward and Carl Bernstein of the *Washington Post*, and congressional committees continued to uncover information about clandestine and criminal activities that pointed to White House involvement. In January 1973 four of the burglars and E. Howard Hunt pleaded guilty to the break-in, and G. Gordon Liddy and James McCord were convicted of burglary. The investigation broadened when a federal district court grand jury, with Judge John Sirica presiding, and the Senate Select Committee on Presidential Campaign Activities, chaired by Sam Ervin, began to investigate the break-in and related activities.

In April, as Watergate revelations pointed not only to White House involvement but also to a White House coverup, H. R. Haldeman and John D. Ehrlichman, Nixon's closest aides, and Attorney General Richard Kleindienst resigned. At the same time, the President fired his White House Counsel, John W. Dean.

In May Archibald Cox was appointed to head the Office of the Watergate Special Prosecutor in the Justice Department and was charged with continuing the investigations begun by the U.S. Attorney. The Senate Select Committee also began its televised hearings, during which Dean testified that the White House had been involved in a coverup of high-level involvement in Watergate and other illegal

activities. Furthermore, a Haldeman aide revealed the startling information that for years Nixon had secretly tape-recorded most Presidential conversations and telephone calls in the Oval Office and in his office in the Old Executive Office Building. The committee and the Prosecutor promptly subpoenaed the tapes, but Nixon refused to comply, citing executive privilege and national security.

The struggle for access to the tapes was fought in the courts throughout the summer of 1973, with both the U.S. district court and the court of appeals ruling that the President had to turn over the tapes to the Special Prosecutor. The President offered to supply verified tape transcripts, but Special Prosecutor Cox could not accept this compromise. In October Nixon fired Cox and returned the investigation to the Department of Justice. The subsequent public outcry against the so-called "Saturday Night Massacre," along with pressure from the Congress, forced Nixon to appoint a new Special Prosecutor, Leon Jaworski.

By the beginning of 1974, the House Committee on the Judiciary began deliberations regarding impeachment. In March the grand jury indicted Haldeman, Ehrlichman, former Attorney General John Mitchell, and others for perjury and obstruction of justice, named Nixon an "unindicted co-conspirator," and forwarded the evidence to the House Judiciary Committee.

Struggles for access to additional tapes continued. In April Nixon released edited transcripts to the House Judiciary Committee for use in its investigation, but he refused to provide copies of any additional tape recordings. In July, however, a unanimous Supreme Court forced Nixon to surrender the actual tape recordings. A week later, upon hearing the evidence within, the House Judiciary Committee adopted three articles of impeachment against the President, charging him with obstruction of justice, misuse of powers, and refusal to obey House subpoenas. President Nixon resigned the Presidency on August 9, 1974. President Gerald R. Ford pardoned Nixon

The documents in this package concern three questions that Americans and their government grappled with during the Watergate episode: Should President Nixon have been impeached, should he have been prosecuted, and should he have been pardoned? This package contains only a few documents for each question, but they provide a sampling of Watergate records. They also suggest why Americans held differing interpretations about Watergate at the time, as they do today.

The documents are from several record groups held by the National Archives and Records Administration. Document #3 contains two excerpts from transcripts of the tapes as used by the House Judiciary Committee, the full text of which comprises several hundred pages. "Unintelligible" appears frequently in the transcripts because sound quality was poor, other noises obscured conversations, and beginning words and low conversations were usually lost. The back cover shows a diagram of the Oval Office with the placement of microphones, labeled M-1, M-2, etc. The tapes themselves are surely among the most famous of primary sources. Researchers can listen to unexpurgated copies of them, as played for the jury in *U.S. v. Mitchell et al.*, at the National Archives in Washington, DC.

## IMPEACHMENT OF RICHARD M. NIXON, PRESIDENT OF THE UNITED STATES

The Committee on the Judiciary, to whom was referred the consid-  
eration of recommendations concerning the exercise of the constitu-  
tional power to impeach Richard M. Nixon, President of the United  
States, having considered the same, reports thereon pursuant to H.  
Res. 803 as follows and recommends that the House exercise its con-  
stitutional power to impeach Richard M. Nixon, President of the  
United States, and that articles of impeachment be exhibited to the  
Senate as follows:

### RESOLUTION

Impeaching Richard M. Nixon, President of the United States, of  
high crimes and misdemeanors.

*Resolved*, That Richard M. Nixon, President of the United States,  
is impeached for high crimes and misdemeanors, and that the follow-  
ing articles of impeachment be exhibited to the Senate:

Articles of impeachment exhibited by the House of Representatives  
of the United States of America in the name of itself and of all of  
the people of the United States of America, against Richard M. Nixon,  
President of the United States of America, in maintenance and  
support of its impeachment against him for high crimes and  
misdemeanors.

### ARTICLE I

In his conduct of the office of President of the United States,  
Richard M. Nixon, in violation of his constitutional oath faithfully

(1)

to execute the office of President of the United States and, to the best of his ability, preserve, protect, and defend the Constitution of the United States, and in violation of his constitutional duty to take care that the laws be faithfully executed, has prevented, obstructed, and impeded the administration of justice, in that :

On June 17, 1972, and prior thereto, agents of the Committee for the Re-election of the President committed unlawful entry of the headquarters of the Democratic National Committee in Washington, District of Columbia, for the purpose of securing political intelligence. Subsequent thereto, Richard M. Nixon, using the powers of his high office, engaged personally and through his subordinates and agents, in a course of conduct or plan designed to delay, impede, and obstruct the investigation of such unlawful entry ; to cover up, conceal and protect those responsible ; and to conceal the existence and scope of other unlawful covert activities.

The means used to implement this course of conduct or plan included one or more of the following :

(1) making or causing to be made false or misleading statements to lawfully authorized investigative officers and employees of the United States ;

(2) withholding relevant and material evidence or information from lawfully authorized investigative officers and employees of the United States ;

(3) approving, condoning, acquiescing in, and counseling witnesses with respect to the giving of false or misleading statements to lawfully authorized investigative officers and employees of the United States and false or misleading testimony in duly instituted judicial and congressional proceedings ;

(4) interfering or endeavoring to interfere with the conduct of investigations by the Department of Justice of the United States, the Federal Bureau of Investigation, the Office of Watergate Special Prosecution Force, and Congressional Committees ;

(5) approving, condoning, and acquiescing in, the surreptitious payment of substantial sums of money for the purpose of obtaining the silence or influencing the testimony of witnesses, potential witnesses or individuals who participated in such unlawful entry and other illegal activities ;

(6) endeavoring to misuse the Central Intelligence Agency, an agency of the United States ;

(7) disseminating information received from officers of the Department of Justice of the United States to subjects of investigations conducted by lawfully authorized investigative officers and employees of the United States, for the purpose of aiding and assisting such subjects in their attempts to avoid criminal liability ;

(8) making false or misleading public statements for the purpose of deceiving the people of the United States into believing that a thorough and complete investigation had been conducted with respect to allegations of misconduct on the part of personnel of the executive branch of the United States and personnel of the Committee for the Re-election of the President, and that there was no involvement of such personnel in such misconduct ; or

(9) endeavoring to cause prospective defendants, and individuals duly tried and convicted, to expect favored treatment and



consideration in return for their silence or false testimony, or rewarding individuals for their silence or false testimony.

In all of this, Richard M. Nixon has acted in a manner contrary to his trust as President and subversive of constitutional government, to the great prejudice of the cause of law and justice and to the manifest injury of the people of the United States.

Wherefore Richard M. Nixon, by such conduct, warrants impeachment and trial, and removal from office.

#### ARTICLE II

Using the powers of the office of President of the United States, Richard M. Nixon, in violation of his constitutional oath faithfully to execute the office of President of the United States and, to the best of his ability, preserve, protect, and defend the Constitution of the United States, and in disregard of his constitutional duty to take care that the laws be faithfully executed, has repeatedly engaged in conduct violating the constitutional rights of citizens, impairing the due and proper administration of justice and the conduct of lawful inquiries, or contravening the laws governing agencies of the executive branch and the purposes of these agencies.

This conduct has included one or more of the following:

(1) He has, acting personally and through his subordinates and agents, endeavored to obtain from the Internal Revenue Service, in violation of the constitutional rights of citizens, confidential information contained in income tax returns for purposes not authorized by law, and to cause, in violation of the constitutional rights of citizens, income tax audits or other income tax investigations to be initiated or conducted in a discriminatory manner.

(2) He misused the Federal Bureau of Investigation, the Secret Service, and other executive personnel, in violation or disregard of the constitutional rights of citizens, by directing or authorizing such agencies or personnel to conduct or continue electronic surveillance or other investigations for purposes unrelated to national security, the enforcement of laws, or any other lawful function of his office; he did direct, authorize, or permit the use of information obtained thereby for purposes unrelated to national security, the enforcement of laws, or any other lawful function of his office; and he did direct the concealment of certain records made by the Federal Bureau of Investigation of electronic surveillance.

(3) He has, acting personally and through his subordinates and agents, in violation or disregard of the constitutional rights of citizens, authorized and permitted to be maintained a secret investigative unit within the office of the President, financed in part with money derived from campaign contributions, which unlawfully utilized the resources of the Central Intelligence Agency, engaged in covert and unlawful activities, and attempted to prejudice the constitutional right of an accused to a fair trial.

(4) He has failed to take care that the laws were faithfully executed by failing to act when he knew or had reason to know that his close subordinates endeavored to impede and frustrate

lawful inquiries by duly constituted executive, judicial, and legislative entities concerning the unlawful entry into the headquarters of the Democratic National Committee, and the cover-up thereof, and concerning other unlawful activities, including those relating to the confirmation of Richard Kleindienst as Attorney General of the United States, the electronic surveillance of private citizens, the break-in into the offices of Dr. Lewis Fielding, and the campaign financing practices of the Committee to Re-elect the President.

(5) In disregard of the rule of law, he knowingly misused the executive power by interfering with agencies of the executive branch, including the Federal Bureau of Investigation, the Criminal Division, and the Office of Watergate Special Prosecution Force, of the Department of Justice, and the Central Intelligence Agency, in violation of his duty to take care that the laws be faithfully executed.

In all of this, Richard M. Nixon has acted in a manner contrary to his trust as President and subversive of constitutional government, to the great prejudice of the cause of law and justice and to the manifest injury of the people of the United States.

Wherefore Richard M. Nixon, by such conduct, warrants impeachment and trial, and removal from office.

#### ARTICLE III

In his conduct of the office of President of the United States, Richard M. Nixon, contrary to his oath faithfully to execute the office of President of the United States and, to the best of his ability, preserve, protect, and defend the Constitution of the United States, and in violation of his constitutional duty to take care that the laws be faithfully executed, has failed without lawful cause or excuse to produce papers and things as directed by duly authorized subpoenas issued by the Committee on the Judiciary of the House of Representatives on April 11, 1974, May 15, 1974, May 30, 1974, and June 24, 1974, and willfully disobeyed such subpoenas. The subpoenaed papers and things were deemed necessary by the Committee in order to resolve by direct evidence fundamental, factual questions relating to Presidential direction, knowledge, or approval of actions demonstrated by other evidence to be substantial grounds for impeachment of the President. In refusing to produce these papers and things, Richard M. Nixon, substituting his judgment as to what materials were necessary for the inquiry, interposed the powers of the Presidency against the lawful subpoenas of the House of Representatives, thereby assuming to himself functions and judgments necessary to the exercise of the sole power of impeachment vested by the Constitution in the House of Representatives.

In all of this, Richard M. Nixon has acted in a manner contrary to his trust as President and subversive of constitutional government, to the great prejudice of the cause of law and justice, and to the manifest injury of the people of the United States.

Wherefore Richard M. Nixon, by such conduct, warrants impeachment and trial, and removal from office.

MEMORANDUM FOR RECORD

On 26 June at about 10:00 a.m. I received a phone call from Mr. John Dean at the White House. He said he wished to see me about the matter that John Ehrlichman and Bob Haldeman had discussed with me on the 23rd of June. I could check this out with them if I wished. I agreed to call on him in his office in Room 106 at the Executive Office Building at 1145 that morning. Immediately after hanging up, I called Ehrlichman to find out if this was alright and after some difficulty I reached him and he said I could talk freely to Dean.

At 1145 I called at Dean's office and saw him alone. He said that the investigation of the Watergate "bugging" case was extremely awkward, there were lots of leads to important people and that the FBI which was investigating the matter was working on three theories:

1. It was organized by the Republican National Committee.
2. It was organized by the CIA.
3. It was organized by some other party.

I said that I had discussed this with Director Helms and I was quite sure that the Agency was not in any way involved and I knew that the Director wished to distance himself and the Agency from the matter. Dean then asked whether I was sure that the Agency was not involved.

I said that I was sure that none of the suspects had been on the Agency payroll for the last two years.

Dean then said that some of the accused were getting scared and "wobbling". I said that even so they could not implicate the Agency. Dean then asked whether there was not some way that the Agency could pay bail for them (they had been unable to raise bail). He added that it was not just bail, that if these men went to prison, could we (CIA) find some way to pay their salaries while they were in jail out of covert action funds.

I said that I must be quite clear. I was the Deputy Director and as such had only authority specifically delegated to me by the Director and was not in the chain of command but that the great strength of the Agency and its value to the President of the nation lay in the fact that it was apolitical and had never gotten itself involved in political disputes. Despite the fact that I had only been with the Agency a short time, I knew that the Director felt strongly about this.

I then said that big as the troubles might be with the Watergate Affair, if the Agency were to provide bail and pay salaries, this would become known sooner or later in the current "leaking" atmosphere of Washington and at that point the scandal would be ten times greater as such action could only be done upon direction at the "highest level" and that those who were not touched by the matter now would certainly be so.

Dean seemed at first taken aback and then very much impressed by this argument and said that it was certainly a very great risk that would have to be weighed. I repeated that the present affair would be small potatoes compared to what would happen if we did what he wanted and it leaked. He nodded gravely.

I said that, in addition, the Agency would be completely discredited with the public and the Congress and would lose all value to the President and the Administration. Again he nodded gravely.

He then asked if I could think of any way we (CIA) could help. I said I could not think of any but I would discuss the matter with the Director and would be in touch with him. However, I felt that I was fully cognizant of the Director's feelings in this matter. He thanked me and I left.

SUBJECT: Factors to be Considered in Deciding Whether to  
Prosecute Richard M. Nixon for Obstruction of  
Justice

In our view there is clear evidence that Richard M. Nixon participated in a conspiracy to obstruct justice by concealing the identity of those responsible for the Watergate break-in and other criminal offenses. There is a presumption (which in the past we have operated upon) that Richard M. Nixon, like every citizen, is subject to the rule of law. Accordingly, one begins with the premise that if there is sufficient evidence, Mr. Nixon should be indicted and prosecuted. The question then becomes whether the presumption for proceeding is outweighed by the factors mandating against indictment and prosecution.

The factors which mandate against indictment and prosecution are:

1. His resignation has been sufficient punishment.
2. He has been subject to an impeachment inquiry with resulting articles of impeachment which the House Judiciary Committee unanimously endorsed as to Article I (the Watergate cover-up).
3. Prosecution might aggravate political divisions in the country.
4. As a political matter, the times call for conciliation rather than recrimination.
5. There would be considerable difficulty in achieving a fair trial because of massive pre-trial publicity.



The factors which mandate in favor of indictment and prosecution are:

1. The principle of equal justice under law requires that every person, no matter what his past position or office, answer to the criminal justice system for his past offenses. This is a particularly weighty factor if Mr. Nixon's aides and associates, who acted upon his orders and what they conceived to be his interests, are to be prosecuted for the same offenses.
2. The country will be further divided by Mr. Nixon unless there is a final disposition of charges of criminality outstanding against him so as to forestall the belief that he was driven from his office by erosion of his political base. This final disposition may be necessary to preserve the integrity of the criminal justice system and the legislative process, which together marshalled the substantial evidence of Mr. Nixon's guilt.
3. Article I, Section 3, clause 7 of the Constitution provides that a person removed from office by impeachment and conviction "shall nevertheless be liable and subject to Indictment, Trial, Judgment, and Punishment, according to Law." The Framers contemplated that a person removed from office because of abuse of his public trust still would have to answer to the criminal justice system for criminal offenses.
4. It cannot be sufficient retribution for criminal offenses merely to surrender the public office and trust which has been demonstrably abused. A person should not be permitted to trade in the abused office in return for immunity.
5. The modern nature of the Presidency necessitates massive public exposure of the President's actions through the media. A bar to prosecution on the grounds of such publicity effectively would immunize all future Presidents for their actions, however criminal. Moreover, the courts may be the appropriate forum to resolve questions of pre-trial publicity in the context of an adversary proceeding.

6. There is a definite long-term interest in assuring full disclosure of public corruption.

The factors which mandate in favor of delaying this decision are:

1. Neither this office, Congress, nor the public has had sufficient time to consider the cataclysmic events which began only this Monday and ~~continue~~ <sup>ended</sup> on the President's resignation today.
2. This office will be reviewing important evidence which will have to be analyzed and weighed. This evidence may bear heavily on this decision.
3. Since both the factors which weigh in favor of and against the indictment and prosecution of Mr. Nixon implicate political considerations in the highest sense, it will be important in weighing these factors to determine whether the Congress and public coalesce behind a predominant view. Moreover, it will be important to consider how the public will view the decision in hindsight, after all the evidence is available.
4. There has been considerable concern about the interaction with and the affect of this decision on the Watergate trial. It now appears that there will be at least some delay in the trial, which will give this office more time to consider these interrelationships. In addition, there may be guilty pleas which could affect the decision of whether to indict and prosecute Mr. Nixon.

Finally, in weighing these factors, one should not ignore the possibility of a disposition of Mr. Nixon's offenses by a plea.

## Finding That 'Point of Pure Justice'

SPOKANE—“It's been very traumatic. People have cried and been down in the dumps. But now it's over and maybe we can talk about something else.”

That's how Spokane County's Republican chairman, Homer F. Cunningham, sums up the mood in this city of 170,000 in the hills of eastern Washington. This has been Nixon country for a long, long time. But when President Nixon resigned and his portrait at the U.S. pavilion at Expo '74 was taken down, the first general reaction here as elsewhere was relief.

In more than two dozen conversations with civic leaders and ordinary voters here, another theme emerges as well. For many, Mr. Nixon's downfall has become a matter of law, not politics. That attitude, if widespread, could have tremendous bearing on long-term public opinion about whether and how the former President should be called to account.

According to persons active in both parties here, most Spokanites discounted Watergate, until very recently, as another partisan fracas, a dispute among politicians who all have dirty hands. The local mood began to change, two Democrats believed, when the House Judiciary Committee's televised sessions began. Then, one said, “people could see this wasn't just politics but a serious problem.”

Especially for Republicans, the June 23 transcripts were decisive. Mr. Nixon's offenses were suddenly defined, by his own words, as a clear, unavoidable question of crime. “Crime” seems to have an elementary meaning here. It does not mean debatable abuses of special presidential powers. It does not mean contempt of Congress, since Congress is held in rather low repute. “Crime” means the obvious: lying when one had pledged to tell the truth, concealing evidence, and obstruction of justice—a phrase which has become a layman's term.

And crime means courts, verdicts and punishment. Based on a small, unscientific sampling, opinion here is fragmented on whether Mr. Nixon

should be prosecuted. Some, including most Republicans contacted, thought that the public verdict had been rendered and that the disgrace of resignation was punishment enough. “What more can you do to the guy?” one GOP leader asked.

Richard J. Schroeder, an attorney and county Democratic chairman, took a contrasting view. Mr. Nixon's resignation was not conclusive, Schroeder felt. “From what I understand, he and John Dean did about the same things in obstructing justice. He should be brought before the courts and made to answer like everyone else.”

As Schroeder himself acknowledged, this seemed to be a minority view. For a number of people, however, the question was a difficult and troubling one.

“About 20 of us were talking about it over a campfire in northern Idaho last night,” said A. J. Pardini, a GOP state

legislator. “We couldn't work it out. Most of us wanted no further prosecution of Nixon—except for the implications for the other people on trial.”

Pardini thought that younger people, regardless of their political philosophy were more skeptical about “the system” and more inclined to favor prosecution. “Those over about 35 are more compassionate,” he suggested.

For Pardini himself, however, compassion seemed to collide with a basic sense of fairness. In separate conversations, three women expressed a similar ambivalence in different terms. One, a professor's wife who said she “leaned Republican,” stated, “I think he probably should be prosecuted.” Then, after a pause, she added, “But I don't want to see it.”

The second, a department-store clerk, commented, “Worse people than he have gotten off. But I don't really know what's fair.”

The third, a banker's wife, remarked, “I do feel sorry for the man.

But I also feel sorry for everyone else connected with this garbage who is serving time or has already gotten out of jail. I wish someone could find a way to handle this outside of politics—to get it down to the point of pure justice.”

That seemed to be a common wish: a desire to find some unmistakable “point of pure justice” on which to conclude, in an obviously non-political way, the gravest political scandal in the nation's history.

No clear definition of “pure justice” emerged from these conversations in one moderate-to-conservative community. What did emerge was the wisdom of Special Pro-prosecutor Leon Jaworski's decision to do nothing precipitous and the even greater wisdom of the apparent decisions by Congress and President Ford, the “politicians,” to do nothing about immunity or prosecution at all.

It may be that the question is too difficult, that there is no course which avoids arousing new hostility—if only among that considerable segment of the populace which simply doesn't want to think about the subject any more.

It may be, on the other hand, that a generally acceptable solution will develop through legal processes, through events related to the forthcoming trial of Mr. Nixon's aides and his own conduct as a subpoenaed witness.

To some people here, at least, the law should be the final standard and arbiter. That came through most clearly in the comments of one Republican voter, the wife of a retired city clerk, who talked about the scandal while mowing her small front lawn, on the morning Mr. Nixon left office.

“I feel very sorry for the family,” she said. “But he didn't apologize and we still don't know whether he's guilty of anything or not. I think there's a lot that still needs to be brought out in the open.”

She had been speaking slowly. But when asked where the matter ought to be aired, she answered quickly, almost reflexively: “Why, in the courts!”

SUBJECT: Possible Pardon of Richard Nixon

I have earlier written to you recommending that you contact the White House to ascertain whether President Ford has decided to exercise executive clemency in favor of former President Nixon and if so to urge that this be done immediately, obviating the prosecutorial determination whether or not to charge Mr. Nixon. I also urge, however, that you affirmatively recommend that any pardon which President Ford may be inclined to issue be a conditional one. As you know, and as the recent litigation over former President Nixon's extension of clemency to James Hoffa underscored, a President's flexibility in granting pardons or commutation is considerable. Conditional pardons are not uncommon and in the present circumstances legitimate law enforcement interests and the elementary notions of fairness seem to me to require that at least two conditions be attached to any pardon to Mr. Nixon:

1. The first condition should be a full and formal acknowledgement by Mr. Nixon of his complicity in the Watergate cover-up. Although the mere acceptance of a pardon technically constitutes an acknowledgement of criminal complicity without more, I believe more is required here. Mr. Nixon (like former Vice President Agnew who was permitted to plead nolo contendere to one criminal charge) has continued to maintain his complete innocence of any wrongdoing. Today's newspapers carried statements by Mr. Nixon's son-in-law, David Eisenhower, indicating that the former President intends to remain active in American political life and perhaps to attempt to return to public office -- courses that would certainly have been foreclosed to him if the impeachment process had been allowed to run its course. We now know on the basis of the tapes that are becoming available to us pursuant to the Supreme Court's decision in United States v. Nixon that Mr. Nixon's involvement in the Watergate cover-up was far more extensive and aggressive than even John Dean knew or we could speculate.

In addition to the disclosures on the June 23, 1972 tape which show that the former President endorsed the effort to fob off the Watergate investigation at the outset by misusing federal agencies, the January 8, 1973 conversation with Charles Colson shows that the former President at that time was personally aware of and approved the payment of "hush money" and was actively working with Mr. Colson to promise a pardon to defendant Howard Hunt and early parole to the other defendants in order to buy their silence. For reasons of trial tactics, such tapes may not actually be used at the Watergate trial. I believe it would be a monstrous act to leave the historical record as cloudy as it is now, even on the basis of the Judiciary Committee's inquiry, when we have in our possession evidence of the most persistent and intensive public corruption imaginable. I would not insist on public self-flagellation by Mr. Nixon but I cannot see any just alternative to the most strenuous recommendation from this office that any pardon to Mr. Nixon be conditioned on his formal public acknowledgement of complicity in the Watergate conspiracy.

2. The additional condition that I believe you should press vigorously involves continued access to the White House files accumulated during the Nixon Presidency. Even accepting the highly questionable conclusion of the Department of Justice that these masses of tapes and documents are the private property of Mr. Nixon, we know that they contain substantial quantities of evidence bearing on investigations actively underway within the jurisdiction of this Office. I am not recommending that we insist on "rummaging" through those files on an exploratory frolic. Rather, I believe you should urge the importance of a formal condition that guarantees us access, without the need for litigation, to those tapes and files which we can identify with reasonable specificity as bearing on particular investigations already underway. Indeed, we have been lodging strong objections with the White House and the Department of Justice to any course that would complicate our ability to secure access to evidence that is pertinent to investigations that are assigned to us. It seems only prudent to build in a guarantee of cooperation, to this limited extent, in connection with any pardon that may be extended to Mr. Nixon on grounds unrelated to his own personal innocence or to the innocence of his aides who are currently under indictment or investigation.

Although it has a touch of irony, in light of the condition that Mr. Nixon attached to the Hoffa commutation (the validity

of which was recently upheld by the district court here), you might also point out to White House counsel the possibility of conditioning a pardon on Mr. Nixon's agreement not to seek public office again. Although such a term is one that is beyond the ambit of our official interest and might be politically difficult for the new President, it would bear on matters within our jurisdiction: if a pardon is extended to Mr. Nixon but not to those people who acted on his behalf and have either "paid the price" for their offenses or are being put to trial for them, then it would seem important to see to it that, to the extent possible, the disparity of treatment is minimized. A condition of a pardon that foreclosed efforts to recapture public office would tend to equalize the results, even though Mr. Nixon would be spared the ignominy and hardship of prosecution and possible confinement and would simply be limited to receiving his lifetime pension and emoluments and engaging in any other private activities that remain open to him.

I have promised to uphold the Constitution, to do what is right as God gives me to see the right, and to do the very best I can for America. I have asked your help and your prayers, not only when I became President, but many times since.

The Constitution is the supreme law of our land and it governs our actions as citizens. Only the laws of God, which govern our consciences, are superior to it. As we are a Nation under God, so I am sworn to uphold our laws with the help of God. And I have sought such guidance and searched my own conscience with special diligence to determine the right thing for me to do with respect to my predecessor in this place, Richard Nixon, and his ~~wonderful~~<sup>loyal</sup>

wife and family.

Theirs is an American tragedy in which we all have played a part. It can go on and on <sup>or</sup> or someone must write "the end" ~~to it~~ to it.

I have concluded that only I can do that. And if I can, I must.

There are no historic or legal precedents to which I can turn in this matter, none that precisely fit the circumstances of a private citizen who has resigned the presidency of the United States. But it is common knowledge that serious allegations and accusations hang like a ~~xxxxxx~~ sword over our Former President's head as he tries to reshape his life, a great part of which was spent in the service of this country and by the mandate of <sup>its</sup> ~~the~~ people.

After years of bitter controversy and divisive national debate, I have been advised and am compelled to conclude that many months and perhaps <sup>more</sup> years will have to pass before Richard Nixon could hope to obtain a fair trial by jury in any jurisdiction of the United States under governing decisions of the Supreme Court.

I deeply believe in equal justice for all Americans, whatever their station or former station. The law, whether human or Divine, is no respecter of persons but the law is a respecter of reality. The facts as I see them are that a former President of the United States, instead of enjoying equal treatment with any other citizen accused of violating the law, would be cruelly and excessively penalized either in

During this long period of delay and potential litigation, ugly passions would again be aroused, our people would again be polarized in their opinions, and the credibility of our free institutions of government would again be challenged at home and abroad. In the end, the courts might well hold that Richard Nixon had been denied due process and the ~~verdict~~ <sup>verdict of history</sup> would be even more inconclusive with respect to those charges ~~arising out of~~ <sup>arising out of</sup> ~~the period of~~ <sup>the period of</sup> ~~which I am presently aware~~ his Presidency of which I am presently aware.

But it is not the ultimate fate of Richard Nixon that most concerns me -- though ~~surely it~~ <sup>surely it</sup> ~~deeply troubles~~ <sup>deeply troubles</sup> every decent and compassionate person. ~~But~~ <sup>Rather my concern is</sup> the immediate future of this great country. In this I dare not ~~depend upon~~ <sup>depend upon</sup> ~~my personal~~ <sup>my personal</sup> ~~sympathy~~ <sup>sympathy</sup> ~~longtime~~ <sup>longtime</sup> ~~as a friend~~ <sup>as a friend</sup> of the Former President ~~nor my~~ <sup>nor my</sup> professional judgment as a lawyer. And I do not.

As President, my primary concern must always be the greatest good of all the people of the United States, whose servant I am.

As a man, my first consideration ~~will always be~~ <sup>is</sup> to be true to my own convictions and my own conscience.

My conscience tells me clearly and certainly that I cannot prolong the bad dreams that continue to reopen a chapter that is closed. My conscience tells me that only I, as president, have the Constitutional power to firmly shut and seal this book. My conscience says it is my duty, not merely to proclaim domestic tranquillity, but to use every means I have to ensure it.

~~XXXXXX~~ I do believe that the buck stops here and that I cannot rely upon public opinion polls to tell me what is right. I do believe that right makes might, and that if I am wrong ~~all the~~ <sup>ten</sup> ~~legions~~ of angels swearing I was right would make no difference. I do believe with all my heart and ~~mind~~ <sup>not</sup> mind and spirit that I, /as President but ~~and~~ as a humble servant of God, will receive justice without mercy if I fail to show mercy.

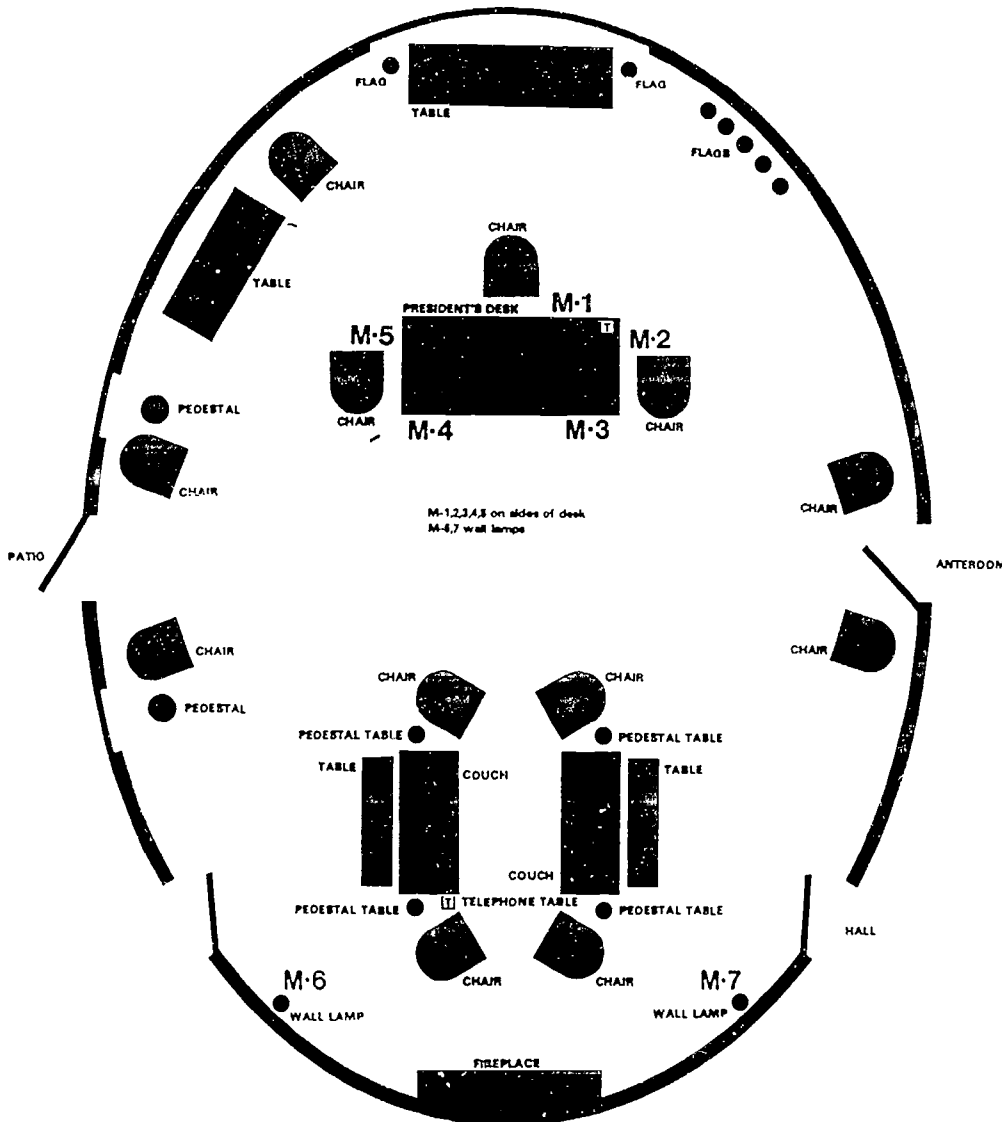

# About Using the National Archives

## A Word to Students and Educators

The National Archives and Records Administration (NARA) is the federal agency responsible for preserving and making available to the public the permanently valuable records of the federal government. These materials provide evidence of the activities of the government from 1774 to the present in the form of written and printed documents, maps and posters, sound recordings, photographs, films, computer tapes, and other information media. These rich archival sources are useful to everyone: to federal officials seeking information about past activities of their agencies; to citizens needing data for use in legal matters; to lawyers, historians, social scientists and public policy planners, engineers, medical researchers, novelists and playwrights, journalists researching stories, and people tracing their ancestry or satisfying their curiosity about particular historical events. In particular, these records are useful to you in pursuing your own research, whether professional or personal.

The organization and description of records in an archives differs from that of books in a library in three significant ways. First, the records are maintained under the name of the agency or bureau that created them rather than under a system of classification such as would be found in a library using the Dewey decimal system or Library of Congress classifications, for example. Instead, each discrete body of records is assigned a record group number; thus the records of the Department of State are arbitrarily designated Record Group 59, and the records of the Bureau of Indian Affairs are arbitrarily designated Record Group 75. There are more than 400 record groups in the National Archives representing the records of as many bureaus, agencies, and departments of the federal government.

Second, records are maintained in the same order as they were maintained in the agency that created them, allowing the researcher to examine how the agency's understanding of

its mission was reflected in its organization. The records of two agencies, bureaus, or departments are never intermixed, however similar their functions. Thus the records of the National Park Service (RG 79) and those of the Forest Service (RG 95) are maintained separately, even though they both have responsibility for public lands.

Finally, the National Archives does not, for the most part, use card catalogs or other library tools to describe its holdings. Rather, it provides narrative descriptions of record groups called inventories or preliminary inventories and also publishes a *Guide to the National Archives of the United States*, which provides brief descriptions of each record group. This form of description is now typical of most larger archives and manuscript collections, which have long since abandoned costly item-by-item description in favor of a method that provides the researcher an overview of an entire collection whose separate items have meaning only in the context of those items around them.

NARA is a public institution whose records and research facilities nationwide are open to anyone 16 years of age and older who will use the records according to the simple rules laid out for their protection. These facilities are found in the Washington, DC, area, in the 8 Presidential libraries across the country and the Nixon Presidential Materials Staff in Alexandria, VA, and in the 12 regional archives ranging from Boston to Anchorage. Whether you are pursuing broad historical questions or are interested in the history of your family, admittance to the research room at each of these locations requires only that you fill out a simple form stating your name, address, and research interest. A staff member issues an identification card, which is good for 2 years.

If you come to the National Archives or its outlying research facilities, you will be offered an initial interview with a reference archivist. You

will also be able to talk with archivists who work directly with the records you want. The best preparation for using the valuable information that these interviews provide is to have a clear definition of your questions and to have read as much as possible in the secondary sources before you arrive. A sound knowledge of the facts of your topic and its historical context is your best preparation for research in primary sources. Among the essential information you must develop before you arrive is the link between your topic and the function of the federal government. You will find information in the National Archives about litigation at the federal level, for example, but not at the state level. You will find information about population numbers and distribution because the federal government conducts a decennial census. You will find information about the Constitutional Convention, which was a national function, but not about the meetings of the Virginia House of Burgesses, which was both a colonial and pre-federal institution. You will find vital statistics for Native American reservations and military posts because these are maintained by the federal government, but not for cities, which are not federal entities.

The best printed source of information about the holdings of the National Archives is the *Guide to the National Archives of the United States* (GPO, 1988), available in university libraries, other research institutions, and some public libraries. The *Guide* describes briefly each record group, gives the background and history of each agency represented by those records, and provides useful information about access to them. To accommodate users outside of Washington, DC, the regional archives hold microfilm copies of much that is found in Washington. In addition, the regional archives contain records created by field offices of the federal government, including district and appellate court records. These records are particularly useful for local and regional history studies and in linking local with national historic events.

If you are interested in the educational and cultural programs of the National Archives, the Education Branch of the Office of Public Programs provides these learning packages, a newsletter for 2-year college instructors, teacher workshops attended by instructors from precollegiate and collegiate levels, a theater program, and courses in using the Archives for genealogical and general

research. The Office of Public Programs also mounts exhibits of records; publishes exhibition catalogs, reproductions of records, and guides to holdings; and develops special events and tours. For information about these programs, write to Office of Public Programs, NARA, Washington, DC 20408.

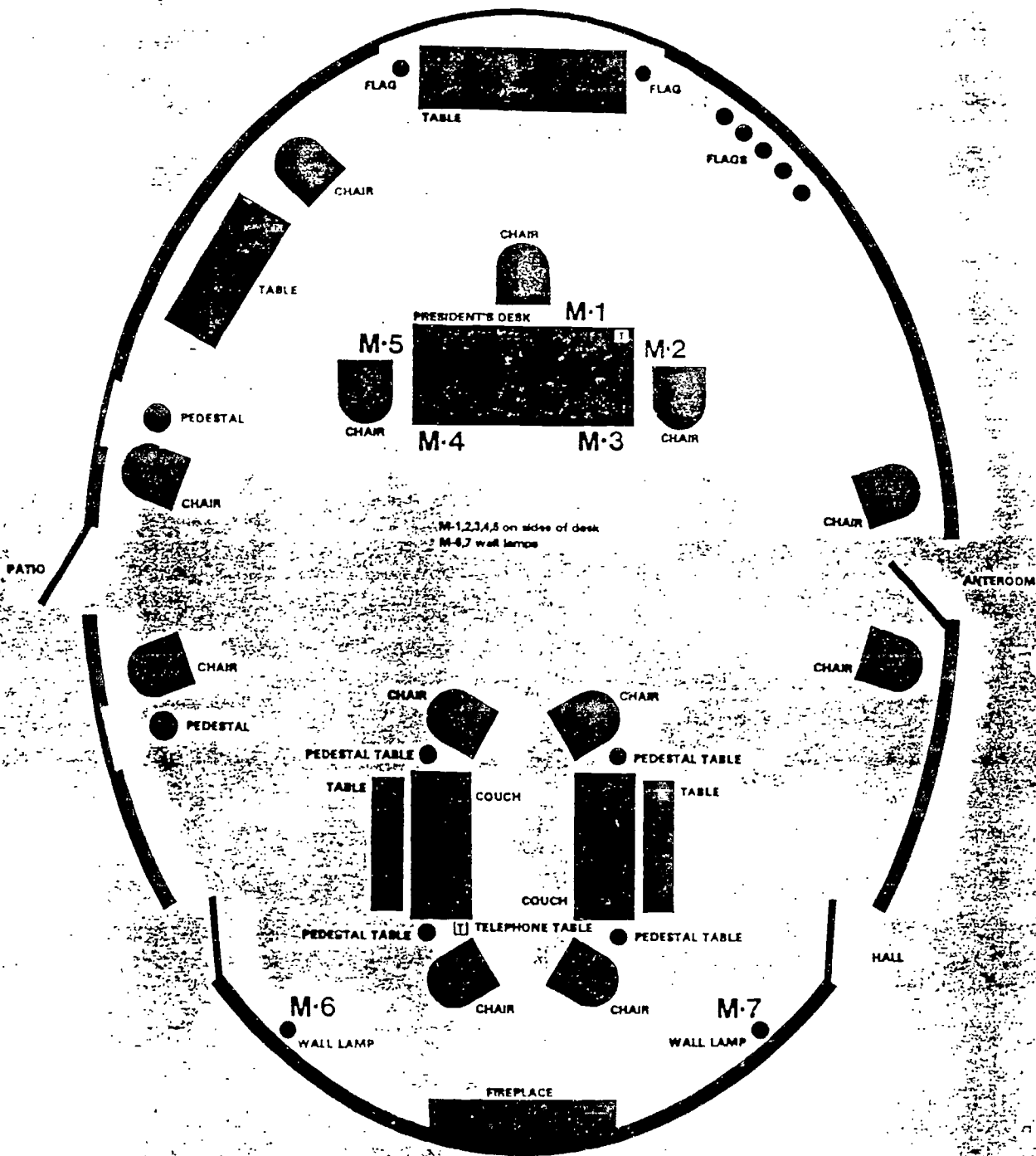
