HONOREE BIOGRAPHIES

Scott Corrigan

Scott Corrigan joined Standard Chartered in March 2014 and currently serves as General Counsel, Europe & Americas, and Global Head, Government Investigations. Scott previously served as an Enforcement Counsel for the Federal Reserve Bank of New York and as an Assistant Direct Attorney at the New York County District Attorney's Office. After leaving government service, Scott represented banks, other financial service entities and financial services executives in government investigations and civil litigation. He also served in a variety of managerial roles as a law firm partner. Scott received a J.D. from Yale University in 1992 and a B.A. magna cum laude from Providence College in 1988.

In addition to his highly successful legal career, Scott is also an active member of his community. He has served as a volunteer in a number of capacities at Village Community School, previously serving on the board of directors and as chair of the annual fund. He now currently serves on the school's capital campaign committee. He has also served on the parish council of St. Joseph's Church in Greenwich Village.

Dr. Chinazo O. Cunningham

Since 1998, Chinazo Cunningham, MD, MS has provided care, collaborated with community-based organizations, developed programs, and conducted research to improve the care and health of marginalized populations, including people who use drugs and have/are at-risk for HIV. She has been the principal investigator on numerous grants funded by the NIH, CDC, HRSA, local and state Departments of Health, and various foundations. Dr. Cunningham has also mentored scores of trainees conducting research, resulting in local and national awards. She has served on numerous national advisory committees, including: the CDC's Board of Scientific Counsel; NIH Office of AIDS Research's Racial and Ethnic Populations Committee; and as Chair of both NIH's Behavioral and Social Consequences of HIV/AIDS Study Section and NYS DOH AIDS Institute's Substance Use Guidelines Committee.

Prior to joining the faculty at Albert Einstein College of Medicine, Dr. Cunningham graduated from Northwestern University and UCSF School of Medicine, and completed residency at UCSF and NYU. Subsequently, she earned a master's in clinical research methods at Einstein.
