LWV Duluth Observers' Report

The Duluth School Board will elect three new members to the Board in the upcoming fall elections. Incumbents Judy Seligo-Punyko (District 2), Mike Miernicke (At Large), and Bill Westholm (District 3) will not seek reelection. The observer reports that, "Someone needs to put all board members into a room and lock the door, until a few issues are settled." Civility has become an issue. The Board will need to focus on success and equality for all students.

Sharla Gardner (3rd Council District), Linda Krug(Councilor at Large), Jennifer Julsrud (1st Council District), and Emily Larson (Councilor at Large) will not seek reelection. Jay Fosle will seek reelection to his 5th District Council seat. Emily Larson and Howie Hanson are candidates for city mayor. The future of the Duluth Zoo, Duluth Library, and Spirit Mountain are issues still to be considered. All members of the City Council have been respectful and meetings are conducted efficiently.

The Human Rights Commission has focused on writing a Homeless Bill of Rights. They will present their statement to the City Council. Racial equality in the schools needs to be addressed. Jim Crow was recommended as a read for students and adults.

The St. Louis County Board is currently involved in a pilot program with the City of Duluth. It is referred to as the Homeless Pilot Program. The goal is to reduce homelessness, particularly by reducing the number of evictions.

The observers will provide the upcoming candidate forums with information and inquiries. Observers are still needed for many of the city commissions.

LWV Duluth Members and Involvement in Political Campaigns



Fall is fast approaching and that means that elections are not far behind. Questions about League members' involvement with various campaigns have come up. I hope this article will help make it clear as to what our policy is concerning members involvement in politics.

LWV promotes political responsibility through informed and active participation of citizens in government. The League's nonpartisanship is the basis of our public credibility and must be carefully maintained. As a group, we do not support or oppose any political party or candidate. The League does take positions on issues after member study and agreement.

LWV believes that participation in the activities of the political parties is an essential ingredient of citizen responsibility. While LWV encourages its members to be politically active and fully informed about candidates and issues, certain constraints are necessary to maintain the nonpartisanship of the organization.

Restrictions on LWV Board Members:

To avoid possible perception of partisanship, high visibility positions have the responsibility of maintaining the nonpartisanship of the organization and need to refrain from political activity or active partisan support during their term of office.

These positions include: President(s); Voter Service Chair(s); Public Relations Chair(s); Action Chair(s); Moderators for forums, and other Board members who have been authorized by the full Board to act as a spokesperson by LWV Duluth.

Board members may run for and serve nonpartisan elective offices such as City Council, School Board, County Commissioner and County Attorney. During the campaign the Board member is asked to take a leave from the LWV Board of Directors, but may come back after the election. Board members running for and elected to a partisan position must resign from the LWV Board of Directors.

Political activities of spouses and other family members of LWV Board members are viewed as distinctly separate.

Lawn Signs:

The President(s), chairs of Voter Service, Public Relations, and action committees may post only LWV vote signs. **Members** may have in their yard- either a LWV lawn sign promoting voting OR a partisan sign promoting a candidate. Members May NOT have both a LWV lawn sign AND a partisan sign promoting a candidate

1. Bottled water is more expensive than tap water (and not just a little).



A Business Insider column noted that <u>two-thirds of</u> the bottled water sold in the United States is in individual 16.9 ounce bottles, which comes out to roughly \$7.50 per gallon. That's about **2,000 times** higher than the cost of a gallon of tap water.

And in an article in 20 Something Finance, G. E. Miller investigated the cost of bottled versus tap water for himself. He found that he could fill 4,787 20- ounce bottles with tap water for only \$2.10!

So if he paid \$1 for a bottled water, he'd be paying 2, 279 time the cost of tap.
