Annual Meeting – February 28 - March 1, 2015

The Midwest Society of Periodontology is an organization of 440 periodontists in the Midwestern States. We have an annual meeting each winter which piggy-backs with the Chicago Dental Society's Midwinter Meeting. This year our Annual Meeting is to be held on Saturday and Sunday February 27 - March 1, 2015, at the Swissotel/Chicago. We expect an attendance of between 275 and 325 members and professional guests. Last year our attendance was 275 periodontists, graduate students and restorative dentists.

Saturday's program will feature a Graduate Student Research Forum. Post-doctoral students and recent graduates in periodontology submit abstracts to compete in the Midwest Society of Periodon-tology's Graduate Student Research Forum. Three students are selected to present in Chicago and each of these three finalists will receive a \$500 cash award plus their hotel expenses. In addition, a first place plaque will be presented to the winner and honorable mention plaques will be given to the other two presenters.

The Saturday program will feature Dr. Steven Chu, who's presentation is entitled "How the Periodontist Can Support the Restorative Dentist and Increase Perio Referrals". Dr. Cary Shapoff will speak on Sunday morning on "Managing the Soft Tissue Interface-Helping Our Restorative Colleagues Achieve Esthetic Outcomes With Dental Implants".

Saturday also will include a Luncheon for Learning Session limited to 60 participants. The speakers will discuss various topics in periodontics.
