#### **GENERAL**

#### **FINISHES**

- 1. The following are to be site stained wood.
  - a. Doors.
  - b. Display Rails (E3/A62)
  - c. Window Grids (A4/A20)
- 2. Guardrail and Stair Rail (B4/A62) is "NOT IN CONTRACT".
- 3. Steel Handrail (A2/62) is to be Site Painted.
- 4. Rooftop Mechanical Units are NOT to be Painted. (A13).
- 5. As per Addendum #1, Dated April 22, 2014, the Historic wall covering photo will be supplied by Owner, installed by Contractor, in standard weight of vinyl of 21" widths.
- 6. The existing white fence along south property line belongs to the residential neighbor and does not require refinishing.
- 7. Neither the existing steel rail at the basement stair, nor the existing painted cornice are to receive new paint.

## **SPECIFICATIONS**

DIVISION 00 – PROCUREMENT AND CONTRACTING REQUIREMENTS – SECTION 00 21 13 INSTRUCTIONS TO BIDDERS, 1.01 G: Performance and Payment Bond is a requirement of the General Contractor only. Does not apply to Sub-bidders.

DIVISION 05 – METALS – 05 12 00 - STRUCTURAL STEEL FRAMING, PART 1 – GENERAL, Delete A. and B. under 1.04.

DIVISION 08 – DOORS AND WINDOWS - 08 52 13 - ALUMINUM-CLAD WOOD WINDOWS, PART 2 – PRODUCTS. This specification section is to be changed as follows:

- 1. Paragraph 2.01, B is to read in part "Pella Architectural Series" instead of "Designer Series".
- 2. Paragraph 2.02, C is to be revised to read "Insulated Glazing: Quality 1 clear float glass complying with ASTM C1036. One inch InsuShield multi-layer Low-E coated dual-seal insulating glass, silicone-glazed. High altitude (argon gas fill) glazings." Note that bronze tinting and integrated blinds are not required.
- 3. Add Paragraph 2.02,C,1 to read "Window 'A' shown on the drawings has permanent divided lights. This window shall not be "high-altitude" argon gas filled like the other exterior windows."

DIVISION 08 – DOORS AND WINDOWS - 08 42 29 - SLIDING AUTOMATIC ENTRANCES PART 2 – PRODUCTS, Manufacturer. Stanley is an approved Substitute.

## DIVISION 09 - FINISHES - Add SECTION 09 54 26, LINEAR WOOD CEILINGS PART 2.01 - PRODUCTS,

- A. Product: Armstrong Wood Works Linear, Veneered Planks in 6" modules with 3/4" reveals, 6460W1, with minimum Acoustic NRC rating of 0.40, and a Class A fire rating.
- B. Finish: Veneer to be "Constants" (Real Wood Veneer) in Cherry finish (CCY).
- C. Suspension System: Provide and install the 5371 suspension system with integral clips and all required installation accessories.

DIVISION 12 – FURNISHINGS - SECTION 12 93 14 SKATEBOARD STORAGE SYSTEM, PART 2 – PRODUCTS, 2.02 Materials, A.2: Change "Capacity" to ten (10) boards.

#### SHEET A12

1. Key Note C2.3 refers to the Axiom Classic Trim by Armstrong, product number AX10STR (10" deep, straight configuration).

#### SHEET A20 - WINDOW SCHEDULE

1. The glass type for window ID 'L' located between Air Lock #100 and Vestibule #101 is to be "1/4" tempered" instead of "insulated tempered".

#### SHEET A41 AND A64

1. Section A4/A41 and Elevation A3/64: See Attached "Similar" detail of added wood wainscot where cabinets are not detailed. (See Replacement Elevation A3/A64 attached.)

#### SHEET A64

1. At Detail A3/A64, the Axiom trim called out is the same product specified in Section 09 20 00, Paragraph 2.02. G, except that it is the 4" deep profile (minimum radius = 24").

#### SHEET A65

1. At Details B3 and E1, the 1x12 panel called out should be 3/4" thick solid Oak.

## INTERIOR DRAWINGS

#### SHEET ID-1

- 1. Clarification: The accent carpet that surrounds the circular insets is "CPT-6".
- 2. Floor base material to be wood as called out in Finish Plan 1, at Multi-Purpose Room #117.

#### SHEET ID-2

1. Clarification: Carpet in the east section of Collections #108 is "CPT-4".


Sheet Title 2-hr Rated Fire Wall
