



NEWS BRIEF: "Volcanic ash relentless as tremors rock Iceland", Reuter's News, April 18, 2010



by Steven Ertelt--LifeNews.com Editor--April 21, 2010--Washington, DC -- A new study conducted by the Environmental Protection Agency shows a correlation between the use of cells from babies in abortions in vaccines to an increase in autism rates. The study provides another problem from pro-life advocates who are already concerned about the abortion-vaccine tie.

The study, published in February in the publication Environmental Science & Technology, confirms 1988 as a "change point" in the rise of Autism Disorder rate.

"Although the debate about the nature of increasing autism continues, the potential for this increase to be real and involve exogenous environmental stressors exists," the study says.

The 1988 date is significant because, as pro-life blogger Jill Stanek notes, the Sound Choice Pharmaceutical Institute indicates that's when the Advisory Committee on Immunization Practices added a second dose of the MMR vaccine, containing fetal cells from aborted babies, to its recommendations.

The study found two other change point dates: 1981, two years after MMRII was approved in the United States with fetal cells, and 1995, when SCPI says the chickenpox vaccine using aborted cells was approved.

Jim Sedlak, vice president of American Life League, said today that his group is joining SCPI in calling for a Fair Labeling and Informed Consent Act to let people know of this link and the use of cells from babies victimized by abortion.

"For years the evidence has pointed toward the link between vaccines using DNA from aborted babies and the rise of Autism Disorder rates," he said. "Parents need and deserve to know the risks associated with vaccinations made from lines derived from the bodies of aborted children."

"While the pharmaceutical industry ignores the evidence and continues to put our children at risk," Sound Choice is conducting studies on the impact of residual human fetal DNA in vaccines on the brain development and autism in children, Sedlak continued.

Stanek also commented on the new developments. "The conspiracy theorist in me wonders if the same sort of ideological culprits we see covering up the abortion-breast cancer link are also involved here." This would be a huge, huge blow to embryonic stem cell experimentation....also huge class action lawsuits are on the horizon if this is proven, Stanek added.

"That virus-laden DNA of aborted babies could be wreaking havoc on the DNA of healthy children is completely plausible," she said.

SCPI will present their studies at the International Society for Autism Research in May 2010.

Aborted Babies & Vaccines

For over thirty years pharmaceutical companies in this country have been producing vaccines derived from tissues of aborted babies, a fact that was brought to light when several prominent religious newspapers published articles on the morality of using the vaccines. The trouble began when a new law in St. Louis County, Mo. required food handlers to obtain the Hepatitis-A vaccine for employment. When the source of the vaccine was revealed, many principled individuals objected and with good reason. And as this information has continued to become more and more public, a large number of physicians and parents are highly troubled by the ethical issues involved. How did this happen? During the Rubella epidemic of 1964, some doctors advised exposed pregnant women to abort their children. The resulting virus strain developed was known in the science world as RA/27/3, where R=Rubella, A=Abortus, 27=27th aborted baby tested, 3=third tissue sample. There were actually 26 abortions prior to finding the right "species" with the active virus. The vaccine was then cultivated on the lung tissue of yet another aborted infant, known as WI-38 (Wistar Institute 38), this sample was taken from the lung tissue of an aborted female infant at 3 months gestation in the 1960s. A second human cell line, MRC-5 was derived from a male at 14 weeks gestation in the 1970s. They were used to cultivate the weakened virus strains of several diseases to produce immunizations. These two human cell lines cultivated in the lab continue to provide an ongoing source for many widely used vaccines.

Vaccines developed from aborted fetal tissues:

- A) Live vaccines against rubella:
- "the monovalent vaccines against rubella Meruvax (Merck) (U.S.), Rudivax (Sanofi Pasteur, France.), and Ervevax (RA 27/3) (GlaxoSmithKline, Belgium); "the combined vaccine MR against measles and rubella, commercialized with the name of M-R-VAX (Merck, US) and Rudi-Rouvax (AVP, France);
- "the combined vaccine against rubella and mumps marketed under the name of Biavax (Merck, U.S.);" the combined vaccine MMR (measles, mumps, rubella) against rubella, mumps and measles, marketed under the name of M-M-R II (Merck, US), R.O.R., Trimovax (Sanofi Pasteur, France), and Priorix (GlaxoSmithKline, UK).
- B) Other vaccines, also prepared using human cell lines from aborted fetuses: "two vaccines against hepatitis A, one produced by Merck (VAQTA), the other one produced by GlaxoSmithKline (HAVRIX), both of them being prepared using MRC-5;

- " one vaccine against chicken pox, Varivax, produced by Merck using WI-38 and MRC-5:
- " one vaccine against poliomyelitis, the inactivated polio virus vaccine Poliovax (Aventis-Pasteur, Fr.) using MRC-5;
- " one vaccine against rabies, Imovax, produced by Aventis Pasteur, harvested from infected human diploid cells, MRC-5 strain;
- " one vaccine against smallpox, AC AM 1000, prepared by Acambis using MRC-5, still on trial.

Deadly airborne fungus in Oregon set to spread--The new, rare strain has killed 1 in 4 infected, researchers say

A deadly, airborne new strain of fungus has emerged in Oregon. It has killed nearly one out of four known affected people so far and might also attack animals. And it is likely to spread, researchers now warn.

The new strain known as VGIIc of the fungus Cryptococcus gattii not only targets humans but has also proven capable of infecting dogs, cats, alpacas, sheep and elk. Other strains have even infected porpoises.

Although it can spread to mammals, it does not jump from animal to animal. Instead, people and other animals get it from inhaling spores released by samples of the fungus that infect trees.

"It's in the environment, and we're exposed to the environment," researcher Edmond Byrnes III of Duke University Medical Center told LiveScience. "And the environmental range of this has been expanding."

While scientists aren't sure how the highly infectious or virulent fungus emerged in Oregon, they caution the new strain now looks set to expand to California and other neighboring areas.

"This novel fungus is worrisome because it appears to be a threat to otherwise healthy people," Byrnes said. "Typically, we more often see this fungal disease associated with transplant recipients and HIV-infected patients, but that is not what we are seeing yet."

Symptoms can appear two or more months after exposure. Most people never develop symptoms, but those infected may have a cough lasting weeks, sharp chest pain, shortness of breath, headache related to meningitis, fever, nighttime sweats and weight loss. In animals the symptoms are a runny nose, breathing problems, nervous system problems and raised bumps under the skin.

Medical treatment requires months to years of antifungal medications, and even surgery to remove the large masses of the fungus known as cryptococcomas that can develop in the body. So far it cannot be medically prevented & there is no vaccine. http://www.msnbc.msn.com/id/36722426

Emergent: Why Can't We All Be Right?

Emergent writers condemn any approach that declares some ideas to be true and others false. Absolute truth claims do not fit into the Emergent "conversation" because they 'divide people'. But the price of giving up such claims is to give up the very claims that the Biblical writers made.

Getting back to Paul's address before Festus and Agrippa, his words indeed got Agrippa's attention:

Act 26:27 King Agrippa, believest thou the prophets? I know that thou believest.

Act 26:28 Then Agrippa said unto Paul, Almost thou persuadest me to be a Christian.

Act 26:29 And Paul said, I would to God, that not only thou, but also all that hear me this day, were both almost, and altogether such as I am, except these bond

Paul believed that truth claims such as the bodily resurrection of Christ (Acts 26:23) were to be proclaimed even before kings who had the power over Paul's life. His was not a conversation with those who were just as likely to be right as Paul was, but a bold proclamation of the truth designed to convince others of the truth.

But the very practice of the New Testament apostles is what most Emergent leaders oppose. Compare that to Paul's assessment of the Judaizers in Galatia:

Gal 1:6 ¶ I marvel that ye are so soon removed from him that called you into the grace of Christ unto another gospel:

Gal 1:7 Which is not another; but there be some that trouble you, and would pervert the gospel of Christ.

Gal 1:8 But though we, or an angel from heaven, preach any other gospel unto you than that which we have preached unto you, let him be accursed.

Gal 1:9 As we said before, so say I now again, If any [man] preach any other gospel unto you than that ye have received, let him be accursed.

Furthermore, Paul urged others to follow his example and charged elders with the duty of correcting false teaching: Titus 1:9: Holding fast the faithful word as he hath been taught, that he may be able by sound doctrine both to exhort and to convince the gainsayers. Contrast Paul's instructions to Christian elders with the ideas of emergent writer Samir Selmanovic: "We have created a false tension between keeping our Christian identity intact and approaching the world in humility. Humility is to be our identity. When we open ourselves to be taught by 'the other,' we don't become less the followers of Christ but more so."3 According to Paul we are to guard the flock against "the other" (or religious beliefs that are not in accord with the faith once for all delivered to the saints) and in the Emergent view "the other" teaches us. Humility is not openness to false religions and false teachings; it is the realization that we are sinners who need a savior.

The real false tension is the one Emergent thinking creates between humility and confidence in the once-for-all revealed truth. Moses was called "humble" (Numbers 12:3) and to him was given the revelation of God's truth. Humble Moses told the Israelites not to listen to anyone who came in the name of a god they had not known—even if they produced signs (Deuteronomy 13:1-4). The idea that God's people would listen to false teachings as a sign of their humility is in opposition to what we are told in the Bible. (from Bob DeWaay's book, <u>The Emergent Church</u>)

Keeping it Under Wraps: Giants, Mummies and Megalithic Mysteries

Several years ago, during a rather clandestine exchange I had with Brad Steiger, I was told a strange series of facts regarding the mummified remains of "giants" discovered throughout the Americas in the nineteenth century.

We had been talking about his book, <u>Worlds Before Our Own</u>, which had recently been reprinted by <u>Anomalist Books</u>, when he asked me a question regarding a strange, mummified skeleton discovered in 1885.

"Micah, I think you may have seen the pictures that I have of the 7-foot female holding her skeletal babe. She also has a rudimentary tail." As I tried to recollect an image of this oddity, he added, "We may truly be products of someone else's laboratory."

Indeed, this was a bizarre concept, but before I had time to ponder what Steiger was saying he added, "I discussed many giant skeletons that were being held in private museums. After the book was published, I learned of even more and included photos of them in my lectures. Soon, individuals beseeched me to cease."

"Why?" I asked.

"The private museums were mysteriously suffering unexplained fires," he told me rather cryptically.

In addition to the strange stories like this that do turn up from time to time, I find it very interesting—and a bit unsettling—that there are instances suggesting some kind of opposition to the ancient mysteries of this world becoming general knowledge among the populace. Comment: The two main reasons for this is: number one it would prove the Bible is true yet again & also it is contradictory to the 'Theory of Evolution'. Nonetheless, there are a surprising number of stories that allege all sorts of conspiratorial happenings, ranging from recovery of mummified bodies by organizations and groups that spirit them away into the shadows, to mislabeling of samples and specimens that leads to filing and mis-categorization; thus, locating the original discovery is more difficult (particularly if they were uncovered more than a century ago).

▲UFOs: Their Spiritual Mission Conference Questions and Answers with Benjamin Creme — Part 2

'UFOs – Their Spiritual Mission' was the theme of Benjamin Creme's keynote talk at the US and European Transmission Meditation Conferences in 2009. His talk was published in Share International, <u>January/February 2010</u> and Part 1 of the Question and Answer sessions was published in Share International <u>March 2010</u>. The concluding Questions and Answers, Part 2, follow here.

Q: In our approach to the public and the media, should we speak more about the 'star' and the Space Brothers, in relation to the emergence of Maitreya?

A: As a member of this group, there is <u>no difference</u> in talking about the 'star' or about the reappearance of the Christ and the Masters of Wisdom. They are part of the same process. It is not one or the other; it is all part of a whole. It is the latest phase in a process that has gone on for years, by which Maitreya and the group

of Masters Who are coming with Him re-enter openly the modern world. They have already been in position in the world for years. This is a new phase and the 'star' is there as a herald for Maitreya's process of working openly, reaching humanity through radio and television.

The 'star', of course, is not a star. It is a spaceship, a UFO, an enormous spacecraft. The 'usual', 'everyday' scout-craft UFOs are only about 25 to 30 feet in diameter, which is big but not all that big. The 'star' is gigantic, the size of five football fields put together. If the reality of the 'star' can be presented to the public it does two things: it is a herald for Maitreya's advent in the physical, everyday world, and is also proof of the reality of the Space Brothers. These 'stars' must have been made somewhere. These two important things come together in this story: Maitreya's approach to the public beginning with His coming on television in the very near future (although unannounced as Maitreya; He will use another name at first), and also the knowledge of UFOs as reality. You cannot talk about one without talking about the other.

[Note: Announced by Benjamin Creme at his public London lecture on 14 January 2010, Maitreya's first television interview in the US has taken place. As we go to press Maitreya has given nine interviews.]

Q: Are governments or media actively suppressing information about the 'star'?

A: Governments are not suppressing information about the 'star', but some media definitely are....They want to know in advance where the 'star' will be on such and such a day, and their cameramen can go out and get a really first class film to show on television and it will be worthwhile. But, of course, that is not going to happen. No one can supply that information. That is one reason the media tend not to respond. They want it on a plate. They have always wanted this story on a plate. Likewise, if I had told them when Maitreya was coming on a particular programme they would all be there with their cameras. They would assess whether that person could be Maitreya or not, and in the end they would not know. So unlike is Maitreya to their idea of the Christ that they would probably just ignore that particular person as a possible Maitreya or Christ.

When He came to the office of the BBC, they rejected Him. He was in the office of the BBC in around 1986. He had interviews with the Director-General and colleagues. They were shown the last hours of Jesus on the cross as if they were there. They witnessed it. They saw it with their own eyes. They experienced it. They saw the agony, the blood, the people, all of that.

The Master Jesus was asked by Maitreya to come into the office and He came, so that they met the Master Jesus as well. They were asked and agreed to mount a big press conference at which Maitreya would appear, talk to the journalists and answer all their questions.

But they did nothing about it. Instead, they made the information known to the Queen who, as head of church and state, they thought should be the first to know. They

probably knew what the Queen would do, which was to call on her advisors in the church, the Archbishop of Canterbury and the Bishops. They met, and their view was that there was no way that this could be the Christ without their knowing.

So there was a complete embargo on this information.

Q: In your talk you mentioned that the Space Brothers are gentle and subtle.

A: It is obvious by the way they have presented themselves through crop circles, crosses of light on buildings and so on, that they are capable of the most gentle type of approach. That is normally part of their way of doing it. They do not want to infringe human free will or create havoc. Their approach is tangential. They go about it very quietly, just showing you, if you have eyes to see and a mind to think with, that they have left their visiting card, clearly stating: "We are from space, the other planets of your system. We have come to help you. We are engaged in work on your behalf. Here is a sample of our work. We hope you like the 'drawing'." We have to ask where the crop circles come from. They appear in the middle of fields in Wiltshire and elsewhere, enormous things. They cannot be made by human hands and yet there is nothing to show how they were done. They are actually created in a few seconds, however big they are. The plan has already been drawn up, the machinery is set, and as the craft moves for a few seconds over a piece of ground, the turning, crossing and bending of the grass of the crop takes place automatically as they guide the craft in. It has all been planned in advance so that the craft will not do anything else. But it is quiet.
