On January 22, 1973, the US Supreme Court voted in favor of legalizing abortion on demand in all 50 states. The decision was based on the premise that a fetus is not person.

Since then, the intentional termination of approximately 50 million fetuses (have taken place in clinics around America – the vast majority of these were not to save the life of the mother or because of rape. The primary reason has been the personal inconvenience of the mother and/ or the father.

This past year, the Governor of New York signed a bill legalizing the termination of a born fetus.

The US Supreme Court has overturned its own precedents 236 times in US history. Nearly half of all Americans believe abortion on demand is morally wrong. It is the hope of hundreds of thousands of prolife people demonstrating in walks in Washington DC, Los Angeles, Chicago and other cities in America this week that the Supreme Court decision in Roe v. Wade will one day be overturned. Pray for us.

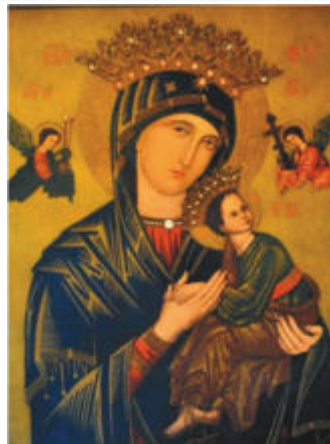
