#### CARS ANNUAL AUDIT REPORT

The CARS audit committee met on Jan 4, 2015 to review the treasurers report for the 2014 fiscal year. Attending the meeting were W8TO, Toby; NI8Z, Gary; K8SAS, Steve; W8GC, Bob Treasurer; also in attendance was Mark, WJ8WM, the newly elected Vice President. Findings in the report: The scholarship funds are solid for at least the next two years. Annual income did not exceed expenditures primarily for the one-time expense of the bus to the ARRL which was paid from the treasury with no offsetting income. The summer CARS Family Picnic, and the Christmas party meeting were both funded with club treasury support. Α new ViewSonic computer projector was purchased for presentations.

Field Day expense is always a CARS funded activity.

CARS member dues covers just about 40% of routine club expenses. Therefore it is incumbent upon members to support the club in other ways, which for the most part they have.

CARS needs future financial support from individuals who donate equipment (*e.g.*. SKs) for sale to members or internet sales. Some expenses may have to be trimmed in 2015. On the cutting block may be Echolink unless some meaningful way to fund it becomes available.

The final result is that CARS is in solid financial position for the year 2015 as agreed unanimously by the audit committee. #### I SURVIVED ITALY

Little did I know this was going to be a tough trip for this kid! I was shocked to learn there was 52 miles of walking involved. We walked everywhere...up hills, down hills, and then up more hills again! That's the way it is in Italy...one walks everywhere! Buses take you to a central location in every city and you walk to and from that bus parking location. That is comparable to a bus parking in downtown Cleveland and from there you walked to and from The West Side Market or Severance Hall.

There were many many wonderful beautiful things to see in Italy. Many churches and art work to see. Our itinerary included visits to Venice, Florence, Assisi, Padua, Rome, the Vatican, the Coliseum, the Christian Catacombs, Naples, and a visit to an excavated Roman city called Pompeii.

Our first stop was Venice, a city on an island, with canals everywhere. It had rained all day and night prior to my visit. There was so much water everywhere that we had to wade in two feet of water up to our ankles for about a hundred feet just to get ashore. From the git go I was soaked and cold! What a wonderful way to first see The Mediterranean Sea! In Venice that day it continued raining all day long. There was so much water that special portable sidewalks were set up to walk on. I bought an umbrella which lasted only ten minutes. A very powerful wind broke the umbrella into shambles. I put the umbrella in a garbage can. I then purchased a poncho which helped. You can't sit down in Venice! I walked 9.2 miles that dav in the cold rain!

We visited The Vatican on two different days. Remarkable place to visit! On the second day (Wednesday)we arrived early (7A.M.) to get one of the portable seats available in order to see Pope Francis. Again it was raining constantly. I bought another umbrella and sat in the rain for three hours. An Italian lady sitting in front of me on two occasions tilted her umbrella, watering

my pants. I complained saying "hey hey" and she only replied with "scuse-a" in Italian. Her husband was sitting next to her and I said nothing more as I certainly didn't want to get into any trouble in a foreign country. I did see Pope Francis...got to about 15 feet from him.

I also saw the Radio Vatican antennas there. I saw a few ham antennas in Italy. One antenna was a three element 10-15-20 meter delta loop. I wish I could've met that Italian ham but didn't have the opportunity. Our bus rode past the long building of The Sovereign Knights of Malta (which is a separate sovereign country...1A0). I had worked 1A0KM years ago.

The best Italian food I have ever eaten is right here in Cleveland. Pizza at Cleveland's Angeles, Antonio's or Athens is the best in the world! Pizza in Italy is horrible! Their pizza is like eating cardboard with tomato soup floating on it. Spaghetti in Italy isn't much better...very bland and tasteless. And food in Europe is very expensive and with skimpy portions.

Pompeii, is an excavated city which was covered with lava and ash when Mt, Vesuvius blew up in 79 AD. Thousands of people were killed instantly. I enjoyed going through all the excavated homes and stores of Pompeii. Pompeii was the highlight of my trip!

I was so happy to boarding the plane going back to the good ole United States. I have no desire to go anywhere in Europe again! We live in the best country on this planet and that's where I will spent all of my vacations in the future! God bless the United States of America! I am glad I survived Italy!

The station is set up with 4 monitors. The radio on the left is an Icom756 pro2 with the PW1 remote head on the top right with 2 lighted meters. The radio on the right under the multilight is a Yaesu FT5000. Under that just beneath the lower shelf is a Flex 3000. There is a computer controlling the Icom behind the keyboard on the left. The small keyboard on the right works on both the Flex and the computer under the desk (in the dark area not visible). The right monitor have HRD and DM780 split . Under the right monitor with Dm780 is the Elecraft KPA500

GOVERNMENT SETS WALKING RULES In the wake of alarming reports of pedestrian deaths, the National Transportation Board (NTSB) has issued

safety regulations for all walkers, hikers, strollers, joggers, and runners. Effective June 1st., 2015, all persons using public facilities for personal foot transportation must be licensed by the federal government. Licensees must attend special pedestrian training courses before licenses will be issued. The new regulations require pedestrians to wear standard safety equipment including helmets, knee and elbow guards, chest protectors, highvisibility reflective clothing, and approved footwear appropriate for the type of activity. The rules will apply to all areas, whether urban, suburban, or rural. Separate, more restrictive rules will govern pedestrian activities within city. state, and national parks, as well as in privately owned public facilities. At present, the NTSB has no plans to apply the rules to privately owned dwellings and real estate. License application may be picked up at any U.S. Post Office and must be submitted with a \$25 registration fee. (KVM5149 & K8DMZ)

#### GROUP DEMANDS INTERNET BAN

A well known computer activist group, Internet Control Inc. (ICI), has demanded that the government immediately ban all internet access because it makes people want to kill themselves. According to the group's spokesperson, J. Percival Birdwheel, ICI wants all internet access forbidden except for government law enforcement agencies. "After all," he said, "there's no need for the common citizen to have instant access to the world's information when they're incapable of understanding it." Mr. Birdwheel explained that "private use of the internet is dangerous and the only reason people use it is to kill or maim somebody." He said that most Americans don't need internet access because "all the information they need is already available from approved sources such as libraries and government agencies." (N8JR & K8DMZ)

#### **VP PROPOSES WAITING PERIOD**

The Vice President of the United States, who wants to put the internet in all schools, claims he is "not forcing innocent children into a life of suicide." Even though he was criticized for supporting young peoples access to the internet, he claimed that "they have a constitutional right to internet access at school just the same as they have a right to get condoms there." He proposed that the supposed problems of the internet access would be solved if Congress passes legislation requiring a 5 day waiting period before each access to an internet address can be completed. "It would mandate a cooling-off period so that known, potential internet criminals could be weeded out by the police" he said. (KVM5149)

#### TRAP CALLS FOR CODE SPEED

TRAP (Traditionalist Radio Amateur Program) has called on the Federal Radio Commission to raise the code speed for all licensees to 45 wpm. They said that if a ham is going to use Morse Code on the air that they should be able to send and copy at 45 wpm. The also called for an end to singlesideband transmissions on all frequencies and a return to AM voice only.
