




Ocean Ranch II Retail Center

Laguna Niguel, California. Regional outdoor shopping/entertainment center. 10 buildings including a 7 screen theater, restaurants, market, bank, and medical building.










Office Building

Ocean Ranch II mixed use center, Laguna Niguel, California. A 48,000 square foot, three story Office Building with a fitness center and swimming pool.

The building is noteworthy for the large percentage of glazed area, sunshades and openable windows. These elements, coupled with a high degree of control over heating and air conditioning systems optimize natural daylighting and personal control over the working environment.







Costa Mesa, California. 150 lofts in 4-story buildings, 5 freestanding live-work units, and 40,000 sf of office space in 3 buildings of 2-4 stories. Concrete structural frames with masonry and steel exteriors reflect the industrial character of the area as well as its emerging urban future. 






29th St. Lofts


