- ▲ This month is our National Collegiate Connection Month, we want to make sure that we reach out to our undergrads
- ▲ Headquarters has a National Reclamation Project to reclaim 4000 sorors. We are encouraged to invite inactive/non-financial Sorors to chapter meetings and chapter events by way of personal contact.

- Post With Caution
 - This workshop focused on the Do's and Don'ts associated with social media and other external communication platforms. The facilitators spoke of proper protocol as it relates to Sorors and Chapters posting on social media.
 - Most of the content for the workshop was gleaned from the Delta Internet Guidelines (D.I.G.). This is a public document and can be found on the national website. All Sorors are

asked to review the D.I.G. Here's a link to the document: http://www.deltasigmatheta.org/docs/policies/The_Delta_Internet_Guidelines012715.pdf. This version of the D.I.G. was updated in 2014. A new version coming out, but no date was given.

- A lot of the conversation focused on banned information (Page 7) that should not appear on any website or social media account (i.e. Sorority Crest, Torch of Wisdom, Secrets, Passwords, Signs, Grips, etc.). The 43-page D.I.G. provides extensive detail.
