Re:	Client Alert - Important Change in CBP's Importer Self-Assessment Program

In a telephone discussion on April 7th with CBP's new ISA Program Director, Joseph Rees, KMZ Rosenman has learned that, effective March 1, 2004, importers who have been notified by CBP that they are Focused Assessment ("FA") candidates may no longer apply for Importer Self-Assessment ("ISA") membership to postpone initiation of a FA audit if they have not yet become "C-TPAT Certified." C-TPAT *membership (i.e., signing and submitting the C-TPAT Memorandum of Understanding) has been a prerequisite for ISA eligibility since the inception of the program 22 months ago, however, until now, C-TPAT Certification was not a requirement.*

According to Rees, C-TPAT Certification occurs after CBP reviews and approves a C-TPAT member's Supply Chain Security Profile Questionnaire. Rees emphasized that although ISA is a CBP "Trade Facilitation Program," the agency decided internally to implement the policy change as of March 1, 2004, as a result of an increasing number of ISA applicants subject to FA notification who had failed to timely submit their C-TPAT Supply Chain Security Profile Questionnaire. Mr. Rees acknowledged that if a FA candidate had timely submitted its C-TPAT Supply Chain Security Profile Questionnaire to CBP prior to submitting its ISA application, it was likely that the importer's ISA application would be considered. (It should be noted that currently, C-TPAT *Validation* occurs after C-TPAT Certification and that therefore, a C-TPAT Validation is not a prerequisite for ISA eligibility. C-TPAT Validation is the process conducted by CBP after Certification to review and confirm (*i.e.,* "Validate") the accuracy of the Certified partner's security practices and procedures as set forth in the party's Supply Chain Security Profile Questionnaire.) Lastly, Rees advised that CBP will be updating its website shortly to reflect this change to the ISA program.

Potential FA Candidates who plan on applying for ISA membership should be aware of this important policy change, and if they have not yet joined C-TPAT and/or submitted their C-TPAT Supply Chain Security Profile Questionnaire to CBP should immediately address the status of their C-TPAT participation. What Is C-TPAT?

The U.S. Customs Service recently launched the Customs-Trade Partnership Against Terrorism (C-TPAT), a joint government-business initiative to strengthen importers' supply chains and increase border security against terrorist activities.

In addition to helping thwart future terrorism, C-TPAT members will enjoy certain benefits, including:

- Reduced number of inspections
- Assignment of an account manager
- Access to the C-TPAT membership list
- Eligibility for account-based processes (e.g., summary payment)

- Improved security along supply chains

How Do I Participate In C-TPAT?

The C-TPAT application process consists of two key steps:

- First, applicants must execute a Memorandum of Understanding (MOU) with Customs, entitled the "Agreement to Voluntarily Participate in Customs-Trade Partnership Against Terrorism."
- Second, applicants must complete the "Supply Chain Security Profile Questionnaire." This document elicits information on various matters and provides the primary basis upon which the applicant's membership will be evaluated. The application should address the company's:
 - Security Program
 - Personnel Security
 - Service Provider Requirements

The "Supply Chain Security Profile Questionnaire" must be submitted to Customs within 60 days of submitting the MOU.

Importer Self-Assessment (ISA)

Katten Muchin Zavis Rosenman and its Global Trade Advisory Group (GTAG) wish to introduce you to the Importer Self-Assessment (ISA) program offered by the Bureau of Customs and Border Protection.

What is ISA?

ISA is a new program from the Bureau of Customs and Border Protection (CBP). In contrast to traditional Customs audits, ISA permits companies to apply for membership in this program and if accepted, avoid most audits conducted by CBP.

How do I participate in ISA?

Participation in the C-TPAT initiative is a prerequisite for ISA. Beyond this, a separate application and memorandum of understanding are filed with CBP. The information you provide in your application is evaluated by CBP to determine if your company is considered eligible.

What benefits does ISA provide?

The benefits include removal from the CBP audit pool, less government interference, improved access to trade compliance information, and enhanced prior disclosure benefits to provide relief from potential penalties.

Is ISA right for my company?

CBP typically focuses its audit resources on companies whose annual import volume exceeds \$10 million. If your company is in this category, *you may be on the government's radar screen for audit selection.* Successful ISA applicants are removed from the audit pool, and the program permits you to manage your trade compliance matters, on your own terms. If you have, or are implementing reliable internal controls to manage your compliance, you could be well-positioned to take advantage of this program.

Here are some questions to ask yourself to determine if ISA is right for you:

- Are you participating or planning to participate in C-TPAT?
- Are your imports greater than \$10 million per year?
- Can your internal controls effectively manage compliance?
- Do you prefer addressing compliance issues internally, without the added presence of government auditors?
- Would you like to address compliance issues easily, and with reduced potential for penalties?
- Would you like better access to the information that CBP keeps regarding your imports?
- Do you conduct audits of your company's entries, including work undertaken by third parties?

Other Frequently Asked Questions about the ISA Program

- **Q** At what stage in the C-TPAT process does a company become eligible to apply for ISA?
- A You may apply for ISA at the same time that you apply for C-TPAT, or at any time thereafter. Your ISA application will not be reviewed until your C-TPAT profile has been reviewed by CBP and your company is C-TPAT certified. C-TPAT validation is not a prerequisite for ISA.
- **Q** How are multiple Importer of Record (IOR) numbers covered by ISA?
- A You may choose which IOR numbers or suffixes to include in your ISA application, as long as these numbers or suffixes are within the scope of your C-TPAT participation.
- **Q** May a company apply for ISA after receiving notice of an upcoming audit?
- A CBP currently allows applications for ISA anytime prior to the audit entrance conference. This policy could change in the future. In any event, you could be required to complete the audit questionnaire, even if the audit is cancelled.
