Submission of an entry form and/or physical presence on the show grounds shall constitute both implied and real consent for both the handler and the dog to be professionally video recorded and streamed live only by the professional video services as contracted by the Club for this show.

All rights to video record and live stream or otherwise exploit this event and/or the persons or animals participating in it, including the names, likenesses and biographical matter of dogs, owners, handlers, breeders and kennels participating in the event shall belong solely to the show giving Club and/or the American Kennel Club, Inc. No spectator, participant, owner, handler, breeder or kennel shall make commercial use of any video recordings of any person or animal participating in this event without prior written approval from the Club. This event may not be broadcast to social media (e.g. Facebook Live, etc) without prior written approval from the Club.

**AKC Sanctioned 4 & Under 6 Months  
Puppy Competition - Wednesday  
Fee - \$25.00**

One combined class will be offered for puppies that are four months and under six months of age on the date of the competition. A foreign born dog may enter this class if they are registered in the country of origin. Best of Breed and Best of Opposite Sex to Best of Breed will be chosen. An AKC registration number or AKC litter number is required for entries.

Dogs are required to be vaccinated in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.

Dogs that are owned or co-owned by a professional handler may compete in this class but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.*

AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise.

Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4-6 month Puppy Special Attraction event.

### AKC National Owner-Handled Series

(Remember to check the box at the bottom of the entry form)

The AKC Owner/Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

All dogs that are owner/handled and are not owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner/Handler eligible the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book and the catalog. **Dogs must be handled throughout the breed level for the regular show by an eligible owner. Professional handlers, household members and current assistants\*\* to professional handlers may not exhibit the dog in this competition.**

The Owner Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and undefeated winners of the non-regular classes. *This excludes all dogs defeated during class and winners competition for the regular show.*

- If the Best of Breed winner is Owner-Handled competition eligible, it will automatically be Owner Handled Best of Breed and be eligible to compete in both the regular as well as the Owner-Handler Group.
- If the Best of Breed winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed is eligible, the Best of Opposite Sex to Best of Breed will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible and Select Dog and Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose dogs of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who completed in Best of Breed for the AKC National Owner-Handled Series.
- If the Best of Winners is eligible, the other Winners are ineligible since it was defeated.
- No class dogs other than the Winners Dog or Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners Competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog.*

*\*\*A current assistant is defined as anyone employed by a professional handlers on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend.*

### Non-Regular Classes

#### Non-Regular (Additional) Classes Involving Single Dog Entries

**Veteran Classes** - Class for dogs & class for bitches seven years & under nine years  
Veteran Classes - Class for dogs & class for bitches nine years & under eleven years  
Veteran Classes - Class for dogs & class for bitches eleven years & under thirteen years  
Veteran Classes - Class for dogs & class for bitches thirteen years & over  
Dogs & Bitches entered in Veterans need not be intact. Spayed & Neutered animals may be shown. Winners, if otherwise undefeated, are eligible for Best of Breed Competition.

**Working Classes - Open to any** dogs or bitch holding a Water Title issued by the Portuguese Water Dog Club of America, Inc. (Note: A junior Water Certificate is NOT a Title). Dogs must be eligible to compete in AKC Conformation in every way. (Spayed & Neutered dogs cannot compete in this class). The winners of these classes are eligible to compete in Best of Breed competition if otherwise undefeated. "Effective 2013, the dog must be presented in the Working Title Class by the same person who handled them to the PWGCCA, Inc. Water Title".

## BEST OF BREED COMPETITION

### **Non-Regular (Additional) Classes Involving Multiple Dog Entries**

**Stud Dog Class** - For Stud Dogs and two of their Get. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with their Get. The owner of the Stud Dog need not necessarily be the owner of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get **MUST BE** entered in a Regular Class, Best of Breed Competition or some other Non-Regular class.

**Brood Bitch Class** - For Brood Bitch and two of their Produce. The Brood Bitch must be entered in the Brood Bitch Class and shown in the ring with their Produce. The owner of the Brood Bitch need not necessarily be the owner of the Produce. While the merits of the Brood Bitch are not to be considered in the placement of the entry, the Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Produce **MUST BE** entered in a Regular Class, Best of Breed Competition or some other Non-Regular class.

**Brace Class** - Two Portuguese Water Dogs, performing in unison and presented by a maximum of two handlers. Both dogs competing in the Brace Class must have at least one common owner. Each dog **MUST ALSO BE** entered in another regular or non-regular class for which an entry is paid. The entry form must be marked accordingly in the space provided for additional classes as "Brace Class". If more than one brace is entered by the same owner, the dogs comprising EACH Brace must be so designated "Brace No. 1" "Brace No. 2" etc.

**NOTE: As the judge's decision in these classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged First in the class will be eligible to compete for Best of Breed by virtue of having won this class.**

**\*Chapter 11, Section 8: of the "Rules Applying to Dog Shows: providing that a "castrated male may be entered as a Stud Dog in the Stud Dog Class and a spayed bitch may be entered as a Brood Bitch in the Brood Bitch Class".**

### **AWARD OF MERIT**

Other than for Best of Breed, Best of Opposite Sex, Best of Winners, Select Dog, and Select Bitch a trophy may be presented by the conformation judge in recognition of superior quality. Awards of Merit will be awarded beginning AFTER Select Dog and Select Bitch, from remaining dogs/bitches in the Best of Breed class that are of merit as deemed by the judge. These awards shall be limited to no more than 10 percent of the total Best of Breed entry (which entry shall be factored up, e.g., 67 total dogs/bitches entered would constitute 70, and 7 Awards of Merit could then be awarded). Rosette/Trophy will be given each PWD selected for an Award of Merit.

### **PWDCA FUTURITY/MATURITY STAKES RULES:**

**NOTE: ONLY PROPERLY NOMINATED PUPPIES MAY ENTER THE FUTURITY AND MATURITY STAKES. Entrants will be verified. Competition in the Futurity/Maturity Stake requires four steps:**

1. The litter is nominated prior to whelping.
2. The puppy owner or breeder nominates an individual puppy from a nominated litter before the puppy reaches 5 months of age.
3. The nominated puppy is entered in the appropriate Futurity/Maturity Class at the Show.
4. Futurity/Maturity entrants **MUST** also be entered in a Regular Conformation Class or Best of Breed. Champions of Records and professional handlers may compete.

Futurity/Maturity Stake must be entered as an additional class. Puppies are eligible only for the futurity stake which is held in conjunction with the first PWDCA National Specialty on or after the date a puppy reaches six (6) months of age. (i.e. A properly nominated puppy may be entered and shown in the immediately preceding futurity stake was held before the puppy was six months of age). **Puppies may be over 18 months of age when the next National Specialty is held for which puppies are eligible to be entered and when the show follows a National where the puppy was under 6 months of age.**

**The Sweepstakes** is open to any purebred Portuguese Water Dog, who on the day of the show, will be at least six months of age and under 18 months of age. Sweepstakes entrants **MUST ALSO be entered** in one of the Regular Classes or Best of Breed at the regular entry fee, and on the regular entry form, shown as "Additional Classes", Champions of Record and Professional Handlers are eligible to participate in Sweepstakes. Entry fee is \$32.00.

Champions of Record and Professional Handlers and neutered and spayed dogs are eligible to participate in Veteran Sweepstakes in accordance with Chapter 11, Section 8. Dogs entered in Veteran Sweepstakes **NEED NOT** be entered in a Regular Class. Indicate "Veteran Sweepstakes" and the appropriate age division in the space provided for "Additional Classes". Entry fee is \$32.00.

Neutered dogs and spayed bitches will be eligible to compete. Indicate Veteran Sweepstakes and the age division on the regular entry form under Additional Classes.
