Maternal Health in FY2021



SPM 4 – Adolescent Mental Health

Sue Gehling, PMHNP, FNP, Classroom Clinic

Sue will share the model of her telehealth company, Classroom Clinic, which provides mental health services to children in rural schools. There is a growing and unmet need for child psychiatry services for children living in rural areas. New models of care are necessary to better meet these needs. This model allows us to connect psychiatric providers with school districts, thereby improving access to children's psychiatric care for rural communities.

Addressing Maternal Mortality in Title V MCAH Agencies

This session will provide a brief overview of SPM1: Maternal Mortality Rate. Stephanie will share state-level work to reduce Iowa's maternal mortality rate, and provide an in-depth overview of the new requirements for MCAH contractors related to the SPM and available resources. Kevin will discuss Iowa blood lead testing data and the importance of routine, periodic testing, referral and intervention services, and working with local Childhood Lead Poisoning Prevention Programs and providers to increase testing.

Tier 2 Direct Services – this breakout is for Tier 2 agencies to discuss plans and any questions related to the new requirements for Tier 2 agencies and share ideas for innovative service delivery. There will be opportunities to discuss the new performance measure and strategies to increase the number of clients seen.

Healthy Child Care Iowa (HCCI) is celebrating 20 years of Child Care Nurse Consultant (CCNC) services! Heidi will provide an overview of the history of HCCI and statewide CCNC services today including a review of the FY20 CCNC performance measure data. The new FY21 CCNC performance measures, tracking tools and strategies to meet statewide goals will be discussed.
