Personal protective equipment (PPE) is used every day by Gaudenzia employees to protect themselves, their clients and others while providing care.



All of Gaudenzia's residential locations in Pennsylvania, Maryland, Delaware and Washington, D.C., have remained open, and we have admitted more than a thousand patients since the coronavirus pandemic began in March.

In total, Gaudenzia operates more than one hundred programs, and operating our residential programs comes with a cost. This was true enough in happier times, as we provide services to everyone seeking treatment, regardless of their ability to pay.

The cost of doing this is even higher now. Most important, for the safety of all, is personal protective equipment (PPE) — cloth masks, surgical masks, gowns and face shields — which comes with a monthly price tag of \$211,000.



**Editor's Note**: The following statement was issued by Dr. Dale Klatzker, Gaudenzia's President and CEO, shortly after the civil unrests began across the nation.

## Letter on Diversity

Nullifying the long-standing racism in our society is imperative for us all. Racism is poisonous, and its effects are real, pervasive and traumatic. Systemic racism is not

beyond our control, but it is ever-present in our society. The Covid-19 pandemic doesn't stop it. The addiction epidemic doesn't stop it. Both of these have disproportionately impacted people of color, and both of these exposes and reveals our racism. Racism is not something that can be delayed, nor can it be postponed for another day to address —it is a constant. White supremacy does not shelter in place, and anti-blackness does not take vacations.

Change is necessary. Author Ta-Nahisi Coates recently wrote that what we are experiencing opens a new window — "An America that looks away is ignoring not just the sins of the past but the sins of the present and the certain sins of the future."

As the leadership of Ben & Jerry's recently wrote, "We do not have an option to look away. No one and not for any of us. Every citizen, every politician, and every company must do its part to look at the truth without flinching. In that way, together, we'll continue the fight for a more just and equitable country." I echo these sentiments, and my heart aches for what we are observing and living—we can and must not let this continue.

Diversity is the mixture of individuals in society, while inclusion is allowing that mixture to exist and work well together. Diversity recognizes that everyone is different. Some differences people are born with and cannot be changed. Other differences are adopted as part of our unique identity. Inclusion is involvement and empowerment, where the inherent worth and dignity of all people are recognized. Gaudenzia was inclusive since its beginnings in 1968 and will continue to embrace diversity, inclusion and all of humanity today and into the future.

I picked this woman up from a coronavirus shelter in the Scranton area. She was eight-months pregnant and had very little prenatal care before coming to our facility. She was eager to be in treatment and start a new life for both her and her baby, but she was very afraid. Her prior experiences had made her hesitant to trust anyone.

I was able to watch this incredibly brave, strong woman give birth. I held her hand and told her how proud I was of her. I spent the night in the hospital with her to make that sure she and her baby were okay. Our facility is all that she has right now. She has no supportive family, so my coworker and I took on the responsibility of encouraging and supporting her during this important moment in her life, when she became a mother.

Every day, I show up to work with the hope that, as a Gaudenzia graduate and now employee, I can be a role model to the women who are wearing the shoes that I once wore. Instead, on this day, a woman taught me something about myself. Her strength and

commitment are two of the reasons I show up to work. It is also why so many of my coworkers show up every day and put their best foot forward. It reminds me that even in the toughest of times, helping someone else through their own struggle is helping me.

# Alumni Spotlight **Shyan S.**

I remember a time in my life when every day was just a different degree of awful, without any hope on the horizon.

For me, "awful" had just become so comfortable. However, I can say that everything I did during that time was motivated by a desire and a need to escape the pain I had become so accustomed to in my active addiction and my life at that time.

My story reflects many stories of recovery regarding my active addiction, causing harm, harming myself and not being able to stop, no matter how much I wanted to. It was a long journey from being unable to realize that there was a better, more compassionate way to live. I had been to jail and rehabilitation programs multiple times since my first use, and I never wanted to put the effort into staying clean or making changes. I had never made it past 30 days of being sober. Eventually, I came to the Community House at Gaudenzia in Erie, Pennsylvania. I resisted and rejected the ideas and the process of recovery via AA/NA, and I fought the program each and every step. The staff at the Community House started to work with me to develop hope that things could be better. They never gave up on me, and they gave me the feeling that I could do something better and that they really cared about me.

Slowly, I began to really participate in the community, discovering that "those girls" (my community members) and I had so much in common. I felt like I became a part of something. I started going to recovery meetings, got a sponsor and worked on my 12 steps. Things got so much better in my life and within myself.



The clients and staff at Gaudenzia Erie, Inc.'s **House of Healing** have been busy painting inspirational messages on rocks, which were scattered throughout the Erie community. This outreach was done to provide a boost of morale to individuals who located the rocks while they were out walking.

I was able to see my son for the first time in months, and I was able to get a job for the first time in a very long time. I noticed that I was able to have honest conversations with others as well, which was revolutionary for me. This was a totally different way of living, and I learned that every day is a chance to practice these skills from when I started to make these changes up until today.

My life is still imperfect. Things still go wrong for me at times, and the deepest changes are still unfolding. I no longer wake up in the morning preparing for only pain and misery as my only feelings. Learning how to cope with disappointments and unhappy events that come up by using the skills and support that I started learning at the Community House is my new normal. It transformed me and my life.

I owe the staff and my peers during my Community House days a debt that I feel I can never repay directly. Without them in my life, just when I needed them, I know that I would still be suffering and on a journey to an early death. I am forever grateful for the opportunities that Gaudenzia's Community House gave to me. The sustained care and support that I have received gave me the courage to apply to become an employee of the agency and give to others what was given to me.
