

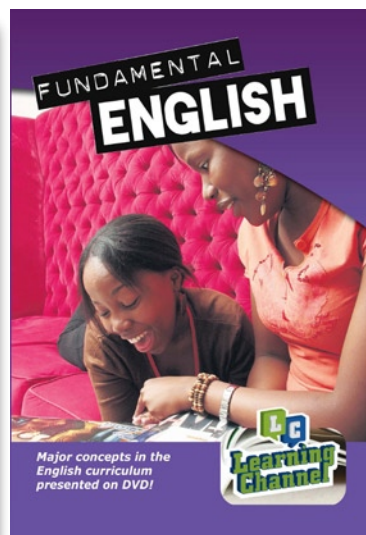
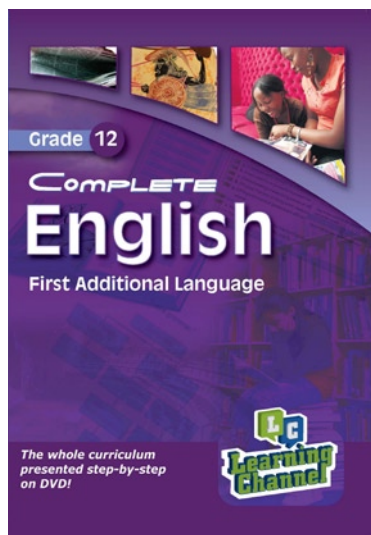

**SECTION A: COMPREHENSION****QUESTION 1**

Read the following passage (Text A) and answer the questions that follow.

**HAITI EARTHQUAKE: THOUSANDS FEARED KILLED**

1. A major earthquake rocked Haiti, killing possibly thousands of people as it toppled the presidential palace and hillside shanties alike and left the Caribbean nation appealing for international help.
  2. A five-storey UN building was also brought down by Tuesday's 7,0 magnitude quake, the most powerful to hit Haiti in more than 200 years according to the US Geological Survey. Reuters television footage from the capital, Port-au-Prince, showed scenes of chaos on the streets with people sobbing and appearing dazed amid the rubble.
  3. The quake's epicentre was only 116 km from Port-au-Prince. About 4 million people live in the city and surrounding area. Aftershocks as powerful as 5,9 rattled the city throughout the night and into Wednesday.
  4. Reports on casualties and damage were slow to emerge due to communication problems. UN officials said normal communications had been cut off and the only way to talk with people on the ground was via satellite phone. Roads were blocked by rubble. Brazilian General Carlos Barcellos said at least four Brazilian members of the UN peacekeeping mission in Haiti were killed. A large number of Brazilian soldiers were also missing.
  5. A reporter in the hillside neighbourhood of Petionville reports that he saw no police or rescue vehicles. "People were trying to dig victims out with flashlights," he said. "I think hundreds of casualties would be a serious understatement." Witnesses said they saw homes and shanties built on hillsides tumble and cars bouncing off the ground as the earth shook.
  6. The poorest country in the Western Hemisphere, Haiti is ill-equipped to respond to such a disaster, lacking heavy equipment to move debris and sufficient emergency personnel. "I am appealing to the world, especially the United States, to do what they did for us back in 2008 when four hurricanes hit Haiti," Raymond Alcide Joseph, Haiti's ambassador to Washington, said in a CNN interview. "At that time the UN dispatched ... a hospital ship off the coast of Haiti. I hope that will be done again ... and help us in this dire situation we find ourselves in."

7. UN peacekeeping chief, Alain Le Roy, said the main UN building in Port-au-Prince had collapsed. "We don't know how many people were in the building," he told reporters. Le Roy's deputy, Edmond Mulet, said 200 to 250 people work in the building during normal hours. Since the earthquake struck after 5 pm local time – after working hours – it was not clear how many people would have been inside. Some 9 000 UN police and troops are stationed in Port-au-Prince to maintain order.
8. There were more houses destroyed than standing in Delmas Road, a major thoroughfare in Port-au-Prince, another Food for the Poor employee said. The Hotel Montana, where many Foreigners stay, was also damaged. "Within a minute of the quake ... soil, dust and smoke rose up over the city, a blanket that completely covered the city and obscured it for about 12 minutes," Mike Godfrey, who works for USAID, told CNN. About 100 of the hotel's 300 guests had been evacuated.

## QUESTION 2

Read the following passage (Text B) and answer the questions that follow.

### Mom begs for kidnap gang to return her son

1. The mother of five-year-old Samuel Amoes is begging the men who snatched her youngest son from church on Sunday morning to return him to her unharmed. Samuel is the youngest son of a wealthy Angolan couple who have mining and other business interests in that country.
2. The boy was allegedly taken by a gang of four men who "pulled him by the arm and dragged him away" as he played with his older brother in the Sunday school section of the family's church in Johannesburg.
3. His mother, Maggie Amoes, who lives with her husband and four children in Johannesburg, flew back to South Africa yesterday from a business trip in Angola after hearing about the kidnapping. Too upset to speak, she asked private detective Declan Condon, who is investigating the case, to relay this message to the kidnappers: "Whoever has taken him, all I am interested in is getting back my youngest son. I am willing to meet any demands you may have. I am pleading with you, please phone me. I will meet you anywhere."

4. Condon said neither he nor the family had received a ransom demand and they were appealing to the kidnappers to make contact with them. Condon said neither he nor the family had received a ransom demand and they were appealing to the kidnappers to make contact with them.
5. While their parents were away on an eight-week business trip to their home country, the Amoes children, two girls and two boys, were cared for by an aunt and a domestic worker. Samuel's kidnappers are believed to have scouted the Portuguese Catholic church two months ago, and had asked if they could join the congregation – though they could not understand Portuguese. Before they left the church, the men asked to be shown the Sunday school area.
6. The same men are believed to have returned on Sunday at 9am, this time armed. They held up the congregation at gunpoint, locked worshippers inside the church, and two headed for the Sunday school. "They brushed the other children out of the way and walked right up to Samuel, pulled him by the arm and dragged him away," Condon said. The gang left the congregation locked inside the sanctuary and disappeared with little Samuel.
7. Samuel was last seen wearing light-blue jeans, Michael Jordan shoes, white socks, a red and blue short-sleeved shirt with white stripes, and a blue long-sleeved tracksuit top with dark blue stripes.

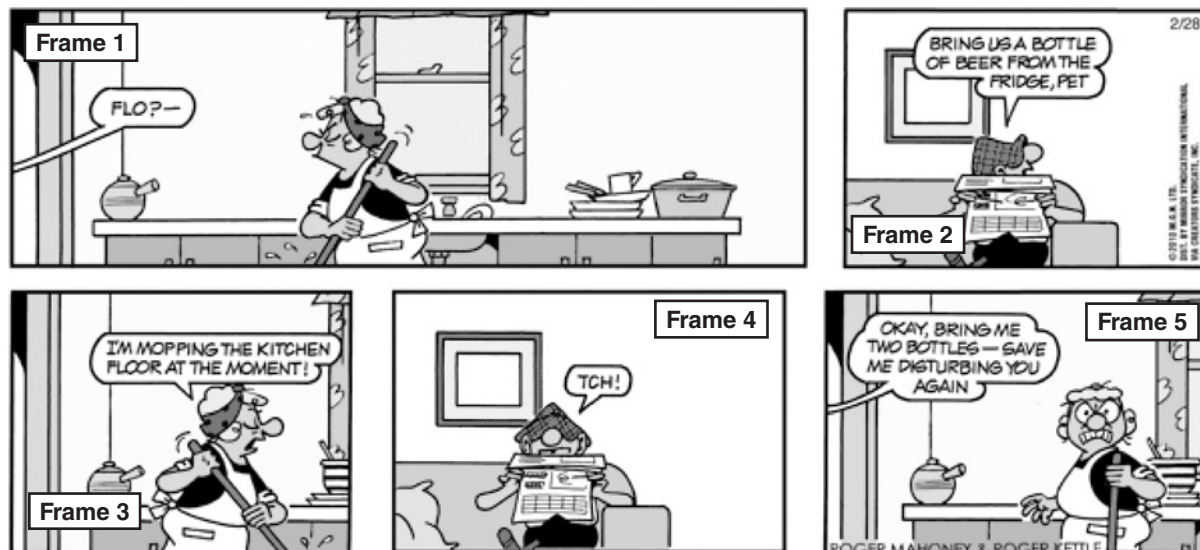
