# The Number System

**Know that there are numbers that are not rational, and approximate them by rational numbers.**

<b>Math.Content.8.NS.A.1</b> Know that numbers that are not rational are called irrational. Understand informally that every number has a decimal expansion; for rational numbers show that the decimal expansion repeats eventually, and convert a decimal expansion which repeats eventually into a rational number.					
<b>Math.Content.8.NS.A.2</b> Use rational approximations of irrational numbers to compare the size of irrational numbers, locate them approximately on a number line diagram, and estimate the value of expressions (e.g., $\pi^2$ ). <i>For example, by truncating the decimal expansion of <math>\sqrt{2}</math>, show that <math>\sqrt{2}</math> is between 1 and 2, then between 1.4 and 1.5, and explain how to continue on to get better approximations.</i>					

# Expressions & Equations

## Expressions and equations work with radicals and integer exponents.

<p><b>Math.Content.8.EE.A.1</b>            Know and apply the properties of integer exponents to generate equivalent numerical expressions. For example, <math>3^2 \times 3^{-5} = 3^{-3} = 1/3^3 = 1/27</math>.</p>					
<p><b>Math.Content.8.EE.A.2</b>            Use square root and cube root symbols to represent solutions to equations of the form <math>x^2 = p</math> and <math>x^3 = p</math>, where <math>p</math> is a positive rational number. Evaluate square roots of small perfect squares and cube roots of small perfect cubes. Know that <math>\sqrt{2}</math> is irrational.</p>					
<p><b>Math.Content.8.EE.A.3</b>            Use numbers expressed in the form of a single digit times an integer power of 10 to estimate very large or very small quantities, and to express how many times as much one is than the other. For example, estimate the population of the United States as 3 times <math>10^8</math> and the population of the world as 7 times <math>10^9</math>, and determine that the world population is more than 20 times larger.</p>

Interpret scientific notation that has been generated by technology.</p>

Compare two different proportional relationships represented in different ways. For example, compare a distance-time graph to a distance-time equation to determine which of two moving objects has greater speed.</p>

<p><b>Math.Content.8.EE.B.6</b> Use similar triangles to explain why the slope <math>m</math> is the same between any two distinct points on a non-vertical line in the coordinate plane; derive the equation <math>y = mx</math> for a line through the origin and the equation <math>y = mx + b</math> for a line intercepting the vertical axis at <math>b</math>.</p>

<p><b>Math.Content.8.EE.C.7</b> Solve linear equations in one variable.</p>					
<p><b>Math.Content.8.EE.C.7a</b> Give examples of linear equations in one variable with one solution, infinitely many solutions, or no solutions. Show which of these possibilities is the case by successively transforming the given equation into simpler forms, until an equivalent equation of the form <math>x = a</math>, <math>a = a</math>, or <math>a = b</math> results (where <math>a</math> and <math>b</math> are different numbers).</p>					

## Analyze and solve linear equations and pairs of simultaneous linear equations.

<p><b>Math.Content.8.EE.C.7b</b> Solve linear equations with rational number coefficients, including equations whose solutions require expanding expressions using the distributive property and collecting like terms.</p>					
<p><b>Math.Content.8.EE.C.8</b> Analyze and solve pairs of simultaneous linear equations.</p>					
<p><b>Math.Content.8.EE.C.8a</b> Understand that solutions to a system of two linear equations in two variables correspond to points of intersection of their graphs, because points of intersection satisfy both equations simultaneously.</p>					
<p><b>Math.Content.8.EE.C.8b</b> Solve systems of two linear equations in two variables algebraically, and estimate solutions by graphing the equations. Solve simple cases by inspection. <i>For example, <math>3x + 2y = 5</math> and <math>3x + 2y = 6</math> have no solution because <math>3x + 2y</math> cannot simultaneously be 5 and 6.</i></p>

<b>Math.Content.8.F.A.2</b> Compare properties of two functions each represented in a different way (algebraically, graphically, numerically in tables, or by verbal descriptions). <i>For example, given a linear function represented by a table of values and a linear function represented by an algebraic expression, determine which function has the greater rate of change.</i>

<p><b>Math.Content.8.F.A.3</b>                      Interpret the equation <math>y = mx + b</math> as defining a linear function, whose graph is a straight line; give examples of functions that are not linear. For example, the function <math>A = s^2</math> giving the area of a square as a function of its side length is not linear because its graph contains the points <math>(1, 1)</math>, <math>(2, 4)</math> and <math>(3, 9)</math>, which are not on a straight line.</p>					

**Use functions to model relationships between quantities.**

<p><b>Math.Content.8.F.B.4</b>                      Construct a function to model a linear relationship between two quantities. Determine the rate of change and initial value of the function from a description of a relationship or from two <math>(x, y)</math> values, including reading these from a table or from a graph. Interpret the rate of change and initial value of a linear function in terms of the situation it models, and in terms of its graph or a table of values.</p>

# Geometry

Use relative frequencies calculated for rows or columns to describe possible association between the two variables. <i>For example, collect data from students in your class on whether or not they have a curfew on school nights and whether or not they have assigned chores at home.
