Justice Center – There have been 150 inclement weather days so far. Contractor is making good progress inside with painting and dry wall. The new furniture is scheduled to be delivered on October 25, 2021. There will be a pre-conference meeting with moving bidders this coming Friday. Tentative date for moving will be a 2–3-day transition for each department. PMP for \$97,000. Al Peeler has a meeting tomorrow with the architect about washing bricks.
