Grunts Move Junk Tariff

Interstate and Vermont Household Goods

Applicability of Tariff

This tariff contains the regulations and rates applicable to the provision of interstate and intrastate household goods moved by GRUNTS MOVE JUNK. These services are furnished between points and places originating in Vermont.

SECTION 1**1.0 Transportation Charges**

Transportation Charges include the hourly rates as listed below.

1.1 Hourly Rates and Charges

Moves will be conducted on a “straight time”/ “Port to Port” basis, with a minimum hourly charge as set out below plus actual travel time. The clock starts at the appropriate hourly rate when the movers leave the GRUNTS MOVE JUNK office location, and includes the movers estimate return time to the office location. Equipment is billed out at the rate U-haul Charges for Grunts Move Junk has an equipment contract with uhaul.

1.2 Office Hours / Minimum Hourly Charges:

GRUNTS MOVE JUNK will operate Monday – Friday, 8:00 am – 6:00 pm and Saturday and Sunday from 8:00am – 4:00pm.

Monday- Friday

Two-Hour Minimum Charge

Saturday- Sunday

Three-Hour Minimum Charge

Recognized Federal Holidays

Three- Hour Minimum Charge

After the minimum hourly charge, the hourly rates are calculated in fifteen-minute increments. Any interim charge is rounded up to the next fifteen-minute increment. If customers cancel within 48 hours of their move, GRUNTS MOVE JUNK will charge the applicable minimum. Hourly rates are the same, seven days a week, 24 hours a day, in every season of the year. Customers are not charged an additional fee for overtime labor. For interstate moves the driving time will be calculated using Google maps shortest route, and billed at rates in section 1.1

SECTION 2**2.0 ADDITIONAL SERVICES**

The following charges shall be assessed in addition to the hourly rates quoted in Section 1 of this tariff, in connection with a move involving additional items:

2.1 Bulky Article Charges (per item)

- • Floor Model Television (48" or above) - \$120
- • Pool Tables- \$275
- • Gun cabinet - \$100
- • Steel Gun Cabinet (in excess of 400 lbs.) - \$250
- • Hot Tubs, Whirlpools - \$250
- • Riding Lawnmowers- \$100
- • Freezers - \$100
- • Flat Screen Televisions (41" or above) \$100.00
- • Golf Carts \$100

2.2 Elevator or Stair Carry

GRUNTS MOVE JUNK does not charge an additional fee for elevator or stair carry, except as specified in Section 2.1 above.

2.3 Excessive Distance or Long Carry Charges

GRUNTS MOVE JUNK does not charge an additional fee for carrying articles an excessive distance to or from the motor vehicle.

2.4 Pick Up and Delivery

GRUNTS MOVE JUNK does not charge an additional fee for making additional pick-ups or deliveries after the initial stop.

2.5 Packing and Unpacking

1. **2.5.1** GRUNTS MOVE JUNK does not charge an additional fee for packing and unpacking. The packing rate is the same as the hourly rate listed in Section 1; plus the market price of packing materials, including sales tax on the materials.

1. **2.5.2** GRUNTS MOVE JUNK is not responsible for items packed by the customer. If the Customer Begins Packing and Request Grunts Move Junk to complete the packing, Grunts Move Junk is not responsible for all items packed, due to the inability to determine what boxes were packed by the customer and what items were packed by Grunts Move Junk. Boxes containing fragile or breakable items must be properly labeled. GRUNTS MOVE JUNK reserves the right to decline any moves consisting of extremely large or fragile items.

2.6 Piano Charges

GRUNTS MOVE JUNK will assess the move for pianos and has the right to decline any piano move. Upon arrival be sure to declare any pianos.

2.7 Articles, Special Servicing

The rates and charges in this tariff do not include servicing or connection of appliances such as freezers, refrigerators, computer equipment, washers, dryers, televisions, and similar articles.

2.8 Waiting Time

The customer is charged the rates specified in Section 1 for all waiting time or delays, which are not the fault of GRUNTS MOVE JUNK. To include waiting for customers arrival to loading and/or unloading site, and including waiting for customer to complete final walk through and inspection of items. If customer declines to conduct final walk through with Grunts Move Junk, Grunts will take photos of completion of move customer also waives responsibility for damaged items.

SECTION 3**3.0 RULES AND REGULATIONS****3.1 Claims**

3.1.1 All claims for loss, damage or overcharge must be written and should be attached to the Bill of Lading.

3.1.2 Claimant must notify carrier of all claims for concealed damage within 9 months of the move. GRUNTS MOVE JUNK must be given reasonable opportunity to inspect damaged items.

3.1.3 Although our movers will be careful with your possessions, from time to time damages may occur. If damages are caused by our service, GRUNTS MOVE JUNK reserves the right to repair the damage(s) in question. If we determine that damages can not be repaired, we reserve the right to either replace or compensate at \$.60 per pound for the damaged Item. (Accidents happen even to the most careful of people or **moving companies**. ... coverage is called "released value protection" and is set at **60 cents per pound**.) If there is damage, notify GRUNTS MOVE JUNK immediately. They will complete a Damage Report before they leave your site. If you discover damage after the move, call the office within 30 days of your move. If you discover damaged items photographic proof is required upon first claim, if no photographic evidence is provided within 30 days no damage claim will be honored. No damage claims will be honored until the charges for moving services are paid in full.

3.1.4**Full Value Protection**

Under Full Value Protection, your mover is liable for the replacement value of lost or damaged goods in your entire shipment. This is the more comprehensive plan available for the protection of your belongings. Unless you select the alternative level of liability described Above—Released Value—your mover will transport your shipment under the Full Value Protection level of liability. If any article is lost, destroyed or damaged while in your mover's custody, your mover will, at its discretion, offer to do one (1) of the following for each item:

- **Repair the item**
- **Replace with a similar item**
- **Make a cash settlement for the cost of the repair**

Under this option, movers are permitted to limit their liability for loss or damage to articles of extraordinary value, unless you specifically list these articles on the shipping documents. An article of extraordinary value is any item whose value exceeds \$100 per pound (such as jewelry, silverware, china, furs, antiques). Ask your mover for a written explanation of this limitation before your move.

3.1.5 Full Value Protection - The minimum declared value of a shipment for Full Value Protection is \$10,000 or \$6.00 multiplied by the total weight of the shipment in pounds, whichever is greater. **Maximum Coverage for house hold goods is limited to \$30,000 and a single item claim can not exceed \$10,000**
FVP - Coverage is calculated at 1% of Value (ex. \$10,000 in value would cost \$100)

For additional insurance on these items a third party insurance may be able to assist.

3.2 Computing Charges

GRUNTS MOVE JUNK rates are computed by multiplying the applicable hourly rate by the time as provided in Section 1.

Plus any additional Insurance,

Plus Materials and any cost attritubited with the move.

3.3 Governing Publications

GRUNTS MOVE JUNK rates and charges are governed by the terms and conditions of this tariff, and the Rules and Regulations of the Vermont Public Service Commission.

3.4 Items of Particular Value

GRUNTS MOVE JUNK does not assume any liability whatsoever for documents, currency, credit cards, jewelry, watches, precious stones or articles of extraordinary value including accounts, bills, deeds, evidences of debt, securities, notes, postage stamps, stamp collections, trading stamps, revenue stamps, letters or packets of letters, alcoholic beverages, firearms, art, paintings, drawings, coin collections, articles of peculiarly inherent or intrinsic value, precious metals or articles manufactured there from. GRUNTS MOVE JUNK will not accept responsibility for safe delivery of such articles if they come into possession with or without GRUNTS MOVE JUNK's knowledge. These items should be loaded into customers POV or shipped USPS UPS, Fedex, or another shipping service.

5. 3.5 Bill of Lading, Contract Terms, and Conditions

Each customer will be provided with a copy of GRUNTS MOVE JUNK’s Bill of Lading. The terms and conditions of the Bill of Lading, attached hereto, are hereby incorporated by reference.

5. 3.6 Delays

GRUNTS MOVE JUNK shall not be liable for any delays in transporting household goods resulting from an act of God or fault or neglect of any unforeseen entities.

SECTION 4

0. 4.0 PROMOTIONS

GRUNTS MOVE JUNK shall apply the following promotions, in a uniform and nondiscriminatory fashion:

0. 4.1 Military/Senior Citizens

A promotional rate of normal hourly service charges for moving, packing and unpacking items listed below will be applied for customers who are active duty military, disabled veterans, and senior citizens that provide proper proof of same. Extra chargeable items will follow rates in Section 2. 2.1. Moves will be conducted on a “straight time” basis, with a minimum hourly charge as set out in Section 1.2 plus actual travel time. The clock starts at the appropriate hourly rate when the movers leave the GRUNTS MOVE JUNK office location, and the movers estimate return time to the office location. The hourly rates and charges are indicated below:
