- A HAZARD is something with the potential to cause harm
- (this can include articles, substances, plant or machines, methods of work, the working environment and other aspects of work organisation)
- Possible examples chemicals, electricity, machinery, working from ladders etc.





- RISK is the likelihood of potential harm from that hazard being realised. The extent of the risk will depend on:
 - The likelihood of that harm occurring
 - The potential severity
 - The population who might be affected



DANGER - DEFINITION

- The Oxford Dictionary definition includes ".. Liability or exposure to harm, risk, peril, danger of death..." - clearly the intent is "risk"
- In common usage, the term means different things to different people – to some hazard and to others risk.
- Best to stick to "hazard" and "risk" unless there is a good reason to use "danger" in a particular context.



MAIN (LEGAL) PURPOSES

- Enable dutyholders to identify the measures they need to take to comply with health and safety law
- Identify how the risks arise and how they impact on those affected. This information is needed to make decisions on how to manage those risks

RA IN MANAGEMENT REGS KEY ISSUES (1)



- Duty on employer Regulation 3(1)
 - Risks to employees
 - Risks to non-employees
- Duty on self-employed Regulation 3(2)
 - Risks to themselves
 - Risks to others
- Suitable & sufficient



SUITABLE & SUFFICIENT

- Key HSE principle of proportionality
- Degree of sophistication of a risk assessment should be proportional to the risk itself

Ultimately it is a question for the Court.....

SUITABLE & SUFFICIENT Some Pointers!



- That all significant hazards have been identified
- That the risks have been properly evaluated considering likelihood and severity of harm
- Measures necessary to achieve acceptable levels of risk have been identified (Principles of Prevention)
- Actions have been prioritised to reduce risks (Hierarchy of Control)
- The assessment will be valid for some time
- Actual conditions and events likely to occur have been considered during the assessment
- Everyone who may be harmed has been considered

RA IN MANAGEMENT REGS KEY ISSUES (2)



- Purpose: for identifying the measures needed to comply with requirements & prohibitions imposed by relevant statutory provisions
- RA to be reviewed if:
 - Reason to suspect it is no longer valid
 - Significant change to matters to which it relates
 - What might these be?
- RA to be changed if the review shows it is necessary

RA IN MANAGEMENT REGS KEY ISSUES (3)



- Record to be kept if the employer has 5 or more employees, to include:
 - Significant findings
 - Any group of employees identified as being especially at risk



SIGNIFICANT FINDINGS

- An effective statement of hazards and risks which leads management to take the relevant actions to protect health and safety including:
 - a record of the preventive and protective measures in place to control the risks;
 - what further action, if any, needs to be taken to reduce risk sufficiently;
 - proof that a suitable and sufficient assessment has been made.

RISK ASSESSMENT KEY ELEMENTS





NB: Don't forget under **Step 3** to also consider whether existing precautions are adequate or whether more should be done.

COSHH 2002 – Suitable & Sufficient



Regulation 6(2) + ACoP L5 Paras 56-63

- (2) The risk assessment shall include consideration of-
 - (a) the hazardous properties of the substance;
 - (b) information on health effects provided by the supplier, including information contained in any relevant safety data sheet;
 - (c) the level, type and duration of exposure;
 - (d) the circumstances of the work, including the amount of the substance involved;
 - (e) activities, such as maintenance, where there is the potential for a high level of exposure;
 - (f) any relevant occupational exposure standard, maximum exposure limit or similar occupational exposure limit;
 - (g) the effect of preventive and control measures which have been or will be taken in accordance with regulation 7;
 - (h) the results of relevant health surveillance;
 - the results of monitoring of exposure in accordance with regulation 10;
 - in circumstances where the work will involve exposure to more than one substance hazardous to health, the risk presented by exposure to such substances in combination;
 - (k) the approved classification of any biological agent; and
 - (I) such additional information as the employer may need in order to complete the risk assessment.

CONAWR 2005 – Suitable & Sufficient




Regulation 5(3) + Guidance L108 Paras 49-59

- (3) The risk assessment shall include consideration of -
 - (a) the level, type and duration of exposure, including any exposure to peak sound pressure:
 - (b) the effects of exposure to noise on employees or groups of employees whose health is at particular risk from such exposure;
 - (c) so far as is practicable, any effects on the health and safety of employees resulting from the interaction between noise and the use of ototoxic substances at work, or between noise and vibration;
 - (d) any indirect effects on the health and safety of employees resulting from the interaction between noise and audible warning signals or other sounds that need to be audible in order to reduce risk at work;
 - (e) any information provided by the manufacturers of work equipment;
 - (f) the availability of alternative equipment designed to reduce the emission of noise;
 - (g) any extension of exposure to noise at the workplace beyond normal working hours, including exposure in rest facilities supervised by the employer;
 - appropriate information obtained following health surveillance, including, where possible, published information; and
 - (i) the availability of personal hearing protectors with adequate attenuation characteristics.










Control Measures are Key!

Health and Safety Offences, Corporate Manslaughter and Food Safety and Hygiene Offences Definitive Guideline Been in place since 1 February 2016

- In 2018/2019 fines totalled £54.5 million
- In 2017/2018 fines totalled £72.6 million
- In 2016/2017 fines totalled £69.9 million
- In 2015/2016 fines totalled £38.8 million


