Congratulations! HF2253/SF1861 Passed House&Senate:Now on Governor's Desk

When the bill is signed, Medicaid will cover children who are deaf, deafblind, and hard of hearing that use American Sign Language (ASL) as their first language and need accessible inpatient mental health treatment. Thanks to Bruce Hodek and John Gournaris for their technical assistance, to Dr. Rebecca Goffman, Sheena Gamm, Cindy Bruning for their compelling testimony. And thanks to all of you for your advocacy and contacting your legislators. It clearly made a difference. We asked the Governor's office for a signing ceremony (no pun intended). We'll let you know what he says. In the meantime, please contact rep.kathy.lohmer@house.mn and sen.michelle.benson@senate.mn and thank them for being the champions of this the bill.

Update

Crazy at the capitol. For the first time since I began working here, I do believe they will end early. FYI Andrew Palmberg has been our eyes at the capitol. March Meeting Synopsis

Bob Knoll introduced our speaker, Steve Cunningham, who is retired from a career as Operations Manager with various corporations, served in Vietnam and as a Regional Manager for the American Red Cross. He came to us representing AARP, and his topic was "Fraud and Scams".



Scammers are becoming very technically involved, their methods being harder to detect, therefore, the importance to be equipped with the basic "red flags". There are door-to-door scams, postal, telephone, computer, email, iphone scams to name a few. Their commonality is giving you a line and taking your money. Remember, you have the power, not them. Always wait a day to decide. If it's good today, then it will be good tomorrow likewise.

Sweepstakes, lotteries, insurance offers, and medical coverage offers are all very common. Government representatives do not sell by phone or mail. Go online or place a call to check out any offer you may receive. Never click on an email link which you are not familiar with since this little bit of information can be used to obtain more information about you that you don't want out there. Often banking and checking security contacts arrive; respond only by calling your financial institution.

Be suspicious of anything that comes to you which you did not seek out. Review all your monthly bills and check for accuracy; scam artists can get into the system to add charges, which, while small, add up by their numbers for the scammer. Never ever give out social security numbers, bank account numbers or membership numbers; if you are asked, you can be 100% sure it is a scam.

Information was provided in packets of much information that we all need to know and remember and pass on to others. Steve had much more information, far too numerous to detail here, but some of the "red flags" he did name for us to watch out for:

1. You won some lottery money, just send money to collect it.
2. You are asked to purchase a product and send money upfront.
3. Grandmother Scam, a call reporting a family member is in distress, trouble, or injured and needs money sent.
4. Unordered merchandise and checks or money orders which you are asked to cash, which are of course bogus, and you end up the loser.
5. Any transaction you are asked to "keep quiet" about; contact your local police department as soon as possible and report this.
6. Never ever mail valuables from a home mailbox, take them to the post office and place in their blue mail box.

After such a wealth of information was presented, a very great discussion session followed, Steve did a great job answering those queries and hearing the experiences and comments of our members.

After break time, the meeting resumed with Mary Andreson giving a quote. Being it was St. Patrick's Day, she chose an old Irish blessing. Linda brought past president Monique Hammond forward to talk about her new book release which Vicki Martin has reviewed in this newsletter. Door prize winners were Marion, who received a copy of Monique's new book, and Jeanette Larson.

New Book Release

Interview with Author Monique Hammond

During our March meeting spotlight member HLAA TC past President Monique Hammond introduced us to her recently published book: **“What Did You Say?” An Unexpected Journey Into the World of Hearing Loss**. For those who were not at the meeting, Monique answers a few questions for us today.

What actually happened to your ear(s), and how did it affect your life?

Until the 12th of September 2005, I had wonderful acoustic hearing. However, on that day, I suffered a very sudden, profound hearing loss in my left ear. My hearing went into freefall over a four-hour period. A little later, I was beset by a vertigo attack so severe that I ended up in the hospital: My whole inner ear had gotten whacked. I was told that I had a Sudden Sensorineural Hearing Loss (SSHL).

The “ear event” left me with a severe loss in the upper frequencies, lopsided hearing, aggressive 24/7 tinnitus, noise sensitivity, and pesky balance problems. The incident became a life-changer and ultimately a career-ender. Yet, it also put my life on a different track with a different mission.

When did you start writing?

I began writing early 2007. As I tried to learn about my condition, I found out that I either did not know enough about ears and hearing or that I knew the wrong stuff, which made it hard to communicate effectively with my specialists. I finally decided that, in order to make sense of the puzzle, I had to do some serious studying up myself — starting with the very basics. It took a bit over three years to write, refine, and organize the text. After that, the editing and publishing processes followed, which are not for the faint of heart.

What is the book about?

This is my story — what happened, how it affected me, but mostly what I learned from the experience. It is a book for “we the people”, and not a medical

textbook. It has three basic messages regarding hearing loss: Importance of education, raising of awareness, and prevention.

What were some of the challenges you found in writing about your own hearing loss?

When writing anything even vaguely biographical one relives the events over and over, which can be painful and unsettling. I kept wondering if and where I dropped the ball. Making sense of disjointed and often contradictory reference materials was a major challenge. One must also be careful with the choice and credentials of internet sources.

What convinced you to write the book?

Hearing loss is a very complex issue. I share what I learned to ease the road for others. I wrote the book to help the general public, with hearing loss and without, understand hearing loss and its often complicating consequences better.

How long has the book been on the market?

The paperback version listed with amazon.com in mid-March. It is listed with Barnes & Noble and e-versions are now available. I also invite you to visit me at my website www.what-did-you-say.net to learn more about the book. The blog supports the book, and I try to post interesting, new, and amazing things about ears, hearing, and health in general.



Employment and Workplace News:

Carole forwarded a link to the March publication of the **MN Department of Employment and Economic Development (DEED)**. One of the articles entitled “Ready and Able” highlights **Walgreens** as an employer committed to hiring people with disabilities. Walgreen’s Distribution Centers across the country have a goal of filling more than 20% of their jobs with people who have disabilities. One of them is located in Rogers, MN.

A quote from the article: “Walgreens’ vision is unusual, considering the reluctance of many companies to hire people with disabilities. The road for job seekers with disabilities often can be difficult in a competitive labor market. In Minnesota, where about 1 in 10 people have a disability, the employment rate for working-age adults (ages 21 to 64) with disabilities was 44.3 percent in 2009, compared with 82 percent for people without disabilities.”

For their deaf employees, Walgreen’s hires interpreters for meetings when needed and has a video phone at work in case their deaf workers need to make a phone call. One of their deaf employees has been trained to drive a forklift. This woman’s last employer would not let her drive a forklift because she is deaf, she said. She feels Walgreens job assignments are based on capabilities – not disabilities.

Plan now to participate in the 2012 Walk 4 Hearing. The Minneapolis Walk will be held on September 29, 2012 at Lake Calhoun. The national 2012 fundraising goal is \$1.3 million. The Minneapolis W4H goal is \$40,000. Funds raised are shared between national and local HLAA .

The Hearing Loss Association of America's (HLAA) Walk4Hearing is the largest walk of its kind in the country that raises awareness and helps to eradicate the stigma associated with hearing loss. HLAA's Walk4Hearing is held in multiple cities across the country. Since 2006, over 26,000 walkers have stepped up and helped raise money for programs and services for people with hearing loss and their families. Money raised is shared between the national organization and local Walk sites. Examples of how funds are used include:

National Programs and Services

- Provides timely and reliable information about hearing loss through its website, *Hearing Loss Magazine*, the online e-News, the Hearing Loss Support Specialists Training, message boards/chat forums, monthly webinars and holds annual conventions
- Works at the national level to affect legislation that impacts people with hearing loss, whether it's funding for hearing aids and cochlear implants, communication access in public places, or other important issues
- A nationwide network of 200 chapters providing personal support and 14 state organizations advocating for expanded state services
- Support for parents of children with hearing loss at www.kidsandhearingloss.org
- Outreach to veterans returning with hearing loss
- Social networking site for young adults with hearing loss at www.hearinglossnation.org

Local Programs and Services

- Captioning and hearing assistive technology at HLAA chapter meetings to make them accessible
- Scholarships toward college tuition for students with hearing loss
- Funding for hearing aids and devices for people who cannot afford them
- Installation of hearing assistive technology in public places, such as community rooms and public libraries
- Captioning of live theater productions
- Seminars on coping with hearing loss for families

You may start your own team, or join with another team that is already formed, or walk as an individual. It is not mandatory that every walker on a team raise money for the Walk, but it is hoped that they will if they can. You may get support for the walk from your family, friends, neighbors, and/or coworkers.
