Dial 2-1-1 is a free, confidential and anonymous service providing non-emergency information & referrals to connect community members to the health & human services they need.

2-1-1 services are available 24 hours a day, 7 days a week, and are also available during times of disaster. Available by telephone and online, 2-1-1 provides callers and web visitors with detailed information on community resources for help and assistance in a wide range of areas.

Community members who have been laid off from a job, experienced a death in the family, need important services such as physical healthcare and mental healthcare, need help accessing legal or tax assistance, are lacking basic needs such as food, shelter or clothing, or could benefit from assistance with a wide variety of other needs ALL use 2-1-1 to help for themselves and others in need.

- Use the phone number and ask for info about the services and how you can receive them.
