HIANG Dedicates Newest Aircraft

A blessing ceremony for the 154th Group's newest aircraft will take place at 2:00 p.m. tomorrow in Hanger 35.

The blessing will be for a C-130H-3 Hercules transport that rolled off the Lockheed waii sometime today with Lt. Col. Ed Miyahira at the controls.

At 9:00 a.m. today, a ceremony will mark the beginning of construction for the 154th Air Control Sauadron's Forward Air Control Point (FACP) facility. The \$8.67 million project will be located at Barking Sands on Kauai. Legal Line

With the onset of football season and the advent of elections, what a better time to review good old Standards of Conduct than now!

Remember, gambling and betting on government property or while on duty are prohibited. This includes those fun office pools.

Various state and federal laws limit the political activity of members. For instance one cannot participate in political activity such as soliciting votes for a particular candidate, sellina fundraising tickets, while on duty or while in uniform or when on government property. Members must not use their position in the Guard to give the impression that they represent the Guard in their endorsement of the candidate by distributing political literature, etc., displaying large political signs on private vehicles.

Conflicts of interest and the appearance of conflicts of interest between a person's official duties and his personal affairs and interest are to be avoided. These include conflicting financial holdings, the use of inside information or of one's official position, personal commercial solicitations to service members junior in rank.

Gratuities from government contractors of from those whose business interests are affected by DoD functions should not be accepted. Gifts to superiors are generally prohibited with the exception of nominal gifts presented on appropriate occasions.

Use of government property for personal reasons are illegal.

Members are required to make good on all legal and just financial obligations such as loans and child support payments.

Discrimination based on race, color, religion, age, sex, national origin, political affiliation, handicap or marital status is prohibited. Additional sexual harassment in any form that results in the creation of a hostile or offensive working environment will result in serious penalty.

Cross trainees must attend the Legal Services Specialist course at Montgomery AFB, Al., course length is six weeks and must be completed within a year of entering.

General AQE score of 50 percentile (60 preferred); minimum typing speed of 40 wpm; average combined score of the eleventh grade or higher on reading comprehension and vocabulary examination by an Air Force Education Office.


Prior qualification in any AFSC at the 5-skill level or higher. Applicants must be computer capable. Submit resume to Maj. Itamura at 154 GP/JA.



LEAD POISONING

Lead is perhaps the oldest known health hazard, going back to the 4th century B.C. It is a poison and serves no useful function in the body. Large doses of lead can kill in a few days while chronic buildup can damage vital organs.

Lead paint is the largest culprit in lead poisoning. It is used as a rust inhibitor on steel structures. If lead paint is left undisturbed, it is of little hazard. In construction projects, this disturbance occurs when arc welding, or abrasive blasting is performed on painted steel surfaces. High temperatures generated during welding melt the lead and convert it into a fume. Abrasive blasting pulverizes the lead into a fine dust. In this form, lead enters the body through the respiratory system and the body cannot rid itself of it.

Lead can enter the body through ingestion. Children are especially at risk when lead paint is peeling. They will consume it, not knowing any better.

Engineering controls that eliminate lead dust and fumes generated in industry are local exhaust system at the worksite, wet blasting, and vacuum blasting.
Other controls are handwashing before and after meals and after work, and respirators are sometimes recommended.
