#### **Evora Groundbreaking Marks Major New Development in Las Vegas While Benefitting Opportunity Village's 'Betty's Village'**



## **U.S. Department of Labor and U.S. Department of Veteran Affairs Sign Memorandum** of Agreement to Enhance **Services to Veterans**

partment of Labor and the U.S. Department of Veterans Affairs (VA) signed a Memorandum of Agreement today to further collaboration between the VA's Veteran Readiness and Employment

WASHINGTON, DC - The U.S. De- Service (VR&E) and the Department of Labor's Veterans' Employment and Training Service (VETS).

> VETS and VR&E began joint efforts 25 years ago to serve their mutual par

ticipants and signed the first MOA. The agreement formalized both agencies' commitment to continue their cooperative efforts to help achieve participants' employment goals.

Since then, both agencies have made great strides to create a strong partnership to benefit veterans through efforts such as joint training initiatives; information exchanges; routine and open communication lines; problem solving; and disciplined, proactive oversight. Since the first MOA's implementation, the number of disabled veterans finding suitable employment has increased steadily.

"The Veterans' Employment and Training Service's vision is to enable all veterans to reach their full potential in the workplace," said Assistant Secretary of Labor for Veterans Employment and Training Service John Lowry. "The strategic partnership between VETS and the Veteran Readiness and Employment Service is a powerful example of federal agencies working together on behalf of veterans of all eras."

"At the Veterans Benefits Administration, strong cross-agency partnerships are core to the accomplishment of our mission of delivering benefits and services to our veteran community," said Under Secretary for Benefits Dr. Paul Lawrence.

The work we've accomplished together with the Veterans' Employment and Training Service's team is a perfect example of high-performing, integrated partnerships paying off in better opportunities for veterans."

VETS oversees the Jobs for Veterans State Grant program that assists veterans with significant employment barriers. Each year, the grant supports individualized career and training-related services for more than 40,000 veterans who attain employment, while VETS' job training, employment accommodations, resume development and job placement assistance helps more than 10,000 veterans find employment. In 2020, the two agencies are collaborating to increase the number of VR&E participants who enroll in apprenticeships. With an average starting annual salary of \$70,000 and a post apprenticeship retention rate over 90 percent, this collaboration will benefit veterans and their employers.

VETS prepares America's veterans, service members and spouses for meaningful careers, provides them with employment resources and expertise, protects their employment rights and promotes their employment opportunities. Throughout the coronavirus pandemic, VETS remains at work serving its Transitioning Service Members, veterans and military spouses, along with state workforce agencies and its other partners.



## **VASNHS** Distributes Flu Shots, **Prepares for COVID Vaccine with Point-of-Dispensing Exercise**



NORTH LAS VEGAS, Nev. - Every a little bit different this year by mainyear, VA Southern Nevada Healthcare System holds a Point-of-Dispensing (POD) exercise to provide flu shots to staff and Veterans, as well as practice emergency management techniques. This year, the coronavirus pandemic has made the flu vaccine and POD exercise more critical than ever.

"In previous years, staff were given the option to receive the flu vaccine, this vear it is mandatory," said Felix Acevedo, VASNHS' emergency manager. "We're getting great participation from both Veterans and VA employees so far.

Since opening the POD on Sept. 30, VASNHS has processed 1,767 VA staff, Veterans, and volunteers. This doesn't include the hundreds of Veterans and staff who received their flu shots through the VA at other locations as well as in the community since distribution began last month

In addition to the distribution of flu vaccinations, the POD exercise has a secondary purpose as a training tool for VASNHS personnel. "During a public health emergency or biological threat, a POD provides us with the ability to treat the masses with antibodies or countermeasures, depending on what the threat is," said Acevedo. "By practicing this

event every year, it builds musclememory. They understand how the POD operates and it builds familiarity with the necessary process. "


COVID-19 has created additional challenges for the POD exercise. "We had to run things

taining physical distancing while requiring maximum participation among VASNHS staff," said Acevedo. "Our lines were a bit longer, and masking was strictly enforced."

With the potential for a COVID vaccine in the near future, VASNHS staff used the POD as a way to prepare employees and Veterans for a large-scale vaccination event. "We anticipate that when a COVID vaccine becomes available, we will go through the same procedures, and our staff is going to be better equipped to facilitate the process," he said.

While there is still a ways to go to meet the goal of 100% compliance, Acevedo believes that there has been great participation so far. "People have a sense of urgency," he said. ## Medicare, Made Simple

o you qualify for Medicare but do not know which plan is right for you? Understanding the difference between Medicare plans can be a cost-effective way to get the healthcare you need. Below is a breakdown of what each Medicare plan offers.



#### So, what is Medicare?

Medicare is a government health insurance program for individuals that are 65 years of age or older and have worked a total of 10 years or are married to an eligible individual. Individuals that are under the age of 65, disabled and have received Social Security disability payments for 24 months or more are also eligible for Medicare.

#### What are the differences between Medicare Parts A, B, C and D?

Medicare Part A – most individuals are automatically enrolled in Medicare A on their 65th birthday. Medicare Part A covers hospital care.

- Medicare Part B individuals must elect to enroll in Medicare Part B, which covers doctors and specialists.
- Medicare Part C also called Medicare Advantage plans, this plan has Part A, B and D all in one.
- Medicare Part D individuals must also enroll in Medicare Part D, which has prescription drug coverage.

#### Here is a breakdown of the three combinations of Medicare Plans available to individuals:

Original Medicare with a Prescription Drug Plan: In general, this plan will cover up to 80% of hospital and doctor's visits along with a portion of prescription drug costs. Users pay a premium that is dependent on your income for Part B and a premium to a private company for Part D.

Original Medicare with a Medicare Supplement Plan and a Prescription Drug Plan: In this type of coverage, Original Medicare pays first, then the selected supplement plan steps in to cover most of the costs that Medicare did not

cover. Your prescription drug plan will cover a portion of your medications.

With this plan, you pay for Medicare Part B, the premium of the Medicare Supplement (that increases each year) and the premium for your Prescription Drug Plan.

Medicare Advantage: Medicare Advantage Plans, or Medicare Part C, cover Medicare Part A, B and D all in one plan. These plans typically have networks that individuals are required to use. Medicare Advantage has added bonuses including gym benefits dental, vision, hearing aids and over the counter medications. Medicare Advantage plans provide all of your coverage through one company and are available for \$0 per month. All members must still pay their Medicare Part B premium.

Senior Care Plus is here to help you navigate your Medicare Advantage plans. Visit seniorcareplus.com to learn more about the different plans. Open enrollment is from Thursday, Oct. 15 to Monday, Dec. 7.

## **Still In Pain After Surgery?** -Treatment for Post Spine Fusion Pain or Post Laminectomy Syndrome

he Neuropathy & Pain Centers of Las Vegas has a safe and effective treatment for patients who suffer from low back and/or leg pain who have previously had back operation(s). either with or without hardware placement. Robert Odell, MD, PhD, a Stanford Medical School graduate, interventional pain management physician and anesthesiologist, is the Founder and Chief Medical Officer of the clinic. Over the past 6-7 years Dr. Odell and Richard Sorgnard, PhD (molecular biology), have worked hard to develop specialized treatment protocols by using an electric signaling device.

We specialize in difficult to treat chronic pain conditions; chronic low back pain after back surgery without hardware (post laminectomy syndrome) and with hardware (post spine fusion pain) The options are limited, and some are risky (including more back surgery). Most pain management physicians can only continue to treat these patients with narcotic medications.

The causes for these syndromes are often difficult to discover, which is why they are called syndromes. Patients may have adhesions (scar tissue) in the epidural space, new degeneration of disks above and below the fusion site, hardware issues, facet mediated pain, and many other causes. We are able to treat this condition using low risk epidural injections, either in the low lumbar spine or caudal space, by using local anesthesia only; this can be done in our office. We do not use steroids. The Sanexas device, which is especially effective in these kinds of cases to reprogram the nerves to function more normally and reduce chronic pain, is then attached to the patient for 20-30 minutes. The device is programmed specific to each diagnosis. The treatments are a process, as the nerves begin to heal themselves; this is accomplished over several treatments.

The programs and clinical protocols have been developed over the last 6-7 years and are continuously fine-tuned for optimal success; they consist of 3-6



weeks of 3 treatments per week with the device, usually with one block per week for the first 2-4 weeks. Sanexas is much more advanced than common TENS devices with which many patients may be familiar. It operates with such a high degree of sophistication that nerves are not able to accommodate to the signals, or "learn" and regress.

Our success rate with the Combined Electrochemical Treatment (CET) for post spine fusion low back and leg pain is greater than 50%. We are signaling nerve cells with electronic impulses instead of smothering them with drugs which have their inherent side effects. Medication (especially narcotic use) is typically reduced significantly in our patients.

Although the treatment is an ongoing process, which must be done over weeks, many have discontinued use of walking aids, begun meaningful exercise, and stopped or severely curtailed their use of pain medications. Results have led to better sleep patterns, better balance, improved walking and exercising, decreases in anxiety and marked improvement in mood and quality of life.

This is a safe and highly effective treatment for post-surgical low back (and neck) pain which no one else can treat as effectively as our clinic can.

Another technique that we can use to treat patients with lower back pain due to lumbar fusion hardware, who haven't responded to other treatments, is to use Radio-Frequency (RF) with the superior Trident RF needle by Diros. RF thermocoagulation treatments are a superior small nerve treatment to reduce pain. This advanced RF method is only performed by Dr. Odell in the Las Vegas Valley.
