A candidate must work individually or through a firm, under contract and fee that pertains separately to lighting as a design medium; or work for other design related firms (i.e., consulting or architectural engineering firms) whose principal business is not lighting design.

A senior lighting designer is responsible for:

- Creating the lighting design strategy and crafting the lighting design concepts for client projects
- Documentation related to the design solutions of the project
- Conveying and exchanging ideas with the client and the project team
- Meeting project design deadlines
- Providing advice throughout the implementation process
- Guiding the outcome of the developed and documented design

VOTING MEMBERS are Fellow, Professional, and Associate members of the IALD. Voting members shall subscribe to the ideals, goals, Vision Statement, Mission Statement and shall subscribe to the Code of Ethics and Professional Conduct. Application Instructions

- **1.** The IALD Professional member portfolio review follows a blind review process. Applicants must use the PowerPoint template provided on the IALD website in preparing the portfolio. No identifying text such as designer's name or company may be shown in the project portfolio or individual slides. Submissions with identifying names or logos will be returned without review.
- 2. Portfolio requirements and the criteria on which the evaluation is based is on the PowerPoint template.
- **3.** The application, resume, project list, references and company profile will not be sent to the reviewing committee with the portfolio. Please send these as separate documents.
- **4.** For presentation, images should be resized in a photo-editing program to a minimum height of 768 pixels or a minimum width of 1024 pixels. (This is the same as a 300 dpi image 2.56 inches tall or 3.41inches wide). This should be saved as a TIFF (.TIF) or JPEG (.JPG) image at the highest possible image quality. Each image should then be inserted into the PowerPoint presentation with one image per slide, with the image expanded to occupy as much of the slide as possible.
- **5.** A minimum of six (6) images is required for each project. Applicants should submit enough images (maximum of 10) to convey the scope of the project. If six (6) images of the completed project are included, the applicant may add supplemental images of renderings, mock-ups, sketches, details, control systems, etc. up to a maximum total image could of ten (10).
- **6.** Photographs must not be digitally altered utilizing Photoshop or other photo editing/color balancing tools. They should be as clear a representation of the actual project as possible. Photographs that show evidence of any meaningful photo editing will be disqualified. If fill light is added to any of the images by a professional photographer, it must be clearly identified on the slide.
- **7.** The PowerPoint presentation should be in order of the text description and limited to only those slides that pertain to the submission. Please do not submit standard marketing presentations.
- **8.** Digital images do not need to be professionally photographed, but should be of sufficient quality to illustrate your work. All photographs will be used by the Membership Committee only for purposes of membership review. Clearly identify images that include fill light or daylight.
- **9.** For daylighted spaces, the applicant should include supplemental imagery to communicate how electric light integrates into the space in the absence of daylight. The applicant should also speak to how it is incorporated in the overall project design.
- **10.** If an applicant has received an IALD International Lighting Design Award, he or she may cite the award-winning project in place of up to two (2) portfolio projects. IALD Award-winning projects do not have to be resubmitted, but can be referred to in the portfolio in place of a portfolio project. Please indicate the name of the award-winning project and the year of the award.
- **11.** IALD and certain other lighting design associations have a reciprocal and/or expedited process for professional applications. For the current list of organizations, visit www.iald.org/Membership.
- **12.** Each member of the Membership Committee will review all professional applications using an objective evaluation system. The Membership Committee will evaluate each candidate's strengths and weaknesses based on the criteria stated in the PowerPoint template and submitted portfolio.
- **13.** All candidates for Professional membership will be notified of the committee's decisions in writing by either the Chair of the Membership Committee or IALD membership staff.
