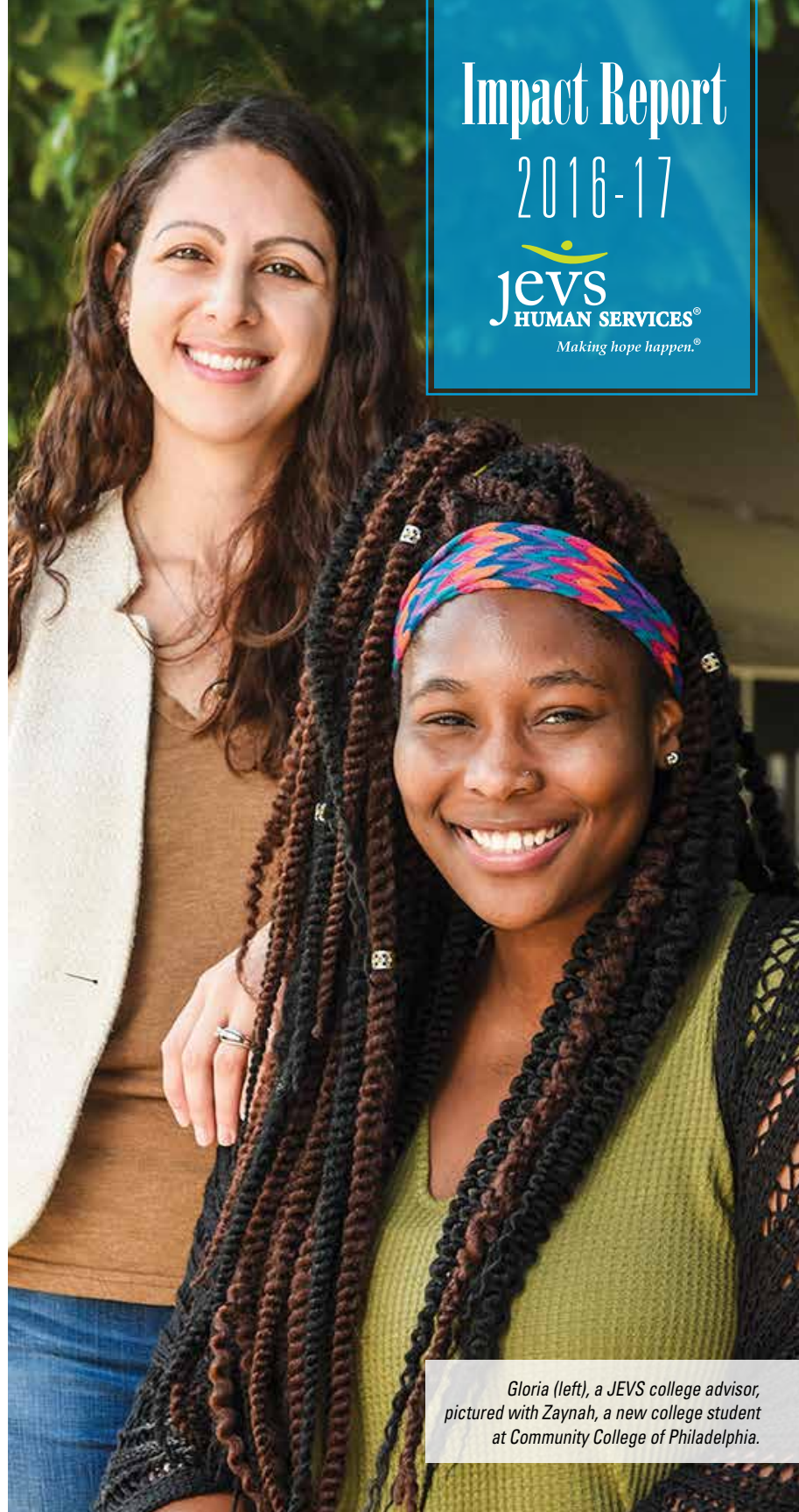

At our **Orleans Technical College (OTC)**, we provide hands on training to prepare the workforce of tomorrow. We offer career training programs to help adults to build the skills they need to begin careers in the building trades and healthcare sectors. For many at OTC, our programs are a second chance at a bright future.
