TREATING THE WHOLE PERSON

how InterFaith helped turn one patient's life around

Lynn Anderson, who works as a cashier at Sav-a-Lot, says that InterFaith helped change her life. "If it wasn't for InterFaith, I don't know where I'd be!" she said.

Years ago, Lynn visited the emergency room for stomach pain. She had no health insurance, so when her cousin told her about InterFaith, she enrolled as a patient. "I was suffering from depression because I'd been sick for so long, and I couldn't afford to go to the doctor," Lynn said.

In addition to depression, Lynn had several physical problems as well. Her diabetes and blood pressure were uncontrolled, so much so that the physician who treated her was shocked that she hadn't suffered a heart attack or stroke. InterFaith's physician was able to help Lynn get her diabetes and blood pressure under control, so that she could then focus on positive changes in other areas of her life: Lynn began seeing our mental health therapist to get healthy mentally and emotionally; she met with one of InterFaith's volunteer nutritionists to help her learn how her diet impacts her diabetes; she quit smoking through InterFaith's smoking cessation program; she's started an exercise program and has lost weight; and just last month she got a partial to maintain her beautiful smile.

Since Lynn became a patient over six years ago, she's utilized nearly every service we offer onsite: medical, dental, and mental health services, access to prescription medications, and wellness opportunities. Because you give and support InterFaith, people like Lynn have access to comprehensive care that improves not just their health, but also their quality of life. "InterFaith makes a difference in how you feel about going to the doctor," Lynn said. "I don't dread coming here, and they make me feel great about myself. They're a thorough clinic, and they follow through when others don't. InterFaith saved my life."
