Incident Report:

On Monday January 28, 2013 at approximately 1045 hours, I, Senior Lead Officer Vartan Bardakjian, responded to TCSOB lobby and met with employee Jeremy Steiner, Designer Imageworks Interactive, to file a vehicle incident report. The following information was relayed:

Victims Statement

"At about 8:50am this morning on the side entrance off of Lindblade (not main entrance off of West Washington Blvd.). As I was pulling up to the security checkpoint to gain access to TCSOB. The security garage gate slammed into the side of my car and caused paint damage. I did not swipe my card, since the arm stayed up for more than a few cars and all of them were pulling in quickly. The first two cars ahead of me pulled in no problem, with no swiping. I began to do the same and as I approached the scanner, I then realized there was no attendant and the garage gate arm slammed into my car, hitting the side mirror, scratching some paint off. I've pulled up many times before in the past and I am usually greeted by a security attendant, Officer Liggins, who sometimes has the security arm up depending on what is going on that day. Since I couldn't see if there was anyone there I assumed it was up and the attendant was letting everyone in."

Incident Investigation:

According to Security Officer David Liggins, each driver is supposed to swipe his access badge to access the parking garage through the Lindblade vehicle gate. During extremely heavy vehicle access times while he is present at the guard shack, he will lift the gate arm but request to see the access badges as the vehicles enter the gated area. Once the vehicle traffic has lessened, he will lower the gate arm for each driver to swipe their badge. On the particular day in question, Officer Liggins had left the guard shack to assist with several large trucks in the loading dock area. When he leaves the shack, he always leaves the gate in the down position for each driver to swipe his ID badge. He did so on 1/28/13 at 0850 hours. Officer Liggins noted that there are some employees who push through the gate area once the vehicle in front of them has swiped their ID badge. The gate arm will stay up for a few seconds once a badge is swiped, which does allow 2 to possibly 3 vehicles to "piggy back" through the raised gate arm, depending on how fast and close the vehicles are to one another. According to Officer Liggins, Mr. Steiner should have swiped his badge at the card reader before attempting to access the parking garage.

There was no video camera footage to recover to view the incident as the guard shack is not covered by a camera. the vehicle sustained several scratches to the front passenger side rear mirror. There were no other reported damages to the vehicle.

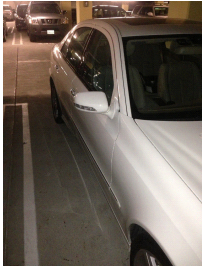
