## How has the CIA exam changed in 2019? How have topics changed?

- To ensure the material within all three parts of the CIA exam stays current and valid, the CIA underwent a global job analysis study to determine the knowledge, skills, and abilities most applicable to today's internal audit practitioners. As a result, the CIA exam syllabi were updated for January 1, 2019 (English exam).

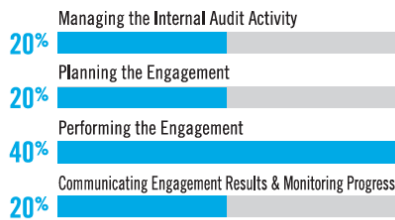

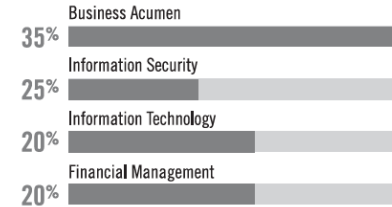

## Is the exam changing for all languages or just English?

- The English language CIA exam was updated on January 1, 2019. The transition plan for non-English exams is listed below. Each candidate should review the changes and determine the best timing to complete their individual studies and take the exam. ## Do I need new study materials for the 2019 exam?

- Yes, due to the significant updates and reorganization, it is advised that you use study materials specific to the revised exam: [The IIA's CIA Learning System Version 6.0](#)
- If you purchased The IIA's CIA Learning System for the 2018 exam (Version 5.0) and still have an active online license, you can upgrade to the revised online version of The IIA's CIA Learning System for free. For details, visit [www.LearnCIA.com/upgrade](http://www.LearnCIA.com/upgrade)

## If I passed one or two parts of the CIA exam in 2018, do I have to repeat them in 2019?

- If you passed one or more exams in 2018, you do not need to repeat them in 2019 under the revised structure (assuming you're still within your 4 year eligibility period). For example, if you passed Part 1 in 2018, you will only have Parts 2 and 3 left to complete in 2019.

## Is the CIA recognized around the globe?

- Yes, the CIA is the only globally accepted designation for internal auditors. To date, over 140,000 individuals in more than 120 countries have earned the CIA certification.

### What are the eligibility requirements for the CIA certification?

- CIA candidates must meet the following eligibility requirements for education, character, work experience, and identification. For complete details, visit [theiia.org](http://theiia.org).
  - **Education:** CIA candidates must hold a 4-year post-secondary degree (or higher) or its educational equivalent from an accredited university. For candidates without a 4-year post-secondary degree, you may be approved with either:
    - Two years post-secondary education and five years **verified experience** in internal audit or its equivalent, **OR**
    - Seven years **verified experience** in internal audit or its equivalent.
  - **Work Experience:** CIA candidates with a 4 year post-secondary degree must obtain a minimum of 24 months of internal auditing experience or its equivalent. A Masters degree can substitute for 12 of the required 24 months
  - **Character Reference:** Candidates must exhibit high moral and professional character and must submit a Character Reference Form signed by a CIA, CGAP, CCSA, CFSA, CRMA, or the candidate's supervisor.
  - **Proof of Identification:** Candidates must provide proof of identification in the form of a copy of the candidate's official passport or national identity card.

### Do I have to meet all CIA requirements prior to applying to the program?

- No. Candidates may sit for the CIA exam prior to completing the Education and Work Experience requirements. All requirements must be completed within the 3 or 4 year program time limit (starting from your CIA application approval date) prior to being issued their CIA certification. CIA candidates approved after September 1, 2019 will have 3 years to complete the program rather than 4 years.

### Are the CIA requirements different in countries around the world?

- With the exception of a few designated countries, CIA requirements are the same for all candidates. Whether a candidate is still in the process of attaining their CIA or they are already certified, the requirements are the same globally. ### Is there financial support or fee adjustments for countries such as Nigeria with unfavorable exchange rates?

- Unfortunately, the fees do not change based on country. However, we do advise you to contact your local [IIA Institute](http://www.iianigeria.org/contact-us/) (for Nigeria, visit <http://www.iianigeria.org/contact-us/>) and ask if any financial support is available in your region.

### If my employer is an IIA member, do I get to pay the IIA price for my application and exam?

- Not necessarily. Individuals would need to be part of a qualifying audit group or have individual membership.

### Why are the Part 1 exam fees more expensive than Parts 2 and 3?

- Exam costs are based upon many things from the develop cost, number of questions and how much time is allocated to sit for that exam part. Part 1 of the new exam has 125 questions and an exam time of 2.5 hours and Parts 2 and 3 have 100 questions and 2.0 hours of seat time.

### How many questions are in the 3 CIA exam parts?

- Part 1 = 125 questions
- Part 2 = 100 questions
- Part 3 = 100 questions



**Is there a Professional Recognition Credit (PRC) for the 3 part exam?**

- *No, there will no credit for any part of the exam in the 3-part format. All candidates must take and pass all three parts.*

**Are any part(s) of the CIA exam waived for individuals with a CFE, CPA, or other professional designation?**

- *No, no parts of the CIA exam can be waived. Candidates must pass all three parts of the exam.*

**How many years do I have to complete all three parts of the CIA exam?**

- *Candidates approved before September 1, 2019 have 4 years to complete the three exams and all other program requirements from the date of application approval. Candidates approved on or after September 1, 2019 will have 3 years to complete the program.*

**Please explain how the 4-year or 3-year period to complete the CIA exam works. If you do not pass all of your exams in the allotted time, do you have to retake the passed exams, or simply reapply to the program?**

- *Candidates approved before September 1, 2019 will have 4 years from the date of the application approval to complete all program requirements (documentation and examination requirements) and become certified. Candidates approve on or after September 1, 2019 will have 3 years to complete the program. If you do not complete the program requirements in the allotted 3 or 4 year time frame, you will forfeit all passed parts and fees and must re-apply into the program as a new candidate. See below for information about one-year extension applications.*

**How can I apply for a one-year extension to the four-year or three-year CIA window?**

- *Certification candidates who are nearing the end of their three-year or four-year program eligibility window now have an opportunity to apply for an extension before their exam part(s) expire. This extension allows participating candidates who haven't yet successfully completed their exam(s), or who have been accepted into the program but have not yet taken their exam(s), an opportunity to extend their program eligibility 12 months.*
- *Candidates may take advantage of The IIA's new one-time Certification Candidate Program Extension\* by completing the Program Extension form in CCMS and paying the applicable fee. To view the fee, visit the [Pricing Structure](#) web page.*
- *Note: This offer may not be valid in all affiliate countries. Candidates in these countries should contact their local IIA representatives.*

**What's the difference between the Audit Section of the CPA Exam and the CIA Exam?**

- *The CIA exam tests the breadth of knowledge internal audits need to be successful on various types of audit engagements whether compliance, financial, operational, etc.*
- *The audit section of the CPA exam is specifically focused on licensing financial statement auditors and is much more in depth covering financial statement auditing.*

**How much accounting knowledge is required for the CIA exam? If I took a college accounting course but have no experience in accounting, can I still pass the exam?**

- *We cannot answer whether or not the accounting course will be enough for you. For the most up to date information on our exam syllabus, we ask that you visit our website:

**How long should I expect to wait from when I apply for the CIA program and receive approval? Is there a time limit to register after being accepted into the CCMS?**

- *Candidates submit their application via the Certification Candidate Management System (CCMS) and once the application is submitted it should be approved within 3-5 days. Candidates will receive an e-mail with the applications status once the application has been processed. Candidates approved before September 1, 2019 will have 4 years from the date of the application approval to complete all program requirements (documentation and examination requirements) and become certified. Candidates approve on or after September 1, 2019 will have 3 years to complete the program. **Once I receive acceptance into the CIA program, how do I register for exam parts?**

- After you apply to the CIA program and receive acceptance, you can register for one or more exam parts via [CCMS](#). Once you register for an exam part, you will have 180 days to schedule a time with Pearson VUE and sit for that exam part.

**Can I apply for an extension to the 180-day exam registration?**

- Yes, you can apply for an extension for the 180 day exam registration. There are fees associated with this. Please visit <https://global.theiia.org/certification/Pages/Pricing-Structure.aspx> for the most complete and current details.

**What are the dates for the CIA exam?**

- Taking the CIA certification exam is very convenient. All IIA exams are offered through computer-based testing (CBT). This means that you will be able to take your exam in any one of more than 500 available testing centers around the world, in the exam language of your choice, at a time that is convenient for you. The IIA has chosen Pearson VUE as its computer-based test administration vendor. Pearson VUE will therefore administer The IIA's exams in a computer-based format at Pearson VUE's approved testing centers throughout the world. You do not have to take all three parts at the same testing center.

**Can I reschedule an exam? If so, how?**

- You can reschedule your exam through Pearson VUE's online system or by contacting their customer service team. There are fees associated with this and limits. Please visit: <https://global.theiia.org/certification/Pages/Pricing-Structure.aspx>

**How far in advance do I have to schedule an exam?**

- It is recommended that you schedule your exam at least 45 days in advance. Exam center schedules are based on a first come, first served basis. The IIA is not the only client using Pearson VUE test centers so it is best to schedule as soon as possible to ensure your first choice for your exam appointment.

**After taking an exam, how long does it take until I find out whether I passed or not?**

- Unofficial results are available at the test center immediately after taking the exam. The unofficial score report will provide your score in numeric value if you did not pass the exam. If you passed the exam the score report will reflect "PASS" and no other information. This report is unofficial until the data is transmitted to The IIA and uploaded into your CCMS record. This generally takes 24 – 72 hours to complete. Once loaded into your CCMS record your results become your official results.

**If I pass all of the exams and submit the required information, how long will it take for me to receive my CIA certificate?**

- Once you pass an exam and meet all other program requirements, you will be eligible to receive your certificate. To order your certificate, you must log in to your candidate record in [CCMS](#) and complete the certificate order form. The certificate will be shipped directly to you using a standard postal service method at no charge. Expedited shipping is available at an additional cost. If you are located in a country that administers candidates directly through an affiliate institute your certificate will be sent to that institute for delivery to you.

**If I need to retake an exam, are there restrictions on when I can take the exam again? Is there a limit to the number of times I can retake an exam?**

- There is a 60-day waiting period that applies to all exam retakes to protect the integrity of the exam. Please reference the Candidate Handbook for additional information on this policy.
- There is no limit to the number of times and exam part can be taken.

**Do I have to pay the application fee again if I have to retake an exam?**

- No, you do not have to pay the application fee again as long as you have not expired from the program. However, an exam part registration fee is due with each exam part that is submitted. Visit <https://na.theiia.org/certification/Pages/Pricing-Structure.aspx> for registration fees.

**If I fail an exam and take it again in 60 days, will the exam be the same?**

- *No, the exam will not be the same.*

**Where is my nearest testing center?**

- *The exam is offered at Pearson VUE Testing Centers worldwide. For a list of locations, please visit <http://vue.com/iaa/>.*

**If I live in Pakistan, how do I register for and take the CIA exam? Are eligibility rules being extended for candidates in Pakistan?**

- *If you live in Pakistan, you will go directly through CCMS to register and take an exam. There are currently no extensions to eligibility rules for candidates in Pakistan.*

**If I register and take an exam part in one country (i.e. Philippines), can I take the remainder of the exam parts in another country such as the USA?**

- *Yes you can. The CIA exam is a global exam and you can take that exam at more than 500 locations worldwide.*

**How do I set an exam date with my local testing center?**

- *Visit the Pearson VUE website to book your exam date: <http://vue.com/iaa/>.*

**Do I need to be a member of The IIA to take the examination?**

- *Generally, no, membership is not required for those residing in North America. An individual does not have to be a member of The IIA to take the certification exams or to become certified. (Please note however, that members can save significantly on exam and course fees.) Membership requirements may differ in countries where the exams are administered through agreements with IIA institutes. For more information, check the map and listings on <https://global.theiia.org/certification/new/Pages/Six-Steps-to-Certification.aspx>.*

**Are there any qualifications to becoming an IIA member?**

- *No, there are no prerequisites to becoming an IIA member. Anyone can join.*

**To show “verified experience” does the document need to be personalized or simply show the job description/history? Does my employer have to sign the document?**

- *In order to show “verified experience” the current employer needs to submit a letter of recommendation, and the candidate needs to submit a resume showing job description/history.*

**What qualifies for professional employment/experience?**

- *CIA candidates with a 4 year post-secondary degree must obtain a minimum of 24 months of internal auditing experience or its equivalent. Acceptable equivalent experience includes experience in audit/assessment disciplines, external auditing, quality assurance, compliance, and internal control.*
- *A master’s degree or work experience in related business professions (such as accounting, law, or finance) can be substituted for 12 of the required 24 months of professional internal auditing experience. Please visit <https://global.theiia.org/certification/cia-certification/Pages/Eligibility-Requirements.aspx>*

**Do internal audit internship hours count for the experience requirement?**

- *Yes, internship hours do count for the CIA experience requirement.*

**What is a character reference and what is the purpose?**

- *To be eligible for an IIA certification, an applicant must exhibit high moral and professional character and agree to abide by The IIA’s Code of Ethics. Please download the Certification Candidate Handbook for all the details at: <https://global.theiia.org/certification/Pages/Certification-Candidate-Handbook.aspx>*
- *Candidates may apply to the CIA program and sit for the CIA exam prior to submitting the Character Reference Form, but will not be certified until all program requirements have been met.*

**Does my reference have to hold a CIA or other designation? Does the reference have to be a current or former employer?**

- *No, your reference does not have to hold a CIA or other IIA designation. The reference should be either your supervisor, your professor, or an IIA-certified individual.*

**Are scanned versions of hand-written documents accepted in the application process?**

- *Yes, scanned versions are acceptable.*

**I plan on getting married in the coming year and will be changing my legal name. Should I wait until my name is officially changed before registering?**

- *In order to change your name in our CCMS system, please log an incident in your CCMS record and provide a government issued form of ID that shows the new name.*

**Is there a listing of "accredited" universities that are recognized by The IIA for meeting the education requirements?**

- *The IIA follows the United Nations Educational Scientific and Cultural Organization's (UNESCO) guidelines on defining accredited universities.*

**Does having a Master's Degree in Computer Information Systems meet the education and/or professional experience equivalent requirement for the CIA program?**

- *Yes, a bachelor's degree (or its equivalent) or higher from an accredited college or university program meets the education requirement.*

**If I don't have a Bachelor's Degree, what qualifies as the equivalent?**

- *Those without a degree can be approved if they have:*
  - *Two years post-secondary education and five years verified experience in internal audit or its equivalent, OR*
  - *Seven years verified experience in internal audit or its equivalent.*

**Can I complete the CIA exams before finishing my Bachelor's degree?**

- *The CIA program does allow students to enroll as candidates, sitting for all exam parts. However, final certification can only be attained once a Bachelor's degree or its equivalent has been completed. For additional information on student candidates, please review the Certification Candidate Handbook.*

**If I already hold another IIA certification such as CFSA, do I have to resubmit the work experience, character reference and proof of education for each subsequent certification application?**

- *No, you do not need to resubmit this information. However, we ask that you submit a request to the Certification staff to apply your supporting documentation from one program to another by submitting and incident in your CCMS record.*

**Will my internal audit experience from 15 years ago count toward my work experience requirement?**

- *Provided that the candidate holds the minimum education requirement of a bachelor's degree or its equivalent their prior experience can be submitted. A statement of the candidate's work history must be attested to by the candidate's former or current manager, or someone holding an active IIA Global Certification.*

**What is the difference between an awareness and proficiency topic?**

- *Awareness level items are testing general knowledge of a topic whereas proficiency level items are testing the ability to understand and apply concepts.*

**Where can I find out which exam topics require awareness vs. proficiency?**

- *Please access the following link: <https://global.theiia.org/certification/CIA-Certification/Pages/Exam-Syllabus.aspx> to view the content of each exam part. Topics that are require a proficiency level of knowledge are designated with "P". Topics where an awareness level is suggested are designated with an "A" at the end of each topic.*

**Do we need to memorize standards and practice advisories in detail, or are summaries sufficient?**

- *For proficiency level items, candidates should understand the IPPF and be able to apply the concepts; for awareness level items related to the IPPF should have a general understanding.*

**What languages are available for the CIA exam?**

- *The CIA exam is available in 17 languages. For details, visit <https://global.theiia.org/certification/Pages/Exam-Language-Offerings.aspx>*

**If I'm taking the exam in a language other than English, will I be able to see both English and my preferred language on the screen at the test center?**

- *Yes, candidates can toggle from the language to the English version.*

**When I register for an exam, do I receive any information or materials?**

- *Upon registration, candidates will receive an Authorization to Test email, providing instructions on how to schedule their exam with Pearson VUE.*

**Do the parts of the exam have to be taken in order? Do you recommend an order?**

- *No, you can take the exam parts in any order, based on your personal preference and experience.*
- *CIA instructors often recommend that experienced auditors begin with Part 1 or Part 2. Students, recent graduates, and those new to the profession may wish to start with Part 3.*

**Do I have to register for all three exams at the same time, or can I do them one at a time?**

- *After you apply to the CIA program and receive acceptance, you can register for one or more exam parts via CCMS. Once you register for an exam part, you will have 180 days to schedule a time with Pearson VUE and sit for that exam part.*

**Can I take more than one exam part at a time (i.e. in one day)?**

- *Yes.*

**Is the CIA exam open-book?**

- *No, books/study materials are not allowed in the testing center.*

**Are all exam questions multiple choice?**

- *Yes.*

**What forms of identification are acceptable at the testing center?**

- *Any form of government-issued photo identification is acceptable (i.e. passport, driver's license, etc.). The name on your identification must match your CCMS record.*

**Are warning prompts provided at key points within the CIA exam (i.e. at 1 hour remaining; 10 minutes remaining)?**

- *There is a countdown time displayed while taking the exam. Please see our exam tutorial located at <https://na.theiia.org/certification/Pages/CBT-Exam-Tutorial.aspx> for an example of what to expect.*

**What items can I take into the exam center's testing room?**

- *The only item you can take into the testing room is a non-electronic language translation dictionary, which may not contain definitions – only direct translations.*
- *All personal items will be stored in a locker outside the testing room.*
- *You will be offered an erasable note board and pen to use during the exam. These must be returned after your exam.*
- *An on-screen calculator will be available during your exam. You are not allowed to bring in your own calculator.*
- *You may not bring food or beverages into the testing room.*

**In the exam, can we flag questions and return to them?**

- *Yes, the exam software allows you to flag questions and return to them at a later point for review.*

**Can you cross out incorrect answers in the computer-based CIA exam?**

- *No.*

**Are you penalized for incorrect answers on the CIA exam? Is it better to skip a question than guess at the answer?**

- A skipped question is treated as an incorrect answer. It is better to guess than to leave a question blank.

**Is the scoring of the test simply a weighted scoring based on the complexity and type of proficiency of the specific question or is the scoring weighted by section?**

- Although the difficulty level of questions may vary depending on the topic for which they are written, each scored question is equally weighted throughout the entire exam and does change per section. The candidate's overall score determines whether or not a passing grade is received
- Your raw score is calculated based on the number of questions that you answer correctly and then converted to a reporting scale that ranges from 250 – 750 points. A score of 600 or higher on this scale is required to pass the exam.

**What percentage of the questions or number of questions on the CIA exam do I have to get correct to pass?**

- Given the reporting scale process, there is no set “passing score”. However, a passing score generally falls between 70% and 80% or 600-750 points.

**Are there any unscored questions on the exam?**

- Each question contributes to your final test score and is pretested to ensure statistical validity.

**What are the average pass rates for the CIA exams?**

- The following are the 2014-2017 global pass rates for all IIA certification exams. The CIA pass rate is reflective of all computer based exams delivered in all countries and all languages, and combines all three parts into one score. The separate scores are not publicized. These are global pass rates. This means scores are reflective of all exams delivered in all countries, in all languages for exams delivered via computer based testing (CBT).

- This is an aggregated global pass rate. Typically, pass rates are higher in countries where exam preparation materials are readily available in the local language.

**Are your CIA exam scores displayed on your CIA certificate?**

- No, scores are not displayed.

**How can I access a copy of the IPPF/Red Book?**

- The IPPF can be purchased from The IIA Bookstore: <https://na.theiia.org/standards-guidance/Pages/Standards-and-Guidance-IPPF.aspx> IIA members can access and download an electronic version of the IPPF from [www.theiia.org](http://www.theiia.org) at no cost.
- Users/purchasers of The IIA's CIA Learning System can access the Standards in the online Resource Center.

**How many Continuing Professional Education (CPE) hours must be earned annually? Is CPE earned on a calendar year or a rolling 12 month year from when I received my CIA certification?**

- *CPE is earned on a calendar year cycle and must be reported by December 31<sup>st</sup> of the candidate's reporting year.*
- *Practicing CIAs must complete 40 hours of CPE every year. For complete details visit <https://na.theiia.org/certification/certified/Pages/CPE-Requirements.aspx>. You will automatically earn 40 hours of CPE the year you become a CIA. You will also receive 40 hours of CPE the following year. You must self-report your CPEs and keep your documentation in case you are audited.*

**Are CPEs awarded after the passing of each CIA exam part or only after completing all three parts and earning the CIA certification?**

- *You do not receive CPEs for completing an individual CIA exam part. You will earn 40 hours of CPE the year you become a CIA. You will also receive 40 hours of CPE the following year.*

**What happens if I don't earn/report my CPE as required after earning my CIA? Do I have to take the CIA exam again?**

- *If you do not report your required CPEs, your certification status will be moved to "inactive" for a grace period. If your status is inactive for less than 12 months, you must complete the prior years' CPE reporting form and report the appropriate number of CPE hours to reinstate. If your status is inactive for more than 12 months, you must report the necessary hours of CPE and pay a reinstatement fee.*

**Some organizations, such as government entities, require that auditors report at least 24 government-relevant CPEs annually or biannually. Of the 80 CPEs that the IIA awards for passing the CIA, how many can be considered relevant for government auditing?**

- *The IIA does not categorize the 80 CPE hours upon certification into specific classifications. It is up to the candidate to work through any requirements such as the one provided in this example with that certification/licensure body to determine how many of the 80 CPE hours they would be amenable to using towards that requirement.*

**Are the CPEs awarded for passing the CIA exam NASBA approved and applicable as CPA CPE?**

- *NASBA does not approve CPE hours awarded for passing examinations. As such, the CPE hours awarded for passing the CIA exam are not NASBA approved.*
- *For further details, contact your [local CPA State Licensing Board](#).*

**The CIA designation seems very specialized. Is it a useful designation if you go work for an external audit function (Deloitte or the like) and what kind of career progression would this designation allow or potentially provide?**

- *The CIA designation is highly valued in the internal audit profession, both by service providers (i.e. Deloitte) and organization with internal audit business units. CIAs are distinguished from their colleagues in terms of demonstrating their proficiency and dedication to the profession. Additionally, while the skills tested in the exam parts of the CIA, are internal audit focused, there are also several other competencies which would add tremendous value in related fields such as finance or accounting. Competence in project management and communication skills are also part of the certification, which are highly valuable in any profession, regardless of the role or industry the CIA eventually moves into.*

**I'm currently an IT security professional. I would like to focus my career on IT auditing. With the CIA help make this move easier? How is it different from CISA?**

- *As The IIA's premier designation for more than 40 years, the CIA sets the standard for excellence within the profession. The CIA covers internal auditing as a whole. The CIA journey begins with a focus on The IIA's International Standards for the Professional Practice of Internal Auditing (Standards) and aspects of mandatory guidance under the IPPF. The journey continues with a focus on managing an internal audit project and culminates with concepts related to internal control, risk, governance, and technology. The CISA is more specialized.*

**How does the CIA add value if I already have other related accounting or auditing certifications such as the CPA, CMA, or CPEA?**

- *While there is some overlap between the professional accounting and auditing certifications, the CIA is focused on the skills and knowledge required of internal audit professionals. The CIA focuses on The IIA's International Standards for the Professional Practice of Internal Auditing (Standards) and aspects of mandatory guidance under the IPPF, managing an internal audit project, and internal control, risk, governance, and technology.*

**If I pass Part 1, do I earn the Internal Audit Practitioner qualification? Are there prerequisites?**

- *The Internal Audit Practitioner is a designation, not a certification. It is a first step into the internal audit career path for new and rotational auditors. After passing Part 1 of the CIA exam, candidates must simply submit an application. For complete details about this designation, visit <https://na.theiia.org/certification/CIA-Certification/Pages/Internal-Audit-Practitioner.aspx>*

**To earn the CRMA certification you must also pass Part 1. Would it be more beneficial to complete the CIA before the CRMA?**

- *Yes, it is beneficial to complete the CIA first.*

**Does experience play a big role in passing the exams? Or are the exams based more on book materials?**

- *Both are important. The CIA exam is based primarily on the IPPF and the CIA exam syllabus which can be studied using book materials. However the exam also includes application questions in which candidates are asked how certain standards are used in varying scenarios, relying more on a candidate's professional experience.*

**What do I do if my CIA has expired?**

- *If it has been less than one year, please complete the prior year's CPE reporting form which can be found inside your CCMS record by clicking on the COMPLETE A FORM link. If it has been more than one year that your designation has been inactive please complete the REINSTATEMENT form. **What are the system requirements for accessing the online tests and study tools? Can they be accessed on an iPad/iPhone or other mobile device?**

- *The online materials are accessible via any computer or mobile device with internet access – regardless of operating system. The IIA’s CIA Learning System has been optimized for mobile devices making it easy to use on any device.*

**Are there printed quizzes or tests to use when I don’t have internet access?**

- *The IIA’s CIA Learning System offers printed reading materials, downloadable reading material, and flashcards can be printed for offline study; however the quizzes and tests are offered exclusively online to allow tracking of progress.*

**How many online test questions are available?**

- *1600+ online test questions are available. 500 new questions were added with the release of Version 6.0. All questions were written specifically for CIA exam preparation as opposed to other review programs that contain may contain CPA and CMA review questions.*

**Are the glossaries for Parts 1, 2, and 3 the same?**
