



InterFaith Saves Patient Thousands On Treatment Plan

Melisa Cherry is no stranger to pain. Before InterFaith, she had her own successful house cleaning business for 10 years and during that time began to experience tremendous joint pain all over her body—particularly in her right hand. Battling a misdiagnosis and medicines that only made the pain worse, she felt hopeless. She was without insurance, without hope, and due to the severity of her pain, she eventually had to quit a business she loved and take up another small business in order to simply survive.

Then a friend told her about InterFaith. In the short time that Melisa has been a patient of ours, she was able to have a much-needed hand surgery. Normally, the surgery would have cost about \$40,000 out of pocket, **but as an InterFaith patient Melisa paid \$4,000.** She has also now been correctly diagnosed with rheumatoid arthritis and has been given medicines that are slowly, but surely, helping her regain her movement *and* restart her cleaning business. The new medicines she is on would have cost her approximately \$5,000 each out of pocket, but because of the patient assistance plan cost is no longer an issue, as some patient assistant plans have no cost and others have a \$15 handling fee.

All of these blessings have allowed her to pick up her cleaning business once again and continue her budding new pet sitting business. "I can't say thank you enough," Melisa said. "InterFaith has been a true life-saver for me."
