PAYMENT INSTRUCTIONS

Student Financial Services offers three type of payment options, online, in person, and by mail. As a reminder you are required to pay your registration fees within 3 days of registering for classes. If you do not pay for these fees you may be subject to disenrollment.

Payment Option #1: Online

Payments can be accepted online with one of the following forms of payment:

- E-Check
- Credit Cards
- Debit Cards

Payments made online via the web are due by 11:30 PM on the due dates given by Titan Online (Web registration).

Payment Option #2: By Mail

You can submit one of the two following forms of payment by mail:

- Money order
- Check

Include your name and CWID# on the money order or check so that the Student Financial Services office can identify your account.

Mail-in payments are due by 5:00 PM on the date given by Titan Online after registering.

Payment Option #3: In Person

You can pay for your fees with one of the four following forms of payment in person:

- Check
- Money order
- Debit Card

INSTALLMENT PAYMENT PLAN

If you are unable to make the full payment you may be eligible for an Installment Payment Plan.

The Installment Payment Plan gives CSUF students the opportunity to pay their Registration and Tuition Fees or Non-Resident Tuition Fee in **three monthly** installments.

**Required course fees (distance fee, piano usage fee, evaluation fee, orientation fee, book fee, professional program fee) for specified majors are not available for Installment Payment Plan. A non-refundable administrative fee is charged to sign up for Installment Payment Plans.

Installment plans are NOT available after September 8, 2015.

INSTALLMENT PAYMENT PLAN

ELIGIBILITY REQUIREMENTS:

- You do not have a past due balance for any prior term.
- You are admitted for the term.
- You have not already paid your current term registration and tuition fees or non-resident tuition fee.
- You may not be eligible to participate in this program if you owe the University money or have a history of payment difficulty.
- You have not been awarded Financial Aid: You should not apply for the IPP if you have accepted a financial aid award or your financial aid file is complete and you are awaiting your award notification.

INSTALLMENT PAYMENT PLAN

HOW TO APPLY:

DO NOT SIGN UP FOR INSTALLMENT PAYMENT PLAN UNTIL AFTER YOU REGISTER OR YOUR ACCOUNT WILL NOT CALCULATE CORRECTLY.

- Students 18 years of age and over should apply online **IMMEDIATELY AFTER** they register on Titan Online. This will result in the correct amount due being given to you after you register in TITAN Online.
- Students under 18 years of age should complete the paper application, sign it (both student and the parent's signature), and submit the IPP application to Student Financial Services (UH 180) **IMMEDIATELY AFTER** they register. This will result in the correct amount due being given to you after you register on the TITAN Online.

INSTALLMENT PAYMENT PLAN

MAKING PAYMENTS:

All payments made **online** must be received by **11:30 PM** on the due date given to you when you register.

All **in-person** and **mail-in payments** must be received by **5:00 pm** in the Office of Student Financial Services (UH 180) on the due dates given after you register.

You are responsible for payments by the due date even if you do not receive a bill. **Failure to make payments on time may result in disenrollment from all classes.**

INSTALLMENT PAYMENT PLAN

LATE PAYMENT AND CANCELLATION

- Each late payment made is subject to a \$20 late fee
- A hold will be applied to your student account which will prevent you from requesting transcripts and class registration

ACCOUNT BALANCE

- If you have questions about your account balance or payments submitted, contact the Student Financial Services office by email, phone or visiting the office.

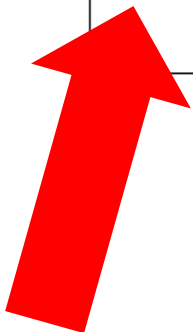
