


IN-DEPTH ANALYSIS

Involvement of the National Parliaments in SCP and NRP – 2013 and 2014

In order to increase the transparency, ownership and accountability National Parliaments (NPs) should take part in the European Semester by being involved in the preparation of Stability/Convergence Programmes (SCP) and National Reform Programmes (NRP). Each Member States' Stability or Convergence Programme shall include information on what national procedures it went through, in particular whether the programme was presented to the national parliament and whether it has been approved by the parliament (Art. 3.4 of Regulation 1175/2011).

The table overleaf provides information on the form of involvement of the national parliaments as specified in the text of the respective SCPs and the NRPs in 2013 and 2014. The following "colour coding" is used in the table:



Summary of the table:

- In 2013, 12 SCPs and 9 NRPs included information on the role of NPs.
- In 2014, 16 SCPs and 15 NRPs include information on the role of NPs.
