About This Document

With most AAFC employees working remotely due to the COVID-19 crisis and increased demands on our internal network, the Indigenous Support and Awareness Office (ISAO) has developed an interim, Internetbased training guide as a means of supporting at-home learning for AAFC employees looking to support the <u>Truth and Reconciliation Call to Action #57</u> without putting additional strain on the network. This guide uses only a handful of selected materials from ISAO's vast training collection on Knowledge Workspace, with additional materials available upon request. All resources here and on ISAO's Knowledge Workspace have been kindly and thoroughly vetted by the Indigenous Network Circle.

ISAO always recommends in-person learning, but based on the current situation, this learner-driven resource will serve as an alternative education pathway. To ensure that the AAFC bandwidth remains free for those performing critical services, we ask that you engage with these training tools while you are not logged into the VPN. Bilingual resources have been included as much as possible under the short timeframe, with more to follow as needed.

History

Residential Schools

 - This books depicts Alice's lived experiences going through four different residential schools, and the impact on her life as a direct result of the Grey Nuns and the Government of Canada.
- Broken Circle: The Dark Legacy of Indian Residential Schools: A Memoir Theodore Fontaine
 - The memoir examined the impact of Theodore's experience in residential schools and posttraumatic stress on his adult life.

Science and Research

- Braiding Sweetgrass: Indigenous Wisdom, Scientific Knowledge and the Teachings of Plants Robin Wall Kimmerer
 - Robin Wall Kimmerer intertwines biology and the teachings of the Potawatomi Nation to reveal a path towards healing the rift between people and nature.
- Native American DNA: Tribal Belonging and the False Promise of Genetic Science Kim TallBear
 - Kim TallBear shows how DNA testing is a powerful and problematic scientific process for Indigenous Peoples, and the consequences attached to land, resources and sovereignty.

Agriculture

- Clearing the Plains: Disease, Politics of Starvation and the Loss of Aboriginal Life James Daschuk
 - Looks at the roles of Old World diseases, climate and Canadian politics, and how a policy of starvation against Indigenous People was used to clear the way for settlement.
 - Lost Harvests: Prairie Indian Reserve Farmers and Government Policy Sarah Carter
 - A historical look at Indigenous agriculture in the Prairies, and how government policies made farming virtually impossible for Plains Indians.
