o Include 4 homes that wanted to participate but were not able to participate

- Need to make as much of the information as publicly as possible.
- All material is property of the state when finished.
- We will need to post it on our sites.
- Needs to include with other stakeholders and the State. The link will be posted publicly
- Cannot do in person visits Do they want the rest paid out for that.
- Outreach to participants is necessary. Phone call and email Support, generating excitement.
- Need to redact all participants and personal information.
- Around 50,000k left on their contract. Can they write a price out? This needs to be done
 in the next 11 days (June 30th is the cutoff date). Due to state law the grant cannot be
 extended due to the Covid-19 pandemic. Fair market price out. Needs to be approved
 before 6/30.
- o Approved, but need plan put in writing.
- o Suggest submitting grant for next cycle to develop website.
- Evaluation reporting bill for that, but not the entire \$50,000.
- o Reasonable to say this is grant this is end date- COVID happened
- Final report should include lessons learned, feedback, explanation of pandemic issues finishing project, suggestions for those who would do it in the future, curriculum,
- Website development now cannot pay for it after the fact.
 - Past projects not that they own the website.
- o Called Penny and invited her to join. Cindy left message and sent link.
 - Can be done by June 30. Working on it now.
 - Not the materials issue ready to share.
 - How do they get it so it is posted on our site? CDPHE and HCPF can post the link.
 - General concerns that the development of the website is outside what was approved.
 - RC discussed Board interest in extension/additional grant. Submit new grant application.
 - Write up report for the initial grant. Materials.
 - Website is \$2000 for creation. Has ability to expand.
 - Deliverables pre and post assessment Post assessment did not happen.
 - Bill final report costs or intent to bill for remaining balance. They planned on bill
 for the remaining balance. Qualitative and quantitative will pull those out. Blog
 component was the way to do this.
 - Experiences in leadership that comes out of it.
 - Min pay for time to do the final report. May be able to pay the \$2000 for the website.

Information regarding CMP Assistive Technology application

- Application for emergency CMP funds for communication devices in nursing homes.
 - Recognizing that COVID-19 visitor restrictions may be difficult for residents and families, CMS has developed an application template for requests for the use of Civil Money Penalty (CMP) Reinvestment funds to provide residents with adaptive communicative technologies.
 - Note: CMS approval of proposals to use CMP funds for other purposes may be temporarily suspended during this public health emergency.
- Approved 40 applications that cover 70+ facilities
- Waiting for revisions for 51 applications.
- Portal message will be sent out next week.
- CMS wants 100% of Co NHs funded for this grant.

 - $\circ\quad \mbox{New and converted training in lieu of conference.}$
 - o More training finishing up this week.
 - Will include 3 full courses and 4 mini courses. (dementia, leadership and group model)

- o Foundational training is necessary to get them ready for the wellbeing course.
- Evaluation could do a prelim video with intro and explanation how programs work.
- Provide tools/framework for leadership on how to drive sustainable change and growth.
- SKB Why so expensive?
 - o Pricing for courses \$199 one of the courses cost is \$249 Priced out to around \$700-\$900.
- RC Operational
 - People would access this in different paces.
 - o How will they be billing? 3 months registration? 6 months registration?
 - How long will they have access to the courses?
 - Will always have access to the courses.
 - Will receive workbooks.
 - People can access learning notetaking may not get everything written down. This way they
 can go back to find information they need.
 - More people will get to learn from. Not able to attend every session at a conference.
 - o New LMS? Licensed? Per resident cost?
 - Private Facebook pages for each course.
 - Courses are sold individually. Not licensed from someone else. It is their own platform.
 - Need something on how you price courses for others individual courses and packages
 - o Functionality for individuals to talk to each other (networking like they would at a conference).
- JRM portability
 - o How will they make the content/reports available to the public?
 - o Will this be available to nursing homes that did not participate?
 - o Post participation feedback. Need to be able to report that information.
 - Independent evaluator will create a separate training just for this project.
 - Will be answering questions that they have along the way and will be able to do comparative analysis as well as after each course.
 - Will be creating a final results report at the end of the timeline. Could create a video with results from the project that anyone can view.
 - o Efficacy and impact how to implement and impact on care for residents ongoing.
 - Questions that will be asked after each course.
 - What stood out to them the most?

- What are they inspired to try in their facility?
- One chapter a week at a time what have they implemented and what works?
- Will these courses speak to the pandemic? The Eden model addresses social isolation. What does the practice look like in an isolation situation?
 - Could look at another element how does this play out in a pandemic?
- The Board has fear of isolation for people in the communities. How do you use this in isolation? Can they make a toolkit? May not be able to conceptualize how that would work.
- What could you implement currently in the facility?
- What does connectedness look like right now? Masks cannot view expressions, cannot eat in congregation, trouble hearing. Cannot touch people (no hugs). In fight or flight mode don't feel like they have to wait till this is over to implement.
- More important now than ever this may be the new normal.
- Thought about how they offer Eden certified associated training set weekly time. Decided to move forward with learning at their own pace approach. Online learning at set times (classroom).
- Master technician to come in. Should come prepared having recent experience in NHs.
- NHs will be more restrictive.

Board discussion

- Different world now need care more than ever.
- o 3 main courses, 4 mini courses, check-in, 3 live sessions.
- Should they change from dementia focus? May lose them because of the change to a focused project.
 - There are more and more facilities having to deal with dementia
- Different preference for the core courses?
- Liked the answers to the questions need to make sure it can be conceptualized and used in the moment.
- o Replicability increasing knowledge for all Co NHs take knowledge wherever they go.
- Accessibility Tied to a log in. Not just engaging with providers we are engaging with workforce.
 Staff can take courses at any time.
- o How will they know that they have done the training? Can the facility see who is taking the courses?
- In the midst of a pandemic management has different priorities and responsibilities (phone calls, meetings). May not be able to be involved for day to day leadership like they normally would.
- Need to have time to do the training.
- o Accountability Can they pull QAPI reports?

- Emotional break and focus from COVID.
- How will they adapt to day to day life in a NF with all of these changes?
- o Can the courses be tailored?
- Recruitment Aug 1 to Oct 1. Conference registration no PO (400 people to \$600 as long as they are registered during that timeframe.
- o In comparison to other online courses it is a good deal.
- Video in a beginning about unprecedented times COVID-19 lingering get back to normality can they add this to the intro video.
- o Live groups as well as intro video.

 - Will be answering questions that they have along the way.
 - Will be able to do comparative analysis as well after each course.
- Final report

 - How do you use this during mandatory isolation situations like the current one?
- o Applicability Current state
 - Look at adding additional element(s) to the trainings (not the same as the toolkit).
 - How does this play out in a pandemic?
 - What does connectedness look like right now?
 - How will they adapt to day to day life in a NF with all of these changes?
- Accountability
 - How will the facility know that they have done the training?
 - Can the facility see who is taking the courses?
 - Can it be pulled on QUAPI reports?
- o Recruitment Aug 1 to Oct 1.
 - Conference registration no PO (400 people to \$600 as long as they are registered during that timeframe).

- HCPF is trying to get a fully funded admin position for this grant.
- Will discuss the new grant cycle next month.
