SUMMARY: The Charlotte County-Punta Gorda MPO and the Sarasota/Manatee MPO worked closely together during the development of their 2045 Long Range Transportation Plans to coordinate projects of regional significance to both areas.

River Road:

The widening of River Road from US 41 to I-75 is fully funded in the FDOT work program in FY 2021/22 as a design/build project. The widening of River Road from US 41 to Winchester is fully funded in the Sarasota/Manatee 2045 Long Range Transportation Plan.

Yorkshire/Raintree:

The development of the local road network in North Port, along with the city's designated economic development area will create the demand for the Yorkshire/Raintree interchange. Connecting Veteran's Highway with Hillsborough/Raintree will further support demand. The interchange has not been prioritized in the FDOT SIS plan, so the Sarasota/Manatee MPO elected to invest Other Road (OR) funds in the early phases of the project in their 2045 Long Range Transportation Plan.

SUN Trail Program




- Provides funding for developing a statewide system of paved, multi-use trails for bicyclists and pedestrians.
- Used for funding projects within the SUN Trail Network.
- ☐ The SUN Trail Network is the paved component of the Florida Greenways and Trails System (FGTS)

 Priority Land Trail Network.
- Program will not fund components such as sidewalks, nature trails, and amenities associated with trail projects.
- Funded projects are operated and maintained by an entity other than FDOT following construction.

 FDOT does not fund operation and maintenance costs.
- ☐ FDOT defines multi-use trail as a paved, shared-use path.
- ☐ Trail width is typically 12 feet wide (may vary 10 to 14 feet). Trail width as narrow as 8 feet may be used in extremely constrained areas such as bridges or environmentally sensitive lands.
- FGTS establishes Florida's vision for a statewide trail network and provides the framework for systematically closing trail gaps and connecting priority corridors through coordinated planning efforts of public and private partners.

Project Description



There is a growing nationwide trend of creating mixed-use communities centered around f, f and transit facilities. By evaluating the existing and future roadway conditions and analyzing the economic impact as well as compiling acquired data, this study aims to evaluate the potential implementation of that trend while providing safe, accessible transportation options along the project limits.




SUN Trail Network



SUN Trail Network (Source FDOT)





Trail Path:

- ☐ Gisinger Blvd. from Jennings Blvd. to Gillot Blvd
- ☐ Gillot Blvd. from Gisinger Blvd. to State Road (SR) 776
- SR 776 from Gillot Blvd. to US 41 (Tamiami Trail).

Trail Length: 11 miles

35% of the length is located within residential land use and the rest (along SR 776/S McCall Rd.) fall within commercial and business districts.






This path aims to boost the local economy in Charlotte County by attracting more nonmotorized consumers, tourists, and visitors and promote multimodal opportunities.







SUMMARY: The Transportation Regional Incentive Program (TRIP) was created to improve regionally significant transportation facilities in "regional transportation areas". State funds are available throughout Florida to provide incentives for local governments and the private sector to help pay for critically needed projects that benefit regional travel and commerce. The Florida Department of Transportation (FDOT) will pay up to 50 percent of the non-federal share of project costs for public transportation facility projects.

Both MPO staffs are working with local agencies and have received their TRIP project submissions to be approved by the respective MPO Boards.

The Charlotte County-Punta Gorda MPO and Sarasota/Manatee MPO Interlocal Agreement for Joint Regional Transportation Planning and Coordination asks that FDOT attempt to award funding on an equitable basis among the three counties (Charlotte, Manatee, and Sarasota) when funding new TRIP projects. As Charlotte County has received a preponderance of TRIP funding since the program's inception, the MPO Directors have agreed to recommend that Charlotte County's priorities should be listed as the third priority on the next Joint TRIP Project Priority list for 2021.



SUMMARY: The Military Order of the Purple Heart, a national organization, established a program to identify a symbolic "Purple Heart Trail" throughout all 50 States, Puerto Rico and Guam. That has been accomplished. Florida has designated the "Purple Heart Memorial Highway" on I-75 from the Ocala City limits to the Georgia State line. US 27 is designated a "Purple Heart Highway" essentially the length of the State. The designations of a transportation facility are an act of the State Legislature, and erection of appropriate markers are contingent on appropriate city or county commissions passing a resolution in support of the honorary designation before Florida Department of Transportation (FDOT) installs signage.

The possible designation of I-75 as a continuous Purple Heart Memorial Highway has been part of the agenda of the Joint MPO Meetings with the Sarasota/Manatee MPO since January 28, 2019 and the Lee County MPO since February 22, 2019. The Charlotte and Lee Counties subsequently supported the initiative through a motion to compose a resolution from the two MPO Boards in support of the effort to designate the portion of I-75 in Lee and Charlotte Counties as a Purple Heart Highway, with the additional goal of the entire length of I-75 being designated.

Of note, during the last Legislative Session, I-95 in Florida was designated as a Purple Heart Highway.

On December 7, 2020, the Charlotte County-Punta Gorda MPO Board added the I-75 Purple Heart Highway Initiative to the 2021 MPO Legislative Position Statement, authorizing its distribution to the area's Legislative Delegation.
